An Act to vest in the Devises and Trustees of the last Will and Testament of the late Stanous Daniell, a certain Road allowance laying between the Credit or Indian Reserve, in the Township of Toronto, in the County of Peel, and the New Survey in said Township.

WHEREAS the Road allowance originally intended to open a Preamble, communication between Dundas Street, in the Township of Toronto, in the County of Peel, one of the United Counties of York, Ontario and Peel, and Port Credit on Lake Ontario, in the
5 said Township, has been found inconvenient, and for that reason has never been opened or travelled; And whereas a new Road allowance was given by the late Stanous Daniell, in his lifetime, in the place of the said original Road allowance, which said new Road allowance is now travelled and used by the public in lieu of the said
10 original allowance; And whereas the said Stanous Daniell, on or about the twenty third day of December, in the year of our Lord one thousand eight hundred and forty eight, duly made his last Will and Testament sufficient for the passing of real estate, by which last Will and Testament the said Stanous Daniell devised and
15 bequeathed all his real and personal estate to his wife, Eleanor Daniell and his sons James Daniell, J. D. Daniell and William Daniell, in trust for certain purposes in the said Will mentioned, and afterwards on or about the twenty-eighth day of December in the year last aforesaid, the said Stanous Daniell departed this life without
20 having revoked or altered the same; And whereas the said Eleanor Daniell, James Daniell, J. D. Daniell and William Daniell, the Devises and Trustees of the said last Will and Testament of the said Stanous Daniell, are desirous of having the original Road allowance, as far as the same is included between the boundaries of
25 the said estate of the said Stanous Daniell deceased, and as far as the same may touch or border upon the said estate, vested in them as such Devises and Trustees for the uses, trusts and purposes in the said Will mentioned, in lieu of the said allowance so given by the said Stanous Daniell as aforesaid; Be it therefore
30 enacted, &c.,

That the original Road allowance running between the Credit or Indian Reserve and the New Survey in the Township of Toronto aforesaid, so far as the same is included between the boundaries of the said estate of the said Stanous Daniell, deceased, and as far as the same may touch or border upon the said estate, shall be and the 5 same is hereby vested in them the said Eleanor Daniell, James Daniell, J. D. Daniell and William Daniell as Devisees and Trustees of the last Will and Testament of the said Stanous Daniell, for the uses, trusts and purposes in the said Will mentioned, and the same is hereby made and declared to be a part and parcel of 10 the said estate for the purposes aforesaid.
