

FREDERICTON,

TUESDAY, the 11th day of JANUARY, 1814.

THE GENERAL ASSEMBLY having been prorogued by several Proclamations until this day, then to meet for the despatch of business; the House met.

Xenophon Jouett, Esquire, Gentleman Usher of the Black Rod, delivered the following Message:---

"His HONOR the PRESIDENT requires the attendance of this Honorable House in the Council Chamber;" upon which the House immediately attended His HONOR the PRESIDENT in the Council Chamber; and having returned.

Read a first time a Bill for the regulation of fees in all actions hereafter to be brought in the Supreme Court of this Province, whenever the sum or matter in demand shall not exceed the sum of *twenty pounds*.

The Speaker then reported that the House had attended His Honor the **PRESIDENT** in the Council Chamber, and that he was pleased to make the following Speech to both Houses, a copy of which he read in his place, and is as follows:—

" Gentlemen of the Council, and

"Gentlemen of the Assembly,

"As no change of importance in the condition of this Province has occur-"ed since your last meeting in General Assembly, the principal objects "which I have to recommend to your present deliberation are the necessa-"ry provisions of the Revenue and Appropriation for the ensuing period, "and a review of the Militia Law, which may perhaps, by some amend-"ments, be rendered more efficient for the essential purposes of defence for "which we are so loudly called upon to be in a constant state of preparation.

"The Royal Approbation of the Act passed with a suspending clause in "the last Session for the further increase of the Revenue of this Province "has been publicly notified. A copy of the order of His Royal Highness "the PRINCE RECENT in Council, made for this gratious purpose in the mame and on behalf of His MAJESTY shall be laid before you.

"Such other subjects as I may have to propose for your consideration, "shall, in the course of the Session, be communicated by Message.

- Gentlemen

" Gentlemen of the Assembly,

"I have directed the Treasurer's accounts and such other documents as "may be required for your further information, to be laid before you. From "the state of the Treasury I am happy to find the Kevenue has, in the last, "been more productive than any former year.

" Gentlemen of the Council, and

" Gcutlemen of the Assembly,

"While we lament the infatuation by which the Government of the Uni-" ted States has been led to take a course directly the reverse of that which "every free people, in a similar situation, ought to have pursued, we have " reason to hope this frenzy will not be of long duration. It broke out, in a " declaration of War against His MAJESTY, at a time when the sanguinary " usurper of France had become more than ever formidable in Europe, and " his lust of universal dominion appeared to be no longer considered as a "hopeless and romantic passion. In that moment the unnatural ambition " of his American Partizans was fired with a hope of sharing in his expected " triumph over that Country which alone continued with effect to resist his " destructive career, the Country from which they were themselves descend-" cd. - Eut a merciful providence has since opened a prospect which may " well animate the courage and the hopes of suffering nations. The glori-" ous successes which have crowned the Arms of His MAJESTY and of his ".reviving Allies in Europe, and the disappointed efforts of unprovoked hos-" tility in America, may with reason be considered as pledges of a " Con-" summation devoutly to be wished' in which the wise and good of every " Country will rejoice to see a general restoration of peace and indepen-" dence to those nations which have so long suffered the horrors of revolu-" tion, oppression and desolation.

"In the mean time whatever may be the course of approaching events, "it will be most sincerely my ambition to contribute, by every means in "my power, to the security and prosperity of the Province committed to "my administration."

On motion of Mr. P. Frascr, resolved that an address be presented to His HONOR the PRESIDENT in answer to his Speech. Ordered, that Mr. W. Pagan, Mr. Leonard, and Mr. P. Fraser, be a committee to prepare the same. The House then adjourned until to-morrow morning at 11 o'clock.

WEDNESDAY, the 12th day of JANUARY, 1814.

PRATERS.

On motion of Capt. Agnew, ordered, that the Speaker do issue his warrant to the Clerk of the Crown, to make out a new Writ for the electing of a Member to serve in General Assembly for the County of York, in the room of Duncan M^cLeod, Esquire, deceased.

Ordered that the Clerk of the Crown or his Deputy do attend this House forthwith, with the last Writ issued to the Sheriff of the County of Westmorland, for the election of a Member, for the said County, and the return thereto.

The House in committee Mr. Leonard in the chair, went into consideration of His HONOR the PRESIDENT'S Speech. The Speaker resumed the chair, and the chairman reported progress, and that the committee were of opinion, that a committee should be appointed to examine what Laws are near expiring, and report thereon further, and a committee to revise the Militia Law, whereupon ordered, that the consideration of His HONOR the PRESI-DENT'S

DENT's Speech be postponed until to-morrow, and that Mr. M^c Donald, Mr. Ward, and Mr. Knapp, be a committee to examine what Laws have lately expired, or are near expiring, and to report thereon.

The House then adjourned until to-morrow morning at 11 o'clock.

THURSDAY, the 13th day of JANUARY, 1814.

PRAYERS.

The Deputy Clerk of the Crown attending with the Writ and return pursuant to the order of yesterday, and it appearing thereby that *William Botsford*, Esquire, is duly elected a Member of this House for the County of Westmorland, in the room of *Amos Botsford*, Esquire, deceased; it is ordered that Mr. Chapman and Mr. Campbell, do attend the commissioner with Mr. Botsford, and see him qualified, who accordingly attended and being returned, report that, Mr. Botsford had taken the oaths prescribed by Law, upon which he took his seat.

Mr. M^cDonald from the committee appointed to examine what Laws have lately expired, or are near expiring, reported that an Act to continue for a limited time, an Act, entituled, "An Act for regulating, laying out, and repairing Highways and Roads, and for appointing Commissioners and Surveyors of Highways within the several Towns and Parishes in this Province:" will expire on the twenty first day of February next.

That "An Act to impose a duty on certain articles imported into this Province, and "An Act to authorise the Justices of the Peace for the Counties of York and Charlotte, respectively, to regulate the Assize of Bread in the Towns of Fredericton and Saint Andrews," and "An Act more effectually to prevent the incumbering and filling up of Harbors, and to authorise the appointment of Harbor-Masters" will expire on the seventh day of March next.

That "An Act for regulating the Militia," and "An Act to provide for the accommodation and billeting of His MAJESTY's troops and the Militia when on their march," will expire at the end of the present Sessions of the General Assembly of this Province.

That "An Act to continue and amend the Act for raising a Revenue in this Province and the Act in amendment thereof," and "An Act for laying additional duties on certain articles imported into this Province," will expire on the first day of April next.

That "An Act to provide for the more effectually repairing the Streets and Bridges in the City and County of Saint John," and "An Act to prevent the the destruction of Moose on the Island of Grand Manan," and "An Act to provide for the erection of Fences and Gates across the Highways, leading through intervale lands in Queen's County, and the County of Sunbury, where the same may be found necessary," will expire on the fourteenth day of March next.

That "An Act for the better securing the navigation of certain harbors in the County of Northumberland," and an Act to continue an Act, entituled, "An Act to prevent illicit and clandestine trade, and for imposing a duty upon certain articles illegally imported or brought into this Province, to be levied and paid after the condemnation and sale thereof," will expire on the first of April 1815.

Mr. P. Fraser, of the committee appointed to prepare an Address in answer to His HONOR the PRESIDENT'S Speech, reported a draught thereof, which he read in his place, and the same being delivered and read at the Clerk's

Clerk's table, was on motion of Capt. Agnew, committed to a committee of the whole House. The Speaker left the chair.

The House in committee, Mr. Campbell in the chair, went into consideration of the Address in answer to His HONOR the PRESIDENT's Speech, and having gone through the same, paragraph by paragraph. The Speaker resumed the chair, the chairman reported that the committee had agreed to the Address with amendments, which was read as amended, and is as follows:—

To His Honor Major General Sir THOMAS SAUMAREZ, President and Commander of the Province of New-Brunswick, &c. &c.

The Humble Address of the House of Assembly.

"MAY IT PLEASE YOUR HONOR, "The House of Assembly truly sensible of the importance of those principal objects recommended by your Honor, ' the Revenue and appropriation for the ensuing period,' and ' a revisal of the Militia Law,' will make them the subjects of their most serious deliberation.

"His MAJESTY'S Royal Approbation of the Act of the last Session "for" "the further increase of the Revenue of this Province," and the Order of His "Royal Highness the PRINCE REGENT thereon, are communications from "your Honor highly gratifying to the House, ever ambitious to obtain His "MAJESTY'S approbation.

"The House also beg leave to assure your Honor, of their due and faith-"ful attention as well to such other subjects, as shall be proposed by your "Honor, for their consideration during the present Session, as to the Trea-"surer's accounts, and all other papers and documents which your Honor "may direct to be laid before them; and they derive high satisfaction from your Honor's communication of the improved state of the Revenue during "the year past.

"The folly and ingratitude of the Government of the United States in "the prosecution of the present war against Great-Britain, and the unwor-"thy motives (so correctly detailed by your Honor) which have led to this "unnatural devotion of their powers, in support of a sanguinary usurper, "against that Country which gave birth to their ancestors, and protection "to themselves, must consign them among nations to obloquy and con-"tempt; and the House unite with your Honor in ascribing to the immedi-"ate interference of a merciful providence the glorious successes which have "crowned with victory the Arms of His MAJESTY and his Allies in Europe, "and blasted the hopes and unavailing efforts of unprovoked hostility on "this Continent; which appear to be pledges of an happy consummation, and of a general restoration of Peace and independence to the suffering "nations.

"The House have also the fullest confidence, that, your Honor's wise and "prudent administration will contribute not only to the present security, "but also to the future prosperity of this Province;" and being read a second time, resolved unanimously that the same be engrossed and signed by the Speaker, and presented to His HONOR the PRESIDENT by the whole House.

Mr. Johnston presented the Saint John Light House accounts to the House, which are ordered to lay on the table.

Mr. R. Pagan moves for leave to bring in a Bill to make perpetual, several Acts of the General Assembly, which are near expiring.

On motion ordered, that Capt. Agnew, Mr. Dunn, and Mr. Chapman, be a committee to bring in a Bill for regulating, laying out, and repairing Highways

ways and Roads, and for appointing Commissioners and Surveyors of Highways within the several Towns and Parishes in this Province.

On motion ordered, that Mr. R. Pagan, Mr. Johnston, and Mr. Knapp, be a committee to bring in a Bill to alter and amend an Act, entituled, "An Act for assessing, collecting and levying County rates."

Ordered that, Mr. Botsford, Mr. Campbell, and Mr. Allen, be a committee to revise and amend the Militia Law.

The House then adjourned until to-morrow morning at 11 o'clock.

FRIDAY, the 14th day of JANUARY, 1814.

" Gentlemen of the Assembly,

" I return you my sincere thanks for this Address, and gladly avail myself " of the occasion to express my entire confidence in your zeal and ambition " to second my best endeavors to secure and promote the welfare and pros-" perity of this Loyal Colony."

Mr. R. Pagan by leave brought in a Bill to make perpetual several Acts of the General Assembly that are near expiring; which was read a first time. The House then adjourned until to more morninget it i o'clock

The House then adjourned until to-morrow morning at 11 o'clock.

SATURDAY, the 15th day of JANUARY, 1814.

Read a second time, a Bill to make perpetual several Acts of the General Assembly which are near expiring, and ordered to be committed.

The House in committee Capt. Agnew, in the chair, went into consideration of a Bill to make perpetual several Acts of the General Assembly which are near expiring. The Speaker resumed the chair, the chairman reported that the committee had agreed to the Bill, which report was received. Ordered, that the Bill be engrossed.

The House then adjourned until Monday morning next at 11 o'clock.

MONDAY, the 17th day of JANUARY, 1814.

As credit is given in the Treasurer's account current for only £53; 2, remitted by the Deputy Treasurer, it appears there is a balance of £1072:19:9 due for Duties there.

No. 7, is the Deputy Treasurer of Shediac's account of Duties collected in 1810, 1811, and 1812, amounting to £265:14:11, credit is given in the Treasurer's account current, £174:11:6; on account of these Duties, leaving a balance, due of £91:3:5. That the sum of one hundred pounds be granted to John Robinson, William Black, and William Pagan, to reimburse that sum advanced by them to be paid towards the support of a Packet, that has been contracted for and employed to ply between Digby and St. John, since the 15th day of May last for one year, in consequence of a like sum being granted by the Legislature of Nova-Scotia, for the same Packet.

That the sum of *fifty pounds* be granted to James Paul, for his past services in acting with his vessel, as a packet between Saint Andrews and Saint John.

That a sum not exceeding one hundred and fifty pounds be granted for the support of a Packet to ply between Digby and Saint John, for one year, to commence the 10th day of May next, and the like sum for the year

Mr. Wetmore from the select committee appointed to examine and enquire into Peter Clinch's petition, gives in the following report, which is read as follows:

The committee of the House of Assembly to whom was referred the petition of Peter Clinch, Esquire, praying for a suspension of the Act passed in the 52d year of His Majesty's Reign, authorising the Justices of the Peace for the County of Charlotte to an assessment for paying off the County debt, and for finishing and completing the County Gaol and Court House lately erected in the said County, until such time as an account of the debts in particular, and gaol building of the said County should be laid before the House;

"Report, that they met at the time appointed, and were attended as well by the petitioner as other of the Magistrates and Representatives of the County, from whom they received information quite satisfactory to your committee, upon such of the allegations of the petitioner as were deemed revelant and proper to be noticed, to induce them to unite in opinion that the prayer of the petitioner ought not to be complied with.

"It appeared to your committee that the expences incurred by Agents for the Penobscot association, were by direction of the Governor of Nova-Scotia to have been defrayed by the proceeds of the sale of certain water lots in the town of Saint Andrews, and of mill priviledges in that part of the County

"County afterwards forming the said County of Charlotte, and that by the "prudent provisions of the Act of the 26th year of His Majesty's Reign, "chapter 41st, all those expences were defrayed, and a considerable ba-"lance carried to the public stock of the County, which has been applied "towards discharging the debts incurred in building the first Gaol and "Court House.

"It further appeared that four of the null priviledges which had been "sold, have not been paid for; but your committee are strongly inclined "to believe that the reason why prosecutions have not been commenced by "the Treasurer of the County, is that those mill lots were of so little value "as not to be worth the expence, which would necessarily attend the giving "of titles to the purchasers.

"It further appeared that the four hundred pounds assessed in 180[±], "(which assessment the said Act of the 52d year of the present Reign, "made legal) the greater part was paid except the proportions rated upon "the Parish of Saint George, in which the petitioner resides, and the Pa-"rish of Campo Bello, neither of which Parishes paid any part of their said "proportions, until after the passing of the same Act, and that the Magis-"trates of the County at large, at a very general meeting of them, resolved, (and as your committee conceive very justly too) that upon any future assessment of the County, those Parishes which had advanced their mo-"ney, and which had been applied in part to discharge the County "debts, then bearing interest, should be so far relieved as the interest of such sums would amount to, to be calculated to the time when the two Pa-"rishes of Saint George and Campo Bello paid their respective quotas of "the same rate.

" It further appeared that the Magistrates adopted the most correct me-" thod within their power when they made the said assessment, to apportion " it equally among the several Parishes.

"It also appeared that no other sum of money, except the said sum of "four hundred pounds has ever been levied or assessed upon the County "for the building of either of the two Gaols and Court Houses, or for any other County purposes, and upon a review of all the circumstances, your committee cannot refrain from noticing the asperity and peculiarity of the language of the petitioner so unwarranted as it regards the Magistracy of the County, and so incompatible with the respect due to this House: "all which is humbly submitted.

Ordered that the petition of William Hazen, James Simonds, and James White, be referred to the committee of roads.

And be it further enacted, that for the purpose of disciplining and improving the Militia in Martial exercises, the Commander in Chief may at such convenient season of the year as he may judge fit, interfering as little as possble with seed time and harvest, order out and keep together each battalion, together or in divisions within their respective districts, those above fifty years of age excepted, for any time not exceeding six days in each year, and every non-commissioned officer and private wilfully neglecting to appear at the time and place specified in such order, shall be liable to a fine of twenty shillings for each and every day that he shall so neglect to appear, and every noncommissioned officer and private who, after having appeared, shall at any time during the said six days, be absent from his company without leave from his commanding officer, shall, for each and every time that he shall be so absent without leave, be liable to a like fine of *twenty shillings*, which fines shall be recovered as herein after mentioned, provided always, that no person shall be required to travel more than thirty miles from his usual place of residence to attend the training of the battalion or the division thereof to which he may belong. And provided also, that persons, other than substitutes, who shall have been embodied and on actual service for the space of twenty days, and also persons who shall have procured substitutes to perform such actual service, shall not be required to attend such drill during the same year in which such actual service shall have been performed.

IV. And be it further enacted, that there shall be allowed and paid out of the Treasury of this Province, annually during the continuance of this Act, a sum not exceeding to be appropri-.

ated

ated for the purpose of defraying the expence of procuring provisions to be issued to the Militia, when so called out, for the purpose of training and disciplining, to be paid as other sums appropriated by law are directed to be paid, and there shall be allowed and issued to every officer, non-commissioned officer and private of the Militia actually attending at such training, the same allowance of meat and bread for every day they shall so actually attend as is usually issued to His Majesty's Troops.

V. And be it further enacted, that it shall be the duty of the several offlcers commanding Regiments or Battalions, immediately after the Regiment or Battalion shall be dismissed, to nominate and appoint a board to consist of not more than five nor less than three commissioned officers of the Regiment or Battalion; the President not to be under the rank of a Captain, which board shall assemble on the next Monday but one after the Regiment or Battalion shall be dismissed, at such convenient place as the said commanding officer shall direct; and a list of the names of all the delinquents in the Regiment or Battalion who shall have been absent from their respective Companies without leave, shall be laid before the said board, who shall have power to hear and judge of any reasonable excuse to be made, to appear to the satisfaction of the said board, on the part of any such delinquents, and either to impose the fines directed in and by the third section of this Act, or to remit the same as to the said board, in their discretion shall. seem just and equitable: and it shall be the duty of the President of the said board without delay to return to the commanding officer of the Regiment or Battalion a list in writing and signed by the said President, of the names of all persons upon whom fines shall be imposed by the said board. and also of the persons to whom the fines shall be remitted, with the reasons for so doing, which lists shall be entered by the Clerk of the Regiment or Battalion in a book to be by him kept for that purpose, and all fines so imposed shall be levied by a non-commissioned officer by an order of the commanding officer of the Regiment or Battalion as directed in and by the seventh section of the said recited Act, which order it shall be the duty of the said commanding officer forthwith to issue, and for want of goods whereon to levy, every such delinquent shall by warrant under the Hand and Seal of such commanding officer he committed to the County Gaol, there to remain not exceeding four days for each days delinquency or until such fine or fines, together with the fees to the non-commissioned officer, and the accustomed Gaol fees are paid, and it shall be the duty of the Gaolers in the several and respective Counties of this Province to receive and keep such delinquent during the time specified in such warrant, and then to discharge him upon payment of the fees to the non-commissioned officer, and the Gaol fees as herein before mentioned.

Ordered, that Mr. Attorney General and Mr. Botsferd, be a committee to meet a committee of the Council, to prepare an humble petition to His Royal Highness the PRINCE REGENT on the subject of the boundary line between the United States and this Province, and acquaint the Council therewith.

The House then adjourned until to-morrow morning at 11 o'clock.

PRAYERS.

Mr. Botsford from the committee appointed to prepare reasons to be laid before the House upon the subject matter of the amendments proposed by the Council to the Militia Bill, reported as follows, wiz.

The House of Assembly direct their committee of conference, upon the subject-matter of the amendments proposed by the Council to the Militia Bill, to state that the House cannot concur in the proposed amendments for the following reasons:—

1st. That the ordering out the whole of the Militia to attend general or Battalion-musters for six days, will in the opinion of the House be attended with serious inconveniencies, as it will tend to withdraw the whole of the male inhabitants between sixteen and fifty years of age from their agricultural, and other pursuits, at a time when the Province is called upon to make every exertion for its support.

2d. That the furnishing the Militia, with provisions, and the necessary camp equipage during the six days general muster, will be attended with an expence, which in the opinion of the House will by no means be counterbalanced by the benefits to result from such musters.

3d. That many of the advantages which attend the general musters, will in the opinion of the House be derived from having the Militia exercised, by two or more companies together, at the discretion of the commanding officers of the Battalions; and when at the same time the ease and accommodation of the inhabitants can be consulted.

4th. That great delay, will in the opinion of this House arise from the mode provided by one of the proposed amendments, for the levying and collecting of fines.

lecting of fines. 5th. That in the opinion of the House, some of the proposed amendments which impose additional burthens upon the people, and appropriate the public monies could not be made by the Council consistently with the usage of Parliament, as they involve principles, which are an infringement of the peculiar privileges of the House.

The House in committee, Mr. Street in the chair, went into consideration of further supplies to be granted to His Majesty for the public service. Mr. Speaker resumed the chair. The sum of *two hundred pounds* towards repairing the road from Sherman's to James Blackney's.

The sum of two hundred pounds towards repairing the portage from Blackney's to the ridge of Pine Land, about an half mile below Carlisle's.

The sum of one hundred and fifty pounds in aid of subscriptions towards erecting a bridge across the Memranicook river, at Lake Belfountain.

The sum of *fifty pounds* towards repairing the Bridge over Studville Mill Stream.

The sum of one hundred pounds towards widening and improving the Road from the finger board, to the head of Belisle.

The sum of *fifty pounds* towards improving the road from Kennebeckacis to Hammond river.

The sum of *thirty pounds* from the farm of the late Judge Upham, to Taber's, at the head of Hammond river.

The sum of one hundred pounds for improving the road from Taber's to Hopewell.

The sum of thirty pounds towards improving the road from Taber's to Quaco.

The sum of one hundred pounds, being one third of the estimate of the expences, to be incurred in repairing the aboideau bridge at Simond's Mills; provided that the sum of two hundred pounds, shall be expended thereon, by the proprietors of the Land, under the direction of Commissioners.

The sum of *fifty pounds* towards improving the road from Carleton, to John Mount's, in Musquash.

The sum of one hundred pounds towards crecting a bridge over the Western branch of Musquash river.

The sum of *twenty pounds* from the main road leading to Hopewell, to Martin's Head.

The sum of *fifty pounds* to assist the inhabitants on the bass wood ridge, to open a road to St. Stephen's.

The sum of two hundred pounds to bridge the Digdaguash river.

The sum of two hundred pounds to bridge the Magagaudavic river.

The sum of three hundred pounds to open a road from the settlement at Letang, in Charlotte County to the settlement at Musquash, in the County of Saint John.

The sum of one hundred pounds to clear the road from Conick's, to the river Magaugadavic, near the forks.

The sum of one hundred pounds to bridge the Magaugadavic river at that place.

The sum of *three hundred pounds* to open a road from thence, to the Oromocto river, in the County of Sunbury.

The sum of twenty five pounds to assist the inhabitants on the Chepitnicticook ridge, to open the road to St. Stephen's.

The sum of three hundred pounds from the head of Belisle, to Jemseg.

The sum of one hundred pounds from Gage Town, to the upper line of the County.

The sum of *thirty pounds* towards erecting a bridge over Little river, on the North West side of the Grand Lake.

The sum of *fifty pounds* towards improving the road from the lower line of the County of Sunbury, to Edward Burpe's house.

The sum of *fifty pounds* towards improving the road from Nathan Smith's house, to the Causey.

The sum of two hundred pounds towards completing the Causey in Burton.

The sum of one hundred pounds towards improving the road from the Oromocto to the Block House.

The sum of one hundred pounds towards repairing the road and bridges in Lincoln.

The sum of two hundred pounds towards repairing the roads and bridges on the river Nashwalk.

The sum of *fifty pounds* for improving the road from the Parish of Lincoln to William Segee's farm.

The sum of *fifty pounds* towards repairing the bridge near Essington's.

The sum of *fifty pounds* towards crecting a bridge over the Creek, below the French Village.

The sum of *fifty pounds* towards widening the bridge over Phillis's Creek. The sum of *eight hundred and fifty pounds* for improving the road on the

general line of communication from the French Village to the Presque Isle. The sum of one hundred and fifty pounds towards making a road from the

river Roostock to the Great Falls.

The sum of one hundred pounds towards making a road from the Great Fall's, to the Madawaska settlement.

The sum of one hundred and seventy five pounds, from the Head of the Nashwalk settlement to Bett's on the Miramichi.

The sum of two kundred pounds from Bett's to Fraser's, or Bobair's Island.

The sum of one hundred and fifty pounds for building ten Gondaloes for the use of the Ferries across ten rivers, between Shediac, and Nappau rivers, inclusive.

The sum of one hundred pounds for erecting two bridges across the Chockpish, and Portage rivers.

For improving the roads from Cocagne to Bucktouche, twenty five pounds. From thence to Richibucto, fifty pounds, and from thence to Passabiquack, fifty pounds.

The sum of two hundred pounds to explore, lay out, and open a road from the Richibucto to the Court House in Miramichi.

The sum of one hundred pounds be granted towards improving the new road, commonly called the back road, leading from the mouth of the Nashwalk, to the upper line of the County of Sunbury.

The sum of *twenty five pounds* towards improving the back read in Maugerville, from the lower boundary of the County of York, to where the said road joins the Maugerville road, on the bank of the river St. John.

The sum of thirty pounds towards completing the winter road from the head of Bates's Mill Pond, so called, in the Parish of Kingston, in King's County, to the river Kennebeckacis.

The sum of one hundred and fifty pounds towards completing the road from the bend of the Peticodiac river to Shediac.

Read a second time, a Bill in further addition to an Act, entituled, "An Act for the better ascertaining and comfirming the boundaries of the several Counties in this Province, and for subdividing them into Towns or Parishes." Ordered to be committed.

Mr. Campbell has leave of absence on his private business.

FRIDAY, the 18th day of FEBRUARY, 1814.

PRAYERS.

Mr. R. Pagan from the standing committee, appointed to examine, liquidate and report on all public and private accounts, reports that they had examined the several accounts submitted to them, which were read, and are as follows, viz.

A. Charles I. Peters, Esquire's, accounts of expenditure of monies on the Westmorland roads, between the Lake and N. Golding's—the sum of four hundred pounds has been received from the Treasury for that purpose, and three hundred and eighty two pounds four shillings and six pence of the same expended. Contracts for the work and vouchers for the payment with affidavit to the accounts are furnished.—There remains the sum of seventeen pounds fifteen shillings and six pence unexpended in the Commissioners hands.

B. Samuel Denny Street, Esquire's, account of monies expended on the Burton Causey—The sum of two hundred pounds has been received, and only one hundred and seventy five pounds eight shillings and seven pence expended, leaving a balance in the Commissioners hands of twenty four pounds eleven shillings and five pence, sufficient vouchers with affidavit to the general account are furnished.

C. Charles I. Peters and Nathaniel Golding's account of monies expended on the Westmorland road between the City of Saint John, and the French Village, the sum of one hundred pounds has been received, and ninety nine pounds fourteen shillings and four pence expended, leaving a balance of five shillings and eight pence with the Commissioners. The account is accompanied with sufficient vouchers and affidavit.

D. Mr. Edwin Hazen's account of monies expended on the road from Hammond River to Hopewell, and on the cross road from Martin's Head to Hopewell road, the sum of one hundred pounds has been received, and one hundred and two pounds one shilling expended, leaving a balance of two pounds one shilling due to the Commissioner—sufficient vouchers and an affidavit accompany this account.

E. Mr. Walter Bates's account of monies expended on the Portage road from Bates's Mill Pond to the Kennebeckacis river, the sum of thirty pounds has been received, and thirty four pounds eighteen shillings and ten pence expended, leaving the sum of four pounds eighteen shillings and ten pence due to the Commissioner; the account is accompanied with an affidavit and sufficient vouchers.

F. Thomas Menzies, Esquire's, account of monies expended on the road between Manawaganish and John Mount's; from the report of this committee mittee in 1812 it appeared, that the sum of seventeen pounds five shillings and one penny half penny, then remained in the Commissioner's hands, the sum of sixteen pounds fifteen skillings has since been expended, as appears by the report and vouchers; a balance of ten shillings and one penny half penny still remains unexpended.

G. Christopher Hatch, Esquire's, account of monies expended in exploring and opening a road from the settlement on Digdequash river to the Pleasant Ridge; the sum of *fifty pounds* was received and expended on that road the account is accompanied with an affidavit and receipt for the sum of *fifty pounds* paid.

No. 1. The Secretary of the Province's account of fees for issuing 59 warrants, amounting to fourteen pounds fifteen shillings.

No. 2. Jacob S. Mott's accounts for printing and publishing the Acts and Journals of last Session, amounting to eighty nine pounds sixteen shillings and three pence.

No. 3. Jacob S. Mott's account for printing public advertisements, &c. amounting to *fourteen pounds thirteen shillings and six pence.*—The committee remark that in their opinion some of the items in this account are not properly chargeable to the General Assembly, but owing to the decease of Mr. Mott, no explanation can be had on the subject.

No. 4. Jacob S. Mott's account for publishing Militia Orders, &c.-amounting to seven pounds two shillings and one penny.

No. 5. Samuel Buchannan's account for airing, and taking care of the Province Hall, amounting to fifteen pounds.

No. 6. The Honorable George Leonard, Esquire, Quarter Master General of Militia's account of expenditures for the Sloop Brunswicker.—'This account is accompanied with distinct and satisfactory vouchers.

From the stated account it appears that the sum of three hundred and fifty three pounds eight shillings and six pence has been received out of the Province Treasury—a charge is made of one hundred and sixty five pounds fifteen shillings and eleven pence half penny; this sum being a balance due to him on a settlement by the committee last year in liquidating his accounts,—the remaining sum of one hundred and eighty three pounds sixteen shillings is the amount of expenditure since the 10th February; from this statement there is a balance of three pounds sixteen shillings and six pence half penny in the hands of the Quarter Master General; the account of expenditure for Couriers, with vouchers has been submitted to this committee, but being of opinion that it is not one of the public accounts requiring their examination, they have therefore declined any other report-on it; which report was read and referred to the committee of supply.

"The President directs to be laid before the House of Assembly sundry "papers numbered one to five in answer to the Address of the House of the "15th instant, respecting the Sloop Brunswicker." "T. S." Read and ordered to lay on the table.

Read an engrossed Bill, in further addition to an Act for the better ascertaining and confirming the boundaries of the several Counties in th i Province, and for subdividing them into Towns or Parishes; and the question being put whether the Bill should pass; the following clause by way of rider was moved and seconded:

And be it further enacted, that this Act shall continue and be in force until the end of the next Sessions of the General Assembly of this Province and no "longer;" and the question being put thereupon, it passed in the negative; whereupon ordered, that the Bill do pass, and that Mr. Attorney General and Mr. Belding do carry the Bill to the Council and desire their concurrence.

Mr. Botsford from the committee appointed to conduct the conference with the committee of the Council on the subject matter of the last conference on the Militia Bill, reported that they had confered this day with the committee of the Council thereon, from whom they had received the following reasons in support of their former objections, to wit:

To the reasons assigned in conference, on the part of the Assembly, as the grounds of their dissent to the amendments proposed by the Council to the Militia Bill; the Council direct their committee to return the following answers:

I. If the inconveniences which must attend the proposed annual training of the several battalions of Militia for six days, will, in the opinion of the Assembly, be so serious, as to outweigh the urgent importance of the object aimed at in this Bill, namely, to render it efficient for the essential purposes of defence at this critical juncture; the Council would propose to the consideration of the House, a provision for enabling His Honor the President to appoint for each battalion, three several periods of twelve days each, to be attended by one third part of the battalion in succession, so that the whole may in turn have the benefit of a much more thorough instruction, and with less particular inconvenience; but, in all cases whenever the Militia are cailed out for training; the Council think it ought to be made an indispensable condition that they should be furnished with rations of provisions at the expence of the Province.

II. The Council cannot recede from their proposed amendment respecting the levying and collecting of fines under the Bill in question.

111. The Council most explicitly disclaim even a wish in the smallest degree to infringe the peculiar privilege of the House of Assembly, to grant and appropriate monies for the public service. They simply meant to sug-

gest to that House the making of such provision as might be adequate for that supply of provisions which they consider indispensably necessary for the Militia when assembled for the purpose of being disciplined and trained WM. F.-ODELL, Clerk. for the defence of the Province.

To Samuel Buchannan for airing and taking care of the Province Hall. fifteen pounds.

That the sum of ten pounds be granted to the Sheriff of the County of York for returning John Murray Bliss, Esq. a member for that County to serve in General Assembly.

That the sum of ten pounds he granted to the Sheriff of the County of Westmorland for returning William Botsford, Esq. a member for that County to serve in General Assembly.

That the sum of *twenty five pounds* be granted towards cleaning out Simond's Creek in the County of Sunbury.

This proposal how-"ever, was not only rejected by the House of Assembly but was considered "as an infringement of their peculiar privileges; in such an imputation " the Council could not acquiesce consistently with their duty to guard " against any innovations in the constitution of this Colonial Legislature. "Yet anxious to avoid at this time all particular discussions of that nature " they merely disclaimed the imputation, in the hope of finding the House " of Assembly alike disposed to abstain from questions of privilege at a " juncture like the present, and endeavor as far as the circumstances of the " Province would admit to meet the wishes of His Honor the President, " which can only be prompted by a sincere ambition to contribute every " thing in his power to the safety and welfare of the Colony committed to " his Administration.

"After several fruitless conferences on this subject, the Council have, as "a measure of conciliation proposed that, as the two Houses have not been "able to agree on any amendments of the existing Law, the further discus-"sion of that subject be for the present deferred, and that the Act of 1813, "be continued to the end of the next Session of the General Assembly. This "measure though it was actually adopted on Friday last by the House, and "was ordered to be on their part proposed to the Council for their concur-"rence, is now on being proposed on the part of the Council, rejected by "the House of Assembly, and a Bill sent up with provisions to which the "council cannot agree, since it is in their opinion much less efficient for the "essential purposes of defence than the Act of 1813, for the amendment "of which the Council still are anxious, but are fearful it cannot be obtain-"ed at present.

"It is stated, on the part of the House of Assembly, that by simply con-"tinuing the Act of 1813, many material benefits would be lost to the country, particularly the imposition of a fine upon aliens, and the recove-"ry of fines before the Captains, the latter of which is stated to have been adopted by the House of Assembly, at the strong recommendation of the Council. To this statement the committee on the part of the Council is instructed to answer that their recommendation was to provide for the recovery of fines not before a Captain, to which they have serious objections, but before a board of officers. But if the House of Assembly continue to be of opinion that the proposed fine upon aliens, and the recovery of fines before a Captain, would be an amendment to the Act of 1813, the "Council " Council will wave their objection on this head, and concur with the House " of Assembly in continuing that Law, thus amended, to the end of the " next Session of the General Assembly.

On motion made and seconded. Resolved, that the House do now take in consideration the statement sent down by the Council on the subject of the Militia Bill. Whereupon resolved, that the House cannot agree to the proposition contained in the statement delivered by the committee of the Council to the committee of the House, in free conference on the subject of the Militia Bill, and that the committee of the House do prepare reasons to be laid before this House why they do not agree to the same.

The House then adjourned until to-morrow morning at 11 o'clock.

THURSDAY, the 3d day of MARCH, 1814.

Message from the Council.

Mr. Robinson delivers the Message.

" Mr. Speaker,

"The Council do agree to the resolution sent up this day by the Assem-"bly respecting a map to accompany the joint Address;" and then Mr. Robinson withdrew.

Mr. Agnew from the committee appointed to bring in reasons in answer to the statement delivered by the committee of the Council on the subject of the Militia Bill, presented a draft of reasons by them prepared, which were read and agreed to and are as follow, viz.

The committee of conference are instructed to state to the committee of conference on the part of the Council, in answer to the communication received from the Council, that the House are of opinion that the provisions of the Bill will greatly improve the state of the Militia and render it more efficient for the essential purposes of defence, and in this they are the more confirmed from a persuasion that the provisions will be acceptable to His Honor the President.

The House forbear making any observations at this juncture upon the notice taken by the Council of what passed in this House; as their knowledge of the same could not have been derived through any source of parliamentary communication.

The House cannot, at this or any time, forbear noticing any infringement or attempt to infringe their undoubted right and privilege of judging what are the burthens which their constituents can bear.

The committee are further instructed to state that the House are constrained to declare it to be their determination to leave the Bill with the Council, still indulging a hope that upon reconsideration the Council will consent to wave their objections, and concur with the House in passing the Bill in its present shape.

Resolved that Mr. W. Pagan and Mr. Johnston do carry the Address of this House, on the subject of a map to accompany the Address to His Royal Highness the PRINCE REGENT, to His Honor the President.

Resolved that Mr. Attorney General, Mr. Botsford and Mr. Street be a committee, with such committee as the Council shall appoint, to wait upon His Honor the President and request that His Honor will be pleased to transmit the joint Address of the Council and Assembly to be laid before His Royal Highness the PRINCE REGENT. Ordered that the said committee of this House acquaint the Council therewith.

Message from the Council.

Mr. Odell delivered the Mcssage.

" Mr. Speaker,

"Mr. Odell and Judge Saunders are a committee to wait upon His Honor the President with the committee of the Assembly to request that His Honor will transmit the joint Address of the Council and Assembly;" and then Mr. Odell withdrew.

The House then adjourned until to-morrow morning at 11 o'clock.

FRIDAY, the 4th day of MARCH, 1814.

On motion made and seconded, ordered, that a committee be appointed to search the Journals of the Council as to their proceedings on the Bill to continue and amend an Act, entituled, "An Act for regulating the Militia." Mr. Street and Mr. Agnew are appointed a committee for that purpose.

Mr. Street from the committee appointed to search the Journals of the Council reported, that no entry had been made on the said Journal respecting the Militia, since the last communication to this House.

Message from the Council.

Mr. Saunders delivered the Message.

" Mr. Speaker,

"The Council have agreed to the Militia Bill with amendments;" and then Mr. Saunders withdrew.

The House in committee, Mr. M'Donald in the chair, went into consideration of the amendments proposed by the Council to the Bill to continue and amend an Act, entituled, "An Act for regulating the Militia;" which are as follow, viz.

Section II, at A. insert " or by companies, as he in his discretion may think best."

At B. dele "two" and insert "six."

Section III, dele the 3d Section.

On motion made and seconded. Resolved, that a conference be requestcd with the Council upon the subject of the amendments proposed by the Council to the Militia Bill. Ordered, that Mr. Attorney General and Mr. Street do acquaint the Council therewith.

Message from the Council.

Mr. Robinson delivered the Message.

" Mr. Speaker,

"The Council do agree to the conference proposed by the Assembly on "the amendments to the Militia Bill, and Mr. Odell and Judge Saunders are "a committee for that purpose;" and then Mr. Robinson withdrew.

Ordered, that Mr. Attorney General Mr. Street and Mr. M'Donald be a committee to manage the conference on the part of this House, with the committee of the Council on the subject of the amendments to the Militia

Bill.

Bill, and that they prepare reasons to be laid before the House for not concurring with the same.

The House then adjourned until to-morrow morning at 11 o'clock.

SATURDAY, the 5th day of MARCH, 1814.

Mr. Attorney General from the committee appointed to prepare reasons, in answer to the proposed amendments of the Council to the Militia Bill, presented a draft of the same, which was read as agreed to, and are as follow, viz.

The House direct their committee of conference upon the subject of the amendments of the Militia Bill, to state to the committee of conference on the part of the Council, that although the House are always desirous to listen with all possible attention to the amendments proposed by the Council to Bills which the House have passed; they cannot consent to concur in the present proposed amendments, which leave to the discretion of the Commander in Chief to call the Militia out (if His Honor may think it expedient) the whole number of six days by Battalions.

The House have the most perfect confidence in the judgment of the present administrator of the Government, and of His Honor's disposition to promote by every possible means the interest of the Province; but it can hardly be necessary to observe to the Council, that it is altogether uncertain, while the present arrangements continue, who may have the execution of the Law. Besides the House consider it their indispensable duty to reduce to all possible certainty the burthens which are to be imposed upon their constituents; and that in the present case it is highly expedient that the people should be informed and assured by the Law, in what manner they are to be called upon to perform their military duty; without which they might be exposed to be assembled and kept together in a way which both Houses have agreed in opinion, would be too burthensome for the Country, and which might under particular circumstances operate greatly to the inconvenience of the people.

In making provision for drilling of the Militia for four of the six days by Companies, the House studied how far they could alleviate the public burthen, while they prepared for the instruction of the Militia in a way, well calculated in the opinion of the House for rendering them efficient, and such as the House trusted would be acceptable to the Commander in Chief.

The House are still confident that the representatives of the people are the constitutional judges of the extent of the burthens which their constituents can bear, but they are not disposed to press this point further at present than may be necessary to assert this their unalienable right and privilege.

The committee of conference are further instructed to return the bill with the proposed amendments to the committee of conference on the part of the Council, in confidence that upon reconsidering the subject, the Council will consent to wave their amendments and concur with the House in passing the Bill. And the committee went to the conference and being returned, the *Attorney General* reported, that they had given the committee of the Council the reasons for disagreeing to the said amendments, and left the Bill and amendments with the committee of the Council. Message from the Council.

Council Chamber, 5th March, 1814.

Mr. Robinson delivered the Message.

" Mr. Speaker,

"The Council do request a free conference on the subject of the last "conference 62

" conference on the amendments to the Militia Bill, and that Mr. Odell and "Judge Saunders are a committee to manage the same;" and then Mr. Robinson withdrew.

Resolved, that the House do agree to the free conference requested by the Council on the subject of the last conference on the amendments to the Militia Bill, and ordered, that the committee which managed the last conference do manage the present on the part of this House, and acquaint the Council therewith.

Mr. Attorney General from the committee appointed to conduct the free conference with the committee of the Council on the amendments proposed by the Council to the Militia Bill, reports, that they have attended the conference which was managed on the part of the Council by Mr. Odell and Judge Saunders; that the said committee of the Council have this day delivered to them a paper containing the following proposition, viz.

" COUNCIL CHAMBER, 5th MARCH, 1814. " The committee of free conference on the subject of the last conference " are instructed to state, that the Council are at all times, and especially in " the present situation of the Province, sincerely desirous to concur, as far " as they consistently can, in every measure proposed by the House of As-" sembly; in this conciliatory disposition they would now wave objections " which they continue to think important, and without further discussion, " guarding only against any future inference of precedent prejudicial to the " constitution of this Colonial Legislature, would agree to the present Bill, " but as the practice, which has hitherto, perhaps inadvertently, been " adopted by both Houses, not only of limiting the time, but also of pre-" scribing the *manner* in which the Militia are to be trained, appears to the " Council, upon a deliberate review of the subject to be clearly unparlia-" mentary; they deem it their indispensable duty, on the present occasion, " to request that the House of Assembly will give this suggestion that deli-" berate consideration which is due to every point of constitutional practice, " and, in this view, the Council hope the House of Assembly will concur in " passing the present Bill, with the first amendment proposed by the Coun-" cil, and with an alteration of their second amendment in lieu of which they " propose to limit the time of training to four days, as proposed by the As-" sembly in a former Bill, instead of six days, and the Council direct their " committee to return the Bill, thus amended to the House of Assembly.

Resolved, further, that, it is the opinion of this committee, that it is consonant to the usage of the mother country, as well as of this, and the Sister Province, to limit by Law, not only the *time* but the *manner* in which the Militia are to be trained. Which report is accepted.

Mr. Attorney General from the committee of free conference appointed to draw up reasons for disagreeing to the last amendments made by the the Council to the Militia Bill, reported, the following reasons which are read, and agreed unto by the House, viz.

A Message from His Honor the President, by Xenophon Jouett, Esquire, Usher of the Black Rod.

" Mr. Speaker,

"His Honor the President commands this Honorable House to attend "His Honor immediately in the Council Chamber."

Accordingly Mr. Speaker with the House went up to attend His Honor the President in the Council Chamber, where the Speaker addressed His Honor the President to the effect following, to wit:

May it please your Honor,

The House of Assembly impressed with a due sense of the necessity of providing for the defence of the Province, have diligently attended to that important duty, and have made such amendments to the Militia Law, as they trust will conduce to that desired end. They have also granted large and liberal supplies, and have devised means to increase the Provincial Revenue. The Bills for these purposes they now tender to your Honor, praying your acceptance of and assent to them, with a confident hope that what their loyalty and patriotism have induced them to grant will by your Honor be wisely and œconomically expended; and then Mr. Speaker delivered the following Bills as engrossed upon parchment to the Clerk of the Council, viz.

A Bill, entituled, "An Act to give full effect to, and to prevent the evasion of an Act, entituled, An Act for the further increase of the Revenue of this Province."

His Honor the President was then pleased to give his assent to the several public and private Bills following, viz.

A Bill, entituled, "An Act to make perpetual sundry Acts of the General Assembly that are near expiring."

A Bill, entituled, "An Act in addition to an Act, entituled, An Act for regulating the exportation of Fish and Lumber."

A Bill, entituled, "An Act to continue several Acts of the General Assembly that are near expiring."

A Bill, entituled, "An Act to continue an Act, entituled, An Act to provide for the accommodation and billeting of His Majesty's Troops and the Militia when on their march."

A Bill, entituled, " An Act for the preservation of Partridges."

A Bill, entituled, " An Act for the better regulation of licenses to Inns, Taverns and Houses for selling strong liquors by retail."

A Bill, "entituled, "An Act further to continue for a limited time the Act for regulating, laying out, and repairing Highways and Roads, and for appointing Commissioners and Surveyors of Highways within the several Towns and Parishes in this Province."

A Bill, entituled "An Act in amendment of an Act, entituled, An Act to repeal all the Acts now in force relating to trespasses, and for making new regulations to prevent the same."

A Bill, entituled, "An Act to repeal an Act in alteration and amendment of an Act for establishing the rates to be taken for Wharfage and Cranage."

A Bill, entituled, "An Act for the indemnification of Commissioners of Sewers."

A Bill, entituled, "An Act to authorise the Rector, Church Wardens and Vestry of St. Andrews, to convey to the King's Majesty, a certain piece of globe land of the said Parish, for the purpose of erecting military fortifications thereon."

A Bill, entituled, "An Act in addition to an Act more effectually to provide for the public registry of all Marriages solemnized within the Province."

A Bill, entituled, "An Act to empower and authorise the Justices of the County of Westmorland at their General Sessions of the Peace, to regulate the grazing and depasturing of the several marshes, low lands and meadows within the said County."

A Bill, entituled, "An Act to enlarge the limits of the Parishes of St. Patrick and St. George in the County of Charlotte."

A Bill, entituled, "An Act to continue an Act to provide for the more effectually repairing the Streets and Bridges in the City and County of St. John."

A Bill, entituled, "An Act in further addition to an Act for the better ascertaining and confirming the boundaries of the several Counties in this Province, and for subdividing them into Towns and Parishes."

A Bill, entituled, "An Act to authorise the Justices of the Peace for the County of Northumberland to hold a Special Session for the purpose of appointing Town or Parish officers for the present year." A Bill, entituled, "An Act to continue and amend an Act, entituled, An Act for regulating the Militia."

After which His Honor was pleased to make the following Speech to the Council and Assembly.

Gentlemen of the Council, and Gentlemen of the Assembly.

In closing the present Session I have only to express my hope that the several Bills now enacted, may be found in their operation, to answer the purposes of public benefit, for which on your part they must have been intended. To this it shall be my ambition to contribute as far as may be in my power, nor can I entertain a doubt of your zeal and diligent attention in your recess to encourage and animate the people to that only observance of the Laws which is at all times essential to the public prosperity, and to those cheerful exertions to which at this time they are called in order to be duly prepared for any emergency that may threaten their future peace and preservation.

And afterwards the Honorable Chief Justice Bliss, by His Honor the President's command, said:

Gentlemen of the Council, and

Gentlemen of the Assembly.
