Last summer we read a great deal in the newspapers about the injury to the crops from lack of rain, but there was one effect of the drought which somehow failed to appear in the headlines. And that was the mental suffering of humanity for lack of an occasional rainy day.

Is there any more restful and tranquillizing experience after a long stretch of uninterrupted sunshine than to awake in the morning to the music of the steady drip of rain outside the window and the gratefully subdued, cheerfully melancholy light of a rainy morning?

In the first place, there is such a luxurious sense of indefinite duration about a rainy day. It is difficult to realize that a rainy day can be only twenty-four hours long.

It seems possible in prospect to do so many things on a rainy day. That well recommended volume which has lain so long on the library table awaiting a leisure hour—this very day its leaves shall be cut. And of course this is the ideal opportunity to finish that centrepiece. Then, what better chance could one have to banish that abominably fat packet of letters in the "Unanswered" pigeon-hole. And so one goes on and on planning quite enough to fill a day of at least forty-eight working hours.

Then there is the rich sense of seclusion which a rainy day begets. For

my part, I somehow like this to be as pronounced as possible. Even the visits of the storeman and the milkman seem unwarrantable intrusions, and although I thoroughly enjoy a friend once she is domiciled, I must say I rather resent her first appearance as a kind of cheapening of my precious seclusion.

Of course, I am not unaware of the bolder joy of getting suitably garbed and sallying defiantly forth in the rain to smell the growing things and catch their spirit, and get one's hair wet and lungs well washed, but this is a pleasure that I am more apt to appreciate the second or third day of a rainy spell after I have had my fill of the delights of seclusion.

The difference in favor between the rainy day and the snowy day is an interesting psychological distinction. There is begotten of both a sense of seclusion, but on the snowy day it is a jolly, hilarious seclusion of the whole family—"all friends shut out, the housemates sit around the radiant fireplace enclosed in a tumultuous privacy of storm." Whereas, on the rainy day one's retirement is more individual and has more of a subdued and dreamy flavor. On the snowy day we make molasses candy, or play games with the young folks, or pop corn. On the rainy day we rummage around in the garret, or sort out old letters, or dream over a book, preferably an old friend with whom we have communed many times before. I know a girl who reads "Little Women" every rainy day and my own "Cranford" is indissolubly associated with the sound and smell of a rainy afternoon.

**PARIS, Oct. 22.**  
The French Government to-day ordered the armored cruiser Comde to proceed to the Mexican coast to protect French interests.

**LONDON, Oct. 22.**  
It is announced that the New Year will bring an addition to the family of King George and Queen Mary. The approximate date is the latter part of February.

**PEKING, Oct. 22.**  
The Chinese Government has decided to appoint a British Naval officer as a naval adviser to the Chinese Admiralty. Rear Admiral Christian has been chosen.

**LONDON, Oct. 22.**  
The Financial News says that Canadian rumor is again busy with the conjecture that the C.P.R. will be split into three separate concerns, (1) Railway, (2) Lands, (3) Steamers and Hotels.

**RIO JANEIRO, Oct. 22.**  
Roosevelt paid his respects to the President of Brazil to-day. The meeting was most cordial. He then visited Foreign Minister Muller, and together they inspected the forts, walks and avenues for which Brazil is noted.

**NEW YORK, Oct. 22.**  
Six men were instantly killed, four badly injured, and Staten Island practically left without a trolley service through a boiler explosion last night in the plant of the Richmond Light and Power Co., Livingston, Staten Island.

**NEW YORK, Oct. 22.**  
Capt. Inch, of the Volturo, was the guest of honor at a dinner given to him by Nelson Lodge, Sons of St. George, in commemoration of Trafalgar Day. He sat appropriately beneath Nelson's famous motto, while British and American flags graced the walls. With characteristic modesty, the Captain declined to make a speech, but was lauded by the speakers for his bravery.

**VERA CRUZ, Oct. 22.**  
General Felix Diaz, candidate for the Mexican Presidency, bound here on the Corconado, will be permitted to land here this morning, but no demonstration will be permitted. A small army of detectives are here from Mexico, and the troops are held in quarters, less the Diaz partisans should prove too enthusiastic. If the peace is disturbed they have orders to shoot. Diaz announces his intention by wireless of proceeding to Mexico City on Thursday.

**SYDNEY, Oct. 22.**  
The Nid, schooner Annie Roberts was sunk in collision with the Dominion Coal Co's steamer Wabana. In the harbor this evening. Four of the schooner's crew are probably drowned. One man escaped. The missing men are John Bovill, John Fruster, Arthur Coffin, John McDonald. According to the steamer's report, the schooner, so far as could be found out by her lights, was steering a wabaly course, and when it was seen that collision was imminent, the steamer slowed down, and finally came to a stop. The schooner carried forward, probably by the tide, crashed into the steamer, hitting her a powerful blow at the stern. The schooner must have sunk forthwith, as she was not seen again. The rescued man is John Pennett.

**SWINNEY, Oct. 22.**  
Referring to his Land Reform speech, Lloyd George said he today that first of all he proposed to establish a Ministry of Lands with control and supervision of all questions dealing with land in both town and country. The functions of the Board of Agriculture would be transferred to the new ministry. Lands would be taken out of Chancery, and landlords be enabled to improve their lands, despite the silly settlements that heretofore barred them. Three commissioners would operate in a judicial capacity, and have the same power to reduce rents on small farms as the Scottish courts possessed. Large farmers would have the right of appeal for reduction of rents. If the action of the State caused a rise in wages for farm laborers.



# The Tables Are Turned!

## Kilbride Bids Loyal Welcome to Liberal Standard-Bearers.

### The People of That Historic Settlement Unite With other Sections of St. John's West and Acclaim Ellis, Cowan and Scott their Future Representatives.

The historic settlement of Kilbride, which was looked upon, particularly by the Big Chief, as the strongest Tory settlement in the country, has decided to host the Liberal banner which was lowered for four and a half years. This was plainly demonstrated last night at the meeting held by Messrs. Ellis, Cowan and Scott, the Liberal standard-bearers. The enthusiasm was wonderful as during the course of two hours tumultuous cheering, which could be heard for a great distance, rent the air for Sir Robert Bond, Ellis, Cowan and Scott and the Liberal Party.

The meeting opened at 8.30 in the house of Mr. Michael Ryan. On motion being made Mr. Edward Connolly—the oldest voter of Kilbride—was appointed chairman and with his usual tact filled that post to perfection. The first speaker introduced was Mayor Ellis, who reviewed the policies of both leaders. He convincingly showed that the policy of Sir Robert Bond was a progressive one and that of Sir Edward Morris, one of recklessness, as the unscrupulous spending of an enormous amount of the people's money during the past four years amply demonstrated. He referred to the two occasions when the Colony was in grave financial difficulties and when Sir Robert Bond was selected to go abroad to get a loan and which he successfully raised after pledging his own money to pay the interest.

If Walsh will not explain we can go to M. P. Cashin who should know all about it, and ask Cashin what sort of certificate will he give Walsh.

## Will You Have Honesty in PUBLIC Men?

It has been shown how Morison, Minister of Justice, stooped to forget a law (prohibiting the cutting of timber without a license) which ordinary laymen like Michael Parrell and Bernard McGrath, his own clients, would be ashamed to forget. Morison's cunning forgetfulness, depraved though it be, is only exceeded, perhaps, by the ingenious face of Premier Morris when he put the stamp of approval upon Morison's lying deception.

If Premier Morris will say publicly that he was deceived by Morison, then he will have proven his honesty of purpose in regard to this matter—though not his sagacity. If he says nothing, or insists that Morison really did forget the timber law, then the charge is that he as Premier is as bad, if not worse than, Morison. Plain words cannot be too plain when we have a Minister of Justice

and a Premier of a Country attempting to cover up gross rascality by worse dishonesty.

It is not conceivable that either Premier Morris or his Minister of Justice could have penned those letters to Governor Williams without an intention to deceive—unless, of course, they intended to exhibit themselves as ignorant fools. They are not fools, and both of them know they are not regarded as such.

What does the boasted cleverness of Premier Morison, as a politician, consist in? Is it clever to be deceived by a Minister of Justice who writes an abominable lie about forgetting a law that has been acted upon by his Premier and himself almost every week since they have been in power? Is it clever in Morison to approve what he knew to be a lying deception? If he was not deceived, or if he did not know, is it clever to even appear to be a fool, politically or otherwise?

The needs of a country are often sufficient justification for changes in policy. But when a compromise between honesty and dishonesty is sought, in an effort to shield a Minister of Justice's rascality, if it cannot be made without worse rascality, let it, at least, be made with such cleverness that the electorate cannot detect the taint. Even cleverness could be admired—though not the dishonesty it would conceal. Rewards for such may come hereafter.

Even though the dishonesty of the Minister of Justice has been made so apparent, Premier Morris may still retrieve himself in this regard by insisting upon Morison's dismissal. If he does not insist on that, then he merits and should get the scorn of the community. If the "ideals" of which the noble Sir Edward Morris boasted, have not received a shock, then we challenge him to read Morison's brazen plea again, and to read it without a blush. Here it is:—

"I had a license," said Morison, "to cut timber over 80 square miles of land, on which land I paid bonus and rent to the Crown for every square mile therein—and no more—according to law. I knew that I could not, by law, purchase logs, cut by others, on adjoining Crown lands, but I thought the law allowed me to go on the adjoining Crown land and cut the logs myself." In other words to steal the logs. Those are not Morison's exact words, but that was Morison's actual plea, which he put up to Governor Williams, the King's representative here. That is what Premier Morris told the Governor his Minister of Justice thought. That is what Governor Williams believed, being assured by Premier Morris that he might do so.

Morison invented the lie, and passed it on to Premier Morris. Premier Morris approved the lie, and passed it on to Governor Williams. The Governor handed their letters to the people, and said Morison was an honest man! An honest man in face of the law that Morison, as Premier, and Morison, as Minister of Justice, acted upon every week since they have been in power—the law which said that no timber shall be cut on Crown lands without first obtaining a license therefor, and paying bonus and rent in respect of every mile.

If Morison did not wilfully deceive Premier Morris, if Premier Morris did not wilfully deceive Governor Williams; then let both of them be written down as fools, and be done with. There is no further need to beat about the bush.

Yet the noble Sir Edward Morris says, "Pay no heed to what you hear!" It were just as well for him to say, "I am an honourable man. Look at my feet!" Morison, with his cold, hard, ascetic nature, says nothing. He stands condemned, though with a cynical composure. It is matter of notoriety that no voice that utters words, no type that spells them, can penetrate his impervious callousness. His mind is not acute enough to be sensitive, though it is not too dull to be brazenly cunning.

If it was Premier Morris's "political sagacity" that prompted him to unblushingly and indecently approve the shameful conduct of his Minister of Justice, then it is difficult to resist the conclusion that his "ideals" are the product of the same noble sagacity. What great wisdom did he exhibit when he made a miscalculation of anywhere from two to six million dollars in the cost of the Branch Railways? Whence came the inspiration that prompted him to pay that political angel, John C. Crosbie, the scalding price of \$2200.00 for two "fourteen dollar spars"? When Sir Edward Morris assumed to himself "high ideals

of statesmanship," as he did in his Manifesto, he should have added: "Pay no heed to what you hear!"

Nevertheless, it was in such a manner that Premier Morris claimed smug pretensions to virtue and raised the issue upon high ground: Will you have honesty or dishonesty in public men?
