No Other Form of Exercise More Invigorating and Enjoyable Than the Physic.

Never in the history of cycling has there been such a demand for bicycles. The desire of every tenth man, woman and child to supply themselves with a wheel is not indigenous to any particular locality—the fever infects the entire country from Maine to California.

Dealers who placed large orders for spring delivery last fall were obliged to keep the mails and telegraph wires red hot with their ringing requests to ship the new models.

When the mail and telegraph failed to bring the makers to time and as the days rolled into weeks and no wheels came to the dealers found it compulsory to send emissaries with certified checks and even cash with orders to their men to go over every wheel turned out in order to fill their city bookings and with instructions to their men to sleep in the factory if necessary to attain this end.

All this has been of no avail, as their agents invariably found the representative of some other retailer who was obliged to content himself with a mighty small pro rata share of completed bicycles.

THE GRAND TRUNK'S FUTURE POLICY.

The policy of the Grand Trunk Railway for many years back has been chiefly concerned in the handling of through freight. Its capital has been greatly increased by the acquisition of lines that would give it a connection between Chicago and the seaboard. There is no doubt that an immense amount of traffic moves along the great route that the Grand Trunk has built up, but, on the other hand, there is so much competition for the handling of this freight that the Grand Trunk has not been able to profit as largely as it expected. The principal point of the shareholders at their annual meetings has been in regard to the lines that the Grand Trunk has absorbed in order to make itself strong as a through route. There are evidences that the new lines are not doing so well as a new policy in the conduct of the road. The rumor that they are about to locate the headquarters of the company in Toronto would lead us to believe that they intend giving more attention to local traffic. As we pointed out yesterday, 80 or 90 per cent. of the Grand Trunk system lies within the Province of Ontario, and although the Grand Trunk has got its reputation from the fact that it is a great through line, yet the bulk of its business originates in this province. This business, large as it is, might have been made considerably larger if the company had cultivated the interests of its patrons. The neglect of the line towards local interests has proved highly detrimental to the company. Until the

C.P.R. came into the field the time between Toronto and Montreal averaged about fourteen hours.

The journey to Montreal in those days was an undertaking that few cared to indulge in. Similarly the accommodation on the branch lines was something very inferior. The Grand Trunk has never had the good sense to anticipate the wants of its patrons. It has rarely had the good sense to cater to their wants, even after they were requested to do so. The reversal of their old-time methods will be the best policy the new directors can adopt. The Province of Ontario, with its large agricultural and manufacturing interests, ought to be a profitable field for any railway that has the extensive local ramifications possessed by the Grand Trunk. Our advice to the new management is to install themselves in the very heart of the system, to cultivate the trade that they can secure at their own doors, and to establish friendly relations with the people. If they do so they will be acting in the interests of the company's long-suffering shareholders.

Victoria Park.

The work that has been going on at Victoria Park during the past six weeks has done more things for it, and the pretty breathing place will this year be more attractive than ever. The grounds have been cleaned up, a large picnic stand erected to the northwest of the restaurant and all the buildings, including the bandstand, are being painted. The rugged cliffs fronting the lake are being smoothed off, and trees have been planted on the beach halfway between the cliff and the water, with the intention, if feasible, of sodding the intervening space. Besides, nearly all kinds of confectionery will be on sale at regular city rates at the restaurant. The discovery of the residents of Kew Beach and vicinity, there are to be three banquets, one on Wednesday and Saturday, and on Saturdays and holidays amusements, such as tennis, croquet, and other sports, will be provided. Messrs. J. & T. Gardner, the lessees of the park, have taken it for three years. They are well known in the city as confectioners, where for years nearly every picnic in the East End was catered for by them. No liquor is to be sold on the premises and the entrance is free.

Strawberries and Apples Safe.

Strawberries and Apples Safe. Erie, Pa., May 13.—A killing frost fell from midnight last night and did extensive damage in the grape belt. In the vicinity of Brockton, Westfield and Ripley the damage is very general and will probably take half the crop. The Concord vines suffered greatly and fully a quarter of the crop is killed. The Niagara, a very early grape, advanced, are almost a total loss. The strawberry vines were not advanced far enough to get caught by the frost. The vines are injured, but not to any great extent. The apple crop in the Chautauque belt has been very promising.

Railroad Traffic Impeded.

Grand Rapids, Mich., May 13.—Western and Northern Michigan was visited by a heavy storm to-day and grape vines are left for fruit, as the storm is the second in a series. In this city the fall of snow commenced about 3 p.m., and is not as great as is reported from the other parts of the State, where a heavy traffic is badly hindered. At Marcellona, snow to the depth of 16 inches is reported. The snow is accompanied by a heavy north wind.
