

It is hoped that with a true spirit of consecration and unanimity, the good work of building up Christ's cause will go on and prosper in the congregation during the year before us to even a greater degree than in the past.

In submitting the Annual Report of the Managers this year, we feel grieved to find a shortage of nearly \$200 to Stipend account. This is the second year we have had to borrow to meet Stipend which is very discouraging to all who have an interest in the Congregation. The Church Schemes are considerable over what they have been for several years. There has been paid in Voluntary Contributions $\$ro\gamma$, Talents \$a4, so that we have been able to pay interest and \$a200 on principal on the Church debt, which is now reduced to \$1300. All of which is respectfully submitted in the name of the Managers.
