DECEMBER SESSION.

FIRST DAY.

COUNCIL CHAMBER,

WELLAND, Tuesday, Dec. 5th, 1893.

By direction of the Warden the Council met in session in Council Chamber, at Welland, for the transaction of general business, at 2 p. m.

The Warden in the chair.

Members present :—Messrs. Barnhard, Barrick, Battle, Bennett, Present.
Cook, Cruikshank, Deans, Fares, Fry, Griffiths, Hagar, Hopkins, Krafft, Macklem, Misener, Orr, Page, Pew, Ripley, Riselay, Sidey, Steele and Weiss—23.

The Warden addressed Council, giving a general *resume* of the business since June session, and laid before the Council the following communications : Matters before Council.

From Thomas C. Dawson, *re* annual grant to St. Catharines General and Marine Hospital ;

Also, from Kostuck & Lymburner ;

Also, from County Huron, *re* resolution passed that section 533 A., of the Consolidated Municipal Act of 1892, be repealed ;

Also, from James Quillinan, *re* County Pupils for Niagara Falls High School ;

Also, from Alex. Reid, Secretary Welland County Agricultural Society, *re* grant ;

Also, from A. M. Rosebrugh, M. D., *re* Prison Reform ;

Also, copies of minutes from other counties ;

Also, County Treasurer's Statement ;

Also, from J. McCuaig, President W. C. T. U., *re* grant for Prison Library.

Moved by Mr. Battle, seconded by Mr. Ripley,

Sessional hours.

That the hours of meeting and adjournment during the session be as follows : Meet at 9 a. m., adjourn at 12 noon ; meet again at 1.30 p. m., adjourn at 5.30 p. m.—Carried.

Moved by Mr. Barnhard, seconded by Mr. Deans,

That the communication from Edgar Ker, *re* James H. Ball, Public School Inspector, be referred to the Committee of Education, to report at this session.

Moved in amendment by Mr. Pew, seconded by Mr. Ripley,

Ker v. Jas. H. Ball.

That the communication from Mr. Ker, *re* the County School Inspector, be taken up by a committee of the whole at 1.30 p. m. on Wednesday, and that Mr. Ball be notified forthwith of the intention of this Council.

The yeas and nays being called were taken as follows :

Yeas :—Messrs. Barrick, Battle, Cook, Cruikshank, Fry, Griffiths, Krafft, Misener, Page, Pew, Ripley, Riselay and Weiss—13.

Nays :—Messrs. Barnhard, Deans, Hagar, Orr and Steele—5.

The motion passing in the affirmative—majority 9.

The original motion was again read and declared lost.

Moved by Mr. Pew, seconded by Mr. Battle,

That the Treasurer's Report be referred to Finance Committee. Treasurer's report.
—Carried.

Moved by Mr. Sidey, seconded by Mr. Page,

That the sum of \$15 be granted in aid of the County Prison Library, as per request of President of W. C. T. U.—Carried. Grant to prison library.

The Warden presented first report of House of Industry, which was read to Council. Report House of Industry.

Moved by Mr. Cruikshank, seconded by Mr. Riselay,

That the report of the House of Industry Committee be adopted.
—Carried.

Moved by Mr. Riselay, seconded by Mr. Weiss,

That the account of Irvin Teal, bailiff of 3rd Division Court, Welland, amounting to \$14.25, for books used as such bailiff, be paid, and that the Warden do issue his cheque for the same.—Carried. Account—Bailiff Irvin Teal.

Moved by Mr. Macklem, seconded by Mr. Fry,

That the account of Wm. Greenwood, for constable fees *re* Kostuck, be paid, and that the Warden do issue his cheque for the same, \$7.50.—Carried. Account—Wm. Greenwood, constable.

Moved by Mr. Macklem, seconded by Mr. Barnhard,

That the account of Wm. Crumb, for blacksmithing on Montrose Bridge in 1892, be paid, and the Warden do issue his cheque for the same, \$2.—Carried. Account of Wm. Crumb.

Moved by Mr. Battle, seconded by Mr. Griffiths,

That the thanks of this Council be tendered to Mr. E. Cruikshank for the energy and ability displayed in compiling the work entitled, "A Century of Municipal History."—Carried. Thanks to Mr. Cruikshank *re* Municipal History.

Moved by Mr. Pew, seconded by Mr. Macklem,

That the communication from the County of Huron, *re* the repeal of Section 533 of Consolidated Municipal Act, be referred to the following committee:—Messrs. Barnhard, Battle, Krafft, and the mover and seconder of this resolution.—Carried. Com. from Co. Huron referred

The hour of adjournment having arrived the Warden left the chair.

SECOND DAY.

MORNING SESSION.

WEDNESDAY, Dec. 6th, 1893.

Pursuant to adjournment the Council met at 9 o'clock a. m.

The Warden in the chair.

All members present except Mr. Cook.

Minutes of yesterday read by Clerk and approved by Council.

Underdraining
Industrial farm.

E. Cruikshank, Chairman of Committee on House of Industry, spoke on employing prisoners on Industrial farm, and thought that to go on with underdraining on farm would be profitable to the county.

Moved by Mr. Macklem, seconded by Mr. Pew,

Purchase of tile.

That the Home Committee be authorized to purchase another car load of tile for underdraining on the Home farm.—Carried.

Roads and
bridges.

The Warden presented report of Standing Committee on Roads and Bridges, which was read to Council.

A discussion arose and the hour of adjournment having arrived, Mr. Battle having the floor.

AFTERNOON SESSION.

At 1.30 o'clock the Council resumed.

Ker v. Ball.

As per resolution of Tuesday, the Warden stated the first business was the consideration of charges by Mr. Ker against Mr. Ball, County School Inspector.

Moved by Mr. Pew, seconded by Mr. Sidey,

That this Council do now resolve itself into a committee of the whole, and that the charges made by Mr. Ker against Mr. Ball, Public School Inspector, be taken up.—Carried.

Pursuant to motion the Council went into committee of the whole, with Mr. Barnhard in the chair.

Mr. German, on behalf of Mr. Ker, was heard by committee, and presented letter from John Millar, Deputy Minister, which was read to Council. Mr. Ker also gave his statement.

Mr. Ball defended himself against the charges made against him,

and presented letter from John Millar, Deputy Minister, which was read to Council.

Mr. Davis, teacher of the school in connection with which the charges were laid, answered questions asked by members of committee.

Messrs. Nunn and Reece, trustees of said school, were also heard, and presented a petition signed by forty-nine ratepayers of the section approving of Mr. Ball's inspectorship.

Moved by Mr. Macklem, seconded by Mr. Pew,

That this committee do now rise and report, that after investigating the charges brought by Mr. Ker against J. H. Ball, County School Inspector, cannot find that he has been in any way negligent or remiss in his duty, or that there is any real foundation for the complaints, the majority of ratepayers in school section referred to being fully satisfied with both teacher and inspector.—Carried.

The committee rose.

The Warden in the chair.

Moved by Mr. Macklem, seconded by Mr. Pew,

That after investigating the charges brought by Mr. Ker against J. H. Ball, County School Inspector, cannot find that he has been in any way negligent or remiss in his duty, or that there is any real foundation for the complaints, the majority of ratepayers in school section referred to being fully satisfied with both teacher and inspector.—Carried.

Mr. Ker's charges dismissed.

The debate on report of Road and Bridge Committee was resumed and the Warden again read the report.

Roads and bridges.

Moved by Mr. Barnhard, seconded by Mr. Misener,

That the report just read be adopted.—Carried.

Mr. Sidey gives notice that he will on to-morrow ask leave to introduce a bill to amend By-law No. 591, appointing special constable *re* vagrants.

Moved by Mr. Barnhard, seconded by Mr. Orr,

That William Burns be paid \$50 for swinging Montrose bridge,

Wm. Burns paid \$50.

for the year ending December 31st, 1893, and the Warden do issue his cheque for the same.—Carried.

Moved by Mr. Battle, seconded by Mr. Ripley,

Thorold High school paid for county pupils.

Whereas, the cost of the entrance examinations was not taken into consideration in making up the expenses of the High schools of the county, and that the Town of Welland High school received last year the sum of \$46.45 for the examination of county pupils, and \$17 has been paid to the Stamford High school this year : therefore be it resolved, that the Warden issue his cheque in favor of the Treasurer of the Thorold High school for the sum of \$18, being amount paid by that municipality for the examination of county pupils during the years 1891 and 1892, as shown in the accompanying report of the presiding examiner.—Carried.

Mr. Sidey asked leave for Gaol Committee to retire.—Leave granted.

A quorum not being present, the Warden left the chair at 5 p.m.

THIRD DAY.

MORNING SESSION.

THURSDAY, Dec. 7th, 1893.

Pursuant to adjournment, the Council met at 9 a. m.

The Warden in the chair.

All members present.

The minutes of yesterday were read by the Clerk and approved by Council.

From G. L. Hobson re monies paid by Fort Erie and Humberstone.

The Warden presented communication from G. L. Hobson, Treasurer, re sums of money paid by Fort Erie and Humberstone.

Mr. Macklem gives notice that he will on to-morrow ask leave to introduce a bill to repeal By-law No. 271 of this county.

Account with Niagara Falls town.

The Warden presented report of Standing Committee on Accounts with Town of Niagara Falls, which was read to Council.

Moved by Mr. Macklem, seconded by Mr. Steele,

That the report just read be adopted.—Carried.

Moved by Mr. Sidey, seconded by Mr. Griffiths,

That leave be given to introduce a bill to amend By-law No. 591.

Leave granted and bill read a first, second and third time, and passed, entitled "A By-law to amend By-law No. 591." By-law 591 amended.

Mr. Cruikshank gives notice that on to-morrow he will ask leave to introduce a Memorial to the Minister of the Interior, respecting the ferry landing at Fort Erie. Fort Erie ferry landing.

Moved by Mr. Griffiths, seconded by Mr. Macklem,

That this Council do visit the Industrial Home in a body on Friday afternoon at 2 o'clock.—Carried. Industrial Home visit.

The Warden presented communication from Sheriff Smith, *re* Mrs. Ashton, which was read to Council. Re Mrs. Ashton.

The Warden presented communication from James E. Morin, Registrar, *re* recommendation from E. F. B. Johnston, inspector, which was read to Council. Registry office fixtures.

Moved by Mr. Griffiths, seconded by Mr. Cook,

That the communication of Mr. Johnston, *re* shelving for registry office, be referred to Gaol Committee, to report at January session.—Carried.

Mr. Macklem gives notice that he will on to-morrow ask leave to introduce a by-law in accordance with sub-section 3, of section 535, of the Consolidated Municipal Act, to provide that the words "rivers, lakes and ponds" as used in sections 532 and 535, shall not include or extend to any river, lake or pond less than eighty feet in width. Re sections 532 and 535, Municipal act.

Mr. Sidey, Chairman of Gaol Committee, asked leave for committee to retire.

Leave granted.

AFTERNOON SESSION.

At 2 p. m. the Council resumed.

Mr. Barnhard, Chairman of special committee *re* communication from County Huron, asked leave to retire.

Leave granted.

Gaol report. The Warden presented first report of Gaol Committee, which was read to Council.

Moved by Mr. Sidey, seconded by Mr. Hagar,

That the report just read be adopted.—Carried.

Report *re* com. from Co. Huron. The Warden presented report of special committee *re* communication from County of Huron, which was read to Council.

Moved by Mr. Barnhard, seconded by Mr. Macklem,

That the report just read be adopted.—Carried.

A quorum not being present, the Warden left the chair at 4 p.m.

FOURTH DAY.

MORNING SESSION.

FRIDAY, Dec. 8th, 1893.

Pursuant to adjournment, the Council met at 9 o'clock a. m.

The Warden in the chair.

All members present.

The minutes of yesterday were read by Clerk and approved by Council.

Moved by Mr. Macklem, seconded by Mr. Riselay,

By-law 271
repealed.

That leave be given to introduce a bill to repeal By-law No. 271 of the By-laws of this Council.

Leave granted.

Moved by Mr. Macklem, seconded by Mr. Riselay,

That the bill be read a first time.

Bill read a first time.

Upon the second reading a vote was taken—majority in the affirmative.

Bill read a third time and passed, entitled "A By-law to repeal By-law No. 271 of the By-laws of this Council."

Mr. German, in behalf of residents of Humberstone and Bertie townships, was heard by Council, in favor of prohibiting the working of pumps or natural gas compressors in the gas territory of this county. *Re natural gas pumps.*

Moved by Mr. Cruikshank, seconded by Mr. Macklem,

That leave be given to introduce a Memorial to the Minister of the Interior, respecting the Fort Erie ferry landing. *Fort Erie ferry landing.*

Leave granted.

Memorial read a first, second and third time and passed, signed, sealed and forwarded to the Honorable the Minister of Interior, as directed.

The Warden presented communication from J. H. Howell, Gaol Surgeon, *re Mrs. Ashton*, which was read to Council. *Mrs. Ashton.*

Moved by Mr. Sidey, seconded by Mr. Macklem,

That the Gaol Committee be instructed to request the Sheriff to engage an extra nurse for the care of Mrs. Ashton while in gaol, and to see that sufficient assistance is procured to keep Mrs. Ashton in a clean, and as far as possible, comfortable condition, until means can be found to have her removed from gaol to a more suitable place.—
Carried.

Moved by Mr. Macklem, seconded by Mr. Cruikshank,

That leave be given to introduce a bill to provide that the words "rivers, lakes and ponds" as used in sections 532 and 535 of the Consolidated Municipal Act of 1892, shall not include or extend to any river, lake or pond less than eighty feet in width. *Re sections 532 and 535 Con. Mun. Act.*

Leave granted.

Moved by Mr. Macklem, seconded by Mr. Cruikshank,

That the bill be read a first time.

Bill read a first time.

Moved by Mr. Macklem, seconded by Mr. Cruikshank,

That the bill be read a second time.

Bill read a second time.

A discussion arose and continued to the hour of adjournment.

The hour of adjournment having arrived, the Warden left the chair.

AFTERNOON SESSION.

At 1 o'clock p. m. the Council resumed.

Moved by Mr. Fares, seconded by Mr. Steele,

Memorial vs.
Natural gas
pumps.

And resolved, that whereas it is alleged that the Provincial Natural Gas and Fuel Company are erecting an extensive pumping (or gas compressing) station in the natural gas field in this county, (of a portion of which such company is the lessee) for the purpose of forcing such gas to the City of Buffalo :

And whereas it is alleged that the effect of such pumps (or gas compressors) will be to exhaust all the gas in such gas field, within a very few years, and not only the gas within the limits of the field leased by such company, but will also draw the gas from the surrounding territory, thus practically allowing the company to take gas which they have not paid for and which the owners thereof desire to retain for local purposes ;

And whereas such gas is being largely and beneficially used for local and manufacturing purposes, and will, it is believed, supply all local demand for many years if taken from the ground by the natural flow only :

This Council is of opinion (if such allegations are shewn to be correct) that the effect of such gas pumps (or compressors) will be to work a great injustice to a large section of this county ; and this Council requests that at the next session of the Ontario Legislature an act may be passed (if within its power) wholly prohibiting the taking of natural or fuel gas from the ground, or the forcing of it from the wells through pipes by means of pumps, compressors, or any other artificial appliances.

And that a copy of this resolution be forwarded to the Hon. Sir Adopted.
Oliver Mowat, Attorney-General of Ontario.—Carried.

The discussion on by-law *re* bridges over rivers was resumed. *Re* bridges over rivers.

The Warden again read the by-law the second time.

Upon the second reading, the yeas and nays being called for, were taken as follows :

Second reading passing in the affirmative—majority 6.

Bill read a third time and passed, entitled “By-law to provide that the words “rivers, lakes and ponds” as used in sections 532 and 535 of the Consolidated Municipal Act, 1892, shall not include or extend to any river, lake or pond less than eighty feet in width.

The Warden presented communication from J. McCaw, Secretary Public School Board, *re* grant to Model School.

Welland P. S. board's claims.

Also for County's proportion of Inspector's salary for Welland Public School.

Since last report one hired man at \$14 per month, and one female servant at \$3 a week, have been employed.

BUILDING.

During the heavy gale of September, the tall chimney in the rear of the Home was so badly shaken that it was found necessary to take immediate measures to stay it, which was done at a cost of \$9.78. Your committee have also engaged Messrs. Taylor & Crow to repair the roof wherever necessary, for the sum of \$23.

DRAINAGE.

Finding that there were a number of able-bodied prisoners in gaol, your committee began laying the tile that remained on hand, on Tuesday, the 14th November, with a gang of six men, in charge of Turnkey J. A. Gilchriese and Michael Hoban as guard. We have purchased 500 six-inch tile for the outlet, for \$15, and 1200 three-inch tile for \$12.

Your committee have decided to purchase 3000 feet of three-inch tile (including the 1200 mentioned above) to be laid the present season. To-day (Dec. 5th) we have ten prisoners at work. Your committee have to acknowledge the ready assistance and courtesy they have received from the sheriff, gaoler and turnkeys at all times, and also very valuable assistance and advice from Mr. Robt. Cooper, county clerk.

APPENDIX C.

MEMORIALS.

MEMORIAL *RE* NATURAL GAS.

*To the Honorable the House of Commons of the Dominion of Canada
in Parliament Assembled :*

The Memorial of the Municipal Council of the County of Welland humbly sheweth :

1. That in the said County of Welland natural gas has been discovered to exist in large quantities, the discovery having been made in the year 1890.

2. That there have been bored in the County of Welland upwards of 130 wells for the purpose of obtaining gas, and many of said wells are capable of producing millions of feet of gas a day.

3. That since the discovery a number of companies have been organised for the purpose of boring and obtaining natural gas to supply the same for fuel and light, and large quantities of gas are now being used in the County of Welland for fuel and light, to the great benefit of hundreds of families in the county and to the benefit also of manufacturers in said county.

4. That although the gas is used as above stated in the County of Welland, still most of the gas that is produced is conveyed by means of pipes across the Niagara river to the city of Buffalo, in the state of New York, where the said gas is consumed.

5. That the said gas is being conveyed across the river in such large quantities that the supply is being rapidly exhausted, and your memorialists fear that if the gas continues to be conveyed across the river in such quantities, this very valuable mineral will soon be exhausted.

6. That one company (The Provincial Natural Gas & Fuel Co.) are now erecting pumps for the purpose of forcing the said gas to the city of Buffalo, the gas heretofore having sufficient force not to require artificial means to force it through the pipes, which demonstrates the fact that the pressure is materially less and that the gas is being rapidly exhausted.

7. Since the discovery of the said gas the Ontario Silver Company have established works in the township of Humberstone, in the said county of Welland, solely on account of the fact that they have been able to procure natural gas as a fuel, and your memorialists understand there are employed in said factory upwards of 70 hands, to the great benefit of the community, and there has also been established, on account of the discovery of natural gas, a glass factory in the village of Port Colborne, and your memorialists understand that other factories are likely to be started if the exportation of natural gas is prohibited.

8. That your memorialists consider that it would be a great benefit to the people of the County of Welland, and to the country in general, if the exportation of gas is prohibited.

Your memorialists therefore pray : That a moderate export duty may be imposed on the exportation of natural gas.

On my inspection to-day, I examined the registers and abstract indexes, and find they are greatly injured and rapidly becoming destroyed by reason of the means adopted for keeping them when not in use. Heavy books such as these are should be kept flat, and the only successful way of accomplishing this is by roller shelves ; these books on roller shelves will last practically for all time, but standing them on end necessitates re-binding, and in many cases re-copying after lapse of some years ; several ought to be re-bound now ; and I write this to you in order that you may bring the matter to the notice of the County Council with the view of having roller shelves put in the office. I would not do this unless the public interest really required it, and I may say that many counties are adopting this shelving with most satisfactory results.

I, Edgar Ker, of the Township of Pelham, County of Welland, do hereby charge James H. Ball, Esq., Public School Inspector of the County of Welland :

(1.) With neglect of duty in regard to S. S. No. 9, Pelham, as directed in clause 1, section 155, of statutes and regulations of public and high schools; to see that every school is conducted according to this act and the regulations of the department.

(2.) I charge Inspector Ball with want of courtesy and neglect of duty in treating my complaints against the teacher in this section (No. 9), made in writing and sent to him in December, 1892, and again in May, 1893, with silent contempt, my letters not being answered.

(3.) I charge the inspector with disrespect for his position, and partiality in conducting an investigation of my complaints in my absence on the 19th of May, 1893, without giving me, as complainant,

in any way, a notice of the same ; and leaving in the visitors' book at the school a report that was very meagre and misleading, and sending on the day following a fuller report to the Education Department, Toronto.

(4.) I charge the inspector with treating instructions received by him from the Honorable the Minister of Education, under date of June 5th, 1893, and over the signature of the deputy minister, with derision and contempt. That this charge be understood, I beg to quote from Mr. Ball's report to Toronto, dated May the 30th, 1893 :

"That geography, although receiving a little attention in forms 1 and 2, is not so well attended to as the teacher informed me he would desire owing to want of time."

"That Canadian history is not as yet taken up in form 3."

"That grammar and composition, for the same reason, lack the attention necessary, although not entirely neglected in forms 1, 2 and 3."

"That in regard to the teaching of reading there is also room for improvement."

"That book-keeping in form 4 appears to have been crowded out for want of time."

I give a copy of the letter of instruction referred to :

TORONTO, June 5th, 1893.

DEAR SIR,—I am directed by the Minister of Education to state in reply to your letter of the 20th of May, that he has read your report upon the investigation held in S. S. No. 9, Pelham. The report shows serious negligence on the part of the teacher, negligence which I do not think you can, with propriety, overlook. The excuses given for neglecting certain subjects on the program are not satisfactory, although in fairness to the teacher it may be said that the school is unusually large, and would be benefitted by an assistant teacher.

I think you should examine the school, especially about the 25th of June, looking into every detail of the work and ascertaining from personal examination the standing of every class. If at that time the school is not equal to the average of your county, or is not conducted

according to the regulations, Mr. Davis, trustee, should be informed officially. You should send him a copy of this letter, as your instructions from the department, when you have fixed a date for the examination.

(5.) I further charge Inspector Ball with a direct violation of the school act in appointing, or having had appointed, Miss D. Ball (his daughter) as presiding examiner at the entrance examination in S. S. No. 2 Pelham, held on June the 28th, 29th and 30th, 1893, Miss Ball's qualifications not being such as required by the act,—entrance examinations, section 38, (3), page 81 S. and R. P. and H. schools.

(6.) That Mr. Ball has, for many years, without authority, been fixing different places throughout the county for purposes of entrance examinations to high schools, whereby he has been able to draw \$1 for each pupil who goes up for examination, and which expense the council has to pay, and which he would not otherwise be entitled to.

Trusting that these charges will receive your serious consideration, and that action will be taken on them at the earliest possible moment,

Re Mrs. Ashton:—

She is afflicted with malignant disease of the bowel of a cancerous nature, which will necessarily prove fatal in a few weeks at least. Her mental condition is not very sound, though not in any way dangerous; rather talkative, and a little noisy, which is probably aggravated by the extreme pain which attends the disease.

The proper place for her would be a hospital, if she would be received at such, as she requires some attention in the way of cleansing and dressing, which a nurse could best attend to.

In some cases of this nature an operation is necessary to relieve the extreme suffering, which could not be very well performed with success in the gaol. At present she seems to be comfortable under the use of narcotics, but the odor from the imperfect cleansing of the diseased parts is very unpleasant in the corridor, in fact it would be undesirable to confine another prisoner in the same place.

At present it would be extremely inadvisable to confine another prisoner in the gaol.
