#### FIRST DAY'S SESSION.

TUESDAY, June 17, 1862.

Synod assembled at the Cathedral Church of St. James, on Tuesday, the 17th day of June. The Rev. Henry Brent, B.A., read the service, the Rev. J. Wilson, B.A., the lessons. The Rev. A. Dixon, B.A., preached from Acts, xi., 42. The Rev. Dr. Beaven and Rural Dean Givins read the anti-Communion Service. The Lord Bishop, assisted by the Ven. Archdeacon of Toronto, the Rev. H. J. The Rev. T. S. Kennedy, on the motion of the Rev. Henry Holland, seconded by the Rev. H. Brent, was elected clerical secretary.

Jas. Bovell, Esq., M.D., on the motion of J. W. Gamble, Esq., seconded by C. J. Campbell, Esq., was elected lay secretary.

J. W. Brent, Esq., was re-elected treasurer.

C. J. Campbell, Esq., and John Westmacott, Esq., were re-elected auditors.

The minutes of the last meeting of Synod were confirmed.

The Bishor then proceeded to address the Synod. He said it was not his intention to address them at any length, but simply to chronicle briefly and as clearly as he could the more prominent occurrences which had taken place since they last met in Synod, and which more immediately affected the Church in her daily progress. On the 1st July, he commenced a tour of confirmations through that portion of the diocese which is comprised between the city of Toronto and the Province Line, accompanied by his chaplain, the Rev. Saltern Givins. His Lordship proceeded to give detailed particulars of his proceedings on this tour. Confirmations were held in 26 parishes, and 794 candidates confirmed. Lindsay was visited on this tour, but in con-

sequence of the confusion caused by the calamity it had just experienced in the fire which destroyed a large portion of the village, he did not hold a confirmation there. The church, in all the parishes visited, seemed in a state of encouraging progress, and the clergy active and painstaking, and becoming daily more sensible of their high responsibilities. On Wednesday, July 21st, he left Toronto in company with Sir John B. Robinson, Bart., and Professor Hatch, for the Sault St. Marie. This excursion, his Lordship remarked, had lost much of its romantic character, since steamboats have superseded the canoes with their French and Indian paddlers and exhilarating songs. Nevertheless, the great variety of views and their surpassing magnificence and beauty, ever changing in their aspects, as you proceed on your voyage, would always continue to make a trip from Toronto to the Sault St. Marie most attractive to all true lovers of nature. On Thursday, August 1st, he held a confirmation at Collingwood, and the same evening embarked on board the steamer. Sault St. Marie was reached early on Saturday, August 3rd. They found a very comfortable house to stop at, where the Hon. Colonel Prince was residing, and with such desirable company they found themselves quite at home. On Sunday, 4th, he preached in the forenoon in the Court House, and confirmed six persons. The attendance was much better than he had expected, and consisted chiefly of genteel families in office, who had come to reside at the county town of the new district. In the afternoon, he embarked in a small canoe and proceeded to Garden Island to spend the evening and lodge with the Rev. James Chance, the missionary who is doing much good among the Indians. On Monday they had a full service at 10 a. m., and he confirmed twenty-two persons. About three o'clock the steamboat arrived, and he again joined his travelling companions. On Tuesday, 6th August, he held service at the Little Current, where he found the Rev. Peter Jacobs and his Indians

waiting; 10 were confirmed. The whole number confirmed on this expedition was 54, of whom 32 were Indians and 22 were whites. They reached Collingwood at 10 p. m., and left for Toronto next morning. They were aware that, when in London in 1850, he called the attention of the proper authorities to the vast extent of the See of Toronto and suggested a plan for its division into four separate dioceses. After many delays and much trouble during more than ten years, he had the satisfaction to behold three of these dioceses, Huron, Toronto, and Ontario, fully established, but the fourth See, or the proposed Bishopric of St. Marie, was still in abeyance, and yet notwithstanding the melancholy aspect of things at present from the American civil war and other causes, the suspension of immigration, and the general depression of the times, he still trusted and believed that it would become the seat of a Bishop of the Church of England, although he might not live to witness its accomplishment. He ought indeed to be more than satisfied in having been in some degree instrumental through God's benignant Providence in establishing three out of the four dioceses proposed in 1850but he still retained a yearning desire to do something for St. Marie before his departure, and it was this that prompted him to touch upon the subject. It was very central, and would become in time a large city, and be required for the religious teaching and civilization of North Western Canada. The region, of which it was the centre, offered space almost inexhaustible for the most extensive agricultural settlements, and mining establishments without number, especially in copper and iron of the finest quality, might in time be profitably erected along the banks of Lakes Huron and Superior and the adjacent islands. It was true we had as yet made very little progress, but the day of small things would not always continue, and the making St. Marie a free port and opening settlements around it were auspicious commencements. His lordship then re-

ferred to the election in June last of the Rev. Dr. Lewis, to be Bishop of Ontario, and his consecration on the 25th of March last, the first consecration of a Bishop of the Church of England in British North America. He then briefly referred to the holding of the Provincial Synod at Montreal in September last, and proceeded to say that only one subject more remained which he ventured for the third time to press upon their serious attention, and he was pleased to see that it appeared in the order of business prepared by the Executive Committee, namely the episcopal endowment. He need not urge upon them the great importance of the object, and he was happy to say that, notwithstanding the general monetary pressure throughout the country, if due diligence were used, there would not be any great difficulty in realising the required amount, £10,000, or \$40,000. They had two successful examples to encourage them-the dioceses of Huron and Ontario. both of which acted with noble liberality in this behalf. Now this diocese was much more wealthy and populous than either Huron or Ontario, which favoured the more easy accomplishment of the undertaking. The members of the Church of England in the diocese might be safely taken at 140,000 souls, or about 28,000 families. Now all of these were bound according to their ability to make up the stipulated sum. It only required from every individual a small donation of 1s. 6d., or from each family a donation of 7s. 6d., leaving in either case a small surplus of about \$2,000. In conclusion he had only further to remark that he had just returned from a confirmation journey of 15 days in the northern portion of the diocese. The missions and parishes visited were 25; the number confirmed 546; and the miles travelled about 320.

REPORT OF THE COMMITTEE OF SYNOD ON SEPARATE SCHOOLS.

Your committee beg to report that, having been in communication with the Chief Superintendent of Education,

they learned that a bill had been prepared by him for the amendment of the existing school law, in which the just claims of the United Church of England and Ireland to the control of her own schools in cities, towns, and incorporated villages, had been recognised and provided for, as far as seemed practicable, under existing circumstances.

As the general provisions of the aforesaid bill had been submitted to his Lordship, the Bishop, and had met with his approval, and farther, had commended themselves to the judgment of those members of your committee who had the opportunity of considering them, and as, moreover, your committee understood from the Chief Superintendent that he had reason to believe that the bill would be brought in as a government measure, they felt, under the circumstances, that no further action on their part was required.

In consequence, however, of the severe illness of the Chief Superintendent, and his inability to be present at Quebec, his proposed bill has not been brought forward, and a member of the house had introduced a private measure intended to afford additional facilities for the extension of Romish Schools.

Your committee would therefore recommend that petitions on the subject, similar to those previously prepared by the Synod, be again presented to the several branches of the legislature, and that the attention of the members of our communion, in parliament, be earnestly drawn to the duty and necessity of endeavouring to secure for the Church of England and Ireland the same educational advantages as are accorded to the Church of Rome.

In the receipts is included a handsome donation from the widow of the Rev. H. Ripley, of \$400, who at the same time announced her gratification at being able to relinquish the pension she had received from the date of her husband's death.

The Burnside bequest our solicitors hoped to have realised early in the summer of last year; in consequence of the non-production of one title to the property there has been some delay, which the solicitors state has been satisfactorily cleared up, and that they have been able to make a very satisfactory arrangement, fully securing the society without being forced to sell the property of the mortgagee at a great sacrifice. Another mortgage in the city, of \$4,000, purchased with Upper Canada bank stock at par, has had to be foreclosed for the non-payment of interest, and after the time required by law will be sold, and it is believed will realise the amount paid; but pending the sale the amount of insurance on buildings, repairs, commission to collector, and law costs, has for this year proved an unproductive investment. The interest of the other investments has, though not punctually paid to the day, realised on the average 8 per cent.

The balance to the credit of this fund is \$889.17, from which will have to be deducted the taxes on lands paid out of the General Purpose Fund.

2. That two clerical and one lay member of the Synod shall act as scrutineers of the votes of the clergy, and two lay and one clerical member of the Synod as scrutineers of the votes of the laity; the scrutineers for each order to be appointed on motion, by the members of each order separately.

3. That ballot boxes shall be provided to receive the votes of the clergy and laity respectively. That upon each member of the Synod depositing his vote, a mark shall be placed opposite his name on the roll by the secretary of the order to which he belongs, and that upon the requisition of any three members of the Synod, the number of votes deposited shall be compared with the number of those who have voted upon the occasion. That the scrutineers shall hand over the votes to the secretaries of the Synod, whose duty it shall be to preserve them until the election of dele gates shall be completed, and then destroyed at the end of the session.

That at a large meeting of leading members of the committee they unanimously agreed to the following as a primary report, to be submitted to the Lord Bishop, under the direction of whom they were required by resolution of Synod to act: "They are of opinion that it should be their endeavour to obtain the recognition of the following principles.

"1. That it is desirable that there should be one University for Upper Canada, which should embrace all the bodies in the province possessing academical powers, and that all graduates of these bodies should be entitled to the same standing in the Provincial University.

"2. That the separate colleges to be incorporated into this Provincial University should be required to abstain from the exercise of their right to confer degrees, except degrees in Divinity, so long as they remain in connexion with the University.

"3. That there should be two distinct bodies for the administration of the affairs of the University, viz.:

"(1). A general Board of Management, who should have the control of all financial matters.

"(2). An executive committee or senate, which should have entire control of the educational system of the University, within the limits prescribed by the charter; the said executive council or senate to consist of graduates of the University, and representatives of the separate colleges.

"4. That there should be no interference on the part of the University in the internal administration of the property, education, or discipline of the separate colleges."

To this preliminary report, presented to his Lordship the Bishop by two members of the committee, deputed for that purpose, his lordship was pleased to make the following reply, in a letter to the chairman of the committee:—

improvement of University education."

"When this resolution was under discussion before the Synod, I consented to its adoption merely as a committee of enquiry and nothing more. With this limitation I thought it might be useful, should any measure be introduced by the government on University education, because it might carefully watch its progress through the legislature, and apprise us of its provisions and bearing on Trinity College, and, should we find any improvements, how far we might be able to avail ourselves of them with safety, or modify them, so as to benefit our system of education; or, if detrimental, to endeavour to get them corrected or rescinded. I was of opinion also that the committee should enquire, as far as practicable, into the workings of the other collegiate institutions in the province, because the information thus obtained might enable us to perfect our own rules and regulations, not only in regard to discipline, but also as respects our literary and ordinary arrangements.

"So much in explanation of the resolution. But what do we find in referring to the report? Instead of a simple enquiry, giving us information respecting the state and working of collegiate institutions in the province, and the particular objects and views of the government (if they can be ascertained) in establishing and modifying a new University, we are called upon at once to receive the following principles: 1st. That it is desirable that there should be a University for Upper Canada, which should embrace all the bodies in the province possessing academic powers, and that all graduates of these bodies should be entitled to the same standing in the Provincial University. Now I do not consider such a colossal University desirable or applicable to the wants of the province. It is said to have failed in Australia; but, be that as it may, as it would be in a good degree without competition, it would either sink gradually into indolence, or in process of time, by its greater power and influence, injure all other institutions, and not only trench upon their independence, but at length extinguish their vitality. The reason why the London University shews so much life is that it confines itself, as far as I can find from its charter and calendar, to public examinations and the conferring of degrees. It admits of no teaching whatever in the common meaning of the word, and is rather felt as a kind protector than an arrogant master.

OF THE DIOCESE OF TORONTO "2nd. "No such severe assumptions as these are exercised by the Hondon University. Alt the colleges and institutions connected with it, so far as I can find from the charter, &c., continue in all things free within themselves. Even in the conferring of degrees matters are so arranged by the London University as not to interfere with the arrangements of the colleges and educational institutions. The undergraduates of them all have the option of taking their degree, if found qualified, at their respective colleges, or at the London University, with the simple provision that they must make their choice, as they cannot be taken at both. Hence in this respect there is no interference or restraint imposed upon any of the colleges by the London University itself. And here it may be remarked that the Board of Commissioners of Education in Scotland, corresponding to the University proposed here, confer no degree, but merely regulate the local colleges and institutions in the manner of giving them. The same practice is followed by the Medical Council of England. It gives no degrees, but allows them to be conferred under its guidance by the local institutions. It may be forther noticed that the Board of Regents at Albany, as the head of the various local institutions, and which is culted the University of the State of New York; confers no degrees, but merely regul lates the manner of conferring them, as the Commissioners of Education in Scotland, it noque denou vise ton bas, and

Again, it does not appear that the colleges and institutions in connexion with the London University, seattered as they are throughout Britain, ever take any part in the management of the London University, or are ever called upon or permitted to share in its business arrangements. Were the connexion between the collegiate bodies no greater than is required by the London University and similar institutions at home, there might be no serious difficulty in according to it, but we are called upon to surrender all the portions of our Royal Charter which we chiefly value, and for which we have been strenuously contending for many years. Moreover, our charter is felt to be a sacred trust granted by the Queen, on our own petition, and we have no power to suspend, alter, or surrender any of its provisions. was annual agol out more success

"Lu the second principle, it is also required that all the separate colleges be incorporated with the University. Now what is meant by incorporation, the extent of the power it confers, no such condition is imposed by the London University. Why, then, should it be imposed of additions, which it is confidently believed will ? siad

"That there should be two distinct bodies for the administration of the affairs of the University, viz.: -1st. A general board of management to have the control of all financial matters, would of nesser even sufframos, the t

"This provision requires no other remark than that in operation it would be found inconvenient and unwieldy.

"2nd. An Executive Council of Senate, which should have entire control of the educational system of the University, within the limits prescribed by the charter. The said Executive Council or Senate to consist of graduates of the University, and representatives of the separate colleges.

"This power appears too extensive, and in its exercise inconvenient, but till the terms of the charter are proposed in more detail, it cannot be satisfactorily considered.

"The 3rd. That there should be no interference on the part of the ministry in the internal administration of the property, education, or discipline of the separate colleges.

"This third provision appears full and reasonable, but requires some elucidation, when taken in connexion with the power conferred upon the Executive Council and Senate."

After the meeting at which the foregoing report was adopted, it was found impossible to secure the attendance of sufficient members of the committee to authorise those members who did attend to take any further action as a committee. The only thing left for those members who took a deep interest in the question was, by interviews and correspondence with the government, members of parliament, and others moving in the same question, to secure such "a measure from the legislature as would be consistent with the interests of the church and the improvement of University education." And your committee have much pleasure in being able to report that their labours have not been entirely in vain, as the Senate of the University of Toronto have unanimously assented to a scheme of affiliation, which it is confidently believed will hold out inducements sufficient to cause the several chartered colleges to become connected with the University of Upper Canada. and that organized the brand form

Your committee have reason to believe that it was the intention of the late government to introduce a measure into parliament in accordance with this scheme, and from the well known feeling of the legislature on the subject, and the publicly expressed opinions of the present Premier in reference thereto, there is every reason to believe that the measure will be carried next session, when Trinity College will be able to benefit by a share in the public endowment on fair and equitable terms, and to bear its part in raising the standard of University education

Rev. Mr. Darling, seconded by Dr. Bovell, moved the adoption of the report of the committee on Separate Schools.

Mr. Hodelns moved that the report be referred back to the committee with a view to make the following amendments to it, viz.: to strike out the last paragraph and to amend the first so that it shall read as follows:

"Your committee beg to report that having been in communication with the Chief Superintendent of Education they learned that a bill had been prepared by him for supplementing the existing school law and providing for the education of vagrant children in cities and towns through the agency of 'any benevolent association, society or congregation of any religious persuasion' which the committee believes will meet the views of the United Church of England and Ireland in regard to schools in cities and towns."

Rev. Mr. Darling consented to the report being referred back, and Mr. Hodgins' name was added to the committee.

Mr. Hopeins gave notice that he would move as an amendment to the resolutions relating to Separate Schools to be moved by Dr. Bovell, and seconded by Rev. Mr. Darling, the following:

"That as members of the United Church of England and Ireland in this diocese, we do not desire to see any interference with the common school system, as established by law, or to demand exclusive privileges not at present shared in equally by other protestant denominations in Upper Canada."

The Synod adjourned at one o'clock.

### THIRD DAY'S SESSION.

THURSDAY, June 19th.

# ALTERATION OF BY-LAW-MISSION BOARD.

That it is expedient that the by-law on the Mission Board be amended, by leaving out the third clause thereof and substituting the following:

"That the Board of Missions assumes the payment of their stipends to all missionaries who have been up to this date liceused by the Bishop to minister within the limits of any district association of this diocese, provided the committee of such district association shall from time to time place the board in possession of sufficient funds to cover the stipends, or shall fulfil such stipulations as may have been, in special cases, entered into with the board.

"That the board will be ready to assume the same obligation in reference to such missions as have had promises made to them by any district association, and have been accepted by the board as having claims upon its consideration, before any other new missions are provided.

"That after such missionaries or missions have been provided for by the board, from the funds contributed by their respective district associations, any surplus there may be shall be applicable to the payment of missionaries in any part of the diocese where the Bishop shall see fit to appoint a clergyman to minister, in any mission recommended to his lordship by the district committee, through the mission board.

The Rev. E. H. DEWAR moved in amendment, seconded by the Rev. T. S. KENNEDY, that the following clause be inserted in the by-law, in lieu of the clauses proposed by the Rev. A. Palmer:

"That, with regard to any parish or mission contributing £100, instead of the words 'shall be entitled to receive from the board £50,' the regulation should read, 'shall receive £50 from the board, if the funds of the board permit, and if, considering the exigencies of the case, in regard to other destitute parts of the diocese, it shall appear to the board expedient to grant it."

Rev. A. Palmer was willing that the clause should be added. This proposal, on a division, was carried by 66

The Rev. Dr. BEAVEN moved the adoption of the report of the committee on music.

"The Musical Committee beg leave to report that according to the direction of Synod, they have published the Chant and Tune Book, which they reported on at the last meeting, and that more than 2,500 copies, out of an edition of 5000, have been sold; Messrs Lovell & Gibson undertaking the risk of publication.

"Since the circulation of the book, they have received, directly or indirectly, several suggestions for the publication of an appendix, to consist in part of tunes for metres for which they have not provided, and partly of such chants and tunes as have proved acceptable to congregations, but are not included in the collection. They find that the publishers are disposed to publish such an appendix at their own risk, and they recommend that they be authorised to publish such an appendix.

"An application has likewise been made to them to pub-

lish the canticles, provided for chanting as in their book, but without the tunes, for the use of those members of congregations who sing only by ear. They recommend that if, upon due consideration, they think it advisable, they be authorised so to do.

"In consequence of the erection of the See of Ontario, some members of the committee are withdrawn from the list; they recommend that the Rev. Mr. Holland, Rev. Mr. Ritchie, Rev. Mr. Palmer, and W. Atkinson, Esq., be added to supply their loss, together with any others

appointed by the Bishop.

"As the Synod is not incorporated, and consequently has no legal status as a holder of property, the committee have found a difficulty in registering the Chant and Tune Book, to guard against piracy, and in entering into any binding contract for its publication. The committee recommend that the Chant and Tune Book be made the property of the Church Society, in order that the secretary of the Church Society may register any new edition, and that if any profits should arise from the publication, the Church Society may deal with them."

The report was finally adopted, and the committee re-appointed, with the addition of the names recommended

in the report.

#### SEPARATE SCHOOLS. ANT ON MAINTANNE

Dr. Bovell moved the following resolutions:

"That a respectful memorial be again presented to the legislature, setting forth the continued desire of the Church of England and Ireland in Canada to have separate schools in cities and towns, as stated in the resolution adopted by the Synod of June, 1861.

"Since making up the annual statement, a further investment has been made in municipal debentures to the extent of £500, leaving the present investments £220,065 12s. 9d. These represent an income of £14,316 14s. 1d. The sum invested as belonging to the Income Fund has been to a certain extent re-paid, it having become necessary, owing in the first instance to the repayment of loans at a high rate of interest, and in the second place to the nonpayment of interest on the Hamilton debentures.

"The amount of liabilities for salaries and management for the present year, is £14,376, showing a deficiency in income for that period of £59 5s. 11d., against which there was a balance of over-due interest on 1st May last of

£2,558 10s. 6d.

"In February last a select committee, composed of the Rev. Dr. Patton, Rev. Dr. McMurray, Hon. G. W. Allan, W. B. Simpson, Esq., the Manager, the Chairman, and C. J. Campbell, Esq., was appointed to examine the securities held by the Clergy Trust, and to ascertain and report upon their present value. In their report to the commutation committee made at the quarterly meeting in that month, after going through the securities in detail, the committee concludes by saying that on the whole, considering the variety and magnitude of the transactions in managing a fund still amounting to £217,967 15s. 9d., after paying the sum of £66,551 to the diocese of Huron, the committee feel that the church has reason to be satisfied with the present position of the fund."

As the much desired measure of Sabbath Reformation, embracing the abolition of labour in the Post Office, on Railways, Canals, &c., on the Lord's day, may not obtain a place in the statute book of this province, in the

present session of parliament; it is important that steps should be taken thus early to secure the transmission of numerous petitions to the three branches of the legislature, as soon as parliament may assemble next year, (1863) in order to strengthen the hands and encourage the hearts of those, who, it is hoped, will be raised up by the Almighty, powerfully to plead the cause of this holy day, and the right of all men to its unfettered and undisturbed enjoyment, and to show that it would be daring impiety in the sight of God, as well as gross injustice towards man, to turn a deaf ear to the plaintiff cry of the people, or put off a moment longer redressing their grievances in a matter of such vital importance.

With sentiments of this nature, influencing the minds of the committee of this society, I am directed by them to beg that you would have the goodness to convey their earnest and respectful request to the Rev. Synod of the Diocese of Toronto, at their next meeting, that they would be pleased to take the whole subject of Sabbath desecration, as perpetrated by the public departments above named, into their deliberate and prayerful consideration, express fully their solemn convictions thereon, and grant authority to their secretary, or other officer, to transmit a petition to the three branches of the legislature soon after the assembling of parliament in 1863, praying for the abolition of all labour in all the public departments on the Lord's day. have the honour to be,
