

An Act to revive the Act of the Parliament of Upper Canada, incorporating the Niagara and Detroit Rivers Railroad Company.

WVHEREAS it is expedient to revive the Act herein- Preamble. after mentioned, subject to the provisions hereinafter made: Be it therefore enacted, &c.

That, subject to the limitations and provisions hereinafter Act of U. C. 5 made, the Act of the Parliament of Upper Canada, passed 6 W. 4. c. 6. in the sixth year of the Reign of His late Majesty King William the Fourth, and intituled, "An Act to Incorporate " certain persons therein mentioned, under the name and " style of the Niagara and Detroit Rivers Railroad 10 " Company," shall be and is hereby revived, and shall have force and effect as if herein repeated and re-enacted.

II. Provided always and be it enacted, That the seven- How the 17th teenth section of the said Act shall be read and construed be construed. as if herein re-enacted, so that the Company mentioned 15 in the said Act shall have two years from the passing of this Act to commence the construction of their Railroad, and ten years from the passing of this Act to construct, finish and put in operation the whole of the said Railroad; subject to the forfeiture of privileges in the said section 20 mentioned, if they shall fail to comply with the requirements thereof construed as aforesaid.
