An Act to amend the Law relative to the administration of Justice in Gaspé.

THEREAS by Acts of this Session, Preamble. the present Courts of Queen's Bench (or King's Bench) and the Court 4 of Appeals for Lower Canada, will be abolished after the time when those Acts 6 shall come fully into effect, and a Court of Queen's Bench will be established having 8 jurisdiction in appeal and error in civil cases, and original jurisdiction in Criminal 10 matters, and a Superior Court will be established having original jurisdiction in 12 civil matters, and the several Circuit Courts in Lower Canada will be united into one 14 Court, the jurisdiction of the said three last mentioned Courts extending throughout all 16 Lower Canada; and whereas it is necessary so to amend the Act hereinafter mentioned, 18 that its provisions may be consistent with those of the Acts aforesaid: Be it there-20 fore enacted, &c.
