## A G R E E M E N T.

This Agreement made and entered into this ninth day of December in the Year of our Lord one thousand eight hundred and seventy-three, between the Port Dover and Lake Huron Railway Company of the first part, and the Municipality of the County of Oxford of the second part.

WITNESSETH that in consideration of that part of the County of Oxford comprised of the Town of Woodstock and the Township of North Norwich granting a bonus to the said Railway Company of fifty thousand dollars to aid and assist in the construction of the said Railway, the said Port Dover and Lake Huron Railway Company for themselves, their successors and assigns covenant and agree with the said County of Oxford as follows :

The said Railway Company in consideration therefor have agreed to erect and maintain within the said Town of Woodstock all the principal workshops that may be required by the said Company and good and sufficient passenger and freight accommodation. Also at the village of Burgessville and Norwich in the said Township of North Norwich to erect and maintain the necessary passenger and freight accommodation, on the land formerly purchased for that purpose by the Woodstock and Lake Erie Railway and Harbour Company.

The said Railway Company have further agreed that the work of construction upon the said line of Railway between the Town of Woodstock and the Village of Port Dover shall be commenced in good faith within three months from and after the passing of the by-law, and shall be completed and ready for traffic within the period of two years from the date hereof.


The said Railway Company have further agreed that the portion of the said bonus to be paid by the said Township of North Norwich shall be expended within the said Township and that portion of the said bonus to be paid by the Town of Woodstock on the line of the said Railway South of Dundas street.


In witness whereof the said Port Dover and Lake Huron Railway Company have caused to be hereunto affixed their corporate seal the day and year first above written.
