A BIG BICYCLE OUTFIT. The figures of one large American factory—the output of the leading United States bicycle factories, "Barnegat" publishes the following interesting item:

"You see a great deal in the trade papers about this concern building 10,000 high-grade wheels, and another concern turning out 15,000, and another concern working day and night to put out 20,000, but in my opinion the numbers are in excess of the actual output of the majority of the concerns."

The fact is you can count on the fingers of one hand the number of concerns in this country who are turning out in the year 10,000 absolutely high-grade wheels.

"I know that for the last two months the Eclipse have been running through their works at least 60 machines a day, and they will no doubt begin to run in time, as they generally do when they are rushed, and they expect to put out 80 wheels a day, which you understand means about 2000 wheels a month."

I suppose that the capacity of the Eclipse Company is well up to that of the largest in the United States, and when you talk about 2000 high-grade wheels a month, it is simply impossible. The concern has been putting in some new machinery right along every few weeks all winter, such for instance as the hub turning machine for putting hubs on to solid wheels, and automatics for turning out work that is about as perfect as can be made."
