MINUTES

OF CANADA YEARLY MEETING OF FRIENDS, HELD AT PICKERING, ONT., BY ADJOURNMENTS, FROM THE 25TH OF SIXTH MONTH TO THE 30TH OF THE SAME, INCLU-

SIVE, 1880.

Sixth day, 6th Month, 25.

1. In the absence of the Clerk, Howard Nicholson was appointed for the day.

2. Reports have been received from all the Quarterly Meetings, by which it appears that the following Friends have been appointed Representatives to this Meeting :--

PELHAM.—Albert C. Stover, David Hulet, Charles J. Treffry, Andrew Hill, and James F. Barker.

YONGE STREET.—Joshua N. Richardson, Elias Rogers, Seneca Doan, George Rorke, Henry James, and Allan Cody.

WEST LAKE.—Esli Terrill, William Robinson, Anthony T. Haight, Stephen W. White, and Jonathan P. Ward.

3. The foregoing Representatives being called, were present, with five exceptions.

4. The following Caretakers have been appointed by Quarterly Meetings, viz.: William Burkholder, William S. Barker, William Nelson Starr, James Richardson, Edward Cornell, and Henry Doyle, who are present, with the exception of four; they, with the addition of Clarkson Rogers, Edmund Wright, and Christopher Dale, are instructed to have a watchful supervision over the Meeting-house and grounds, to facilitate the

work of Committees, to make arrangements for meetings and to keep order, and to encourage our own members to punctual attendance.

7. We appoint Samuel Rogers and James F. Barker a Committee to procure a reprint of 1000 copies of London General Epistle for the use of subordinate meetings, and 1000 for the use of Toronto particular Meeting, and draw on treasurer.

8. The clerks for the time being are appointed a committee on printing, and we direct them to procure 1000 copies of the Minutes of the Men's and Women's meeting and draw on treasurer.

9. We draw the attention of the Representatives to the apportionment of documents to the respective Meetings.

12. About the time adjourned to the meeting again convened.

13. James F. Barker, on behalf of the Representatives, proposed Howard Nicholson as Clerk, and Thomas Harris and John T. Dorland, jr., as assistants, which being separately considered and united with, they are accordingly appointed for one year.

14. Henry Jones and Henry Wilson are appointed messengers to the Women's Meeting.

15. The Epistle of Dublin Yearly Meeting has come to hand and been read in our Meeting.

16. We appoint William Spencer, Herbert Nicholson, Charles J. Teffry, John T. Dorland, jr., Charles Gideon Bowerman, Albert Rogers, Elias Rogers, Seneca Doan, and Christopher Dale, our Committee on correspondence, and direct them to prepare and offer to a future sitting, drafts of letters to those Yearly Meetings with which we are in correspondence.

17. The Queries with answers from the Quarterly Meetings have been read, and a summary adopted, which is as follows :

SUMMARY OF ANSWERS TO THE QUERIES.

1st. Most Friends are careful to attend our Meetings held on First days, while much slackness is reported in the attend-

ance of those held in the middle of the week. The hour is nearly observed, not quite clear of unbecoming behaviour, with some care taken.

2nd. Friends are preserved in love one towards another, with a few exceptions, when differences arise care is taken spedily to end them. Talebearing and detraction are not so fully avoided and discouraged as desirable.

3rd. We believe friends do endeavor to train up their children and those of other Friends under their care, in the principles of the Christian religion as professed by us, and in the plainness of dress, language, and deportment, which it enjoins. With some exceptions they are good examples in these respects themselves, and endeavour to guard their children and others under their care against corrupt conversation and the reading of pernicious books.

4th. With few exceptions Friends are diligent in reading the Holy Scriptures in their families collectively.

5th. With three exceptions Friends avoid the use of all intoxicating drinks except for purposes strictly medicinal, and with two exceptions are clear of attending places of diversion, some care taken in both of the above deficiencies.

6th. The circumstances of the poor amongst us are inspected and relief seasonably afforded them (one report says some relief) they are advised and assisted in suitable employment and we believe their children and all others under our care are being educated for the ordinary duties of life.

7th. Friends are clear in the several parts of this query.

8th. With some exceptions Friends are just in their dealings, punctual in fulfilling their engagements, and are careful to conduct their business as becomes our religious profession. When any give occasion for fear on these accounts they are laboured with for their preservation and recovery, though in some cases not so seasonably as is desirable.

9th. Care is taken to deal with offenders in the spirit of meekness and agreeably to Discipline, though some slackness appears in promptly attending to this duty.

In order that those members of our Meeting who are not present may profit by the loving counsel and kindly admonitions which our deficiencies have called forth, we direct the Clerks to prepare and present to a future sitting a synopsis of the exercise of this Meeting.

Resumed after recess.

18. A circular containing a proposition for the formation of a Missionary Board on this Continent, having for its object the direction and encouragement of Missionary enterprise has been received and read. It informs us that eight of the Yearly Meetings with which we correspond have agreed to submit for our approval and adoption certain rules and regulations for the governance of the Body which shall be called "The American Friends Missionary Board." After a full expression of unity this Meeting appoints Herbert Nicholson, John Wright, Daniel B. Cohoe, Stephen Cronk, Joseph Cody, Smith Clark, Levi Rogers, and Charles Gideon Bowerman, in conjunction with an appointment of Women Friends, a committee to digest the proposals contained in the circular, to bring forward the names of two Friends to act on the Board and to suggest the best way of providing funds for the advancement of the work.

19. In the Minutes of the Pelham Quarterly meeting we notice the following :

PROPOSAL FROM PELHAM QUARTERLY MEETING.

"A proposal from Norwich Monthly Meeting was laid before this Meeting to ask the Yearly Meeting to hold its next Annual Gathering at Norwich. It was warmly united with and decided to forward the request to the Yearly Meeting."

MINUTE OF ADVICE.

Dear Friends,—We prayerfully advise following George Fox's admonition that all our meetings be held in the power of the Lord. Were this the case there would be no drowsiness in them, but having a deep sense of our responsibility in feeding the lambs and building one another up in the most holy faith, we would pray our Heavenly Father to remove from our hearts every worldly thought, to enable us to vocally ask Him to supply our need according to His riches in glory in Christ Jesus, and as we do so we will find our meetings to be times of refreshing from the presence of the Lord.

The deficiencies evinced in the answers to the 2nd query, have brought us into deep feeling. The church needs to be a unit in the matter of consecration, and then we will ever be ready to present the bright side of things and be far more tender in our judgments of others. Let us be careful not to impose burdens on others by telling them things we are not willing every one should know. In a word, if we are kind to one another, tender hearted, forgiving one another, even as God for Christ's sake has forgiven us, nothing of a fault-finding or tale-bearing spirit will be found.

We are convinced of the necessity of parents making a judicious selection of books and periodicals for their children to read, and of investigating the matter contained in them thoroughly, so that no error in doctrine may poison the minds of the children and bring forth bitter fruit in later years.

We tenderly advise our Friends that in our silent waiting in our families there be not opposition in our hearts to the Lord's will, as he may lead us in prayer. Let us be found more diligently seeking his blessing in vocal prayer, and with our hearts so full of His love that out of their abundance we may speak. Whilst we are encouraged by the knowledge that our Friends are almost clear from the use of intoxicants, we are led to realize how necessary it is that our testimony in this respect should be clear from this blemish. We rejoice in the knowledge that our head is the Prince of Peace, and where He is admitted into the heart we will love one another; will be careful in business transactions not to overreach, and will see to it that our Christian influence is not impaired by lightly esteeming our word. We should seasonably counsel those who are becoming cold in the Lord's work without waiting for more marked developments, in a spirit of love and humility, so will the Lord's name be glorified and the members of Christ's body preserved in the unity of the spirit and the bond of peace.

The Friends appointed to have a revision of the Discipline, made report, that circumstances prevented their being able to meet as agreed on, they are therefore not prepared to offer any revision. This meeting unites in having the subject referred to a future sitting for consideration.

Charles J. Treffry is appointed to act, in conjunction with a Friend appointed by the College Committee, to audit the books and accounts of the College for the past year.

Received from the caretakers of the meeting house and grounds, a suggestion that this house be repainted; it is the decision of this meeting that the subject be deferred to a future time.

This meeting adjourns to meet at 6 o'clock, seventh day evening.

SEVENTH DAY EVENING.

About the time adjourned to Friends assembled; eleven members present.

The important subject of revising the Discipline or adopting a new one having been under consideration at this time, it is the judgment of the meeting that the present Discipline of New York Yearly Meeting be adopted.

This meeting suggests to the Yearly Meeting the necessity of appointing a Friend as member of this meeting, to fill the place of William Wetherald, resigned. The Friends appointed to get information of the lack of the Standard Writings of Friends are instructed to forward catalogues to the different preparative and monthly meetings directing them to send lists of such books as they desire, to Samuel Morris, Cheltenham, Chester Co., Pa.

The meeting then concluded.

TO CANADA YEARLY MEETING.

We, your Educational Committee, present for your examination Annual Report and Financial Statements from College Committee.

We are pleased to find, so far as the educational and financial features of it are concerned, it is very encouraging, and shows that the teaching staff have been energetic and earnest in their endeavour to promote the interests of the school.

But we desire to call your attention to the fact, that one of the principal objects of the Society in the establishment of the College has been overlooked, or neglected, and would earnestly request the meeting to take such steps as they may deem necessary to carry that object into effect. We have reference to the spiritual element requisite to accomplish the requirements of the Society in disseminating the religious views of our Society.

We would recommend that in future the College Committee be so appointed that the three Quarterly Meetings be equally represented, by so doing we believe it will have a tendency to create a wider spread interest in the welfare of the Institution.

And we would further suggest that (as the Act of Incorporation provides that the Yearly Meeting is empowered to appoint three Trustees who are to hold the property in trust for the Society during pleasure, and that the said Trustees are *ex*officio members of the College Committee) the Trustees be appointed, as far as practicable, in the same manner as we have proposed for the Committee, thus spreading over a greater space, an interest in the welfare and prosperity of the Institution.

We have nominated Herbert Nicholson and Stephen W. White, as members of the College Committee for three years in place of the two retiring members. REPORT OF COLLEGE COMMITTEE, 1880.

Since our report last year, the Committee of Pickering College have given attention to the services confided to them.

The College was opened, and satisfactorily conducted throughout the year by the officers and teachers mentioned in last report, with the addition for the two last terms of Benjamin Wood to the staff of teachers.

We have passed a year in which we have had difficulties to encounter. Some of them caused by lack of funds to carry on the Institution as efficiently as we could have desired.

The number of Students as shown by the statement, to follow, will be seen to be a considerable increase on the number recorded last year.

The deportment and conduct of the students has been very commendable, and their assiduity in study will, we trust, be proved by many of them in the examinations they expect to attend next week.

We have much satisfaction in attesting to the zeal, efficiency, and indefatigable efforts of the Principal in promoting the best interests of the College, and also to the rest of the faculty who have ably assisted him in maintaining the harmony and successful working of the Institution, and we cordially invite Friends to avail themselves of the opportunity afforded them in procuring their children an education where the benefits are likely to be so great.

In consequence of the increase in the attendance of young men in the Institution, we were compelled to make alterations in the building at a considerable outlay, and we deemed it necess the win building

teramed it necessary to procure storm sash for the greater number of the windows. We also had erected a stable and other outbuildings.

The necessity of procuring a suitable supply of chemical apparatus being pressed on us, we procured during the year from Philadelphia such a supply of apparatus and chemicals as the Principal considered indispensable, every precaution being used with regard to economy in the purchase.

In the absence of a library, the necessity for some useful instructive literature was very evident and being strongly recommended by the Principal, the Committee have fitted up a reading room, with the necessary stands, tables, &c. The officers, students and a few others furnished the papers, magazines, &c., and the Committee are informed by the Principal and others, that it has been a source of great satisfaction to the students, and highly appreciated by them All of which involved an outlay beyond the sum granted by the Yearly Meeting last year, and the Committee having had an opportunity, borrowed (\$907) nine hundred and seven dollars at 6 per cent., the seeming necessity of the case is the only reason for doing so, and we ask the Yearly Meeting to assume the responsibility of the debt.

We herewith forward the enrolment of pupils and financial statement.

Article 1.—The following plan for the organization of a Friends' Missionary Board is submitted to the different Yearly Meetings on the American Continent which correspond with each other, for their approval and adoption. After it has been

so submitted, the Friends who may have been appointed shall constitute the proposed Board, and shall meet and organize in the manner indicated at the call of a committee now appointed by this Conference.

Article 2.—'The Association shall be called the American Friends' Missionary Board.

Article 3.—Its object shall be to promote the work of Missions and advance the cause of Christ in the earth, by effecting a general and more specific co-operation of Friends everywhere.

Article 4.—The Board shall consist of two members appointed by each Yearly Meeting joining in the Association, together with a like number from such Association of Friends in Philadelphia as may unite herein. The Board shall meet annually and oftener when necessary.

Article 5.—The officers of the Board shall consist of a Chairman, Treasurer and Secretary; the former to be chosen from the members of the Board, the latter may be chosen from outside, but will then become a member *ex-officio*.

Article 6.- The Board shall procure information in regard to the needs of the various missionary fields, and exercise a general supervision over the work and workers under its care; shall receive and consider applications from persons who may desire to engage in the work, and recommend them to such fields of labour as may seem to be best, and under such regulations as it may determine. It shall recommend to the Missionary Committees of such Yearly Meetings as may have them, suitable fields for their labour, and suitable workers for those fields : it shall correspond with such committees upon the general and particular needs of the work, and report to the Yearly Meetings, through their committees, where they have such, all information that may be of interest to them, or may aid them in furthering the interests of the cause. It shall keep Friends generally advised, through the press, of the progress of the work, and make such application of the funds entrusted to its care as may seem best, either in the establishment of the new Missions, or in the assistance of those already established by individual Yearly Meetings.

Article 7.—It shall be the duty of the Treasurer to receive all contributions of money that may be made for the purposes of the Board, and to pay bills and drafts upon it when endorsed by the Chairman and Secretary. His accounts shall be annually examined by an Auditing Committee of the Board.

Article 8.--It shall be the duty of the Secretary to carry out the instructions of the Board in any department of the work to which he may be directed.

Article 9.—The expenses of the Board and its work are to be met by voluntary contributions; and to aid in obtaining these, and to promote the general interests of the cause, it is recommended that a Corresponding Secretary be appointed at each Quarterly Meeting.

Article 10.—Such Yearly Meetings as are already engaged in missionary work are encouraged to continue in their respective fields, but when they wish to engage in other fields, it is recommended that they do so only with the sanction of the Board, in order that the work may be properly distributed and the best results obtained.

Article 11.—Where Yearly Meetings have Missionary Committees, they are requested to report full information of their work to the Board.



13. The Friends appointed to prepare summary answers, produced them; and the meeting entered upon the consideration of the state of Society as presented by the answers to the queries. They claimed our careful consideration; a summary of them is as follows :—

SUMMARY OF ANSWERS.

14. 1st.—Most Friends are careful to attend all our meetings for religious worship and discipline, although there are some deficiences in the attendance of those held in the middle of the week. The hour is nearly observed, with an exception in one meeting; unbecoming behaviour is reported in two of the smaller meetings, and care has been extended.

2nd.—Friends are preserved in love one towards another with a few exceptions; when differences arise care is taken to end them. Tale-bearing and detraction not so fully avoided as is desirable.

3rd.—We believe Friends endeavor to train up their children and those of other Friends under their care in the principles of the Christian religion as professed by us, but in regard to dress and language greater care is necessary. Most Friends are good examples in these respects themselves. We trust they endeavor to guard their children and all others under their care against corrupt conversation and the reading of pernicious books.

4th.—With a few exceptions, Friends are diligent in reading the Holy Scriptures in their families collectively.

5th.—Friends avoid the use of all intoxicating drinks except for purposes strictly medicinal as far as we know; one instance of attending a place of diversion and care taken.

hose relief employment, and we believe their children and all others under our care are in a way to be properly educated for the ordinary duties of life.

7th.-Friends are clear in the several parts of this query.

8th.—Friends appear to be just in their dealings and punctual in fulfilling their engagements, and are careful to conduct their business as becomes our religious profession. We know of none who give occasion for fear on these accounts.

oth.—Care is taken to deal with offenders; we trust in the spirit of meekness and agreeably to discipline, but not always as seasonably as would be best.

15. The consideration of these elicited much counsel and encouragement. We were exhorted to be watchful that we sin not with the tongue; that we should ask as David did, "Set a watch, O Lord, before my mouth; keep the door of my lips." "Let the words of my mouth and the meditations of my heart be acceptable in thy sight, O Lord, my strength, and my Redeemer." "And to him that ordereth his conversation aright will I shew the salvation of God."

Desires were expressed that we might so abide in Christ the Living Vine, that we may know of receiving succor in every hour of temptation and grace for every time of need.

Mothers were encouraged to wait upon the Lord in prayer after the reading of the Holy Scriptures, earnestly seeking His blessing to rest upon them and their families, that both parents and children may know of being strengthened day by day for every duty required of them; and that the influence of all be exerted for the spreading of the Redeemer's kingdom in the earth.

16. Men Friends informed us they had appointed a Committee to examine the proposal contained in a circular from Indianapolis, in reference to a Missionary Board, and if way opens for it, to appoint two Friends to act in connection therewith.
