An Act to erect that part of the Parish of St. Roch of Quebec, situate on the North side of the River St. Charles, into a separate Municipality.

WHEREAS the Municipality of the Parish of St. Roch of Quebec, Preamble.
 is divided into two parts by the river St. Charles, and certain inhabitants and proprietors of that part which is situate on the north side of the said river, have, by their petition, represented that the land in the said Municipality on the south side of the said river, is divided in great part into building lots, forming two large Villages, and that the land in the said Municipality on the north side of the said river, is used exclusively for agricultural purposes, and that the said two parts of the said Municipality have no interests in common, being divided by a navigable river and intersected by a portion of the City of Quebec, and have prayed that an Act may be passed to erect that part of the said Municipality situate on the north side of the said river, into a separate Municipality, and it is expedient to grant their prayer: Therefore, Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:—

1. Upon, from and after the first day of July, 1862, all that part of the present Municipality of the Parish of St. Roch of Quebec, which is situate on the north or left bank of the river St. Charles, shall be erected into and constitute a separate Municipality under the name of the "Municipality of St. Roch of Quebec, North," and shall have all the rights, powers and privileges of a separate Municipality, under the Lower Canada Consolidated Municipal Act. New Municipality constituted.

2. The remaining portion of the said present Municipality of the Parish of St. Roch of Quebec, shall be a Municipality with the like rights, powers and privileges, under the name of the "Municipality of the Parish of St. Roch of Quebec, South." Remainder of St. Roch to be a Municipality.

3. This Act shall be deemed a Public Act.
