An Act to repeal the Statute 16 Victoria, chapter 80, and to make better provision for preventing infractions of the Laws against Usury.

WHEREAS it is expedient to repeal the Act hereinafter mentioned, and Preamble.
to make better provision for preventing infractions of the Laws against Usury ; Therefore Her Majesty, &c., enacts as follows :

I. The Act passed in the sixteenth year of Her Majesty's Reign, and Act. 16 V. c.
5 intituled, "*An Act to modify the Usury Laws,*" shall be and is hereby 80 repealed.

II. If any person lending money to another shall require him to purchase or take, privately or openly, any property, article or thing whatever, the value or price whereof is to be considered as part of the sum lent, or Penalty for
