Kitchener--Rosebery

Hero of South Africa Presented With Sword by Cape Town.

Says New Territory Will Prove as Important as America.

Rosebery Urges Liberals to Unite For the Coming Struggle.

London, July 31.—Amid tremendous enthusiasm, Lord Kitchener was tonight presented with a sword of honor, the gift of Cape Town. Sir Jos. Dinsdale, Lord Mayor of London, made the presentation in the course of a South African dinner, which was attended by many of the members of the House of Commons.

When the enthusiasm had sufficiently subsided for Lord Kitchener to make himself heard, he was warmly thanked for the gift, and expressed the confident hope that in South Africa, as in the past, he would be able to draw from his sword.

Lord Kitchener enquired Lord Milner, British High Commissioner in South Africa, and made an appeal based upon his intimate and personal friendship with him, and knowledge of the South African administrator, to give the confidence and support of the British nation.

Referring to the mineral and agricultural resources of the new territory, Lord Kitchener said: "You may assure yourselves that you have nothing less than the makings of a new America in the new territory."

He said the question of who would supply the energy, brains, and money to carry out this great enterprise was one more for his hearers than for himself, but when in South Africa patriotism was joined with self-interest he was not afraid they would fall to see the seed and reap the harvest for South Africa had prepared.

London, July 31.—Lord Rosebery presided at a large dinner given to the Liberal League tonight, at which Herbert H. Ashgill, Sir Edward Grey, Sir Henry Campbell-Bannerman, and other prominent Liberals were present.

Lord Rosebery, in the course of his speech, which resulted in the election of Rowland Osborn as president of the Liberal League, said that the speaker characterized the North Leeds election as a largely attended affair at the government's records, and that the Liberal party had had its single election since the late Mr. Gladstone was first returned for the constituency of Leeds.

Lord Rosebery warned his hearers of the danger of a Liberal party which might not turn out the party in power. He showed, however, that the nation was not so dispirited as it was at the government's records, and that legislation, and to cool with the cooler heads of the Liberal party during the South African war.
