EXTRACT FROM THE "VOTERS' LIST ACT."

The Sheriff shall, immediately upon receipt of his copies, cause one of them to be posted up in a conspicuous place in the Court House. The Clerk of the Peace upon receipt of his copies, shall cause one of them to be posted in a conspicuous place in his office. Every Public or Separate School Head-Master or Mistress, shall, in like manner, post up one of his or her copies on the door of the School house, and every Post-Master shall post up one of his copies in his post office.
