ANNUAL REPORT

ST. GEORGE'S SOCIETY,

For the year ending 5th January, 1846.

GENTLEMEN—Ten years have elapsed since the organization of our National Society, during which period it is known to you that its onward progress has never been retarded—and supported as it is by so numerous and respectable a body of our countrymen, it may be said to have *now* attained maturity.

Pursuant to the Standing Rules, the Tenth Board of Management have the honor to submit their Report on the termination of their tenure of office. This Report will embrace a summary of the proceedings of the Society since the last election day.

The first matter which occupied the attention of the Board, was an Address to William Patton, Esquire, who had retired from the office of President, having filled it with the fullest approbation of the Society during a period of seven years. The Address in question, with Mr. Patton's reply, are inscribed on the Minutes of the Board, and were published at the time in the Quebec Mercury.

The next event which the Board has to notice is of a melancholy character. On the 5th March, the Society was deprived of its Vice-President, and Past-President, William Kemble, Esquire, a gentleman of the highest qualities, who died deeply regretted; and to whose remains and memory, as will appear by the Minutes, every token of respect in the power of the Society was paid. The Members generally attended the funeral, and afterwards wore mourning during twenty-one days; and the resolutions of the Society in this respect were duly communicated to the surviving relatives in England.

A new Edition of the Standing Rules and Regulations, as amended and approved on the 2nd April 1845 has been printed, and copies are in the possession of the Members. The Election of this day will be made subject to the amendments therein contained,

The Festival of the Society, an event of the highest interest to every Member, was duly celebrated by Divine Service in the Cathedral, on St. George's Day ; on which occasion an eloquent Sermon was preached by the Reverend G. Mackie, Senior Chaplain of the Society, and the usual collection was made, which amounted to the sum of £36 3s. 9d. The Musical Service was acknowledged to have been one of the best arranged, and most imposing since the foundation of the Society. The procession was conducted with its accustomed order and propriety ; but the celebration this day was distinguished by the introduction of the new and splendid BANNER of CAMBRIA, which took its place in the procession between the Banners of St. George and Britannia, a compliment due to those Members who derive their origin from the ancient Principality of Wales. The execution of the new Banner is highly creditable to the Artist, Mr. Todd, of Quebec, and to the Sub-Committee

under whose directions it was procured. In the evening of St. George's Day, the Society dined together as usual, on which occasion they were honored as before with the presence of the Representatives of the other National Societies, and other distinguished guests.

The next incidents in the order of time will render the year 1845 for ever memorable in the annals of Quebec. Two successive calamities by fire, on the 28th of May and 28th of June, reduced three-fourths of the City, outside the walls, to ashes, and several thousands of the poor inhabitants to destitution. Every aid that could be rendered was supplied by the devotion of the more fortunate inhabitants-but the Board feel that this is not the time or place to expatiate on the visitation, which by Divine Providence, we were then destined to undergo. Let us hope, that chastened and purified by the calamity, the minds of the sufferers may have regained a well regulated confidence in the result of the exertions they are making to retrieve their position-and that the embellishment and improved regulations of the City may compensate, in after years, for the sufferings which they endured in 1845. To'the Members of the St. George's Society in particular, it must ever be a source of consolation and pride to reflect, that the call of the distressed from this remote part of the Empire was answered by our countrymen at home, with one voice of sympathy and compassion throughout the length and breadth of the land! freely accorded. Succor to an unexampled extent in money, clothing and necessaries of every description, has been poured out amongst'our suffering people of another creed, by the Christian liberality of Protestant England ! What reason have we not then, Sons and descendants of that glorious country, to be proud of our origin, and to rejoice in our descent ! And how imperative becomes the call on every old countryman in our vicinity, to unite with our Society and thus in a foreign soil identify himself more closely with the land of his birth !

- It becomes now a most gratifying part of the duty of the Board to draw your attention to the assistance which has been dispensed to the distressed natives of England and Wales, during the past year, under the able direction of the Sub-Committee of Charity,-the gentlemen composing which department of our Society merit its warmest thanks. The number of cases, in which relief proportioned to the wants of the claimant has been afforded, amounts to 44 ; and the nature of the relief . ncludes donations in money-provisions-clothing-board and lodging-medical assistance-and especially passage home. Full details of these cases are given in the Report of the Charitable Committee approved by the Board-which Report it is customary to publish for the information of Members generally. The total sum distributed in Charity is £171 11s. 3d .- of which £65 have been allotted to the Members of the Society who were grievous sufferers by the late fires, pursuant to a vote of a General Meeting held in August last.

Treasurer, hereunto annexed ; and congratulates the Society on the important increase to the number of Members during the past year, as well as on the great augmentation of the permanent fund, which has been raised from £700 to £1000. This increase of £300 in one year is owing to the accession of New Members who have joined us, and to the number of old Members who have paid the commutation of their annual subscriptions, £6 5s. and taken up Life Membership-a most important object as regards the prosperity of the Society. The £1000 forming the permanent fund is invested, bearing interest; and this interest, added to two-thirds of the Annual Subscriptions, forms what is called the Charitable Fund, out of which aid is distributed. The remaining third of the Annual Subscriptions-the admission fees of new Members, and the commutation fee for Life Membership, with donations not specially limited, are added every year to the permanent fund, which is thereby made a constantly accumulating fund. It has been thought well to give this explanation of the terms, " Permanent Fund," " Charitable Fund," in. order that gentlemen not at present Members may become acquainted with the beneficial working of the Society, and it is confidently hoped, maybe induced to join us without delay.

The Board has much pleasure in informing you that our Chaplains and Physicians, each in their several departments, continue to give their kind, able and gratuitous assistance in furthering to the utmost of their power, the charitable objects for which, above all, the Society was founded. In pursuance of a Resolution passed on the 24th June, 1844, the Treasurer has now in his possession a book, in which are registered upwards of 200 Members of the Society, who have recorded with their own hands, their names in full, ages, places of birth, and other interesting facts having reference to their connexion with the Society,—for a more extended notice of which, and of the advantages which may arise in after years from this registration, the Board begs to refer to the Treasurer's Report : nor can they dismiss the subject without expressing their sense of the unitring zeal of that officer, not only as relates to his fiscal operations, but in all that tends to the honor and advancement of the St. George's Society.

During the past year we have to regret the decease of six members—namely—Messrs. Kemble—Windsor— Jeffreys—Nicholson—Kirkwood, and very recently Mr. J. H. Kerr. The latter gentleman had been a Vice-President of the Society in 1837. His remains were accompanied to the place of interment with every mark of respect by the Officers and Members who attended the funeral at a notice of an hour or two only, to the number of upwards of fifty.

The Board has to communicate to the Members the departure of our Patron the late Governor General of this Province, Lord Metcalfe, from whom the Society always received the kindest consideration and good will. The general character of that nobleman is too well appreciated throughout Canada, to require any extended notice—his goodness and charity can never be forgotten—and there is but one prayer amongst his country-

men here, that his life may vet be spared, and his sufferings alleviated. The St. George's Society having been, in common with the inhabitants of Quebec generally, prevented from offering to their Patron a respectful farewell, have determined to forward a respectful Address to His Lordship in England, through the medium of J. M. Higginson, Esquire, Civil Secretary, now in Montreal.

The Board having thus furnished to the Members a summary of the proceedings during the past year, beg to commit to their successors in office, the prosecution of certain objects already agreed upon at former meetings' of the Society. The first is, the procuring of an Act of Incorporation for the Society, notice of application for which to the Legislature has been given in the Canada Gazette by the President, in pursuance of directions from the Society to that effect. Consequent on the obtaining a Charter of Incorporation will be the adoption of a Common Seal, and Diploma for the Members respectively. The Board on retiring from office also beg to recommend to their successors the procuring of additional collars for the increased number of the officers of the Society-as well as the propriety of a Badge being adopted, to be worn by every Member, on procession and other days, as may be agreed upon bereafter.

In conclusion, the Board would again make the strongest appeal to our countrymen resident in Quebec, and the vicinity, and call upon them to enroll themselves in a Society which has now stood the practical test of ten years experience; and has been found to be equally

easurer, ad have sincere on the h is to no have rs, this ediately The disbursements chargeable to the General Fund will be found to exceed those of the preceding year, but this was rendered unavoidable by the necessity of obtaining four hundred copies of the Constitution and By-Laws after their revision; an expense which will not be necessary for several years.

The late calamities to which our city has been subject necessarily called for a larger outlay than in former years ; the sum distributed for charitable purposes amounts to $\pounds 171$ 11s. 3d. —but the means at the disposal of the Charitable Fund have proved fully sufficient.

The Permanent Fund, which reached last year a sum less than seven hundred pounds, now amounts to one thousand and six pounds; of this sum one hundred and fifty pounds are placed in the Quebec Bank, at an interest of three per cent, and fifty-six pounds are in the hands of the Treasurer, the balance being invested in Bank Stock.

All which is humbly submitted.

TREASURER'S REPORT

FOR 1845,

Presented at the Annual General Meeting

JANUARY 5, 1846.

By the 4th Article of the By-Laws, the Treasurer is required to exhibit to the Society, at its Annual Meeting, on the 5th January, the state of the Funds, and it is with as much pleasure to himself, as it must be satisfactory to the Members of the Society to learn the continued prosperity with which it has pleased God to bless the St. George's Society during the past year.

Notwithstanding the great calamity which has befallen the city since our last Annual Meeting, by the fires of the 28th May, and the 28th June, which rendered houseless the inhabitants of two populous suburbs, amounting to at least one-half of the whole population within the **limits** of the city, and the consequent extraordinary calls upon the Charitable Committee, the Charitable Fund has been found sufficient to meet every exigency without the necessity of touching the Permanent Fund.

The Treasurer has also the pleasure of announcing to the Society, an extraordinary increase to the Permanent Fund, which must mainly be attributed to the large number of Life Memberships which have been taken up since the last report. No less than 42 Life Members, that is to say, 36 old Members, and 6 new ones, have been added to the list. The Admission Fee also of new

ient to iching Members, which amounts to double the sum received on an average for the last eight years, has added considerably to the increase of the Permanent Fund, which now amounts to £1006 18s. 4d., being an augmentation of £306 18s. 4d. since the last Annual Report.

The fact of the Permanent Fund having reached a sum, the interest of which places the St. George's Society in a comparative state of independence, must be a source of sincere gratification to every Member of it, while the steady increase of this fund has at no period interfered with the Charitable Fund, which has at all times been in full operation since its establishment; in fact, they go hand in hand towards the general prosperity and charitable purposes of the Society.

Thirty-three new Members have been elected during the past year, six of whom became Life Members, 36 of the old, and 6 new, make an addition of 42 Life Members since my last report.

The actual number of Members stand thus, viz: 63 Life Members, 8 Honorary, and 136 Ordinary, 128 of whom pay the annual subscription, making a total of 207 on the list of Members.

At the Quarterly General Meeting, held on the 24th June, 1844, it was moved by John Musson, Esquire, seconded by W. B. Meyer, Esquire, and resolved,

That in addition to the list annually published by the Treasurer, the names and registers of place of birth, of all Members, from the foundation of the Society, shall be recorded in a book, to be kept by the Treasurer, and in case of the decease of any Member, that the day of his death and his age be also inserted in the said book. Register

The Treasurer is happy to inform the Society that. the above resolution has been complied with in every particular, and that the register now contains the signature of upwards of two hundred Members, stating when and where they were born, with such other remarks as may have been made by each member for himself. This register is an original and early record of the members of the Society, and in future ages is likely to become a very important document, inasmuch as it may be referred to, as the best evidence in a Court of Justice. of the identity and pedigree of the decendants, and will at all times be an authoritative reference for our children's children, to inform them from whence they sprung, and that too, in the hand writing of their ancestors whom they will be enabled to trace, when we, who are assembled this day, shall have followed our forefathers to the grave.

The Treasurer in congratulating the Society upon its continued prosperity, begs to add the sentiments expressed by the late Lord Durham, at his first interview with the Society in 1838. He expressed himself to the following effect, in alluding to the magnificent charitable institutions of our beloved native country, he said—" many of those now gigantic Charities in England, had a beginning as humble as yourselves, but were made permanent and lasting by *Life Memberships.*" He recommended a similar course to our Society, and added—" that it was only Life Memberships that would impart a character of permanency to this young institution, which time or circumstances could not shake."

PHYSICIANS' REPORT.

Your Physicians, in resigning their office, have to congratulate the Society upon the very few demands made upon them in their professional capacity. They would hope that the great difference in this respect between this and former years, indicates an improved condition in the circumstances of the poor of English origin, in Quebec—at the same time it is partially attributable to the excellent arrangement lately made by the Clergy of the Church of England in the formation of a parochial visiting association, by which the city has been divided into wards or districts, each of which is under the professional care of a Physician. The effect of this is to include all those poor of English origin who have hitherto been dependant upon the Physicians of this Society.


