An Act to establish and confirm the side lines of the Lots in Township of Clarendon, in the County of Pontiac.

WHEREAS by a Petition of the inhabitants of the Township of Clarendon, in the County of Pontiac, it appears that great inconvenience would result should the existing lines, as run parallel with the boundary line between the Townships of Bristol and Clarendon, be disturbed ; And whereas the said inhabitants have prayed that the said lines may be established and confirmed as herebefore run on a course parallel with the said boundary line ; Therefore, Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows :—

Preamble.

10 I. For and notwithstanding any Act or Ordinance to the contrary, all the side lines between lots in the said Township of Clarendon, as run on a course parallel with the said boundary line, are hereby established and confirmed, and all the said side lines in the said Township of Clarendon which shall or may hereafter be run, shall be so run on a
 15 like course : Provided, that in case any party should by reason of this Act suffer any injury or damage, such party shall be compensated by the party or parties who may be benefitted by such change ; and the compensation so to be paid, and the persons to pay and receive the same, shall be ascertained by a Sworn Surveyor appointed by the Commissioner
 20 of Crown Lands, and his decision, when approved by the Commissioner of Crown Lands, shall be final.

Lines as now run confirmed.

Proviso: parties losing land to be compensated by those gaining.

II. This Act shall be deemed a Public Act.
