KITCHENER'S LATE ORDER.

All Boers Who Have Not Lain Down Arms and Ceased Resistance to British Authority by September 15th Will Be Permanently Banished From Africa.

London, Aug. 9, via Skagway, Aug. 14.—In compliance with imperial orders General Kitchener has issued a proclamation that all commandants, field cornets and leaders of armed bands of burghers of the late republics still engaged in resistance to British authority, whether of the Orange colonies or of the Transvaal, and all members of the late governments of the Orange Free States or of the Transvaal shall, unless they surrender by September 15th, be permanently banished from South Africa. That the cost of the maintenance of the families of all burghers who are in the field and not surrendered by September 15th be

charges upon their property whether removable or immovable, and that the families of such unsundered burghers will be collected together in two colonies.

The Daily Mail reports the Boers as having captured and killed in cold blood a lieutenant and trooper of Steiner's Horse out of revenge for the killing of a Boer dispatch rider.

The newspapers comment exceptionally favorably on Trooper Nelson Hill of Virden, Manitoba, who died of enteric fever at Krugersdorp.

THE SANDS OF TIME

Run All to Quickly for Murderer George O'Brien.

George O'Brien was again visited today by a Nugget representative and in the course of a short conversation he reiterated the story told yesterday of how he had been imposed upon by the News in the securing of a bunch of papers from his attorney, Mr. Bleecker. It might be remarked, en passant, that O'Brien was interviewed this morning by a reporter of the News reinforced by the editor himself, but their efforts to secure any information other than that which has been already published in the Nugget, were of no avail, nor did they succeed in getting the man whose confidence had been betrayed to alter his determination to turn over his manuscripts to this paper.

The utter hopelessness of his case is becoming more and more apparent to the condemned man and he is slowly resigning himself to his fate. Much of his time is spent in prayer and the visits of Father Gendreau are becoming more frequent. A history of his past life which O'Brien is now preparing will appear in the Nugget at an early date in the future and will prove of extraordinary interest to those familiar with the tragedy a week from next Friday. Within earshot of his cell the sound of the saw and hammer erecting the gallows upon which the execution will take place can be distinguished. The same trap and fittings and beam from which the rope is suspended, a spruce stock 8x8 which was used in the King execution will be employed in the hanging of O'Brien. The enclosure will be made somewhat larger than the last one as there is a much greater demand for cards of admission. The march to the gallows will be from his cell through the main corridor to the jail yard, thence through the door direct into a closed passage way leading into the enclosure.

Hearing on Appeal.

The famous Hartley-Matson case, a fight being made by a number of miners against the Matson concession on Bonanza creek, is being heard on appeal today before the appellate court. The cases were decided adversely by the gold commissioner, the court holding that the stakers could not bring such an action except by the consent of the attorney general. The decision was appealed from and the judgment of the court of appeals is awaited with interest.

Tacoma, Aug., via Skagway, Aug. 14.—Boyce, the man who made a special trip from Victoria to this place several months ago for the purpose of killing his wife, carrying out his design the day of his arrival, was hanged in the county jail today.

Nothing in It.

The case of the King vs. Potts brought up on appeal from the lower court was today dismissed by Justice Craig. The defendant Frank Potts was charged of the bar on the steamer Columbian and some weeks ago was arrested on the charge of having sold a quantity of liquors while his vessel was lying here in port. His hearing was brought before Inspector Howard on June 25 and from the evidence it was shown that the liquor in question had been secured at Whitehorse for Harry Phillips, of the Office saloon, and Potts had acted merely as an agent in the purchase and transfer of the goods. He was found guilty, however, and fined \$50 and costs and on the case being appealed the decision of the lower court was affirmed. The liquor, which the police had confiscated, was ordered restored to Phillips.

Helped His Feet.

Emil Stauf the well known real estate agent, while watching the approach of the steamer Whitehorse yesterday from the B. V. N. Co. dock made a misstep and fell between the scows which lie alongside the dock and to which the steamers tie up.

As he fell he threw out his arms and saved himself from getting a thorough ducking by catching hold of the scows. He was rescued from his perilous but nevertheless ludicrous position by a couple of bystanders and escaped with no further injuries than getting his feet wet. He thinks that hereafter when on the wharf he will watch his steps a little more closely.

The water front is more quiet today than usual, there being but two boats in port, the Whitehorse and Monarch. The former leaves this evening at 8 o'clock.

FREIGHT VIA ST. MICHAEL.

Steamer Buckingham Chartered to Carry 1500 Tons to the Mouth of River—Former Patrons of W. P. & Y. R. Ship by All-Water Route—More to Follow.

Vancouver, Aug. 10, via Skagway, Aug. 14.—The steamship Buckingham has been chartered to load 1500 tons of Dawson freight for St. Michael. Among the consignees are Dunn, McLennan & McFeely, Brackley, Kerr

and other shippers who formerly shipped almost exclusively by White Pass & Yukon Route. Several other big Dawson shipments will yet be made this season via St. Michael. The Conemagh sails Monday for the mouth of the Yukon with 2500 tons.

FORMER CLERK PUBLIC SUSPICIONED SYMPATHY

Of Having Robbed San Francisco Mint of \$3,000.

San Francisco, Aug. 9, via Skagway, Aug. 14.—Walter N. Dimmick, formerly chief clerk of the U. S. mint here has been ordered arrested on the charge of embezzling \$3000, the shortage which was discovered last month. A memorandum of the combination of the vault was found in his pocketbook by secret service detectives. Dimmick has not yet been arrested.

Causes Steel Trust to Move Location of Big Plant.

Pittsburg, Aug. 9, via Skagway, Aug. 14.—The Steel Trust has ordered that the great Dewees-Wood plant be moved from McKeesport to Kiskimeta valley. The strong sympathy shown the strikers by residents of McKeesport is the cause of the order. The plant is one of the largest and best known in Pennsylvania.

"OUR LADY OF SNOWS."

The pertinacity of Canada in her exhibition of resentment against the chance allegory of Rudyard Kipling has reached the skirts of absurdity, while the beauty and patriotism of the poem dedicated to her, and of which she might well be proud, is entirely ignored. The leading sentiment, its motive, that Canada, while still a dutiful daughter in her mother's house is mistress in her own, is a patriotic sentiment that rings true as steel, and one which would have been a household word and a proud boast throughout the Dominion, had not the chance mention of snow in connection therewith put out, for the Canadian, all its poetic fire and prophetic promise. How foolish all this is, this foolishness of contending that the most Northern territory of any consequence belonging to Great Britain is not a land of snow, when in some parts of Canada snow lies on the ground every day of every year not excepting leap year.

The resentment has burst forth again and the present to be made by Canada to the Duchess of York. The Ottawa ladies desired to make such a present as would be characteristic and remindful of their country, and they chose a fur robe of otter and mink. As furs were for many years the only commercial product of Canada, and are today among its leading sources of territorial wealth, what could be more fitting? Yukon gold would lose its significance from the fact that gold was a product of other parts of the British dominions long before any was discovered in Canada. They might present the duchess with a tiara of nickel, or copper, or one of wood perhaps, but anyone of these could not be made of sufficient intrinsic value unless studded with native gems, of which Canada has none. There is something peculiarly appropriate in the gift proposed by the ladies of Ottawa to any common sense mind. The objection of its tending to convey an impression that Canada is a land of perpetual winter might be easily overcome. Furs are fashionable wear nearly all over the world, and to show that they are only worn in Canada, as all over the world, but for a part of the year, the present for the duchess might be given a strong odor of camphor, mingled with tropical perfumes.

SHAMEFUL, IF TRUE.

The charge is made, with some basis of authority, it is said, that a number of the teachers who have recently secured appointments in the Philippine schools were obliged to pay sums of money to the colleges recommending them. There is no reflection on the war department, for it had nothing to do with the matter; nor on General Superintendent Atkinson, who has charge of the school system in the islands, for he appointed those who were recommended to him by the several institutions of learning to which he applied. Under the act of congress providing for a Philippine educational system, the general superintendent was empowered to request the heads of colleges and schools to select a certain number of persons, each to fill posi-

tions at a stated salary. The names were selected in this way, forwarded to Mr. Atkinson and the appointments thereupon made. The bureau of insular affairs then made arrangements for their transportation, and notified the teachers chosen of the date and manner of departure for Manila. Except the actual transportation, the connection of the government with the matter ended there, and no one has intimated that any of its agents has been a party in any way to the alleged extortion.

It is charged, however, upon authority said to be reliable, that some of the colleges have taken advantage of the opportunity and added to the funds of the institutions by charging those they recommended a percentage of their salaries for the favor. It is well known that some purely business colleges and smaller institutions make a practice of charging a commission for securing positions for their graduates. That is part of the understanding in the beginning, and those who pay it have no right to complain. But it is difficult to believe that a reputable college would resort to the method indicated to enrich its treasury.

A charge of this kind is easy enough to make and often difficult to prove or disprove, and as against reputable concerns should be received charily. Disappointed applicants may imagine wrong treatment and make unfounded charges, and in a variety of ways injuries reports may get into circulation. Often no method of redress can be found, and a slander must fall of its own weight; but in this case there ought to be a way for establishing the truth. The teachers engaged may be qualified for the service, and being glad to secure the employment, even by paying for it, would probably be loath to admit that they had done so but at any rate the charges are made and they should be probed. It could do no harm to innocent institutions, and if there are any that have prostituted their functions as alleged, the public is entitled to know it. The commercial spirit is rampant enough in the world of affairs, and if colleges which profess to teach the ideal depart so far from precept they should be exposed.—P.-I.

The fact that Murderer Nordstrom at Seattle has been again given a new lease on life by the act of a vacillating judge of the federal court does not reflect any credit upon the high and supposedly honorable position which he fills. While the lawyers and courts continue toicker over the fate of a cowardly murderer the blood of an innocent boy spilled eight long years ago cries in vain to heaven for revenge. Justice is not dallied with thus in the Yukon and of that fact we are proud.

In an attempt to kidnap a child from the home for the friendless at Springfield, Illinois, several shorts were exchanged. Evidently a child that can have a shooting scrape over its welfare has firm friends and is out of place in such a home.

(There were special regulations made for the entry of lands in the Indian reservation recently thrown open, but the point you mention is undoubtedly covered by the general lands laws, the section referring to the right to purchase reading as follows: "Section

2301 reads: Nothing in this section shall be so construed as to prevent any person who has availed himself of the benefits of section 2289, from paying the minimum price of land so entered, at any time before the expiration of the five years, and obtaining a patent therefor from the government, as in other cases directed by law, or making proof of settlement and cultivation as provided by law, granting pre-emption rights." Section 2289 makes the minimum price for 160 acres to be \$1.25 per acre.)

Bulls and Bears.

Chicago, Aug. 3.—Stockholders and directors of the George H. Phillips Company are being forced out of office and out of any financial interest in the concern. Beside Abel D. Osman, formerly secretary of the company, Joseph L. Bauman, who was taken into the firm on its reorganization on June 14, after the conclusion of the May corn deal, is no longer connected with it. Bauman had a big line of May corn, and traded in all the grain pits after the deal was over. News of the retirement of the two men revived rumors that several of the employees and stockholders of the company were indebted to it in the sum of \$125,000. Officials of the company would neither affirm nor deny the stories regarding the \$125,000, nor would they discuss the retirement of Osman and Bauman, although it was admitted the men were forced out.

Mr. Phillips was seen tonight and confirmed the impression—that the retiring stockholders had sacrificed their interests by getting on the wrong side of the market. "Osman had \$10,000 of stock, while Bauman had \$25,000 worth," said Mr. Phillips. "Both speculated and lost the amount of stock and something more. They turned their stock into the treasury to square their accounts, being unwilling or unable to put in cash. The company will be doing business again, there is no question about it, probably under the same name. It will probably take a week to straighten out the books. No other stockholders are indebted to the company. President Collins, Mr. Hill and myself are the heaviest creditors."

Returned to Life.

Mishawaka, Ind., Aug. 3.—A singular case of suspended animation was recorded here. A telegram came from Harvey, Ill., announcing the death of Charles Vrooman, until a short time ago a well known merchant here. Blood poisoning due to burns was the cause assigned. Local papers published his obituary. Upon receipt of the dispatch the relatives hastened to the Illinois town to take charge of the remains and arrangements were progressing in this city for the reception of the corpse and the burial, the supposed dead man being a leading member of local secret societies.

A second message came declaring that Vrooman had returned to life, the remarkable transition taking place in view of relatives and undertaker, who was about to give the body final attention. Vrooman appeared to be dead for hours.

PECULIAR RELIGION

Cause People to Give Up Their Jewelry and Spundulicks.

Cleveland, Aug. 3.—Frenzied worshippers, some of them shrieking aloud in their religious excitement, tore rings from their fingers and watches and jewelry from their clothing and cast them at the feet of President of A. B. Simpson, of New York, head of the Christian and Missionary Alliance, at the alliance camp meeting at Beulah park.

Similar scenes at previous annual gatherings of this sect were outdone. The excitement among the 5000 at the meeting under the impassioned appeals of the president was boundless. A newsboy gave \$5. An aged woman who said she "washed the money from dirty clothes" gave \$5. She was blind, and attended the meeting in hope of a divine healing of the disease of her eyes, so that she can continue to make a living by washing. One woman flung her watch through the air toward the platform where the president stood.

In addition to the jewelry, \$12,700 was collected at the afternoon meeting and another large sum this evening. Some one, whose name was kept secret, gave \$3000. "Here's my Pan-American trip," shouted one man, as he thrust a roll of bills into one of the bushel baskets used for receiving the contributions. The gifts were greeted by cheers of "Praise the Lord" and similar exclamations.

Much valuable jewelry was given, this not being included in the total of \$12,000. The announcement was made that only solid gold and genuine gem jewelry was wanted.

Tragedy Reunites Family.

St. Paul, Aug. 3.—A tragedy in which the man was crippled and the woman killed has restored to Bernhard Sandler his wife and four children. Mrs. Rose Sandler, the wife, her love rendered by his helpless condition, has come all the way from New York to nurse back to health the husband she had lost. As soon as he recovers she will take him back to New York. The reconciliation took place today at the City hospital.

A year ago Sandler eloped with Florence Argeburg and came to St. Paul. Last week by a gasoline explosion the woman was killed. She was buried as Mrs. Sandler.

Thinking he was about to die, Sandler disclosed the identity of the woman, and later notified his wife of his misfortune and whereabouts. She came here, and the reconciliation was effected. Sandler will be a cripple for life.

UNEXPLAINED MYSTERIES

The Ex-Ray as Great a One as When Discovered.

Even the Discoverer, Prof. Roentgen, Can Not Account for the System on Which it Works.

It is six years since Prof. Roentgen passed his new light rays through wood, paper, and flesh, and to this day no one alive understands why, or how, these rays act as they do. In despair, some scientists fell back upon the old theory of light, which was that a radiant substance gave off light as a flower does scent. But, as this idea is totally exploded, the mystery is still as great as ever, and newer discoveries have added to it, instead of clearing it up.

X-rays are a greater miracle than X-rays. By their aid, their discoverer, Alex. Croff, has steered torpedoes at a distance of two and a half miles, and without wires or any connecting medium but the air and water. He made the torpedoes go forward or back, in a curve or a straight line, and sink or rise, exactly as he desired. At two miles distance the X-rays' beam is two hundred yards across, and the torpedo can be controlled anywhere within this area.

To puzzle the average man still more, the Polish scientist Cuire has invented the Becquerel rays, with which he has obtained results which puzzle nobody more than himself. A substance called radium, which he has discovered, has been made to act as a sort of mineral glow-worm. It will store up sunlight, and, even if kept in pitch darkness for five years, be found to gleam with the soft radiance at the end of that time. Becquerel rays pierce not only flesh, but bone. They offer a sure test for distinguishing between true and false diamonds, but are not likely to be largely used for that purpose, as radium costs \$500 an ounce to prepare.

One more mystery of light. By simply spinning a lump of loaf sugar on a lathe, and tapping it rapidly with a small hammer, a constant play of light can be produced; and here, again, is an effect without a known cause.

When M. Tesla came over to this country some years ago, he horrified an assemblage of scientists by transmitting through his own hand and body a current of electricity a hundred times greater than is generally used to kill a criminal. He stood there perfectly unharmed, while a steady crackling blaze at the end of the conductor which he held showed the appalling power of the forces he handled so calmly. Asked why he was not instantaneously burnt to a crisp he replied that it was perfectly safe to handle a current if it was alternating electricity. He even offers to transmit through his body the whole energy of the 40,000 horse power obtained from the falls of Niagara. The currents he has actually handled have been sufficient to melt thick iron wires like wax. His experiment is about as much a miracle as anything ever seen.

By means of an instrument made of glass prisms, and called the spectro-scope, scientists have discovered that the sun and moon and all the stars we can see in the skies are made up of similar materials to this of which this earth is composed. Iron, gold, and different elements, produce different dark lines across the rainbow-like play of colors into which the prism divides white light. We know by experiment where the lines of each different substance will be found in the spectrum, and we know that these lines are produced by interference of rays. But why the various substances should produce such rays is another mystery. As in so many other matters, a result has been reached without the cause being understood.

Even so seemingly simple a contrivance as the compass is really a miracle. We have discovered that a magnetized strip of steel swung upon a pivot will point in a certain direction; but why it does is not known for certain, and perhaps never will be. We are aware that the magnetic pole is not always in the same place, but slowly and constantly shifts. We know also that there are parts of the world where the compass will not act at all. At a place called Katchetowka, in Russia, Prof. Leyst, of Moscow, found that the dipping needle pointed downwards, just as it does at the magnetic poles. And yet there is no iron within 600 feet of the surface of the earth.

The whole subject of magnetism and electricity is full of miracles and mysteries. Man can make young plants grow at nearly double their natural rate by passing a mild current through the soil they are planted in. He can in a similar fashion double the size of cucumbers and cabbage; but he cannot tell why such results are obtainable.

Even more wonderful and mysterious are the results obtained by doctors with electric light. By using rays of a certain kind, the most horrible cases of tumors, or cancer of the face, are being

cured in London and other big cities. The wounds are healed, fresh, clean skin grows over the shocking sores, and after six months' treatment the patient is cured. But no doctor nor anyone else, has the faintest idea how these splendid cures are effected.

Neither can the man of medicine say why it is that keeping a patient suffering from smallpox or measles in a room hung in red has such a wonderful effect in allaying eruption, and in preventing the former disease from leaving its marks upon the face of the sufferer.

FOUND BY A WOMAN

Lost Art of Hardening Copper Discovered by Tacoman.

Tacoma, Aug. 6.—Mrs. Harry Renstrom is preparing to make trouble for the great American steel trust. This comes in the way of the discovery of one of the lost arts, the process of hardening copper, which has been the stalking ghost of the steel industry for a hundred years. Mrs. Renstrom is no theorist or dreamer, but a clear headed, practical woman, who has quietly worked away until now she has produced edged tools of copper that will cut the hardest of wood and hold their edge as well as the best steel. She feels confident that she has solved the problem of hardening copper and thus making edged tools that will drive the steel article out of the market. She has already through an attorney made application to the department at Washington for a patent to protect her rights and will carefully guard her secret until that is gained. Overtures have been made to her from a number of capitalists, among them being J. Pierpont Morgan, negotiating for the purchase of the invention when completed.

Mrs. Renstrom has been working on this process for years and has read everything relative to the matter that has been written. From her study of the matter she has become convinced that the hardening of copper was once a universal art. The American Indians practiced it on Lake Erie, where numerous evidences in the way of copper utensils and cutlery have been found. Among these copper chisels have been picked up that will cut the hardest steel. It is a well known fact that the ancient Romans and Egyptians understood and utilized this process. A returned Filipino soldier recently brought back to Tacoma a bolo knife found in Luzon the blade of which was of hardened copper and possessed a fine edge and was well tempered. These facts have led her to believe that at one time, thousands of years ago, copper was hardened and used for tools and weapons all over the world, and she claims the process was undoubtedly a simple and cheap one, as the ancients had no intricate or costly methods or costly machinery.

Runaway in a Cemetery.
Branford, Conn., Aug. 3.—Mrs. W. N. Smith and Mrs. Sarah Hunt, with Mrs. Mary Munson, of Chicago, were buried out of Mrs. Smith's carriage in the Central cemetery today in a runaway which shattered headstones nearly two centuries old and put all of the women on the verge of nervous prostration.

Mrs. Munson and Mrs. Smith received severe nervous shocks. Mrs. Hunt was thrown out among the tombstones, but received no serious injuries. The horse went tearing through the historic cemetery for a quarter of a mile.

Among the monuments broken or chipped were those erected to J. Harrison, 1819; Timothy Bradley, 1812; Mercy Linsley, 1818; Betsy Blackstone, 1842; Sarah Russell, 1876, and child of James Hale, 1827.

The horse was caught amid a breast-work of uprooted monuments. He was only slightly injured, but the wagon was torn to pieces. The horse took freight at a passing lumber wagon.

WHITE MEN SUSPICIONED

As Having Perpetrated the Umimak Island Murder.

Seattle, Aug. 6.—The steamer Queen yesterday brought down some further advice regarding the murder of Sullivan brothers and of P. J. Rooney on Umimak Island last June. A passenger tells a story to the effect that two white men—deserters from a fishing schooner—planned and executed the murder for the purpose of robbery. Who the men are is not known. They are said to have been seen on the island at the time of the murder and to have had in their possession a rifle and revolvers formerly belonging to the Sullivan brothers and Rooney. They also showed to Rev. Mr. Scott, one of the men who saw them, about \$1200 in money, which is believed to have been a portion of the \$1500 Con Sullivan had on him at the time of the murder.

On the other hand, however, Owen Jackson, the only surviving member of the Sullivan party, in a sworn statement, says that the killing was done by natives. He tells of the return of the four members of the party to the spot where they had left their tent and provisions and of finding two natives in the act of carrying away the last of their outfit. Florence Murphy followed the men and was shot down. Later, as Jackson and Con Sullivan were running toward the beach, Sullivan was shot through the back. Another bullet hit Rooney in the knee and one went through Jackson's rubber boot. Jackson then left the spot and wandered around for several days, when he was found by a man named Fred Williamson, to whom he reported the murder. Jackson is sure that the men who committed the murder were natives, but admits the possibility of being mistaken.

J. C. Reilly Dead.

J. C. Reilly, known at Dawson, Nome, Seattle and all over Alaska, the founder or first promoter of the Arctic Brotherhood, died recently at Nome. He was one of the survivors of the schooner Jane Grey, when so many passengers and members of the crew were lost off Cape Plattery.

Mr. Reilly was found dead in his room at the Bolega lodging house at Nome. He went there recently from Dawson ailing in health. Dr. Hill pronounced that death was due to valvular disease of the heart.

The funeral of J. C. Reilly took place on Sunday, July 21 last, from the Masonic Hall, under the auspices of the Arctic Brotherhood. There was a large attendance of members and Judge Hannum, the Grand Arctic Chief, presided. W. C. Hayner had embalmed the remains which were interred for the present, but it is believed that the parents in the East will wish their son to find his final resting place at home.

Reilly was the son of a wealthy contractor of Hartford, Conn., who is still living. He was 43 years of age and some ten years ago achieved celebrity on the stage under the name of Walter Weldon. He was one of the passengers of the ill-fated Jane Grey, and was rescued hours after the wreck by Major Ingraham, who was on a steam launch and heard him call from a raft for help.

Reilly owned Nos. 1 and 2 on Eldorado in the Klondike, and left claims in Nome which prospectured well. It was while on a trip North on the City of Seattle that Reilly first thought of and wrote out a brief outline of the organization now known all over the North as the Arctic Brotherhood.—Seattle Times, Aug. 6.

ALLEGED KIDNAPPER HERE

And Given Partial Hearing in Police Court Today.

Elasticity of Mortimer's Word Said to by Sergeant Holmes to Be Proverbial—Rogers Held on Bail.

Mortimer, the man who accuses J. H. Rogers of enticing him into a shaft on discovery claim, Thistle creek and keeping him there for 12 hours without food or water in order to force certain statements from him, has, according to the evidence given under cross examination in the police court this morning by Sergeant Holmes, who brought Rogers to Dawson yesterday, a reputation for enlarging and distorting the truth. In the fall of '99 just before the freeze-up Mortimer informed the authorities of an accident which occurred above Thistle creek—a boat in which were four men coming to Dawson and according to his story the accident resulted in the death of all the men. A thorough investigation of the circumstances revealed the fact that the whole occurrence was a creation of the imagination of Mortimer, parties who were with him at the time saying that nothing of the kind had happened and all of the parties reported as being in the accident were found alive and well in Dawson. Other circumstances of a similar nature has given Mortimer a general reputation as a man who is in the habit of enlarging the truth to make the story fit his own ideas and purposes. Under further cross-examination Sergeant Holmes stated that he has known Rogers about six months and during that time has never known or heard anything against him and that he has a general good character and is well spoken of by the miners on the creek.

The evidence of Sergeant Holmes was the only evidence taken in the case this morning as the defense was not prepared to go on with the case. No objection was raised to the taking of the evidence of Sergeant Holmes who has to return to his post on Stewart. The evidence concerning the case other than that above stated, given by the sergeant was that Mortimer had come into the station house and made a complaint against Rogers. He (the sergeant) had gone to the claim and investigated the shaft where the assault

was alleged to have been committed. The shaft was possibly between 20 and 30 feet deep, the top covered with a tent. He could not see the bottom but the sides were covered with ice and icicles. There were big chunks of ice jutting from the sides all the way down as far as he could see. There was a rope at the shaft with frayed ends which had been spliced together. Two poles had been spliced together and were placed cross wise in the shaft about 12 feet from the top. About 10 feet further down there was another pole stuck in the side of the shaft. On the claim there are three cabins in a row situated about 1200 feet from the shaft, two of which are occupied. One of them is occupied by Rogers and the other by a party whose name the sergeant did not know. The magistrate asked him if it would be possible for any one in the occupied cabin to see a man walking from Roger's cabin to the shaft and the witness replied that it would, that the view was altogether exposed.

Witness was asked if any other complaint had been registered with him recently and he said that Rogers had complained to having been robbed of a poke containing \$1500 about three weeks ago. He had reported the matter to headquarters and he believed a detective had been sent to investigate the case.

Upon the conclusion of the evidence of Sergeant Holmes the magistrate fixed the prisoner's bail at \$500 personal bond and two sureties of \$500 each and adjourned the case until Saturday morning at 10 a. m.

BOTTLED BEER THIEVES

Were Sentenced to one Month at Hard Labor Today.

George Griffith, George Brown and Wm. McLaughlin were each sentenced this morning by Justice Craig to one month at hard labor for having breached a barrel of beer on board the steamer Yukoner and consumed 28 bottles of the extract of hops. Attorney McDougall made a special plea for leniency on behalf of Griffith saying that it was his first offense and that from the evidence it appeared that he was more sinned against than sinning. He further stated that it seemed to be the policy of the White Pass people to induce their employees to work for as near nothing as possible and that men are shipped on almost every boat coming down the river who work their passage to Dawson, receiving no compensation other than their board and transportation. In passing sentence his lordship remarked that it was a matter of regret that he was unable to ascertain for a certainty who had first broken open the barrel, the evidence being so conflicting. If that fact could be fixed an example would have been made of the offender which would not soon have been forgotten. The prisoners were told that they could each be given 14 years for the offense, but in view of the circumstances they were let off with a warning and a light sentence. They have already spent nearly a month in jail.
