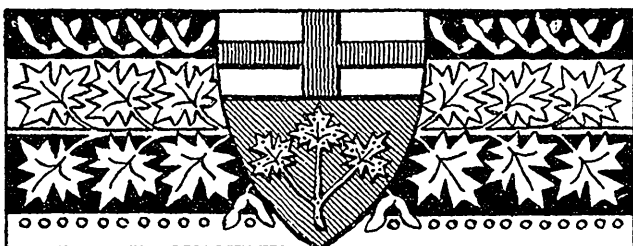

Gare-la-bête.

TEMPLE GROVE, June 1900.

Editor of Ontarian Genealogist :

SIR,—It has sometimes occurred to me that it would be interesting to ascertain how many of the Norman or Breton names which came in with the Conqueror could still be traced in their cradle of eight centuries ago. An instance of such continuance came under my notice recently. I met an intelligent Frenchman, who came from La Cote du Nord, in Brittany, and I availed myself of the opportunity to enquire if the name Gare-la-bête still existed; he at once replied in the affirmative, that he had known four of the name in his native province, about thirty leagues from the boundary of Normandy. Now these are the same stock as our Gabbetts, of Caherline, and other places, still seated in Ireland, etc. The name, also written Garbett,* has assumed its present form from the more graceful original as above, and the bête in question still flourishes on the shield as a griffin supporting a knightly banner. It comes home to us in Canada through the O'Briens of Shanty Bay (Lord Inchiquin): William Smith O'Brien, M.P., married Lucy Gabbett, whose first cousin Maria-Daly-Fortye Maunsell, was my wife's mother (Maunsell, of Thorpe Malsor, Landed Gentry,

and the Mansels Baronets of Margam, etc.). There is a Gabbett connection in the Ontarian Families of the late Bishop Fuller of Niagara and Chadwick.

Mobility—English and Continental.

IN the genealogy of the family of Von Ebertz, printed in this number, mention is made of a grant or patent of nobility being made to an ancestor of that family by the Emperor Charles V. It may be well to explain to our readers that in former times the people of European countries were rather arbitrarily divided into "nobles," or "patricians" (meaning not only persons of baronial or higher rank, but including a large number untitled), and "ignobles" or "plebeians." This distinction even now continues in some sort, but it is so utterly and absurdly at variance with all social conditions of modern life, that, speaking generally, its existence can hardly be regarded as more than theoretical. Attempts by certain heraldic writers, and even heraldic authorities, have been made to introduce similar distinctions into England, but only in the periods of heraldic decadence and debasement. The whole notion is, and always has been, inconsistent with British character and social customs. There is no class in the British Isles corresponding to the continental "nobles" or "patricians," though some have assumed or asserted untitled persons bearing arms to be so. There are writers of the present day who insist upon this view, to the great disadvantage of the true spirit of heraldry, but they will, no doubt, maintain their opinion in vain, for such imaginary social distinctions as a

mere accident of birth regardless of personal worth and culture, British peoples do not want and will not have. British "nobility," are those of baronial or higher rank: the term "lesser nobility" is sometimes applied to baronets and some others. "Plebeians" are not known in the British Empire, where persons of inferior social status are classed according to their personal or social condition, and not by the supposed tint of the blood which runs in their veins.

Sixth in descent from Caspar Ebertz, knighted by the Emperor Charles V. *circa* 1535 for valour against the Turks, was

Jacob-Friedrich Ebertz to whom a patent of nobility, "to himself and his heirs lawfully begotten, male and female, forever," was granted at Vienna by the Emperor Leopold, 27 Novr. 1658, with the coat of arms of his ancestor "confirmed and augmented," and the

right to use the prefix "von;" and from whom was descended

Hermann-Melchoir von Eberts, b. 1753, d. 1819, Surgeon in the Regiment of Prince William of Hanau, in the British service under command of Col. von Gall in the American Revolutionary War, from which regi-

ment he retired 17 July 1777, at Cassenton or Castleton, New York, subsequently settling as a U.E. Loyalist in the Province of Quebec, removing from there in 1792 to Detroit, where he was Sheriff of Wayne Co. and Administrator of the Territory of Michigan (under British rule) until 1796; he served, as Surgeon-Major, under General Brock in the War of 1812, with his four elder sons, all, except Ignace, being present at the taking of Detroit; m. Marie-Francoise Huc, of Sorel, and had issue, viz: (besides three sons and a dau. who d. inf.)

1.—Ignace, b. 1781, d. 1821, served in Lower Canada in 1812 as a Sergeant in the 104th Regt., was m. and had issue an only dau. Elizabeth, m. to Dr. John-Baptiste Allard of Beloeil.

2.—Joseph, b. 15 March 1785, at Boucherville, of whom below.

3.—William-Henry, b. 1797, served in the War of 1812 as Lieut. of Artillery, and was killed, after showing conspicuous bravery, at Lundy's Lane, 1814.

4.—Richard, b. 1799, served in 1812, and owing to his fleetness and discretion and knowledge of French and Indian languages, although only 14 years of age, became the General's private courier; m. Joseph, above named b. 15 March 1785 at Boucherville, Lower Canada, served for some years as an officer of the Northwest Fur Company, under the late Alexander McIntosh of Moy (now in Windsor, Ontario), and subsequently became a trader and manufacturer at Windsor; served throughout the war of 1812 as a Captain in the Essex Regiment of Militia, and participated in all the chief events of that war on the Western Frontier; on one occasion, during his absence on service, his house was destroyed by the Americans, his wife and two children being turned out into the road; he m. Anne dau. of Captain William Baker, U.E.L.* and had issue, viz.:

1a.—William-Duncan of whom below.

2a.—Walter, b. 1813, m. Mary Van Every of Detroit, and had issue, Joseph-Melchoir, b. 21 Augt. 1840, of H.M. Customs in Chatham.

Simcoe, he founded the City of Chatham, Ontario, 9 Oct. 1794.

Mewburn.



The family of Mewburn are descended from a soldier of the name of Blunt or Blount, who came to England in 1066 with William the Conqueror. During the wars of the Roses certain of the Blounts being adherents of the losing side fled to Holland where they remained in exile for a time, subsequently returning to England, when one of them took the name of Croke and was the ancestor of the family of that name, while another settled in Yorkshire and being a master of falconry, an important position in those days, took the name of Mewburn, i.e., "of the stream by the mews," or place where hawks were kept. In the Church registers of Ormsby, Stokesley, Croft and other places in Yorkshire are seen the names of Mewburns from the year 1500. In 1748 a William Mewburn emigrated to America and settled in Virginia with his family, and about the same time another of the name went to Demerara.
