## STATUTE XC.

### RESPECTING AN ADDITIONAL MASTERSHIP IN UPPER CANADA COLLEGE.

---

I. That an additional Mastership be established in Upper Canada College for instruction in Mathematical and Physical Science.

II. That the salary and emoluments attached to said Mastership shall be the same as those now attached to the Second Classical and Mathematical Masterships, and the person appointed to such Mastership shall occupy the same position in the College as the Second Classical Master, their relative precedence being regulated by seniority in their respective appointments.

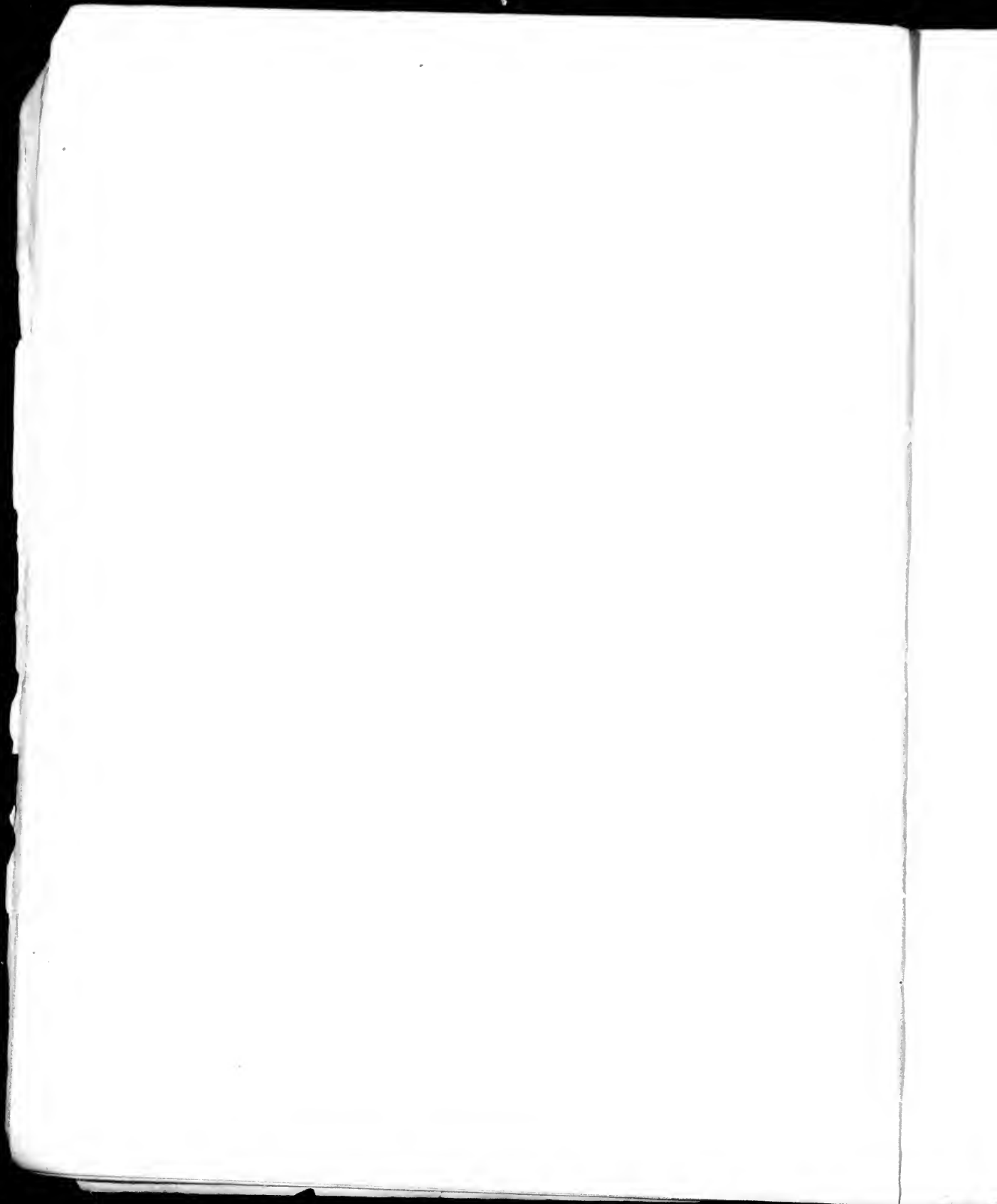

## STATUTE XCI.

### RESPECTING AN APPROPRIATION OF \$2000 FOR THE LIBRARY.

---

That the sum of two thousand dollars be appropriated from the General Income Fund of the University for Library purposes, and that it be applied in finishing the internal arrangements of the Library, and for acquiring books as may be determined by the Committee on the Library, in addition to the annual allowance in the Special Departments.



## STATUTE XCII.

APPOINTING W. G. FALCONBRIDGE, M.A.,  
REGISTRAR.

That William Glendholme Falconbridge, Master of Arts, be appointed Registrar in the room of Thomas Moss, Master of Arts, who, having been appointed a member of the Senate, has resigned the office.

## STATUTE XCIII.

RESPECTING THE ELECTION OF CHANCELLOR  
AND MEMBERS OF THE SENATE.

---

That the votes to be given at the Election by Convocation for the Office of Chancellor and for Members of the Senate, respectively, under the Act respecting the University of Toronto, shall be delivered to the Registrar in the University Building not later than three of the clock on the afternoon of the second Thursday in May in each year, and that the Registrar may proceed to open the voting papers at the expiration of fifteen minutes thereafter.

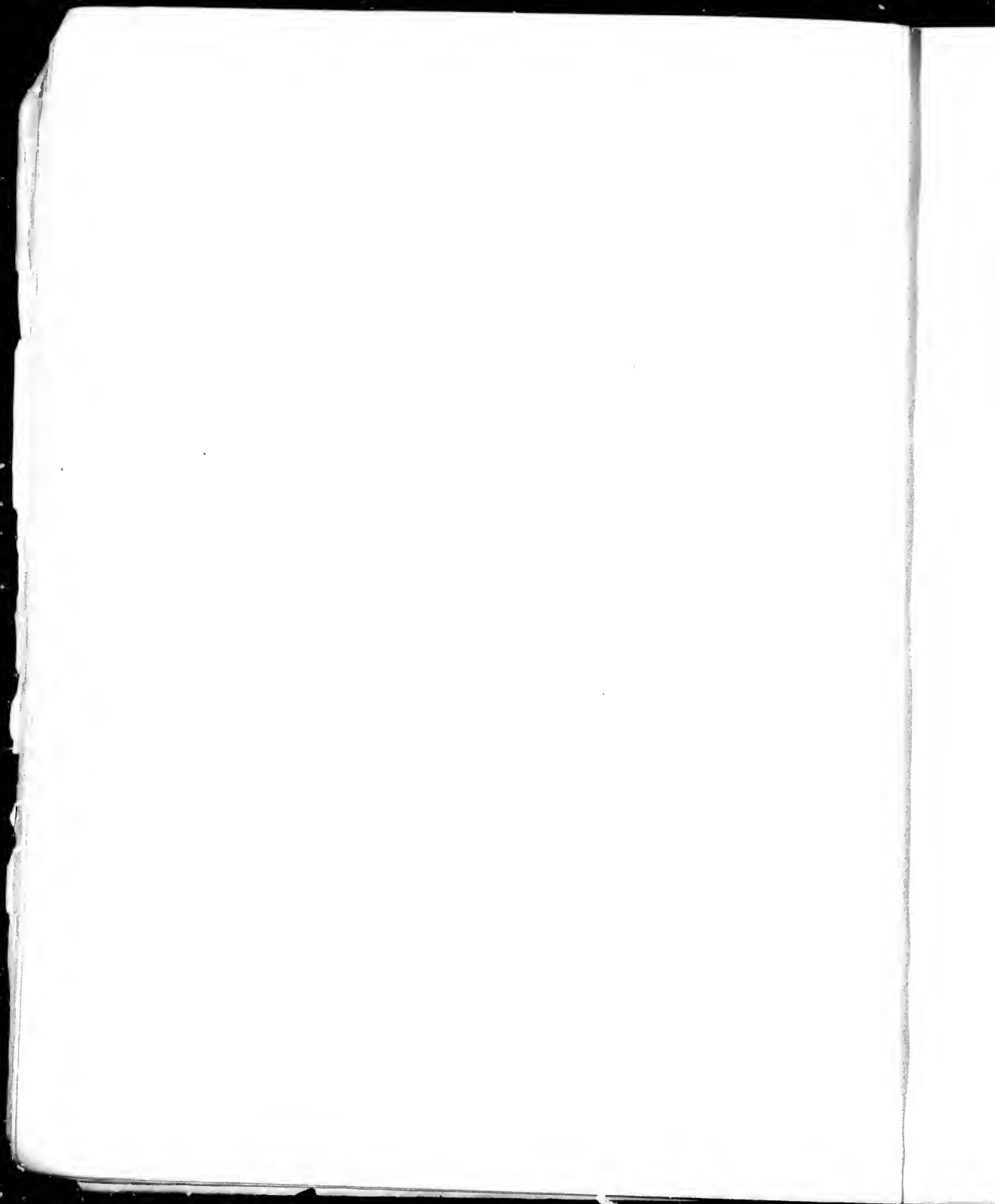

## STATUTE XCIV.

RE-ENACTING AND AMENDING THE STATUTE  
OF THE FINANCE COMMITTEE, 77.

---

I. That there shall be a Committee of the Senate, who, in conjunction with a Committee of three of the Council of University College appointed for a similar purpose, shall determine from time to time what portion of the expen-



diture of the Income available under order of the Executive Council shall be borne by the University and University College respectively, and shall form a joint Committee to control the items of joint Expenditure. This Committee shall also supervise and manage all matters of a financial character within the control of the Senate and Council, but no extraordinary expenditure shall be incurred without the previous approval of the Senate and Council.

II. That the said Committee of the Senate shall consist of the Chancellor, the Vice-Chancellor and two members of the Senate to be annually elected on the first Thursday, after the first Tuesday in October in each year, and subject to the Statutes and directions of the Senate, shall have supervision and control of that portion of the expenditure which is to be borne by the University, but no extraordinary expenditure shall be incurred without the previous approval of the Senate ; and such Committee shall make reports to the Senate relative to the same once in every three months, at least.

III. That two shall form a quorum of the Committee of the Senate, and three a quorum of the joint Committee of which, at least, one shall be the Vice-Chancellor or an elected member of the Senate.

IV. Such Committee shall keep regular minutes of their proceedings, and shall, from time to time, report the same to the Senate.

V. That Thomas Moss, M. A., and John Macdonald, Esquire, be elected to serve on this Committee until the next regular Election.

(Read a 2nd time, and passed 4 June, 1873.)

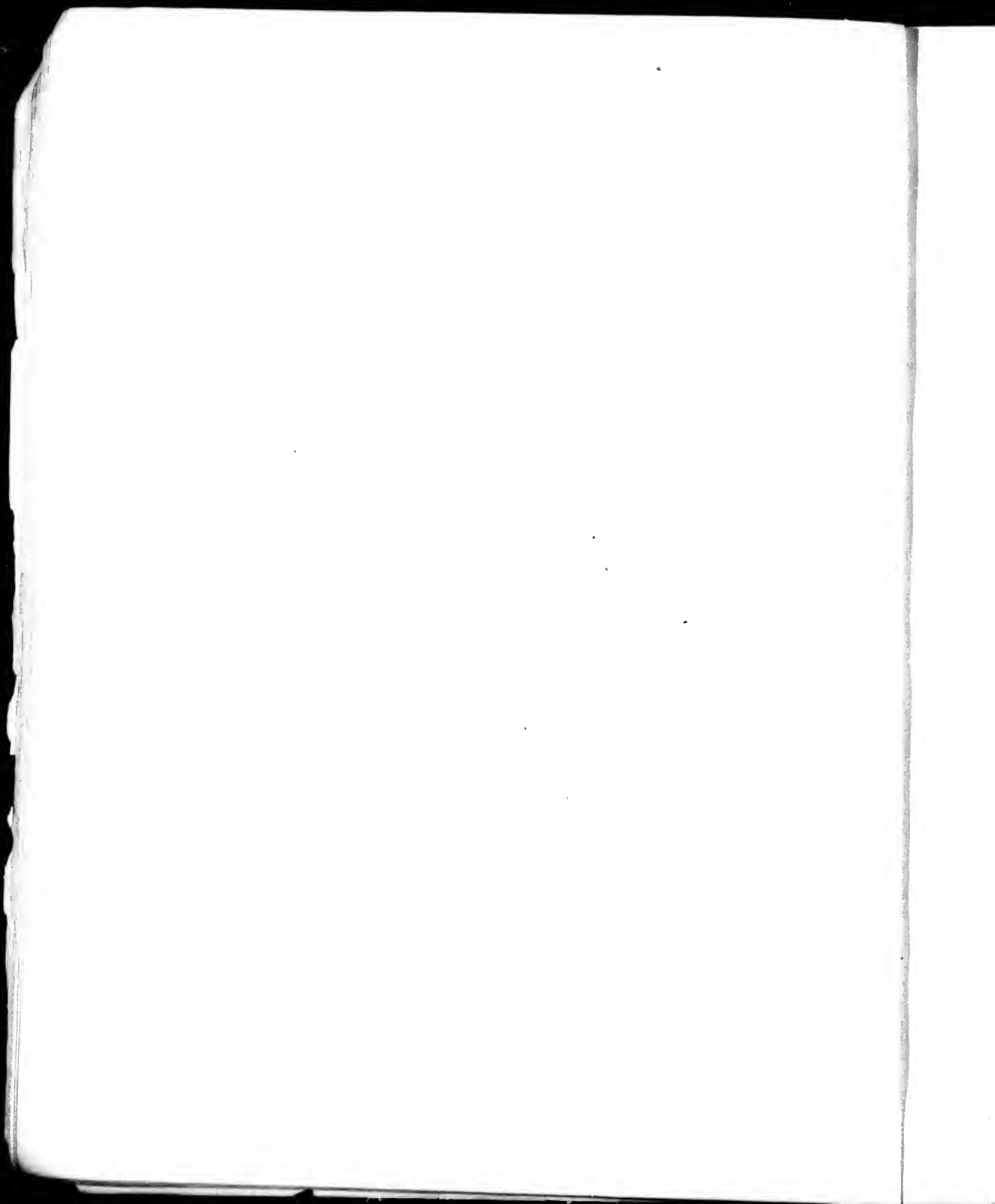
#### AMENDING THE STATUTE OF MEETINGS OF SENATE.

---

That clause 2 of Statute 2 be amended by adding thereto the following words :—

“Special Sessions shall be called by the Chancellor or Vice-Chancellor within two weeks after being required so to do by the written requisition of ten members of the Senate.”

(Read 2nd time, and passed 16 June, 1873.)





## STATUTE XCVI.

AMENDING STATUTES 23 AND 24.  

---

I. That clause 1, of Statute 23, be repealed, and the following be substituted in lieu thereof, viz. :—

The care of the Museum shall be entrusted to a Committee consisting of the Chancellor, the Vice-Chancellor, the President of University College, the Professors of Chemistry, of Natural Philosophy, of Natural History, of Mineralogy and Geology, and of English Literature, and of two members of the Senate to be appointed annually on the first Tuesday in October of whom any three shall form a quorum.

II. That clause 1, of Statute 24, be hereby repealed, and that in lieu thereof there be substituted as follows :—

The Superintendence of the University Grounds shall be entrusted to a Committee consisting of the Chancellor, the Vice-Chancellor, the President of University College, the Dean of Residence and four other persons to be appointed annually by the Senate on the first Tuesday in October, of whom any three shall form a quorum.

(Read 2nd time, and passed 16 June, 1873.)

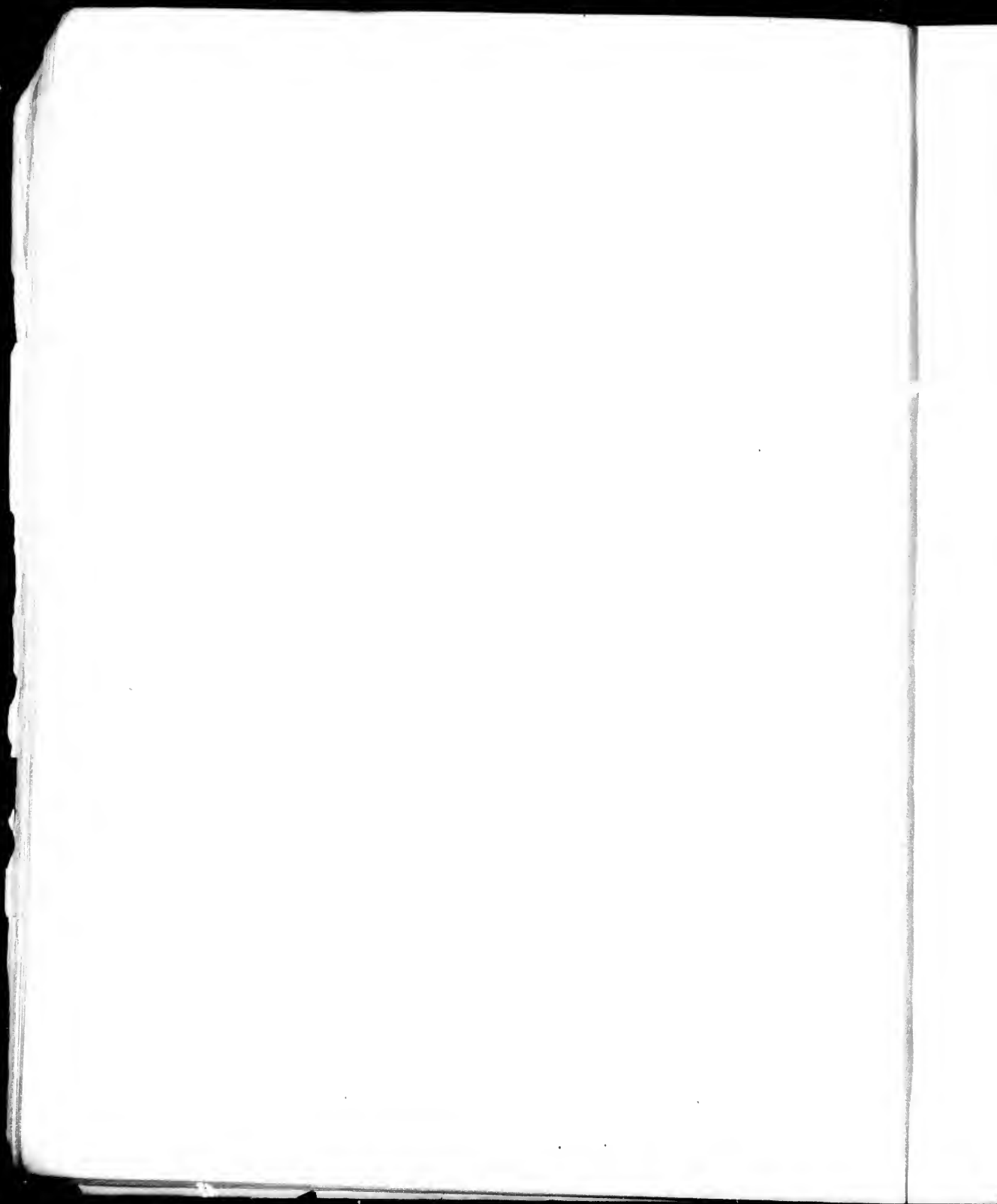

That William Henry Vander Smissen, M. A., is hereby appointed Librarian of the University, that office being hereby declared to have been vacated by the affliction of the late Incumbent.

That Sub-section 5 of Section 4 of Statute 79 be and the same is hereby repealed.

STATUTE XCIX.  
RESPECTING VOTING PAPERS.

---

That a Voting Paper for the Election by Convocation of a Chancellor and of Members of the Senate shall be mailed by the Registrar to the addresses (where known) of each of the Members of Convocation not less than three weeks before the day appointed for such election, and that such voting paper shall be accompanied by a circular in the form set forth in Schedule "A," or to the like effect (vid. orig'l Stat. and printed circulars.)

(Passed 4th April, 1874.)

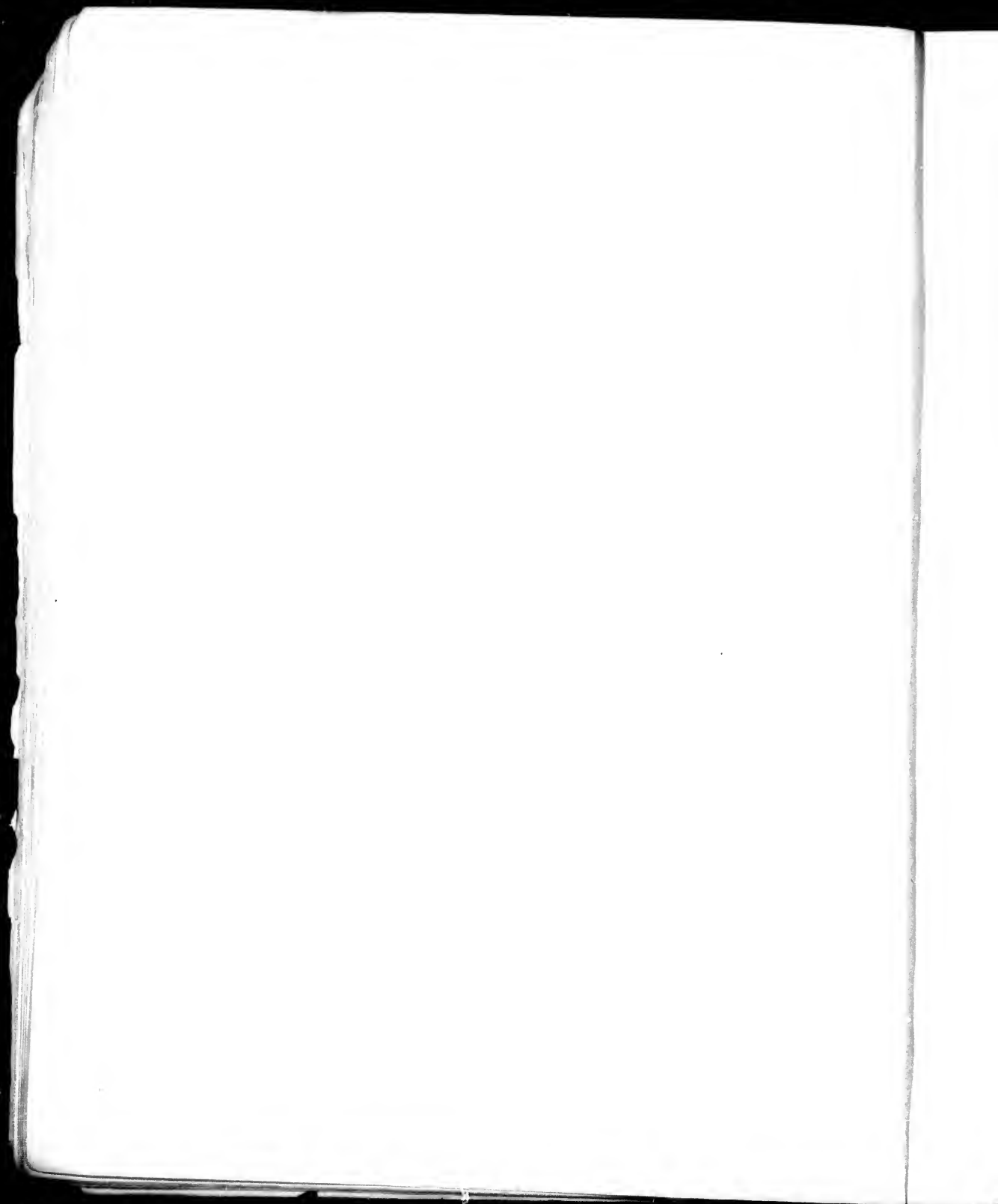

STATUTE C.

I. That at the first meeting of the Senate after each annual election there shall be elected from their number seven persons, who shall be a Committee to strike all standing Committees for the ensuing year. If default shall happen in electing such Committee at the time above appointed, a special meeting shall be forthwith called for such election.

II. That forthwith after the Report of such Committee is submitted to the Senate, the elective Members of all Standing Committees shall be elected by the Senate.

III. In case a vacancy occur in any Standing Committee the same may be filled up at any regular meeting.



IV. The Standing Committees shall consist of those Committees at present known as the Observatory Committee, the Library Committee, the Museum Committee, the Committee on Grounds, the Financial Committee, the Committee on Upper Canada College, and such other Committees as the Senate shall hereafter declare to be Standing Committees.

(Passed 18th April, 1874.)

STATUTE CI.

FOR THE APPOINTMENT OF A COMMITTEE  
ON EXAMINATIONS.

---

I. That there shall be a Standing Committee (to be called the Committee on Examinations), who shall recommend to the Senate the names of suitable persons for Examiners.

II. That all proposed changes in the Books named in the Curriculum be referred to this Committee.

III. That said Committee shall consist of the Vice-Chancellor and six Members of the Senate.

(Passed 16th May, 1874.)

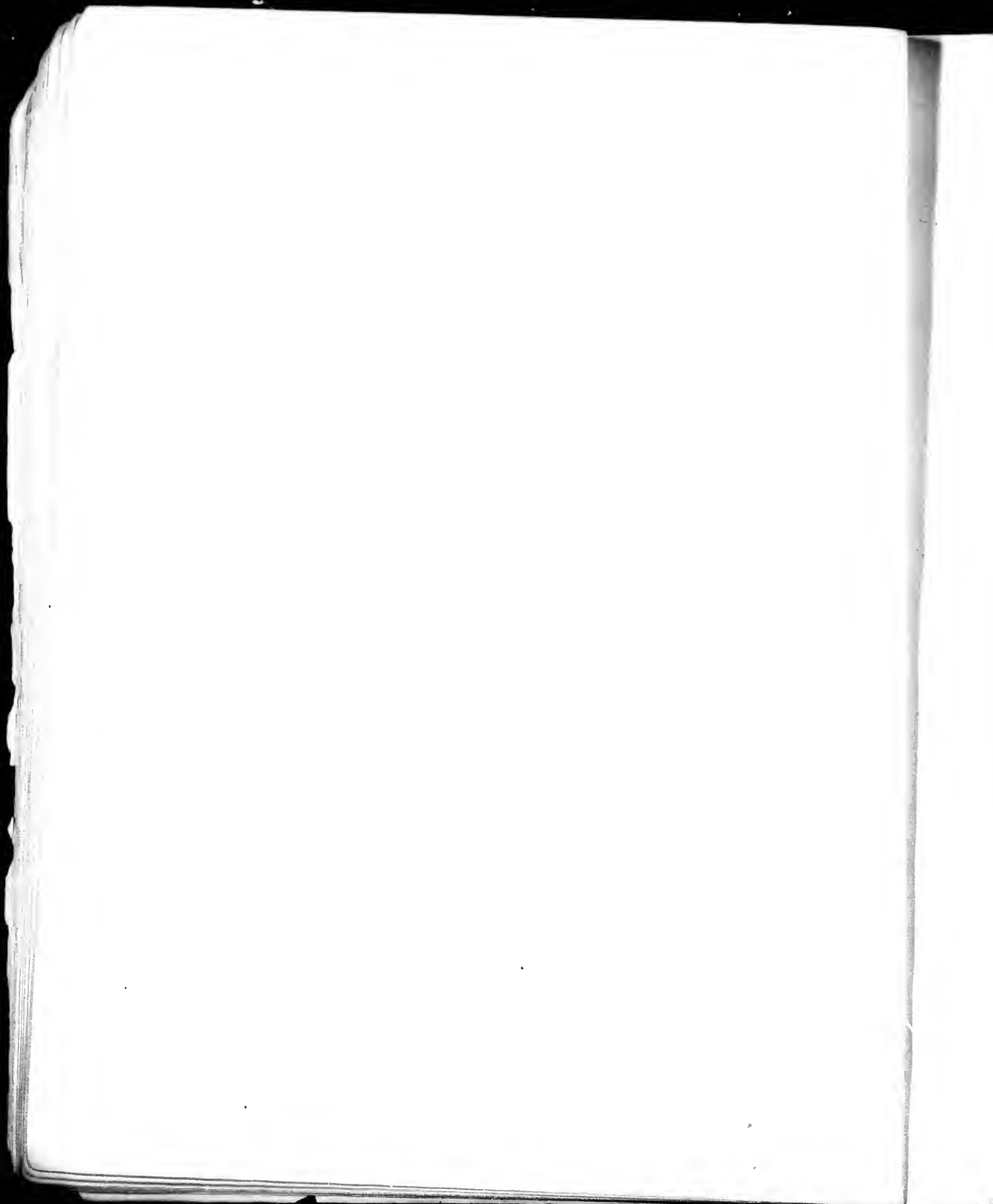

## STATUTE CIII.

OF THE APPOINTMENT OF A COMMITTEE  
ON APPLICATIONS AND MEMORIALS.

1. That there shall be a Standing Committee to be called the Committee on Applications and Memorials, to whom shall be referred all Memorials of Undergraduates, and Applications for Degrees and Standing.

II. That such Committee shall consist of the Vice-Chancellor and four Members of the Senate.

(Passed 18th June, 1874.)

## STATUTE CIV.

AMENDING STATUTE 60 OF FEES AND SAL-  
ARIES IN UPPER CANADA COLLEGE.

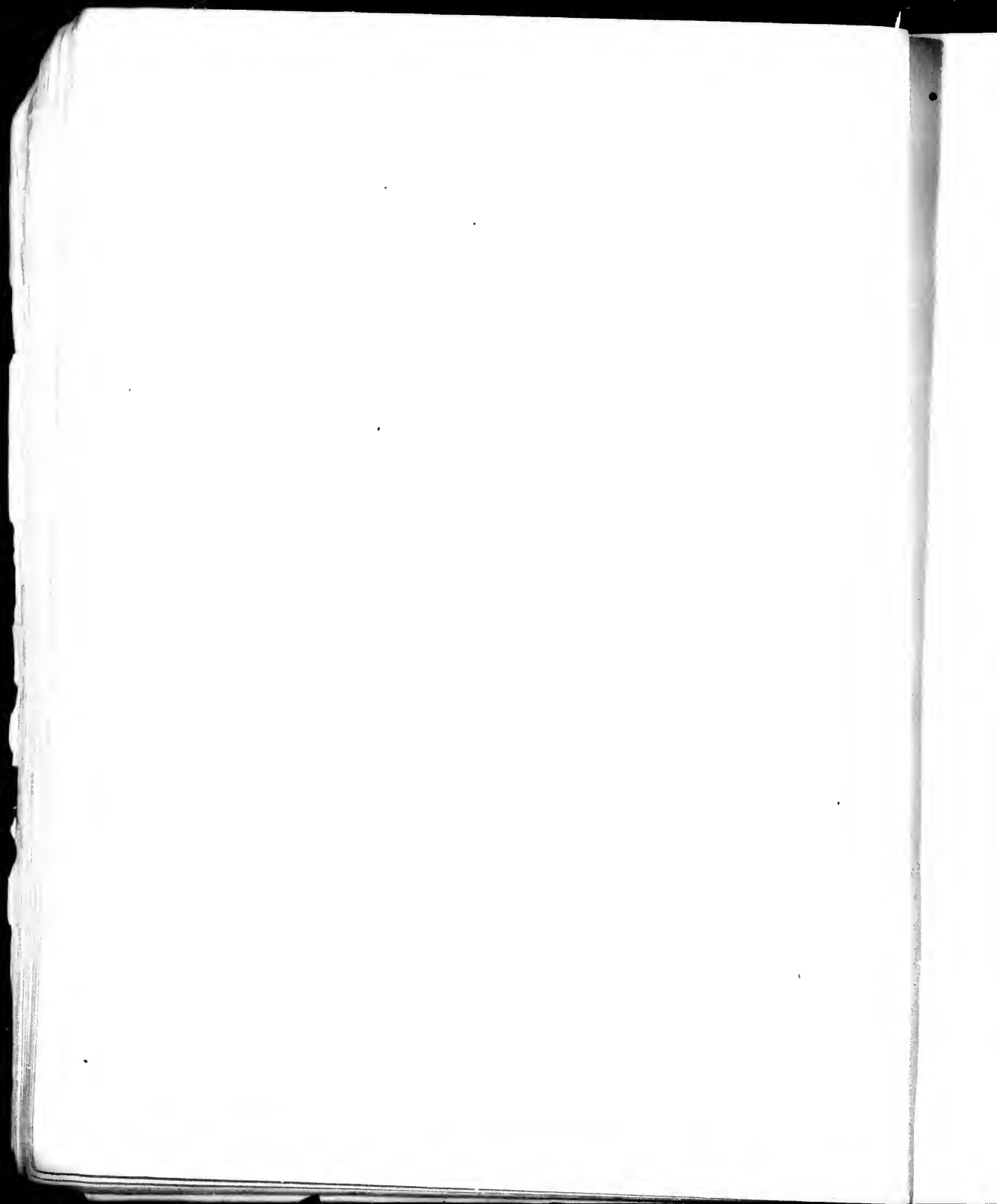
That Statute 60, Sect. I. be repealed, and that the following be substituted therefor :

Upon Report of the Upper Canada College Committee the Senate may from time to time, by resolution, alter and modify the Tuition Fees ; and until the passage of any such resolution they shall be at the following rates :

For Students not resident in the Boarding-house they shall be at the rate of twelve dollars and a half per term. If there shall be two pupils from one family, the Tuition Fees shall be at the rate of eleven dollars and a half each per term, and if there shall be three or more pupils from one family they shall be at the rate of ten dollars and a half each per term. The proportion of the Fees now payable to the Masters shall remain as established by Statute 39, Sect. III. The Tuition Fees for Pupils in the Boarding-house shall be seven dollars and a half each per term.

And that as soon as conveniently may be after the conclusion of each financial year the Committee on Upper Canada College shall report to the Senate the amount derived from such additional Fees which in their opinion should be reserved to the purposes of additions and permanent improvements, and the Senate may thereupon, by resolution, direct that such sum, or any part thereof shall be set apart and invested for that special purpose.

STATUTE CVI.  
COMPRISING AND APPROVING THE FORM OF  
LEASE TO THE CITY OF TORONTO OF A  
CERTAIN ROADWAY THROUGH THE PARK.

---

BY THE SENATE OF THE UNIVERSITY OF TORONTO.

That the Lease prepared by the Solicitor and transmitted by the Bursar demising a roadway through the Park to the City of Toronto be and the same is hereby confirmed and approved of, and the Bursar is hereby authorized to execute the same.

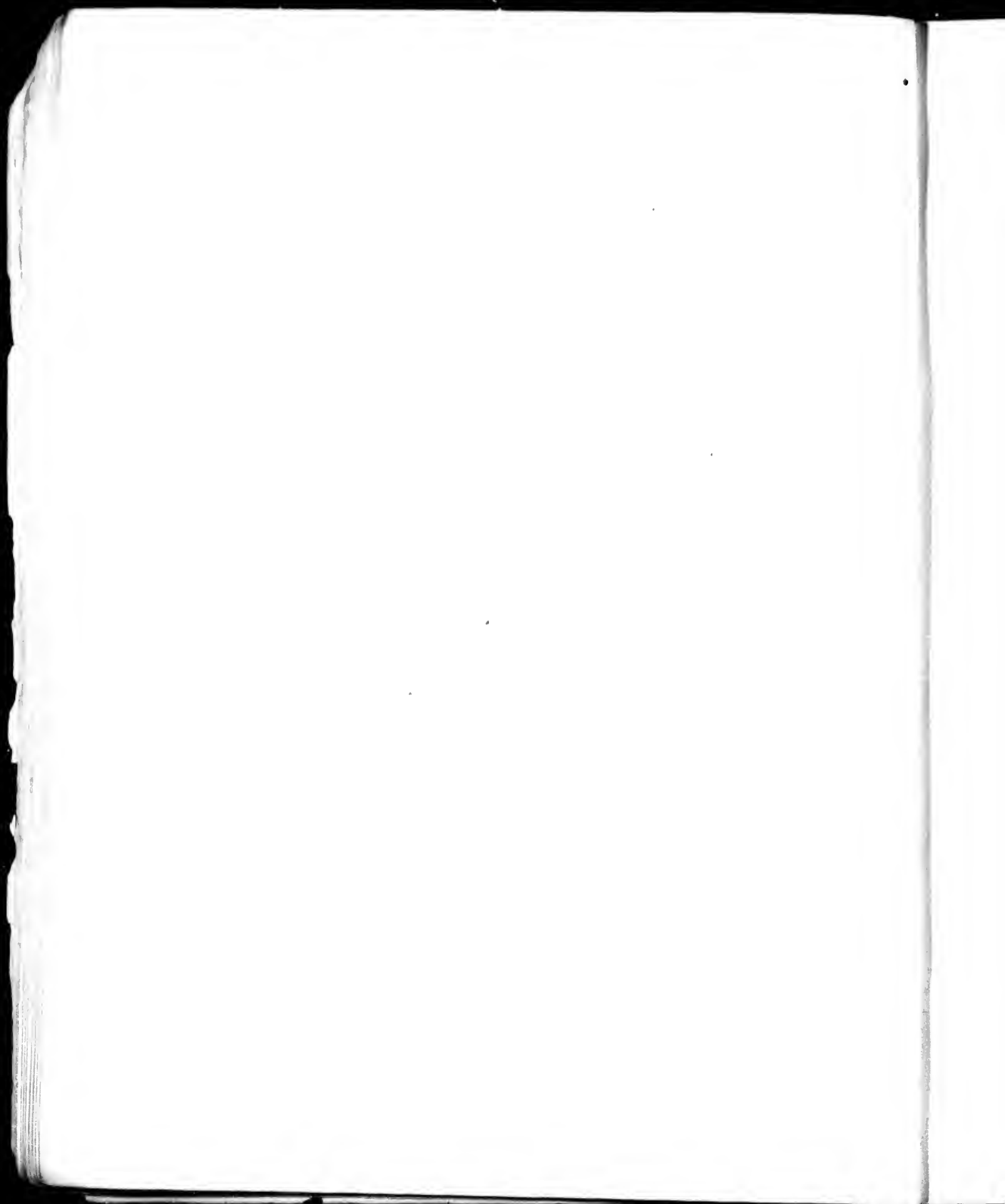

STATUTE CVIII.  
OF THE BLAKE SCHOLARSHIP.

---

WHEREAS the Honorable Edward Blake, M.A., Chancellor of the University, has offered a donation of twelve hundred and fifty dollars for the purpose of founding an annual Scholarship of one hundred dollars for the promotion and encouragement of the study of the Science of Politics, Political Economy, Civil Polity, and Constitutional History.

I. That the donation of twelve hundred and fifty dollars from the Chancellor be accepted by the University for the purpose of founding an annual Scholarship of one hundred dollars for the promotion and encouragement of the study of the Science of Politics, Political Economy, Civil Polity and Constitutional History, and be placed by the



Bursar to a separate account to be called the Blake Scholarship Account, and that the said sum shall be invested in the same manner and upon similar securities as the other funds of the University are invested, and in consideration thereof, a permanent Scholarship of one hundred dollars per annum be established for the promotion and encouragement of the said subjects of study to be called the Blake Scholarship.

II. The said Scholarship shall be annually awarded to the undergraduate of the third year who shall pass the best examination in the Pass and Honor work in History (not including Ethnology) and Civil Polity with such additional work connected with either of these sub-departments as the Senate may from time to time prescribe.

III. The Senate shall have power in that behalf to require only a portion of the Pass and Honor work in the History and Civil Polity of the third year to be taken along with such additional subjects as may be prescribed, if such a course shall appear best calculated to promote the object of the donor without unduly interfering with the pursuit of the ordinary course.

IV. The said Scholarship shall not be awarded to any candidate unless he shall have obtained first-class honors in each of the sub-departments of History and Civil Polity.

V. The said Scholarship shall be treated and considered as a University Scholarship with reference to conditions of attendance upon Lectures, holding a double or triple Scholarship, and declaring recipient's intention of proceeding to a degree, and all other conditions annexed to the ordinary University Scholarship.

VI. Until otherwise provided the subjects of examination shall be as follows :

Roger's Manual of Political Economy.

Fawcett's Political Economy.

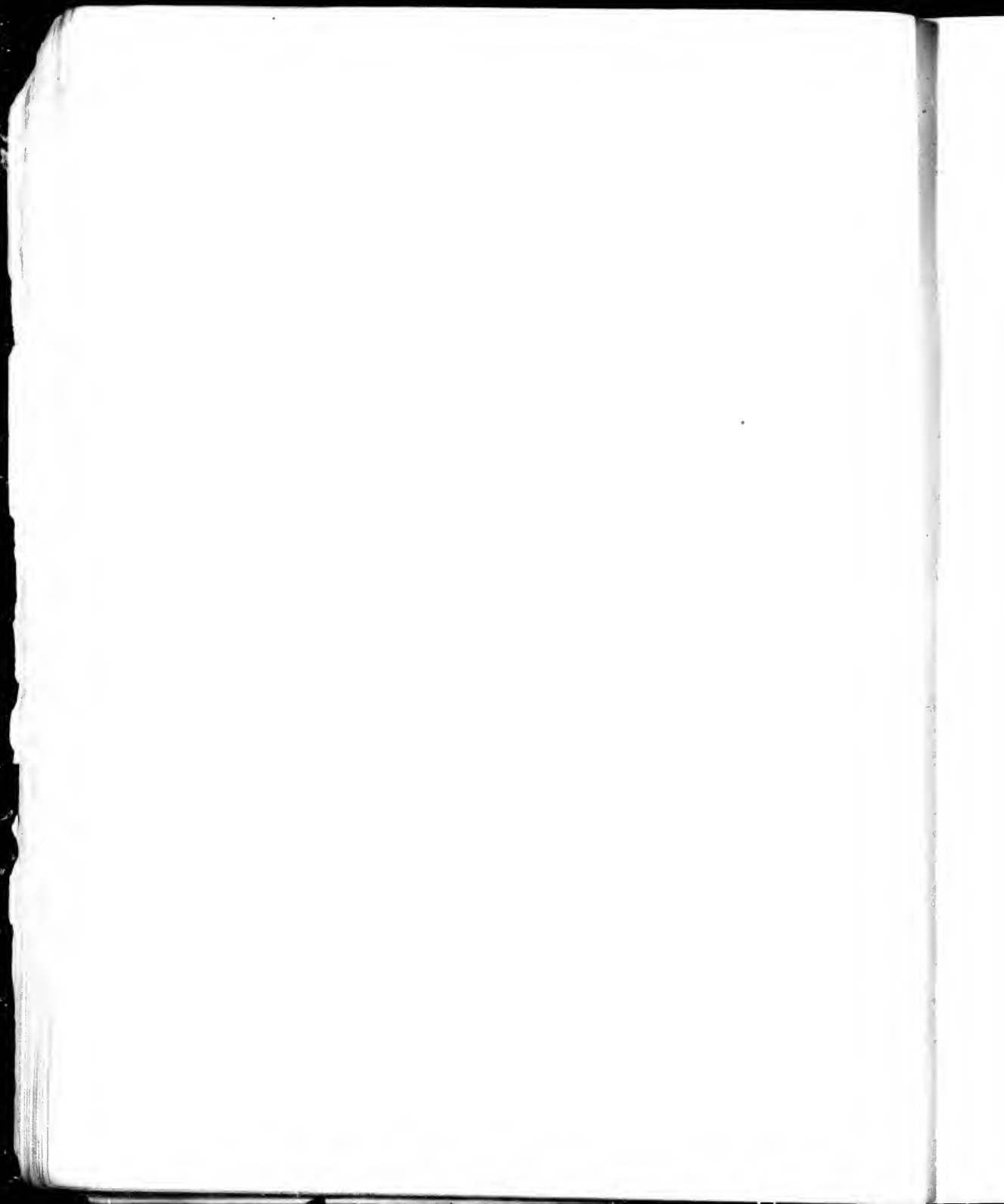
Lorimer's Institutes of Laws.

Taswell Langmead's English Constitutional History.

Brown's Constitutional Law.

Maine's Early History of Institutions.

## STATUTE CIX.

TO DETERMINE THE MODE OF IDENTIFYING  
THE PAPERS OF CANDIDATES AT EXAM-  
INATIONS.

WHEREAS it is expedient to adopt a mode of identifying the Papers of Candidates at the various Examinations held in the University.

I. That at each examination to be hereafter held in the University, the Registrar shall cause to be delivered to each Candidate, on the first morning of the examination, a sealed envelope addressed on the outside to the Candidate and containing inside a number.

II. In order to determine the number appropriated to each Candidate, the Registrar shall place in one box the envelopes addressed to the several Candidates, and in another cards marked with numbers from twenty upwards; he shall then proceed by taking an envelope from one box and a card by chance from the other, and the number on such card shall be the number appropriated to the Candidate whose name is on the envelope.

III. During the whole examination the Candidate shall sign his papers with such number, and shall use no other distinctive mark whatever.

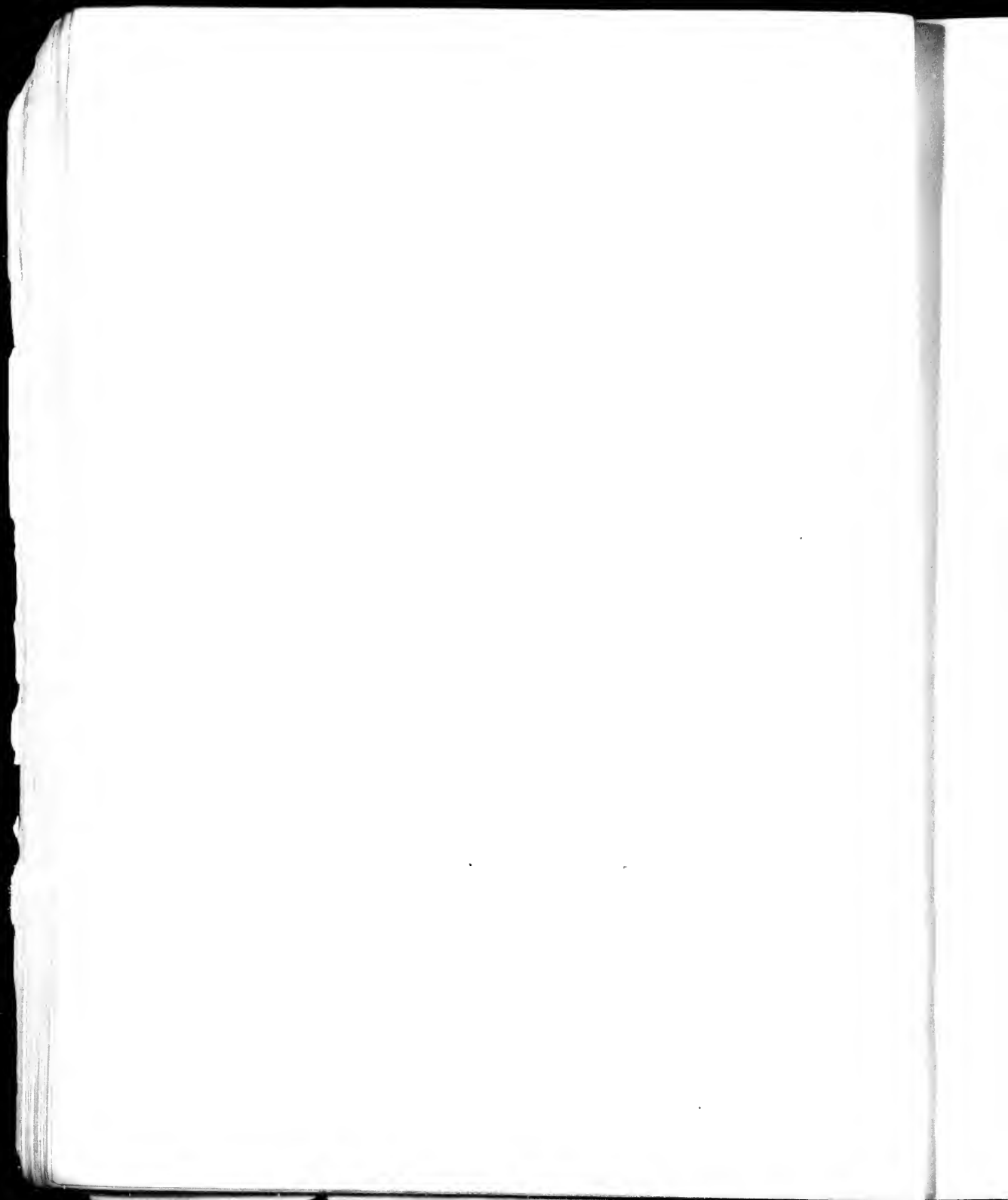
IV. The returns of the Examiners shall be made with reference to the numbers signed to the papers, and the Registrar shall not disclose the names to which the numbers are attached until the report upon the examinations has been received and approved by the Senate.

(Passed 12th June, 1877.)

## STATUTE CX.

TO PROVIDE FOR THE HOLDING OF EXAM-  
INATIONS AT AFFILIATED COLLEGES

I. The Annual Examinations both for Pass and Honors in the Faculty of Arts may, at the request of any affiliated College communicated to the Registrar at least



one month before the commencement of the Examination, be held at such College, provided there are at least six students to be examined there upon the work of any year of the course for which the examination is requested, or that the Principal of such College shall undertake to pay the same fees as if that number were prepared to present themselves.

Proper accommodation for holding such examinations shall be provided by the affiliated College, including Stationery of precisely the same kind as that used at the examinations at Toronto.

II. The examination papers shall be transmitted or delivered under seal to such Officer as the Senate may appoint at least one day before they are required to be used, and the said Officer shall perform the duties which, by the regulation of the Senate, are prescribed for the Examiners, touching the giving out and collection of the papers, and the conduct of the examinations generally.

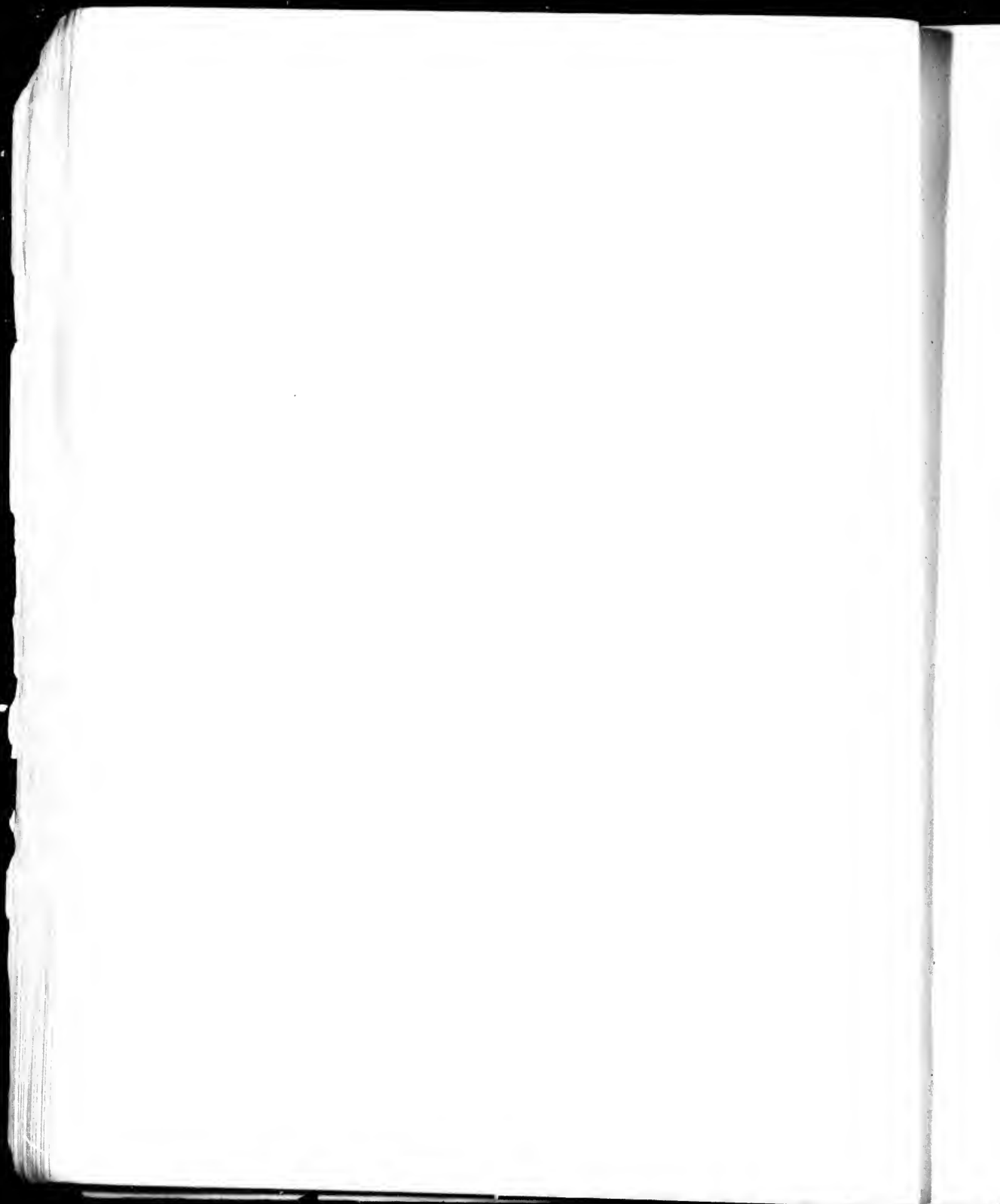
III. At the close of each Examination such Officer shall seal up the papers of the Students, and day by day transmit the same to the Registrar, who shall deliver them under seal to the examiners.

IV. No oral Examination shall be required, except in the case of Modern Languages, and the Registrar shall make arrangements with one of the Examiners in that department to proceed to the affiliated College at some appointed time and there hold an oral Examination in person, for the purpose of testing each Candidate's ability to read and pronounce the Language or Languages in which he presents himself.

V. The programme of the time of holding the several Examinations shall be as strictly observed in the affiliated College as if they were being held in the Convocation Hall of the University.

VI. Upon every Examination so held a Fee of two dollars in addition to the ordinary Fee for Examination shall be paid by the Principal of such affiliated College on account of each Student so examined, and shall be applied towards defraying the expenses of such Examination.

VII. This Statute not to extend to Honor Examinations in the Department of the Natural Sciences, nor to any of the Examinations of the third and fourth years.





VIII. The provisions of the Statute to determine the Mode of Identifying the Papers of Candidates at Examinations shall apply to such Examinations at affiliated Colleges.

IX. The proper Officer of each affiliated College shall, at least two weeks before the time appointed for holding such examination, communicate to the Registrar the names of all Candidates from such College, and the Registrar shall send to the Officer mentioned in the second paragraph an envelope for each Candidate, as provided in the said Statute.

X. The Fourth Section of Statute 14 is hereby Repealed in so far as it conflicts with the Provisions of this Statute.

(Passed 12th June, 1877.)

STATUTE CXI.  
OF EXAMINATIONS FOR WOMEN.

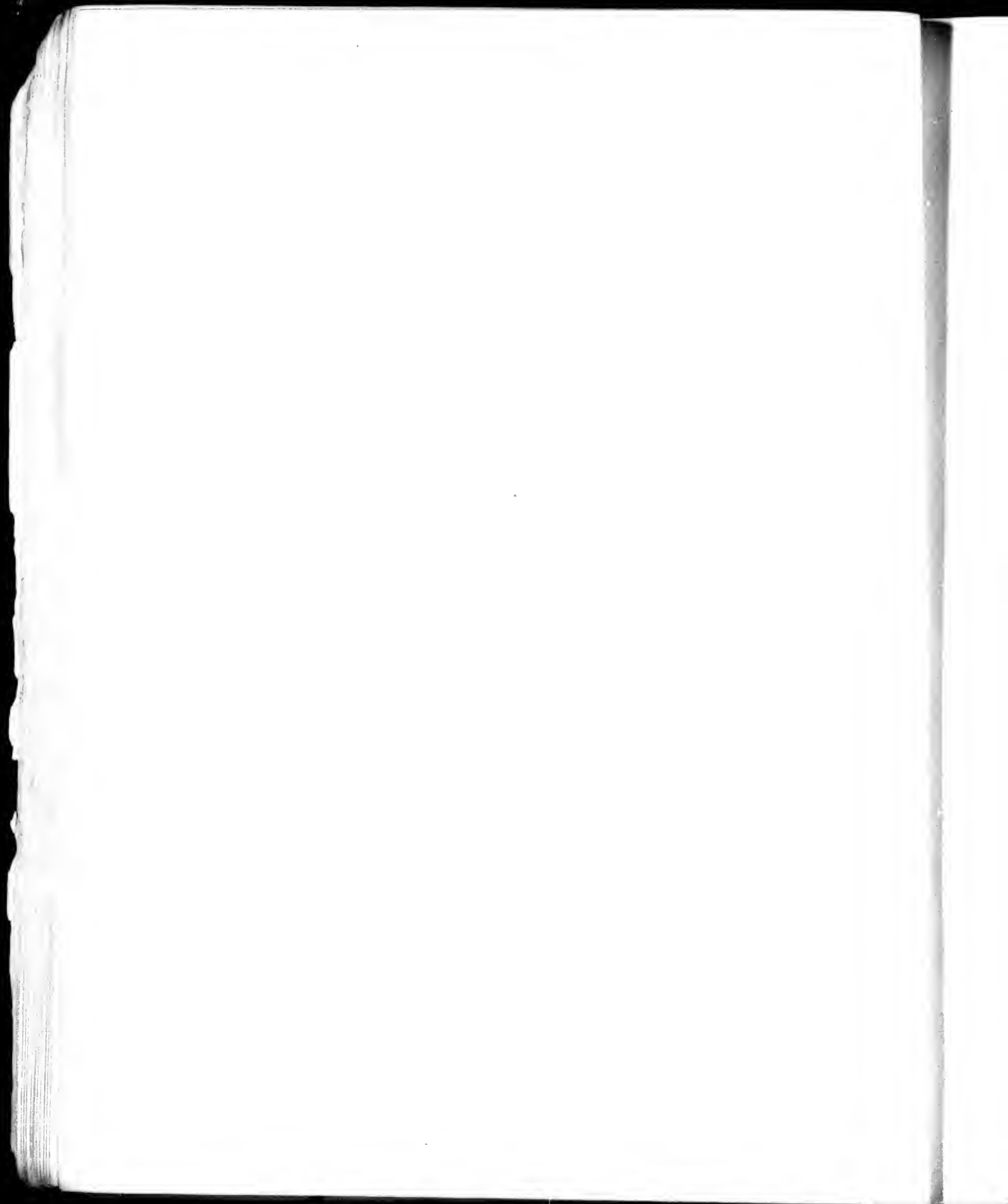
---

WHEREAS it is expedient to permit Women to present themselves for Examination at suitable places in certain of the subjects prescribed for Junior Matriculation and the First Year without requiring them to take the whole Examinations.

I. That Examinations for Women in certain of the subjects in the Faculty of Arts may be held at Toronto and elsewhere in the Province, according to the regulations hereinafter mentioned.

II. No Examination shall be held at any place until after the formation of a Local Committee prepared to guarantee the attendance for the Examination of at least six Candidates and the payment to the University of a sufficient sum to defray the additional expenses occasioned by holding such Examinations.

III. Upon application being made for holding the Examinations for Women at any place, the Committee to be appointed under this Statute as hereinafter mentioned, shall approve of the Local Committee before such application is granted.



IV. At least Five Ladies shall be Members of the Local Committee, and they shall undertake that suitable board and lodging shall be provided at reasonable rates for Candidates who may come from a distance.

V. The Local Committee shall be required to make arrangements for the attendance of at least Two Ladies, Members of the Committee, in the Examination, to assist the person to whom the papers are sent in Superintending the Candidates.

VI. No Candidate shall be admitted to the first examination unless she has completed her fifteenth year, nor to the second examination unless she has completed her sixteenth year.

VII. The examinations shall be upon the subjects of Junior and Senior Matriculation hereinafter specified, and shall be held simultaneously with the ordinary June examination for Matriculation, and the papers shall be distributed by a person to be named by the Senate, who shall collect the answers and return them under seal to the Registrar for delivery to the examiners.

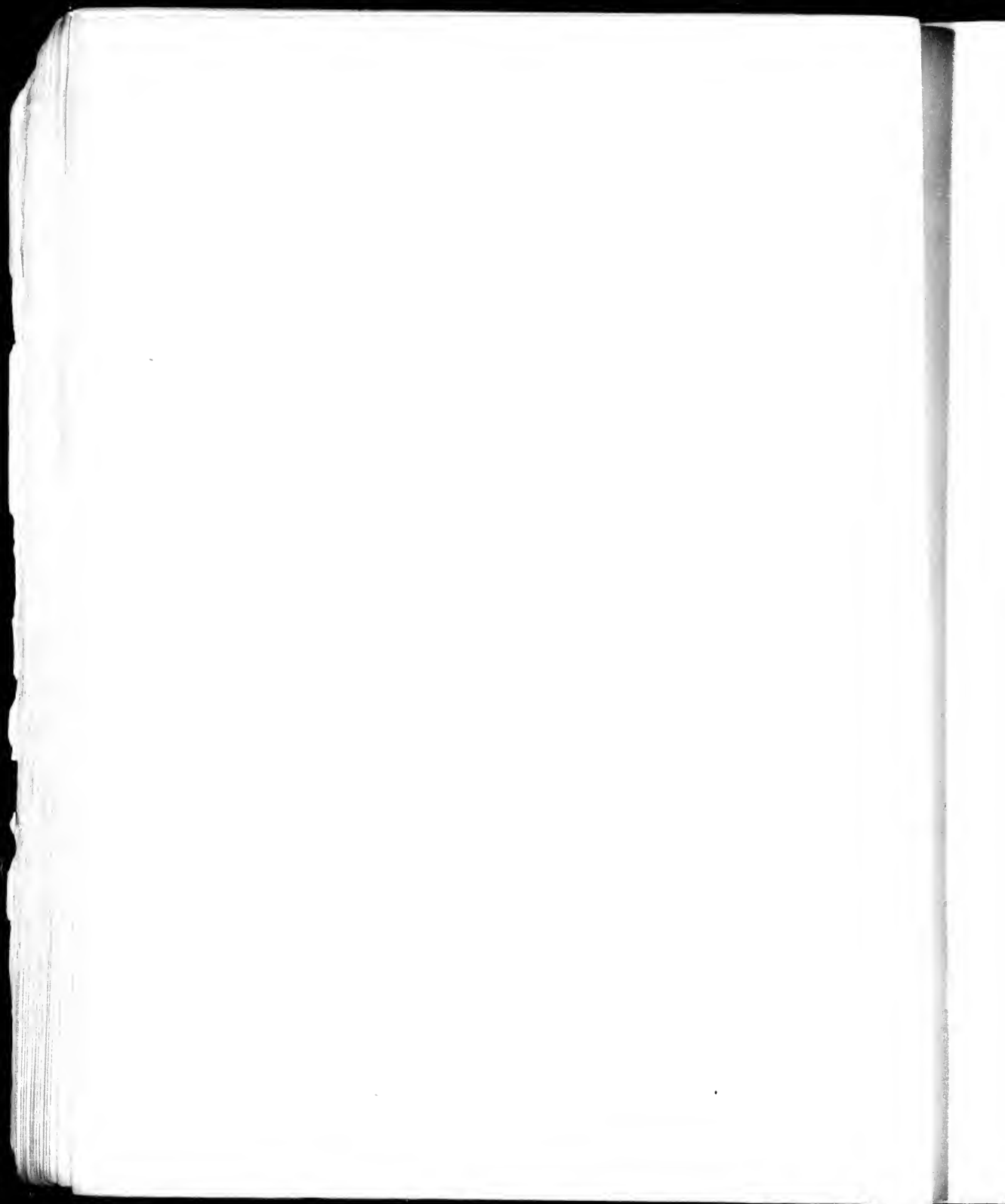
VIII. The questions shall be precisely the same as those proposed to male Candidates in the same subjects.

IX. The subjects shall be sub-divided into groups for any one or more of which a Candidate may enter, and a Candidate may take either the pass examinations or both the pass and honor examination in any such group or groups.

X. The names of all the successful Candidates shall be published in a separate list in the class list. The names of those who have taken honors being placed in order of merit, and of those who have simply passed alphabetically.

XI. Every Candidate who passes in all the subjects of the pass examination for Junior or for Senior Matriculation shall be entitled to a certificate signed by the Vice-Chancellor and Registrar of her having passed.

XII. Every successful Candidate for honors shall be entitled to a certificate of her exact standing among all the Candidates at the examination for women.



XIII. A Standing Committee shall annually be appointed by the Senate in the same manner and at the same time as other standing committees are appointed to arrange the requisite details for carrying on the examination hereby authorized.

XIV. The subjects shall, for the purposes of this Statute, be subdivided into the following groups :—

GROUP 1.—Classics of Junior Matriculation.

GROUP 2.—Mathematics of Junior Matriculation.

GROUP 3.—English History and Geography, French or German of Junior Matriculation.

GROUP 4.—Latin, English History and Geography of Junior Matriculation.

GROUP 5.—Latin, French and German of Junior Matriculation.

#### SECOND EXAMINATION.

GROUP 1.—Classics of Senior Matriculation.

GROUP 2.—Mathematics of Senior Matriculation.

GROUP 3.—English, French and German of Senior Matriculation.

GROUP 4.—English and Latin of Senior Matriculation.

GROUP 5.—Latin, French and German of Senior Matriculation.

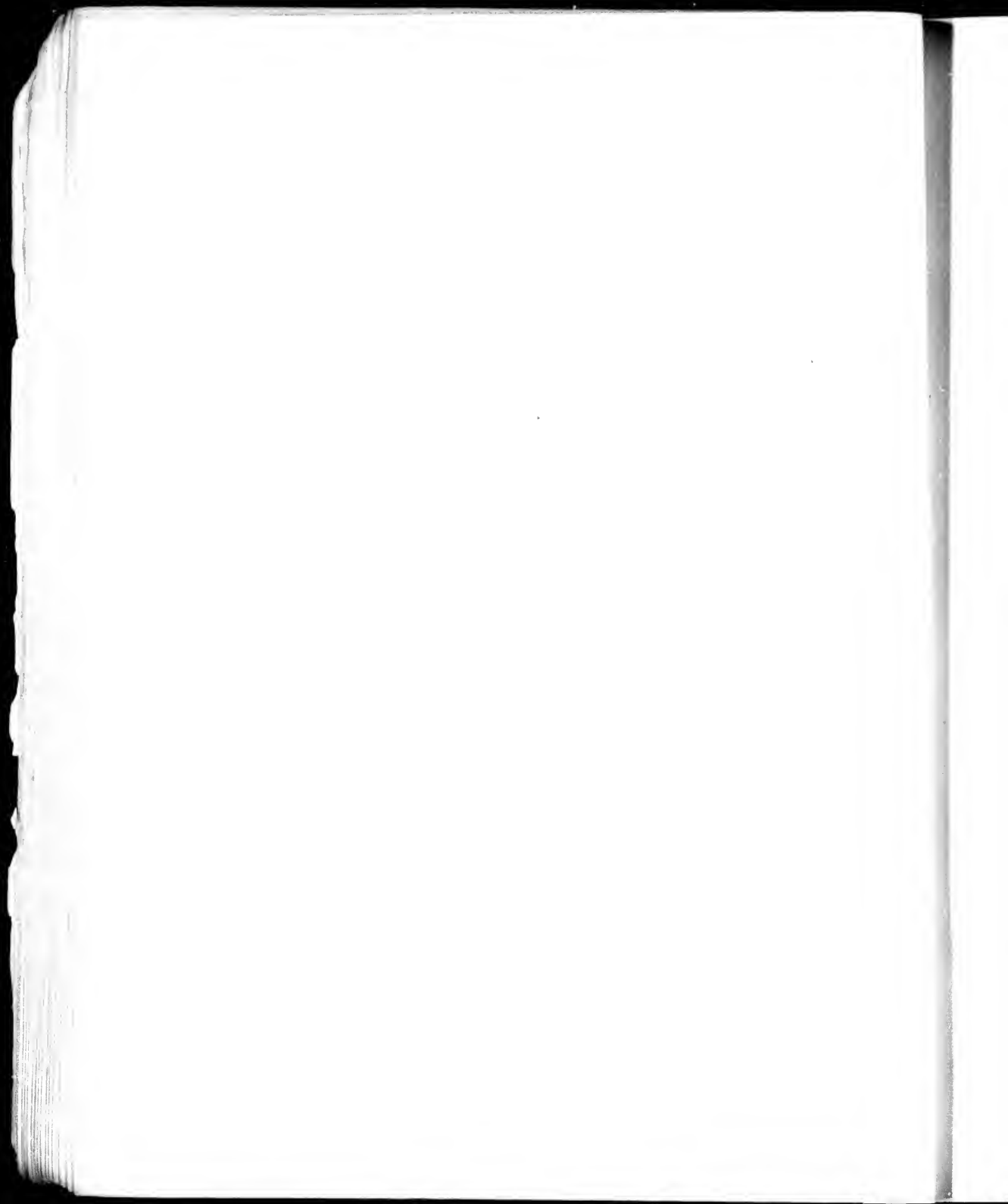
GROUP 6.—The first examinations in Chemistry, Natural History, and Mineralogy, and Geology.

GROUP 7.—Logic and Mental Philosophy of second year.

XV. No Candidate shall be considered to have passed in any subject unless she shall have obtained at least twenty-five per cent. of the marks, and no Candidate entering for a single group shall be entitled to a place in the class lists unless she shall have obtained an average of not less than fifty per cent. of the total number of marks allowed to the subjects of that group, and no Candidate entering for two or more groups of subjects shall be entitled to a place in the class lists unless she shall have passed in each subject and obtained an average of at least thirty-three and a third per cent. of the total number of marks allotted to all the subjects comprised in such groups.

XVI. No Examination under this Statute shall be held until after the Matriculation examination of September, one thousand eight hundred and seventy-seven.

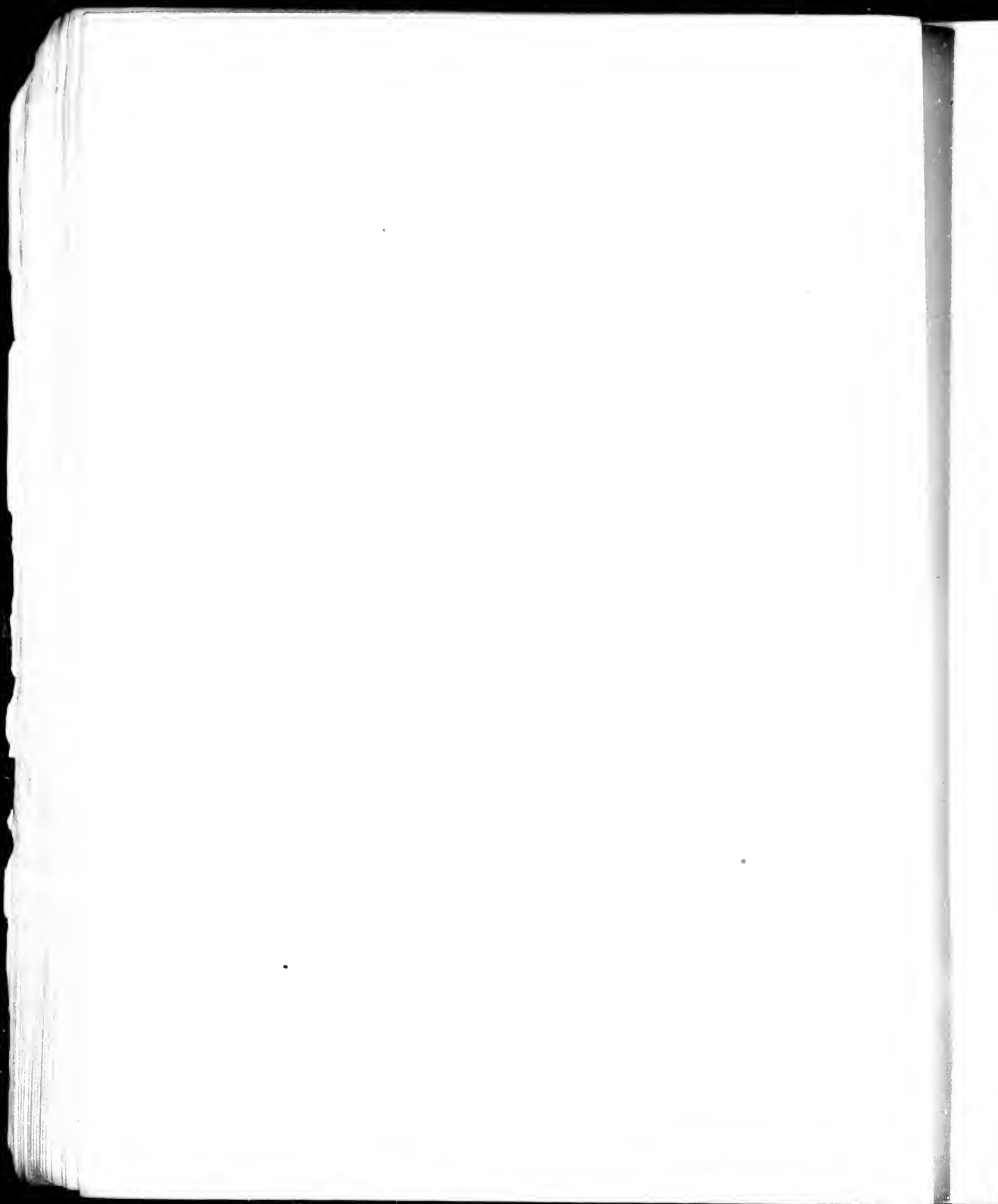

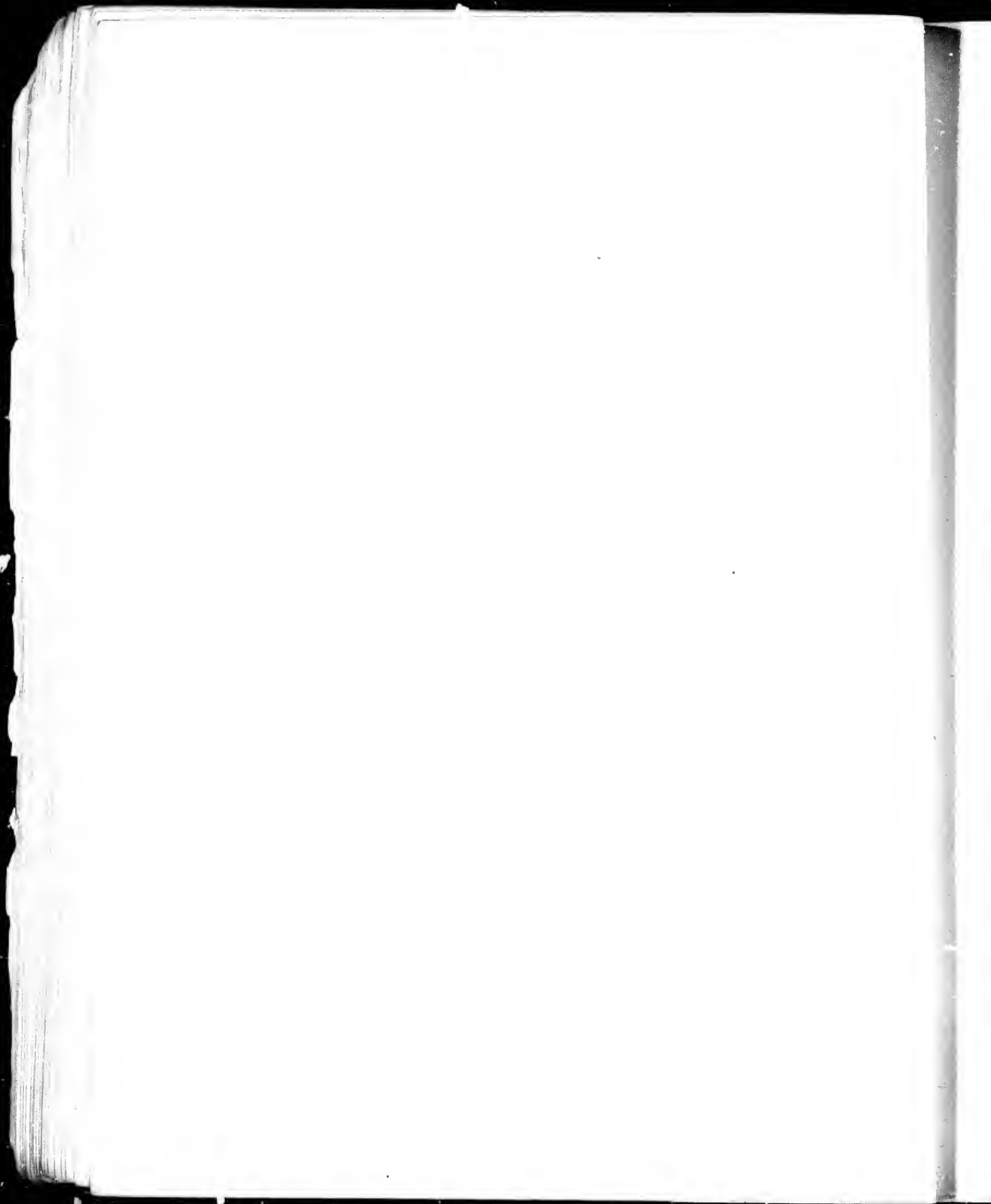
WHEREAS the Government of this Province are desirous of erecting on the University Grounds the School of Practical Science, the establishment of which has been authorized by the Legislature, and have applied to the Senate for their consent to erect the same on a suitable site, and whereas the establishment and maintenance of the said School on the University Grounds will be of great benefit as well to the Students prosecuting their special studies in the said School as to undergraduates in the University taking the Honor Course in the department of Natural Sciences.

I. That a parcel of Land to the East of the Observatory, of convenient size, shall be appropriated as a site for the said School of Practical Science.

II. That Professor Croft, Professor Loudon, and Mr. Taylor be a Committee to fix the metes and bounds of the said parcel, and upon the said Committee, or any two of them notifying the Provincial Secretary of the fixing of the said limits, the erection of the said building may be proceeded with.

III. That the said Committee, or any two of them, shall have power to agree to the construction of any roads that may be necessary to the proper and convenient use of the said parcel of Land for the purpose aforesaid.

IV. That all expenses attendant upon the fixing of the boundaries, the construction of Roads, and upon any other work connected with the said School be borne by the Government.

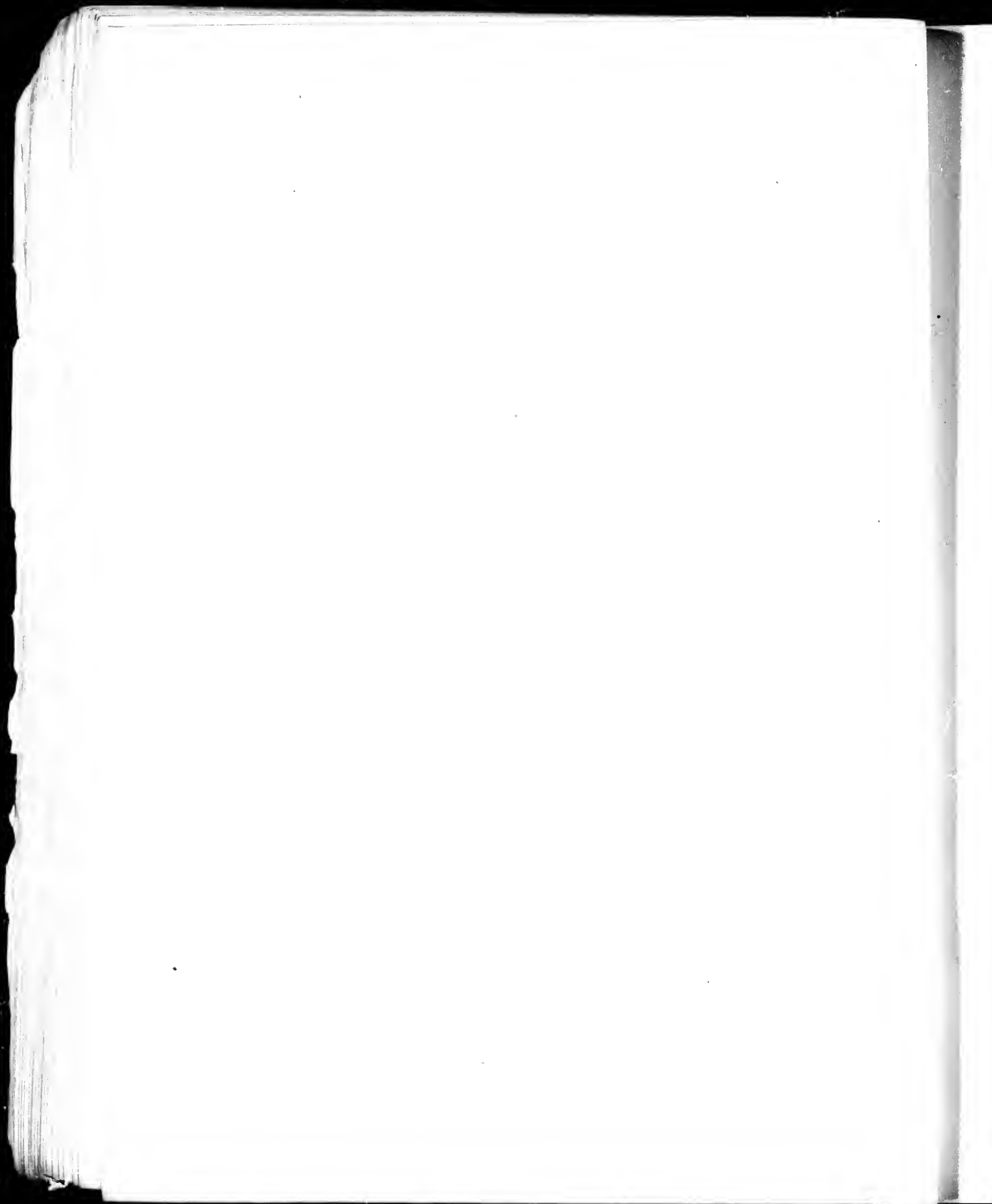

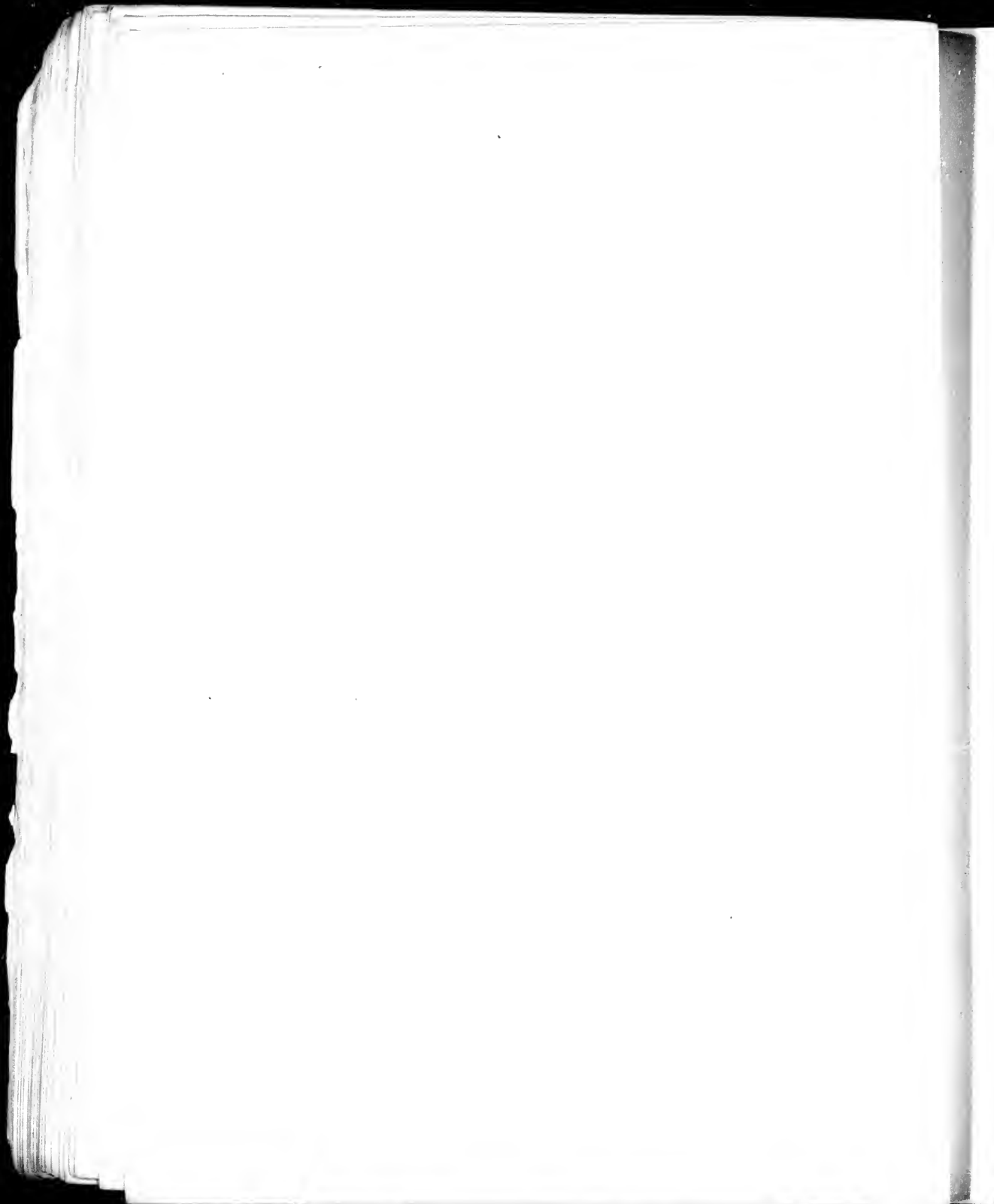

No Undergraduate in the Honor Course who shall have degraded into a lower year shall be permitted at the next ensuing Examination to compete for Medals, Scholarships or relative standing, except by special permission of the Senate, to be granted only in case of illness or for other grave reasons.

Undergraduates, below the standing of the Fourth Year, who have been rejected, or those who have been prevented from attending the annual Examinations in April, by Sickness, Domestic Affliction, or other causes beyond their control, may present themselves for Examination in September, at the time of the Supplemental Matriculation Examination. A Candidate who has failed in one subject of Examination, but has shown respectable proficiency in the other subjects, may be permitted by the Examiners to take it at the next ensuing Examination.

Candidates who failed to attend at the April Examinations must prove to the satisfaction of the Vice-Chancellor, before presenting themselves in September, the existence and sufficiency of the alleged cause of absence. Candidates who were rejected must pay a fee of \$10.00, and those who did not attend, a fee of \$5.00, before offering themselves for the September Examination.

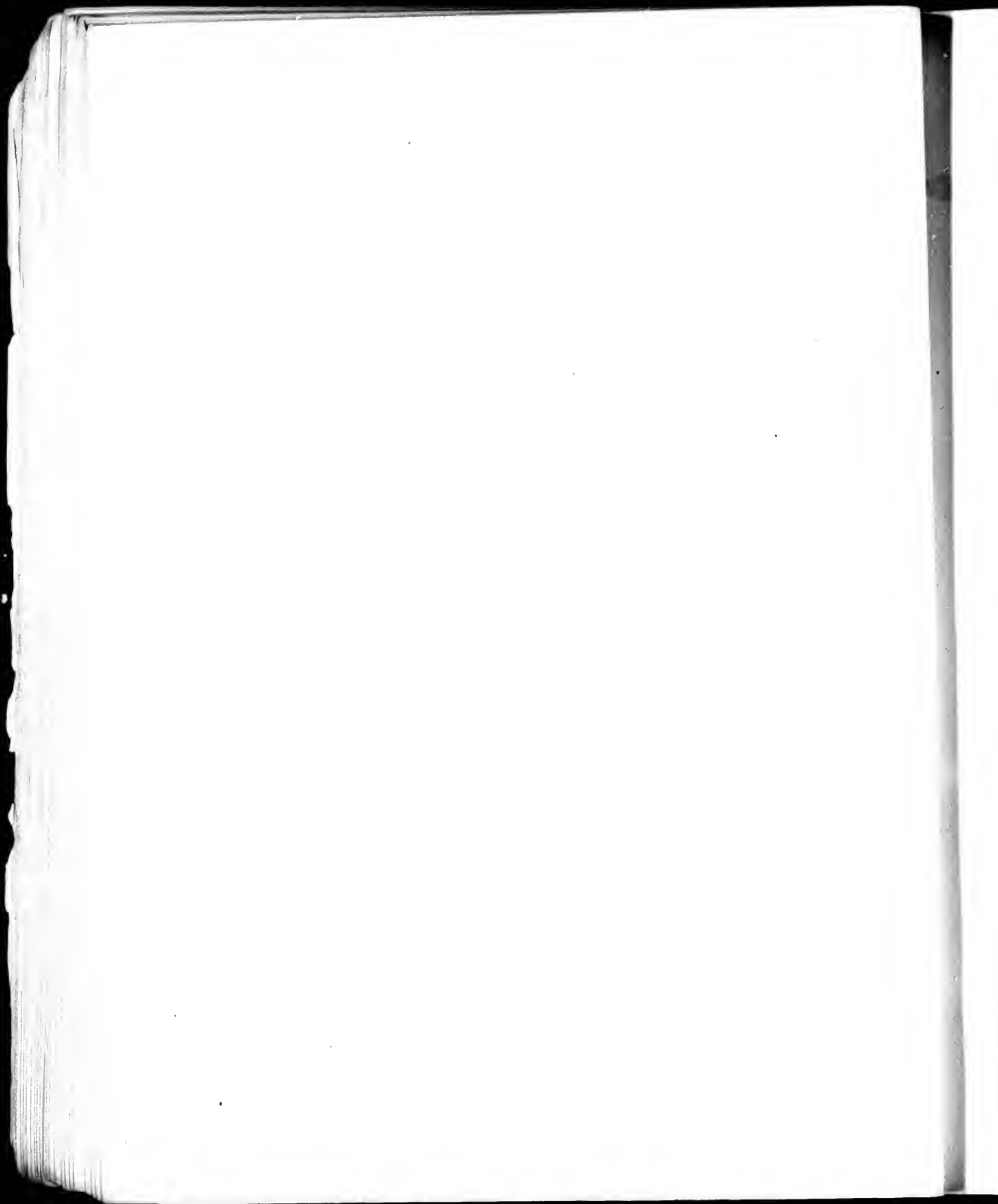

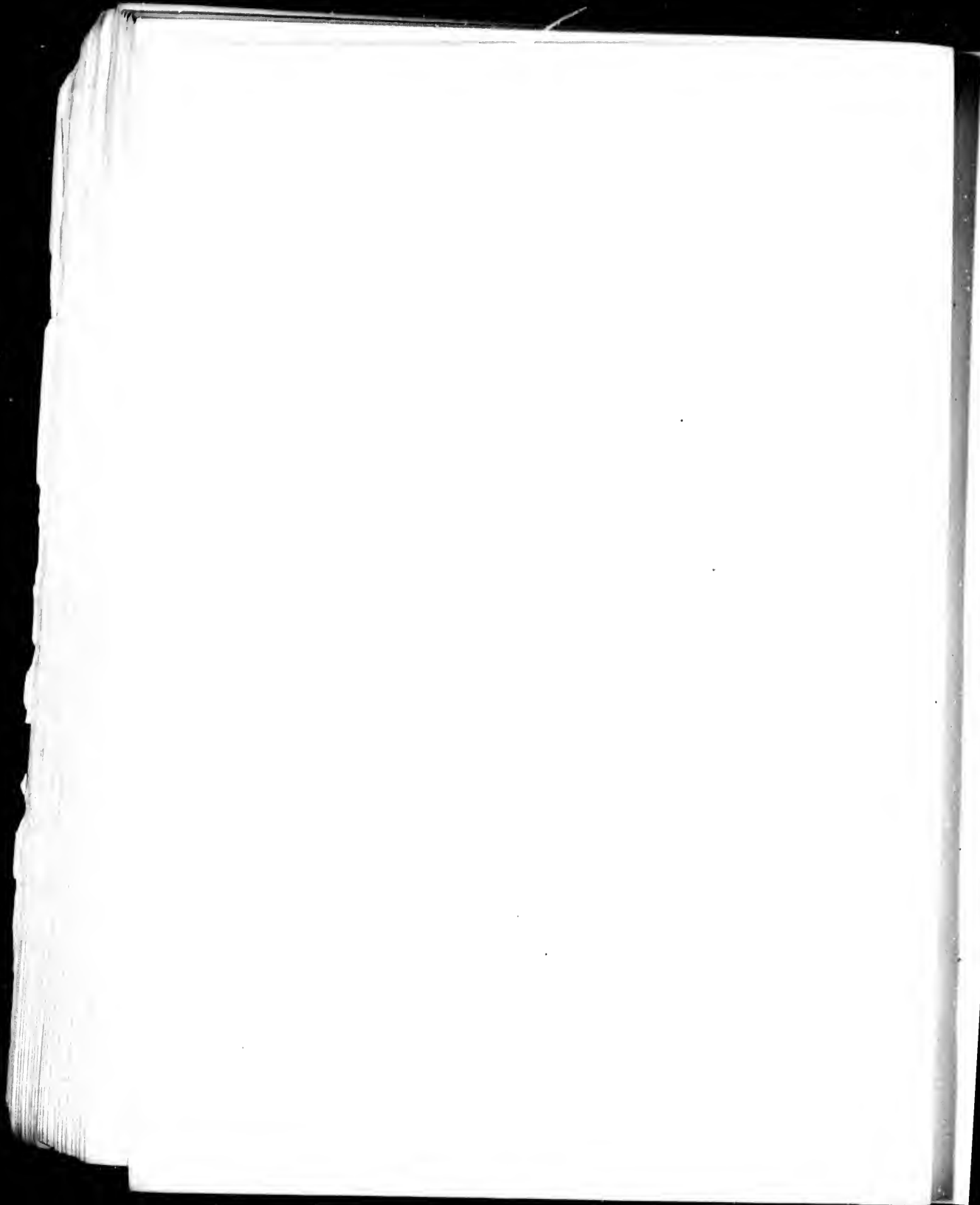

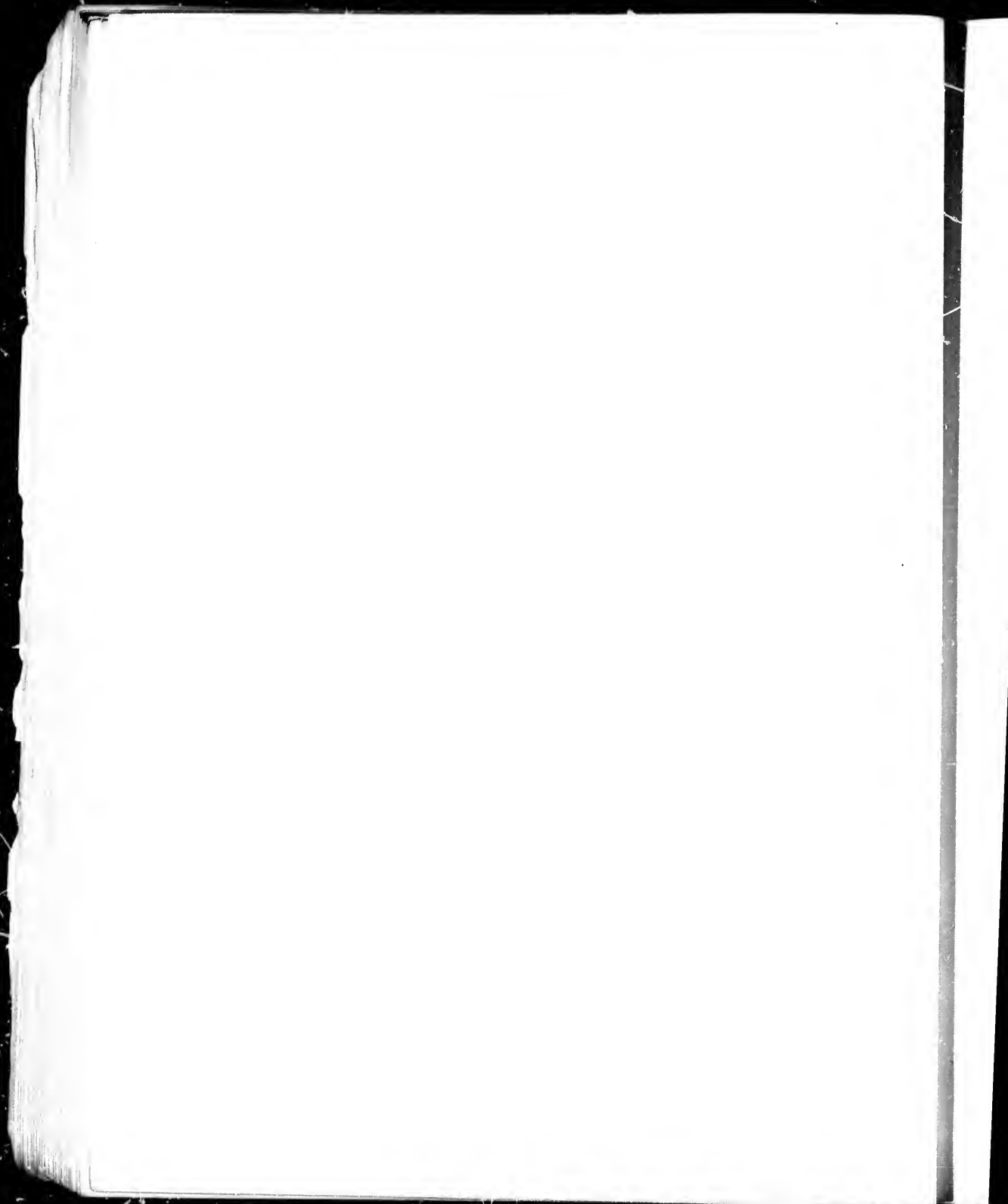

In the Department of Logic, Mental and Moral Philosophy, the Curriculum in the Faculty of Arts is hereby amended by the omission of Text Books, with the exception of Cicero de Finibus and Aristotle's Nicomachean Ethics, and the definition of the prescribed work as follows :

Pass Course—Second Examination—Logic, Names, Notions, Propositions, Syllogisms, Mental Philosophy, The Senses, The Intellect, The Emotions.

Pass Course—Third Examination—Mental and Moral Philosophy, The Will, Theory of Obligation, Ethical Systems.

Pass Course—Final Examination—Logic, Induction and the Subsidiary Operations.

Honor Course—second year—All Candidates will be examined on the papers of the Pass Course, Logic, Names, Notions, Judgments, Syllogisms, Mental Philosophy, The Senses, The Intellect, The Emotions. Honors will be awarded according to the degree of excellence exhibited in the answers.

Honor Course—third year—History of Philosophy, Ancient and Mediaeval, Cicero de Finibus, books 1 and 2 in the original.

Honor Course—fourth year—Mental and Moral Philosophy, all the work of previous years, History of Philosophy, Modern, Aristotle, Nicomachean Ethics, B. 1 to 4 inclusive in the original.

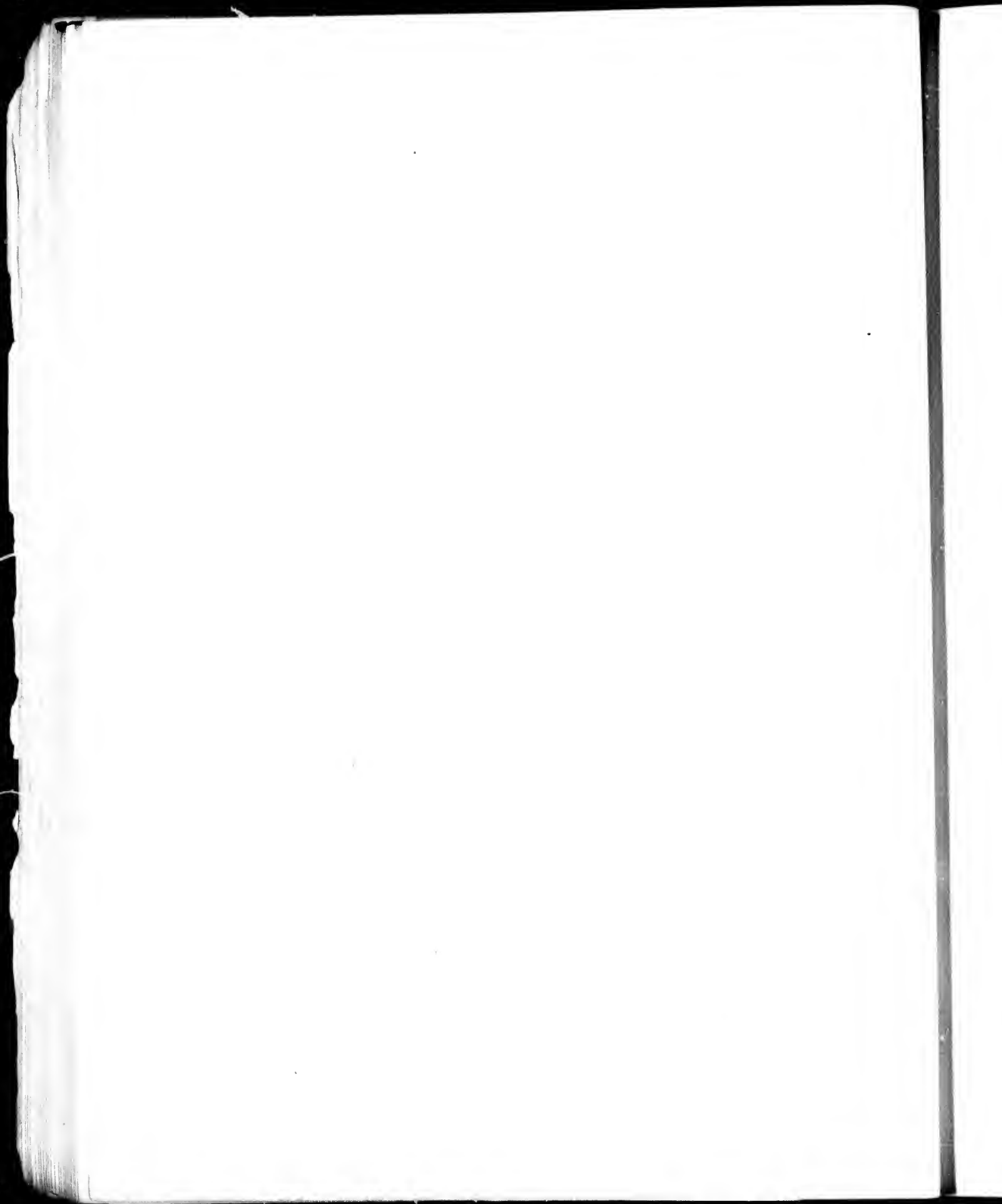

That a Candidate who competes for Honors at the Final Examination for B. A. and fails to obtain the requisite number of marks to entitle him to be classed in Honors, may be awarded a Pass Degree if the examiners certify in their report that the proficiency he has manifested fairly



entitles him to that standing, providing that it shall be at the option of the Candidate to accept of the award of a Pass Degree, or to delay to a subsequent examination and again compete for a Degree in Honors, though not for relative standing.

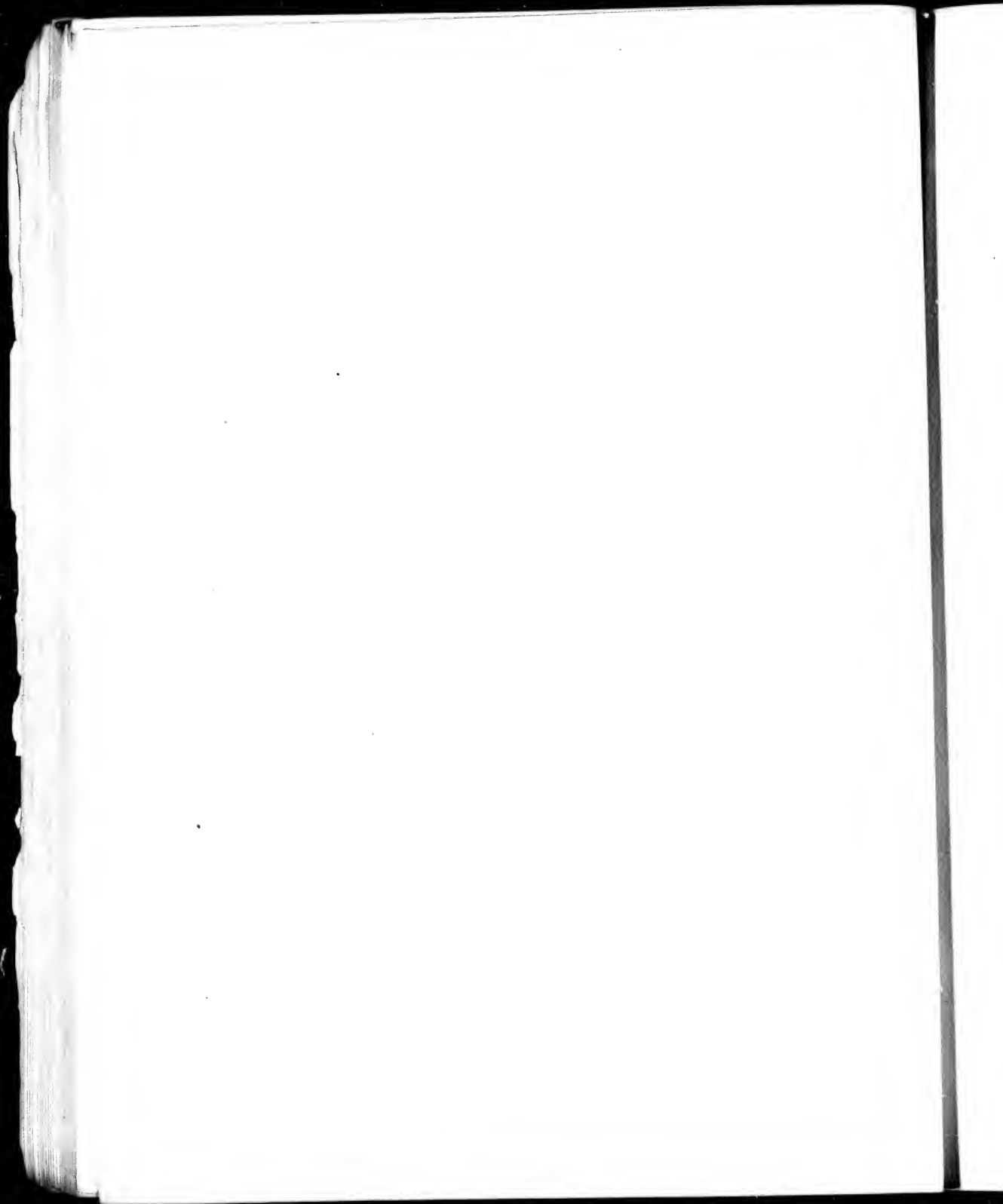

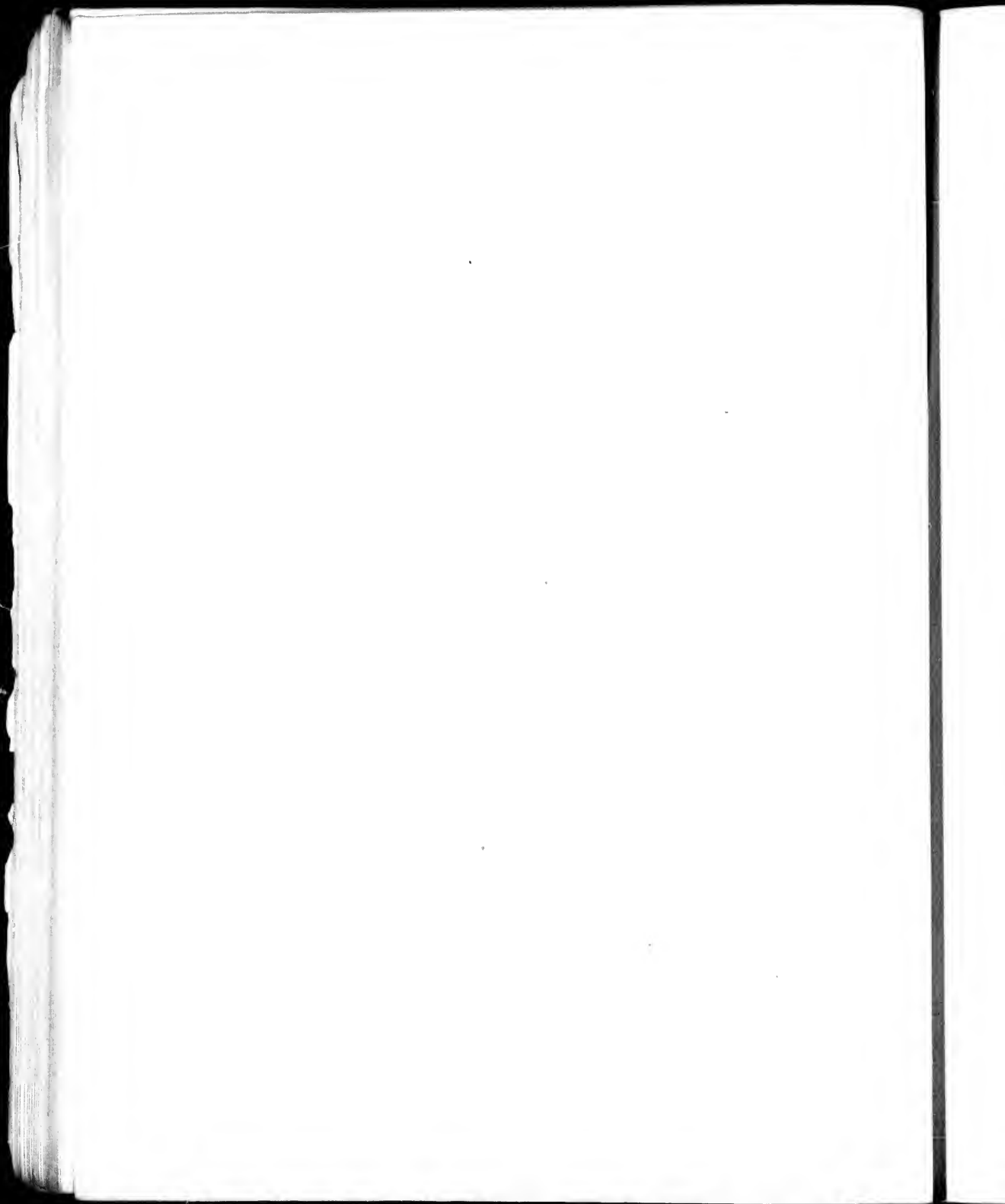

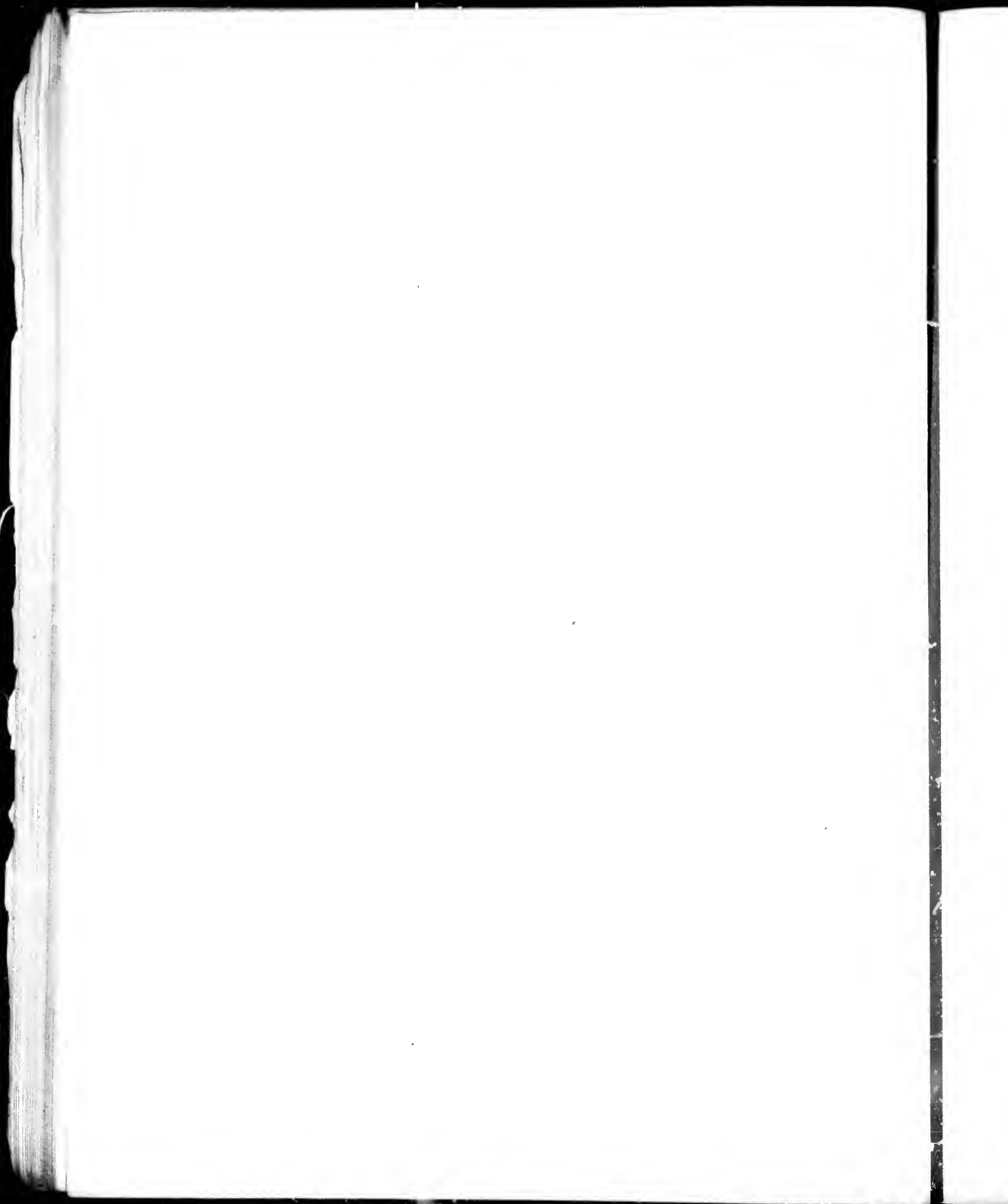

Provided always that it shall be lawful for the Senate to extend the time for, or remit the payment of, such fees in any case which the Senate shall deem it proper to do so, by reason of the inability of a Candidate to pay the same.

Subject to the foregoing provisions, all such Fees shall be payable when application is made for examination, for admission *ad eundem statum* for Registration in any Faculty for Dispensation from attendance at Lectures, or for Certificates of Honor and before the conferment of the Degree for which the Fee is to be paid.

All Statutes respecting Fees, in so far as they are inconsistent with this Statute, are hereby repealed.

The foregoing provision shall take effect on the First Day of January, 1883, except that relating to certificates of Honor, which shall take effect forthwith.

I. That the Staff of Upper Canada College shall consist of :

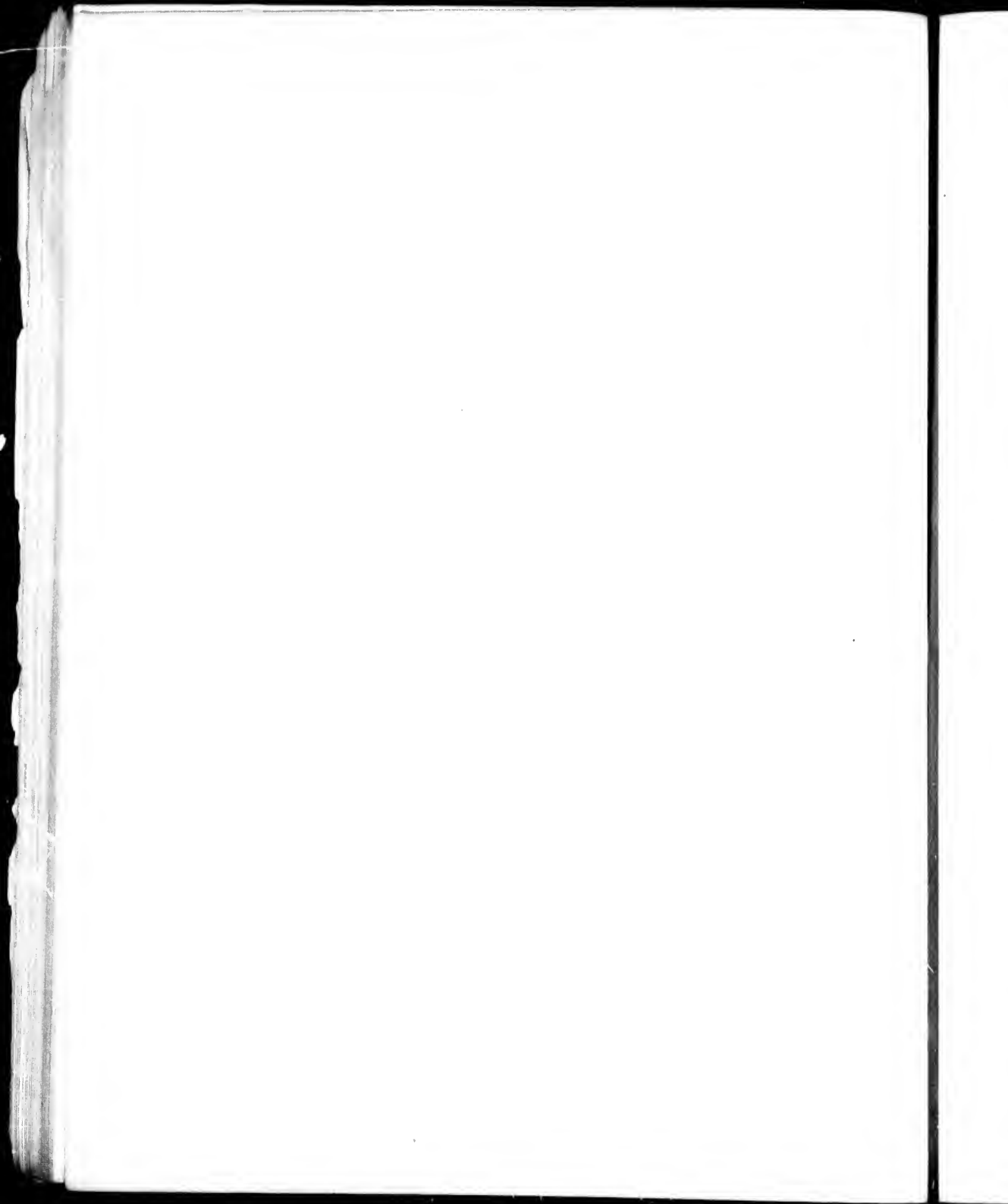

A French and German Master,

or

A French and a German Master, and as many assistant Masters as may be necessary in addition.

II. That either the First Classical, the First Mathematical, or the First English Master shall be Principal.

III. That no Officer of the College, except as hereinafter provided, shall be entitled to any share of the Fees.

IV. That the Salaries and Emoluments except as limited or changed by succeeding clauses shall be as follows :

I. The Principal shall be entitled as Principal and Master to two thousand six hundred dollars a year and residence.

II. Each other Master of the First Grade shall be entitled to one thousand six hundred and fifty dollars a year and residence.

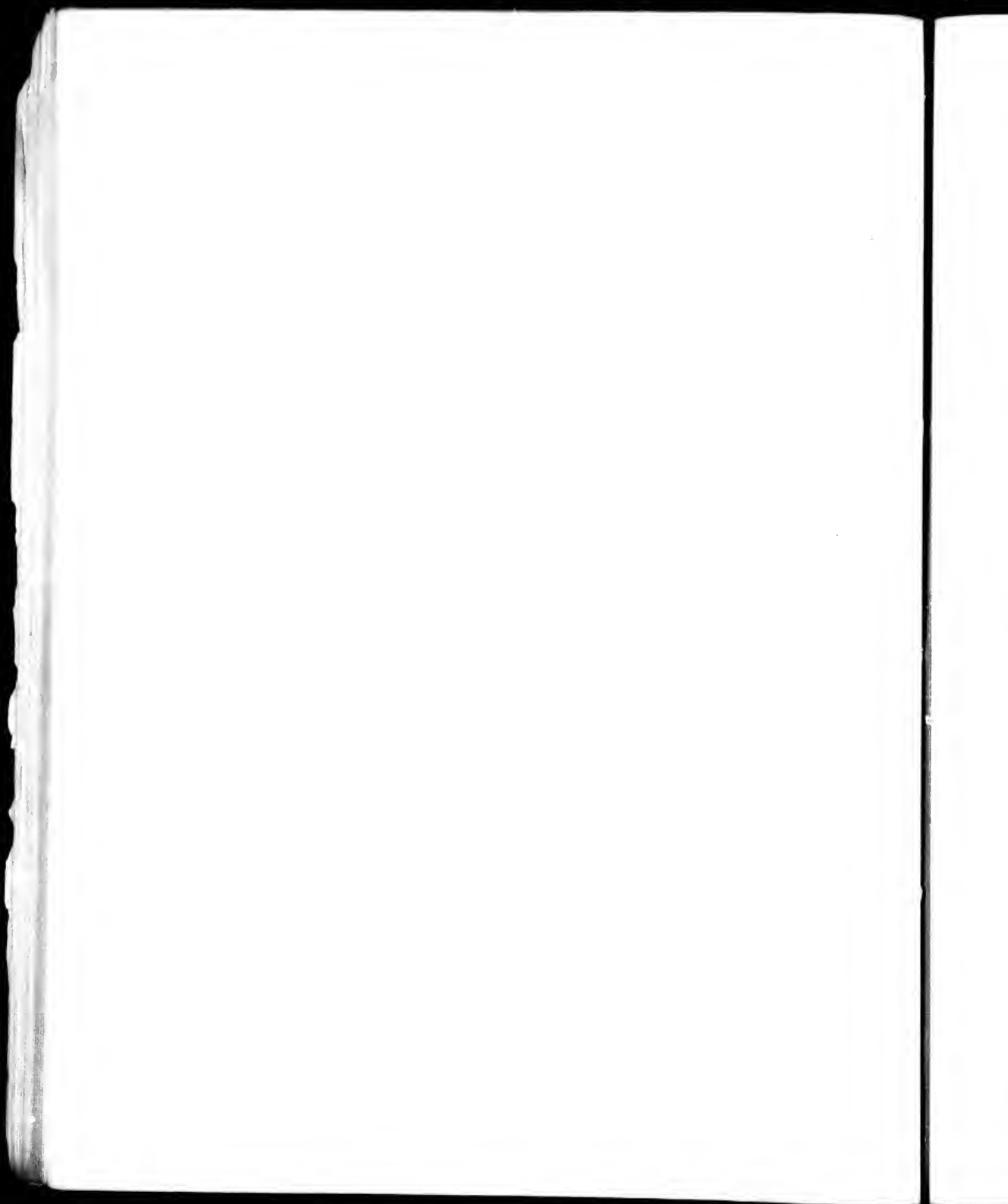
III. Each master of the Second Grade shall be entitled to one thousand two hundred dollars a year and residence.

IV. The French and German Master shall be entitled to one thousand three hundred and fifty dollars a year and residence.

If at any time it should be found difficult to secure the services of one man competent to teach both languages, a French and German Master shall be engaged at suitable salaries.

V. That the Residences mentioned in the preceding clause shall, with the exception of the Principals, be held in the understanding that whenever an increase of pupils renders increased accommodation for boarders necessary, the Senate through its committee on Upper Canada College, or otherwise, may from time to time require that such Residences, or some of them, be used as supplementary boarding houses, so long as the same shall be necessary and shall allow to the Masters whose Residences may be so utilized, such reasonable remuneration therefor and for their services as resident Masters in charge as to the Committee or Senate shall seem equitable.

VI. That one of the Masters of the College shall be Superintendent of the Boarding House.



VII. That the present Superintendent shall be relieved from teaching at half-past twelve o'clock each day, that he shall be paid for his services as Master one thousand three hundred dollars a year, and that he shall be remunerated for his services as Superintendent on the principle laid down in Statute 79, provided always that he shall not receive in any one year under this head a larger sum than one thousand dollars.

VIII. That this Statute shall take effect from the first day of July 1882.

IX. That all parts of preceding Statutes inconsistent with this Statute are hereby repealed.

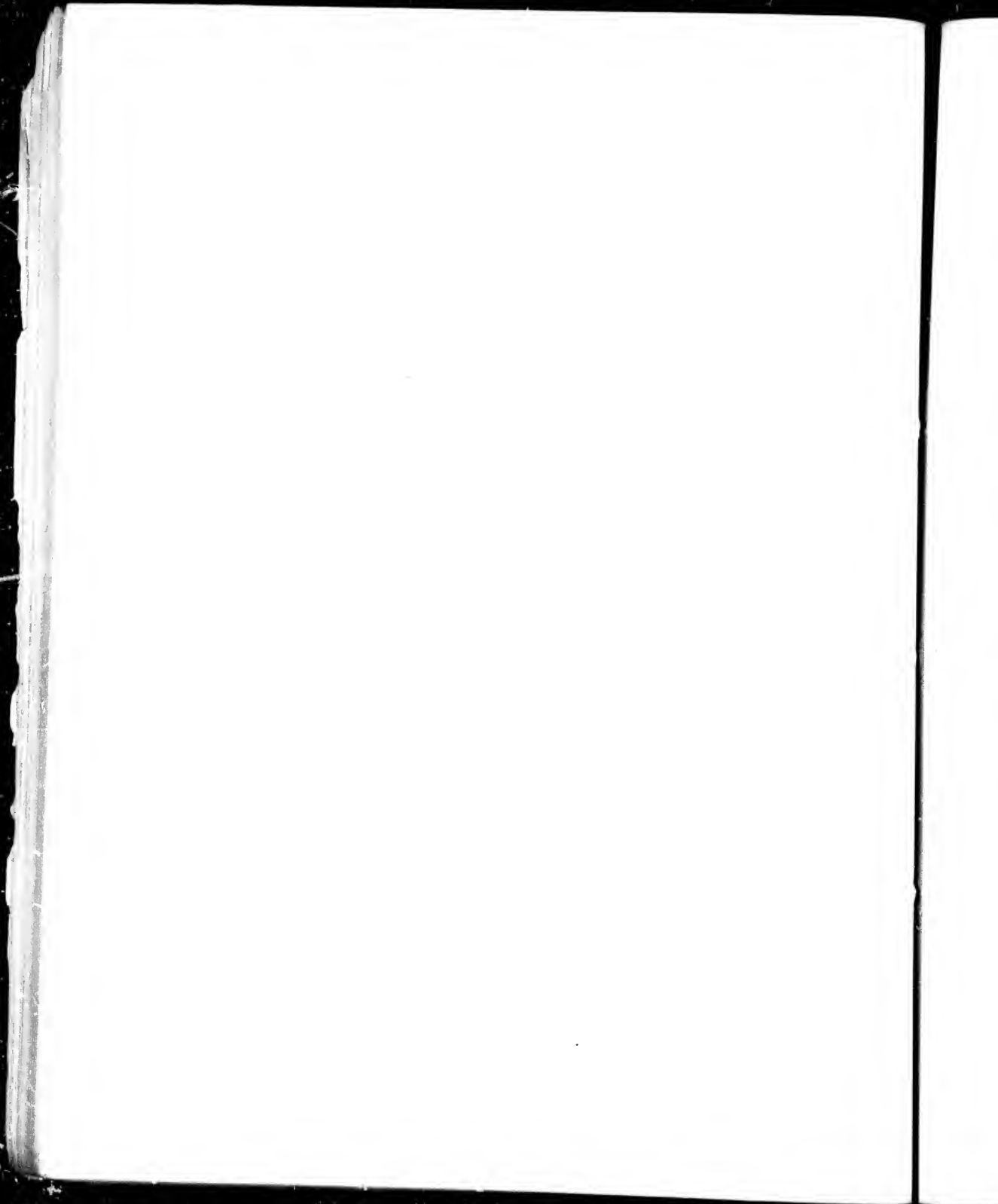

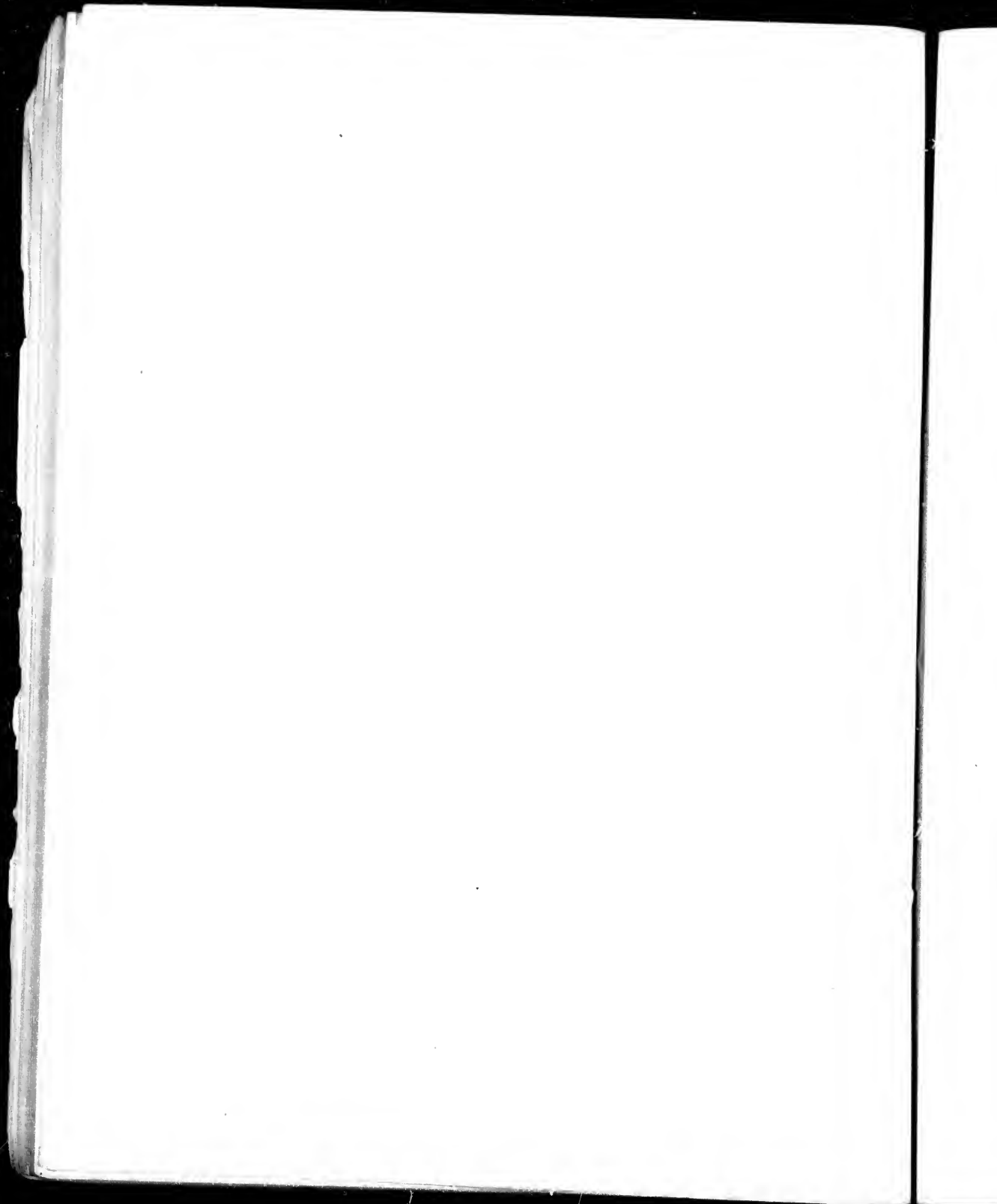
II. Four of these shall be annually awarded for proficiency in the work of the Fourth Form, and four for proficiency in the work of the Fifth Form, according to the following scheme :

One in each Form to the Candidate who, having passed a satisfactory examination in a sufficient number of subjects to enable him to Matriculate in the University of Toronto, shall stand highest in the Ancient Classics.

One in each Form on the same conditions to the Candidate who shall stand highest in Mathematics.

One in each Form on the same conditions to the Candidate who shall stand highest in Modern Languages with History and Geography.

One in each Form on the same conditions to the Candidate who shall stand highest in General Proficiency.





III. No Student shall hold more than one Exhibition at the same time, but if two or more Exhibitions have been awarded to him, he shall be entitled to receive twelve dollars out of each additional Exhibition, his Exhibition being called a Double, a Triple, &c. Exhibition as the case may be, and the Exhibitions thus diminished may be awarded to the Candidates next in rank in proportions to be decided.

IV. The Examinations shall be held at the end of the Summer Term. The Exhibitions shall be open for competition to the whole Province, and they shall be tenable for one year by pupils attending regularly at Upper Canada College or at any High School or Collegiate Institute in Ontario.

V. All persons who intend to become Candidates in any year for these Exhibitions shall give notice to the Principal of the Upper Canada College on or before the eighth day of June of that year.

VI. The Principal of the Upper Canada College shall annually name examiners to conduct the Exhibition Examinations and report the result to him.

VII. All preceding Statutes or parts of Statutes relative to Exhibitions in Upper Canada College are hereby repealed.

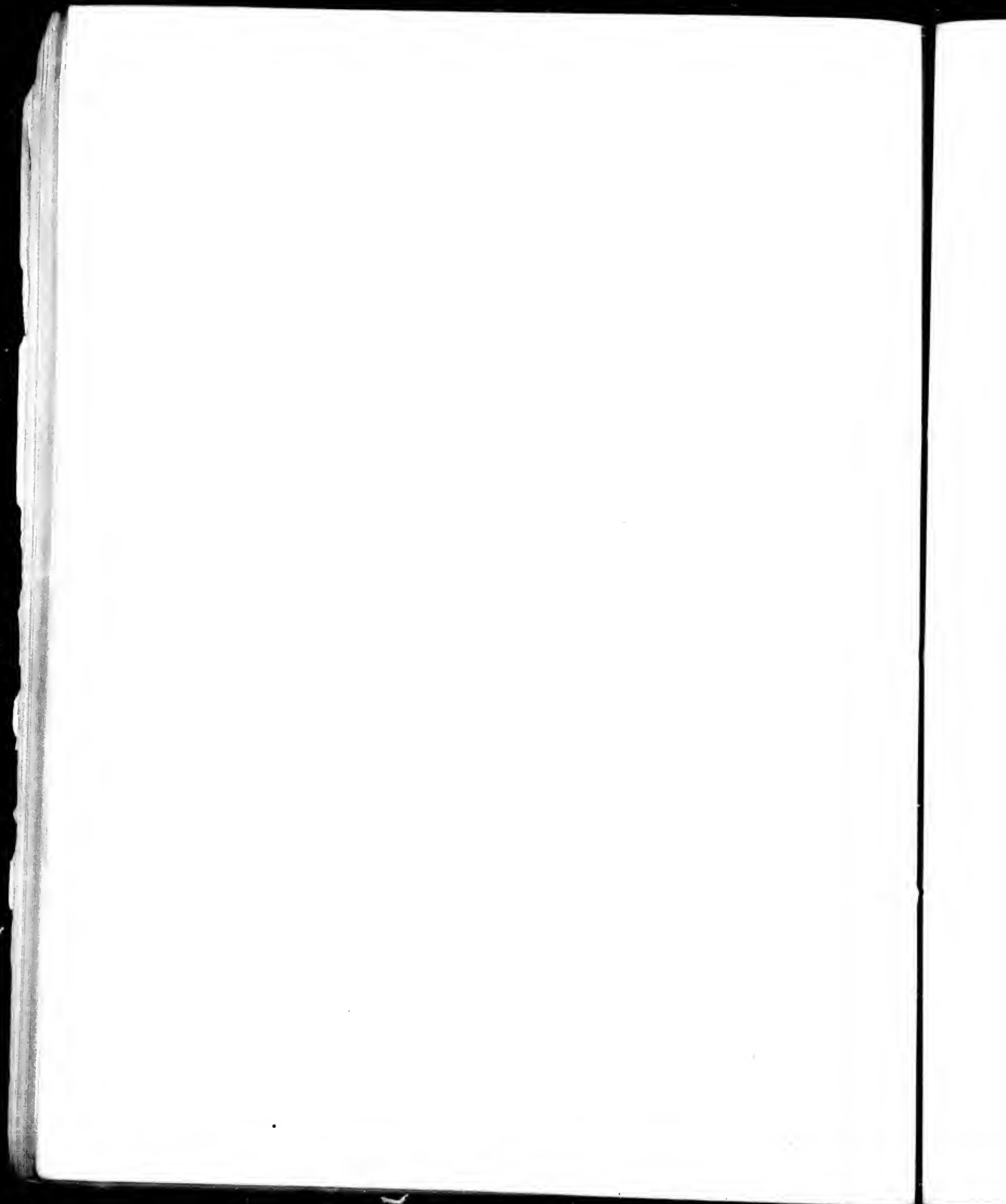

That in Statute 111 the following changes and additions be made :

In clause 7 all the words preceding the words " and the papers shall be distributed " be struck out and the following inserted in their place : " The examinations shall be upon the subjects specified for Junior Matriculation and for the examinations of the first and second years and upon the Mental and Moral Philosophy of the third Examination in the Faculty of Arts. The first Examination shall be held simultaneously with the ordinary June Matriculation Examination and the second and third Examinations shall be held simultaneously with the ordinary May Examination in the Faculty of Arts.

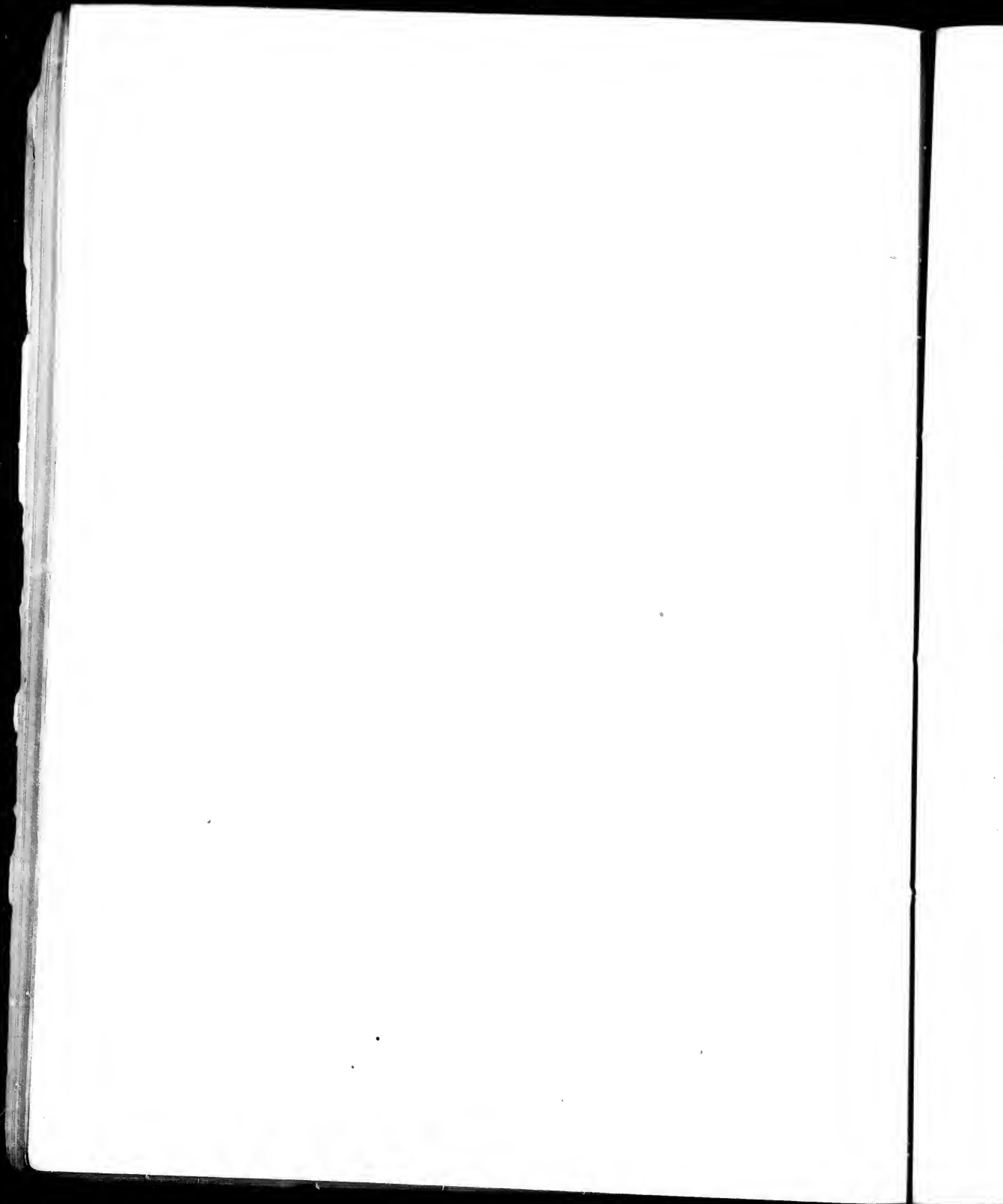

GROUP 6.—The Chemistry and Mineralogy of the second Examination in the Faculty of Arts.

GROUP 7.—The Mental and Moral Philosophy of the third Examination in the Faculty of Arts.

STATUTE CXLVI.

RESPECTING THE MARY MULOCK CLASSICAL SCHOLARSHIP.

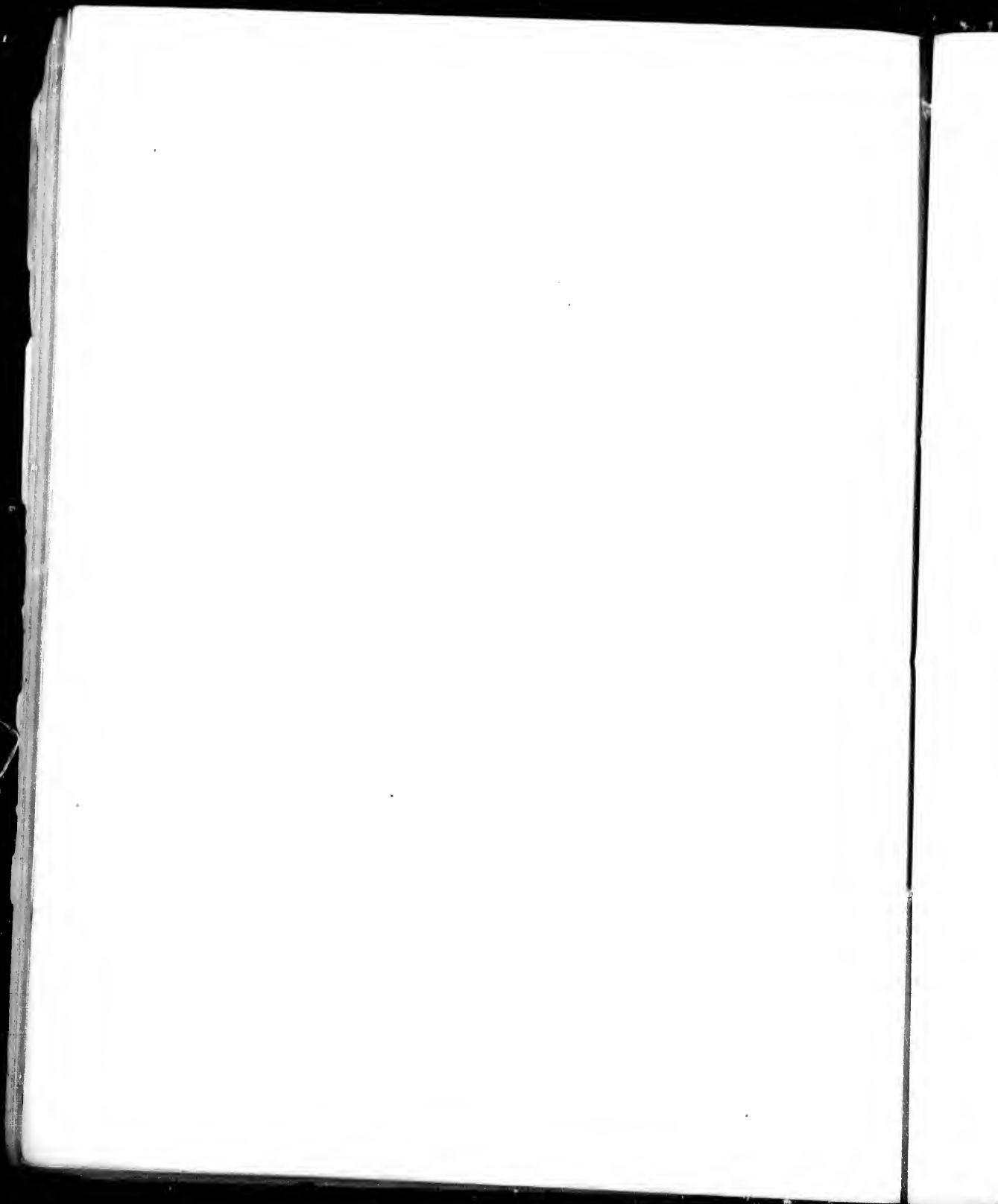

That the Arts Curriculum be amended by inserting on page 31 line 5, after the word "Classical" the words "the Mary Mulock Scholarship," and by adding on page 34 the following paragraph :

The Mary Mulock Classical Scholarship. The late Mrs. Mulock having donated the sum of \$2000 (which with accrued interest amounts to \$2250) for the encouragement of the study of the Greek and Latin Classics, a Scholarship of the value of \$20 will be annually offered for competition at the Junior Matriculation Examination, and shall be known as the Mary Mulock Classical Scholarship.

STATUTE CXLVIII.  
RESPECTING ATTENDANCE AT LECTURES IN  
AFFILIATED COLLEGES.

That Undergraduates are required to attend as Matriculated Students one of the Colleges affiliated to the University of Toronto; but in special cases, upon adequate reason being shown for asking exemption, the Senate may dispense with this rule.

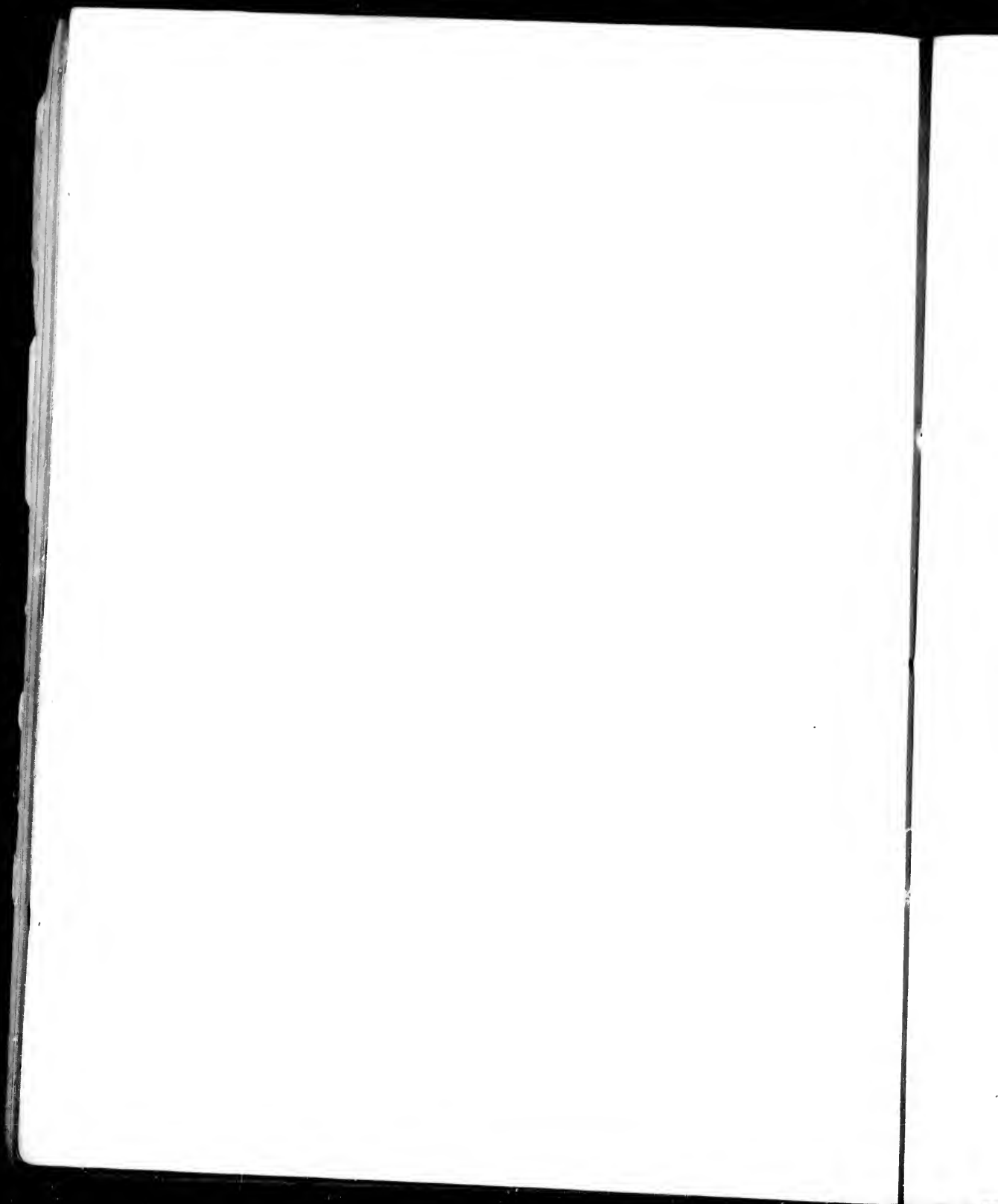
STATUTE CXLIX.  
RESPECTING AGE LIMIT OF SCHOLARS AT  
JUNIOR MATRICULATION.

That the regulation respecting Scholarships contained in the fourth paragraph on page 32 of the Arts Curriculum of 1880, enacting that "at Junior Matriculation no Scholarship will be awarded to any candidate who, at the time of the commencement of the examination, is more than 23 years of age," be repealed.

STATUTE CL.  
RESPECTING DEGRADING IN ARTS AND  
MEDICINE.

That the Regulations relating to the Honor Course in Arts be amended by omitting the paragraph on page 7 of the Arts Curriculum of 1880, beginning, "No Undergraduates in the Honor Course" and ending, "or for other grave reasons," and that the regulations relating to the Honor Course in medicine be amended by omitting the same regulation on page 7 of the Medical Curriculum of 1881.

STATUTE CLI.  
RESPECTING DEGREE OF C. E.

---

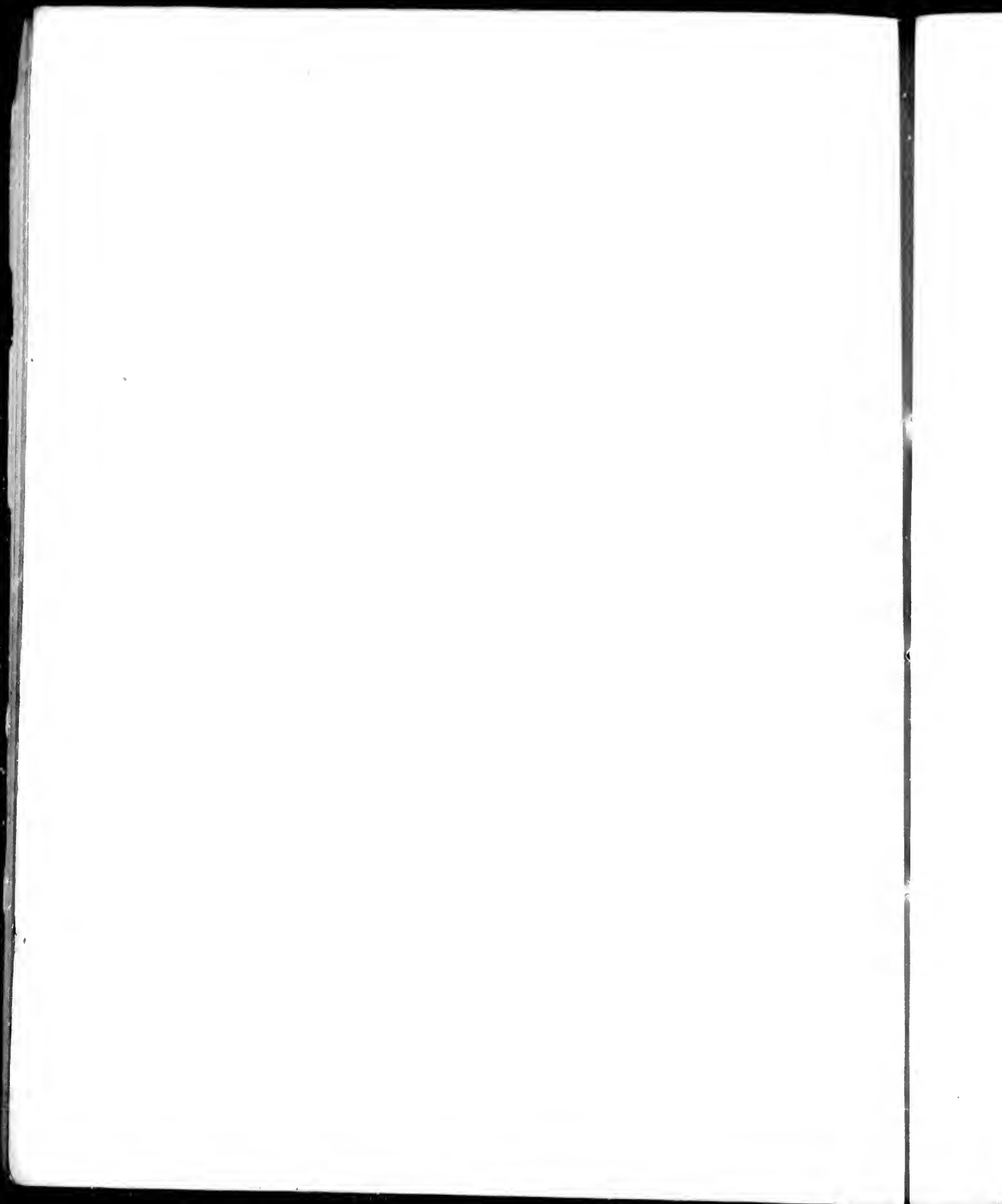
I. That all previous Statutes of the University relating to Degrees or Diplomas in Civil Engineering be hereby repealed.

II. That the Degree of C. E. be hereby established, to be granted subject to the following conditions and regulations:—

(1) Candidates for the said Degree shall hold the Diploma in Civil Engineering of the Ontario School of Practical Science.

(2) Candidates shall have spent three years after receiving the said Diploma in the actual practice of the profession of Civil Engineering.

(3) Candidates shall have spent, at least, two years of the said period in the construction and operation of engineering works as distinguished from surveys merely.



(4) Satisfactory evidence shall be offered as to the periods spent on the different classes of engineering employment, and intervals during which the Candidate was not engaged in the construction or operation of engineering works, or in the prosecution of surveys shall not be included as portions of the aforesaid period of three years.

(5) It shall not be necessary that the several intervals required to make up the period of three years be consecutive.

(6) Each Candidate shall prepare for the approval of the Senate an original essay on some engineering subjects, accompanied with detailed explanations, drawings, specifications and estimates. He shall also be examined on the subject of the essay, as well as on the work or works on which he has been engaged, unless exempted therefrom on the special recommendation of the examiners.

(7) The subject of the said essay shall be forwarded to the Registrar for the approval of the Senate, not later than the first day of February.

(8) Candidates shall notify the Registrar of their intention of proceeding to the Degree of C. E., not later than the first day of April.

(9) The evidence required in Section 4, together with the essay, drawings and estimates shall be sent to the Registrar not later than the first day of May.

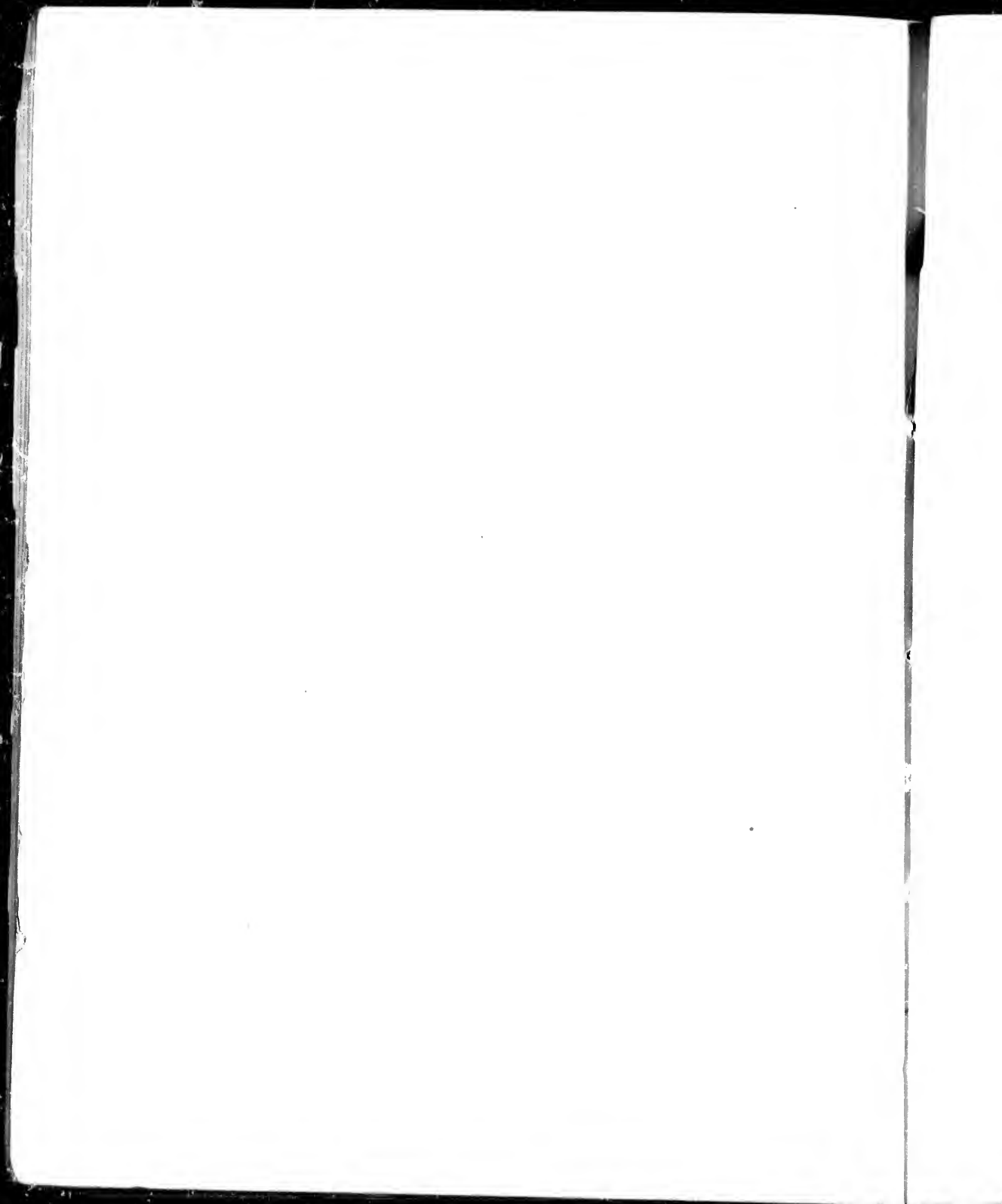
(10) The examination of the essay, drawings and estimates, and any further examination of the Candidate that may be considered necessary may be held in May.

(11) The fee for the degree of C. E. shall be twenty dollars and shall be paid to the Registrar not later than the first day of May.

(12) The essays, drawings and estimates submitted by the Candidates shall be the property of the University.

STATUTE CLII.  
RESPECTING MEDICAL EXAMINATIONS.

---

That in the Faculty of Medicine the Senate may allow a Candidate to take two professional examinations at the same time.

That the Statute shall be held to have come into effect at the examinations held in the month of April, 1884.

(Passed June 6, 1884.)
