2nd. The club agents fly around and pick up the customers or would-be customers of the news dealer.

3rd. The great bulk of the orders are sent direct to the publisher and the dealer is cut off from all chance of profit. In many cases his regular, every day, subscribers dropping him for the season and sending in their orders direct.

Come, now, Messrs. Publishers, give us fair play. It will not hurt you and will help us. Last year a leading journal refused to give special rates to the season and they claimed rightly the public could and should pay regular prices when the papers were at their best.
