CONSTITUTION

Article I.

This Club shall be called the Argonaut Name Rowing Club.

Article II.

Sec. 1.—The object of the Club shall be the encouragement of rowing, sailing and aquatic sports generally, and other forms of athletic exercise among amateurs. Objects.

Sec. 2.—An amateur is a person who has not competed in any competition for a staked bet, money, private or public, or gate receipts, or competed with or against a professional for a prize; who has never at any period of his life taught or assisted in the pursuit of any athletic exercise or sport as a means of livelihood; who has never, directly or indirectly, received any bonus, or any money consideration whatever, for any services rendered as an athlete, excepting his actual traveling or hotel expenses; who has never entered into any competition under a name other than his own, or has never been guilty of selling or pledging his prizes.

Definition
of an
Amateur.

Article III.

Sec. 1.—The colors of the Club shall be Oxford Blue and Cambridge Blue. Colors.

Sec. 2.—The Club ribbon shall be two inches in width and of slanting alternate stripes of dark and light blue, arranged in the following series: stripe of dark blue seven-

Ribbon.

eighths of an inch in width, stripe of light blue one-quarter of an inch in width, stripe of dark blue one quarter of an inch in width, stripe of light blue one-quarter of an inch in width, and so on in the same order.

Uniform.

Sec. 3.—The Club uniform shall consist of jersey in Club colors in horizontal stripes, two inches wide, with dark blue knickers.

Members.

Article IV.

Sec. 1.—The membership of the Club shall be confined to amateurs and divided into five classes, honorary, life, active, inactive and non-resident.

Sec. 2.—An honorary member shall be one to whom the freedom of the Club has been presented for important services rendered to the Club or its representatives. He shall be exempt from payment of any fees, and shall be entitled for life to all the privileges of the Club.

Sec. 3.—Life, active and non-resident members shall be entitled to all the privileges of the Club.

Sec. 4.—An inactive member shall only be entitled to the privileges of access to the Club's premises and the use of the periodicals on the files.

Sec. 5.—A non-resident member is one who resides more than twenty miles from the City.

Election.

Article V.

Sec. 1.—Honorary members may only be elected at a general meeting of the Club by unanimous vote.

Sec. 2.—Every other candidate for membership shall be proposed by one and seconded by another Honorary, Life or Active member in a written application to the

Secretary-Treasurer, containing the name, occupation and address of the applicant, the grade of membership for which he is proposed, and the signature of his proposer and seconder.

Sec. 3.—If the application be made between the 15th day of April and 30th day of September inclusive, the Secretary-Treasurer shall forthwith post the same at the Club house, and no applicant shall be eligible for membership until the application shall have been posted for at least one week.

Sec. 4.—After the expiration of one week from the date of posting, the Secretary-Treasurer shall submit the application to the Executive at their next meeting, who, if no ballot has been demanded, shall, in their discretion, either direct the same to be held over for a subsequent meeting or declare the applicant elected.

Sec. 5.—If the application be made between the 30th day of September and the 15th day of April, exclusive, the Secretary-Treasurer shall, within reasonable time of the receipt thereof, mail to every Life or Active member in Toronto, a notice setting forth the particulars of the application. If no ballot be demanded within one week from the posting of the notices, the Secretary-Treasurer shall submit the application to the Executive, pursuant to section 4 of this article, and the election shall proceed as therein provided. If a ballot be demanded, the Secretary-Treasurer shall hold the application over until after the 15th day of April.

Sec. 6.—In the event of premises being secured for the use of the members during the winter months, applications for membership, to which the next preceding section applies, and the notice of a ballot, if such is demanded, shall be posted at such premises,

and the election shall in other respects proceed as if section 5 of this article had not been passed.

Ballot.

Sec. 7.—A Life or Active member may compel a ballot to be taken by notifying any member of the Executive of such his desire. When a ballot is demanded, the election shall proceed as provided by section 8, unless the application be withdrawn.

Sec. 8.—On a ballot being demanded the Secretary-Treasurer shall post a notice to this effect at the Club house or winter premises, as provided in section 6 of this article, stating the particulars required by section 2, and the place and time fixed for the proposed ballot. No ballot shall be held until such notice has been posted one week.

Each member voting shall write his name on a card and insert the same with a white or black ball in the ballot box. The Secretary-Treasurer and one member of the Executive, or, in the absence of the Secretary-Treasurer, two members of the Executive, shall, after the hour fixed for the close of the ballot, open the box and ascertain the result. One black ball in five shall exclude, and no ballot shall be valid unless twenty-five votes be cast. In the event of an irregularity in the ballot affecting the result, another or more ballots may be held at such time, and on such notice as the Executive shall direct, but no ballot shall be declared void for irregularity not affecting the result.

Sec. 9.—An Active member in good standing may become a Life member on being elected in the usual manner.

Sec. 10.—An Inactive member in good standing may become a Life or Active member on being elected in the ordinary manner.

Sec. 11.—No rejected applicant shall be

permitted to apply for membership within six months of his rejection.

Article VI.

Sec. 1.—Any member of a regularly organized Amateur Rowing Club, at home or abroad, not resident in Toronto, may be admitted as a Privileged member during a period not exceeding two weeks in any one year, on being introduced by any member not belonging to the Inactive class.

Privileged
Members.

Sec. 2.—Any member not belonging to the Inactive class may introduce as a Visiting member, for a period not exceeding two weeks in any one year, any person resident at a distance of not less than twenty miles from Toronto, provided his name be approved of by one member of the Executive.

Visiting
Members.

Sec. 3.—Privileged members shall be entitled, during the period for which they are admitted, to all the privileges of Active members, so far as regards the use of the Club premises and property. Visiting members shall be entitled to all the privileges of Inactive members.

The admission of Privileged and Visiting members may be extended for a further period of two weeks on the approval of the Executive.

Sec. 4.—The names of all Privileged and Visiting members shall be posted during the period for which they are admitted, together with the names of the members by whom introduced and approved.

Article VII.

Sec. 1.—Life members shall pay a fee of Fees.
\$100 in one sum.

Sec. 2.—Active members of seven consecutive years' standing, may become Life members on payment of \$75.00 in one sum.

Sec. 3.—Active members of fifteen years' good standing shall automatically become Life members by virtue of such term of membership.

Sec. 4.—Active members shall pay an annual fee of \$15.00 on or before the 1st day of July in each year, such fee to include locker and towels as required.

Sec. 5.—Non-resident members shall pay an annual fee of \$5 (such membership not to count in the purchase of a Life membership).

Sec. 6.—Inactive members shall pay an annual fee of \$5.

Sec. 7.—The annual fee shall be due on the first day of May.

Sec. 8.—All applications for membership shall be accompanied by the required fee, and no application shall be considered unless this condition be complied with. In the event of an application being rejected the fee shall be returned to the applicant.

Article VIII.

Defaulter.

Sec. 1.—It shall be optional with the Executive to post any defaulter on or after the first day of July, and to suspend or expel him on or after the first day of August, but any member whose annual fee is unpaid by the first day of November, shall, ipso facto, become suspended as a member of the Club.

Any suspended member shall continue to be liable for all arrears of fees and charges, notwithstanding such suspension.

Sec. 2.—Any member expelled or struck off as above provided shall still be liable for all arrears, but may, upon payment thereof, be proposed and elected in the usual manner.

Article IX

Sec. 1.—Any member desiring to resign must do so by notifying the Secretary-Treasurer in writing before the first day of June. All resignations shall be submitted to the Executive, and the sender notified of the action taken thereon. Resignations.

Sec. 2.—No resignation shall be accepted after the first day of June, except upon payment of all arrears and of all fees due for the current year, unless the failure to send in the resignation be explained to the satisfaction of the Executive.

Article X.

Sec. 1.—The annual general meeting shall be held on the second Friday in March. Meetings.

Sec. 2.—The Secretary-Treasurer shall, at any time, upon a requisition signed by any five members of the Club (none of whom shall be Inactive members), or by order of the Executive, call a special general meeting.

Sec. 3.—All general meetings shall be called by giving every Honorary, Life and Active member resident in Toronto one week's notice, in writing, of the place and the date fixed for the proposed meeting, and the business to be transacted thereat.

Sec. 4.—Only members in good standing may vote at any meeting of the Club.

Sec. 5.—A quorum shall consist of twelve members (Honorary, Life or Active), and no meeting shall be competent to transact business unless a quorum be present.

Sec. 6.—The Executive shall meet at the call of the Secretary-Treasurer upon order of the President, or upon the written request of three members of the Committee, on receiving forty-eight hours' notice, and at such other times as they may agree on.

Article XI.**Officers and Committees.**

Sec. 1.—The officers of the Club shall be an Honorary President, President, First Vice-President, Second Vice-President, Captain, Vice-Captain, Honorary Secretary, Secretary-Treasurer and with eight Committee men shall form the Executive of the Club. All past Presidents, so long as they remain members of the Club, shall be ex-officio members of the Executive Committee.

Sec. 2.—There shall be a Rowing Committee, consisting of the Captain, Vice-Captain and three members to be selected and appointed by the Executive from among themselves at an early meeting after their election.

Sec. 3.—There shall be a House Committee, consisting of the Honorary Secretary and three other members, to be annually appointed by the Executive from among themselves at an early meeting after their election.

Nomination.

Sec. 4.—Nominations for the Executive Committee shall be made in writing to the Secretary-Treasurer during the week ending on the day prior to that of holding the annual general meeting (second Friday in March).

Election of Officers and Executive Committee.

Sec. 5.—The officers (except the Secretary-Treasurer) and members of the Executive, shall be elected by ballot by majority vote at the annual general meeting. The Secretary-Treasurer shall be appointed by the Executive Committee, and shall perform such duties as may be assigned to him by the President or the Executive Committee, in addition to the duties prescribed in section 4, article XII.

Article XII.

Sec. 1.—It shall be the duty of the President to preside at all meetings of the Club and Executive, to enforce the Constitution, By-laws and Rules, and generally to supervise the affairs of the Club.

Duties of
Officers.

Sec. 2.—The first or second Vice-President, as the case may be, shall, in the absence of the President, perform the latter's duties, and they shall assist that officer in a general way in the discharge of his duties.

Sec. 3.—It shall be the duty of the Captain to have the control of all Club boats and apparatus, of which he shall keep an inventory, and he shall see that they are kept in proper repair. (Any crew injuring any of the Club boats through careless handling will be charged with the expense of repairing same, subject to the discretion of the Executive Committee). The Captain shall be Chairman of the Rowing Committee and shall superintend generally and promote the best interests of the Club in rowing matters.

The Vice-Captain shall assist the Captain in all the duties above outlined.

Sec. 4.—It shall be the duty of the Secretary-Treasurer to call meetings of the Club and Executive, to conduct the correspondence, post all notices, by-laws, and rules, to notify candidates of their election and members desiring to withdraw of the action taken on their resignation, to keep an account with each member of the Club, to collect all dues and receive and account for all moneys belonging to the Club and to disburse same under the instructions of the Executive Committee, without whose order no money shall be paid out. He shall prepare an annual statement and cause same to be audited, printed and distributed during the first week

after the close of the fiscal year. The fiscal year shall end on the last day of February.

He shall keep and be responsible for all books and records of the Club, keep a record of all aquatic matters of interest to the Club, keep correct minutes of all meetings of the Club and Executive and generally advance the welfare of the Club, and he shall enjoy all the privileges to which members of the Executive Committee are entitled.

Sec. 5.—The Secretary-Treasurer to be a paid officer, his salary to be decided upon by the Executive Committee; and he shall furnish a bond to the club in a sum to be decided upon by the Executive Committee for the faithful discharge of his duties.

Auditor.

Sec. 6.—The annual statement rendered by the Secretary-Treasurer shall be certified by a Chartered-Accountant, who shall be appointed by the Executive Committee.

Article XIII.

The
Executive.

Sec. 1.—The Executive shall have the entire management of the affairs of the Club, with full power to take whatever steps they may deem advisable in its interests, and to repeal, pass or amend such By-Laws and Rules as, from time to time, they may think fit, provided, by so doing, they do not infringe the Constitution. All By-Laws and Rules passed or amended and notices of all By-laws and Rules repealed shall be posted. They shall enforce the observance of the Constitution, By-laws and Rules, and they shall have control of all Club funds, with power to invest any part of them in such securities as they may think fit. They shall be responsible to the Club for their actions, and the entire body, or any member or members thereof, shall be liable to expulsion from office, or from the Club, by a two-

thirds' vote of those present at a meeting of the Club.

Sec. 2.—It shall be the duty of the Rowing Committee to choose all representative crews, and the crews for the Club races, and they shall be responsible for their proper training. They shall also have control of the gymnasium apparatus, and shall advise and assist the Captain in the discharge of his duties. It shall also be their duty to arrange all regattas, and the rules under which they shall be managed, and to direct generally this department of the Club.

Sec. 3.—It shall be the duty of the House Committee, through its Chairman, to see that the caretaker fully performs his duties, to see to the proper storage of private boats and to supply the files with proper papers and periodicals, and to provide for the general comfort and convenience of the members.

Article XIV.

Sec. 1.—In the event of a vacancy occurring in the Executive or other committees, the Executive shall have power to fill the same and shall do so within one month from the time the vacancy occurred.

Vacancy.

Sec. 2.—Should any member of the Executive or Rowing Committee be absent from three consecutive meetings without a satisfactory excuse, he shall be liable to expulsion from office, by a majority vote of the Executive Committee, and the place of any member so expelled shall be filled pursuant to the preceding section.

Neglect
of Duty.

Sec. 3.—A quorum of the Executive shall consist of five members, and the Rowing Committee of three members, and no meeting shall be competent to transact business unless a quorum be present.

Quorum.

Article XV.

Subsidiary
Clubs.

Any organization formed within the Club or subsidiary to it and for which the Argonaut Rowing Club may in any way be, or be regarded as, responsible and bearing the name Argonaut or any other name, and having for its object the promotion of athletics in any form or for social purposes, shall first have obtained the consent, revocable at will, of the Executive Committee of the Argonaut Rowing Club, to such organization; and shall have as its officers, who shall be members of the Managing Committee, the elected officers (except the Captain and Vice-Captain who shall be members of the Managing Committee of such organization) of the Argonaut Rowing Club in their respective capacities; and the Managing Committee of such organization shall not consist of more than six members, (exclusive of the Captain and Vice-Captain of the Argonaut Rowing Club as already provided) who shall be elected by such subsidiary organization.

Article XVI.

Expulsion.

The Executive may suspend any member whose conduct, in their opinion, merits such a course, and shall in such a case forthwith direct the Secretary-Treasurer to call a meeting of the Club, in whom alone the power of expulsion shall rest. A vote of two-thirds of the members present at such meeting shall be required to expel.

Article XVII.

Assessment.

All Life members, elected after the 7th day of April, 1886, and all Active members shall be liable to be assessed for Club purposes. No assessment shall be valid unless ordered at a general meeting of the Club by a two-thirds vote of those members present.

Article XVIII.

Sec. 1.—No alteration shall be made in this Constitution except at a general meeting and upon mention being made in the notices calling the same of the nature of the proposed alteration.

Sec. 2.—A copy of the Constitution shall be sent to every member of the Club upon election.

Sec. 3.—Every member on his election shall be held to have notice of, and to be bound by, the Constitution, By-laws and Rules of the Club.
