CARSON'S CAMPAIGN AGAINST HOME RULE PROVES A FIZZLE

Rabid Unionists Admit It is No Longer a Factor

"THE BELFAST COMEDY"

Daily Mail's Account of the Proceedings in Ulster Yesterday—Prominent London Paper Gives up Fight Against Irish Parliament—Suffragette Attacks Churchill

(Canadian Press) New York, N. Y., Feb. 9.—A London cable to the Times, this morning, says:—

With the notorious ending of the Belfast comedy, it is now clear that, even of the rabid type, that opposition to home rule as represented by Sir Edward Carson, can no longer be regarded as a serious factor.

And the reports of the day's proceedings in Ulster yesterday, as reported by the Daily Mail, it is a dispatch conspicuously non-partisan.

"No home rule," Mr. Churchill himself, in great contrast to Mrs. Churchill, who had been a member of the Ulster League, appeared at a journey-ridden, sea-sickness sufferer.

"Belfast had at least as gloomy a reception as Mrs. Carson's, who was met by a group of men, some of whom were carrying flags and banners.

"Outside the Great Central Hotel, where the party proceeded for breakfast, the most obvious feature of the scene was the one note of energy of exceptional interest that so far had cheered the proceedings.

"Mr. Churchill's progress from Central Belfast to the Celtic football ground, was in effect with a very different reception from that which he had met with in London.


"At the Celtic club ground, Mr. Churchill received a boisterous welcome together with John Redmond and Mr. Devlin—striking trio.

CHURCHILL'S GREAT BELFAST SPEECH

London, Feb. 9.—(Through reuter's Ottawa agency)—In his speech at Belfast yesterday, Hon. Winston Churchill said that the case of Home Rule rested upon three main sets of arguments—The imperial argument, the home of commons argument, and the Irish argument. He especially emphasized the imperial argument as the largest and widest, and said the settlement of the long quarrel between the British government and the Irish people would be to the British Empire as liberating a treasure beyond comparison.

In his own island the Irish race had increased. While the population of Ireland had decreased, but elsewhere all over the world the Irish held their own, and in every country where English is spoken the Irish are a power—a power for good or for ill, a power to harm or a power to help us, a power to unite us, or a power to keep us asunder. "What can these Irishmen think," he continued, "who, we are assured, are in their own minds the most capable of managing their own affairs, but who, in every other part of the English speaking world, gain their livelihood out of all proportion to their numbers, to positions of trust, affluence and authority. I must say that on the whole, in varying degrees, no class of people have been more filled with feelings of resentment and anger against the British power and aims, and they worked counter to our interests. As the years have passed, especially since Gladstone's failure, the British attitude to the home rule cause, things have not got better, and a gentler feeling supervened, but still Irishmen everywhere have done us much harm. In the past they have been an adverse force for the British Empire, and they are now the most serious obstacle to Anglo-American friendship. We got along despite all that. **SAVE OUR SHIPPING**  
A Protest Against the Action of the Government of Mr. Borden

(Ottawa Free Press)

The action of the present government in renewing the rights of Norwegian vessels to coasting privileges in Canadian waters, a privilege which has been terminated by the Laurier government, is creating considerable agitation in Nova Scotia, an agitation which has been transferred to the lobby of parliament.

For years past practically the whole of the coast carrying trade between Cape Breton and Montreal has been done by Norwegian steamers. Pressure was brought to bear upon the late minister of marine, Hon. L. P. Robeson, with the result that the government gave notice that the privilege granted to the Norwegians would terminate on December 31 last.

On the strength of this understanding a number of British shipping companies purchased vessels to put on the route, but now they find themselves confronted with a situation in which they are subjected to competition from aliens who do not live on the same scale as British seamen and who can work much cheaper than those employed on steamers which fly the British flag.

The extension seems to have been granted solely in the interest of the Dominion Coal Company. It cannot be because there is a lack of British steamers to do the work. Several vessels, which last year were operated on the Norwegian register, have been purchased and are available, but will not find their usefulness gone in view of the extension of the Norwegian's chances and of the continued discrimination by the coal companies in favor of the alien vessels.

It is declared to be a common sight at Sydney and other coal shipping points to see half a dozen or more British vessels (including Canadian, of course) awaiting their turn for loading while the docks are filled with the Norwegian boats.

So long as we are to have protection, let it be fair to protection. **BUILDING LAW CHANGES APPLYING TO THE CITY**

Fire Chief to Have Greater Powers — The Discussion at City Hall

After a full discussion of the need for a new building law at a joint meeting of aldermen, fire underwriters and city officials at city hall last evening, it was decided to wait another year before sending a complete law to the legislature for adoption, but to ask for some of the more pressing amendments at this session. Building amendments at this session were appointed to draw up a bill limiting the height of buildings in different districts, this section to be added to the act this year.

The chief of the fire department will be given wide powers in jurisdiction over the conditions affecting the safety of buildings, and this will be arranged by amending the by-law of the fire department. This means will also be provided for more stringent inspection and regulation of theatres and other places of public amusement.

Ald. G. H. Green, chairman of the civic committee, appointed to deal with the matter, presided at the meeting, and there were present, Chief Kerr, and Peter Clinch, R. W. W. Frink and F. R. Fairweather, representing the fire underwriters.

The recommendations of a committee of the fire underwriters were laid on the table and contained suggestions for the framing of a new building law founded on the Vancouver law. They recommended that a fire inspector be thoroughly competent and that he receive a salary of not less than \$1,200 a year. Owing to no assessment being available for the purpose this year the matter was not taken up.

The committee then recommended that the chief of the fire department have full authority to compel owners of buildings to keep all fire appliances in a safe condition and generally to use every precaution to prevent fires.

After the decision was made not to proceed with the framing of the new act, it was decided to secure the same results by amending the by-law of the fire department relating to the duties and powers of the chief.

The insurance men also recommended that provision be made for the following features in the new law: Thickness of walls for brick buildings, safety of public chimneys, fire, etc., mansard roofs, fire escapes, fire protection and stand pipes, electrical work, moving picture machines and storage of lime, storage of hay, straw, etc., explosives and gasoline, mapha and benzene regulations, fences, signs and bill boards.

There was a general discussion as to the value of the present law and the creation of a new fire district in the North End for the whole length of Main street was suggested. The recorder stated that he had been paid in insurance losses and repairs since the street was first built up more than the brick structures would have cost originally.

As these present had no information as to the proper course in the revision of the fire districts as at present constituted, and the time is short before the meeting of the legislature, it was decided to leave the amendment of the act as far as limiting the height of buildings is concerned to a committee consisting of Ald. Green, Mr. Clinch, Mr. Mott and the building inspector.

Mr. Clinch asked that single brick chimneys be also prohibited, and this will be taken into consideration.

It is now being considered will be the matter of discussion at the meeting of the Builders' Exchange tonight.

You cannot make a mistake by talking about the things you have. In the past everything we had was in connection with the forestry branch. The advice one received on every side was to begin with a monopoly of the fruit growing business. The object of the speaker's visit to Fredericton was to attend a meeting to arrange for a provincial conference on the immigration question. He had always felt that the immigration policy of the federal government had been directed altogether too much towards the west and to the neglect of the rest of the country. He was glad that a change was to be made in this respect. In conclusion he heartily congratulated the Board of Trade on the success of the banquet.

Howard P. Robinson said that he was very glad to be present at such a gathering. As a New Brunswicker he had always felt that this province would sooner or later come in to its own. All we need at the present time is faith and hope. He hoped that the immigration conference to be held here would be well attended and productive of good results.

**WANT MORE MONEY SPENT TO CONSERVE THE FORESTS**

Forestry Association's Appeal to Federal and Provincial Governments — Important Matters at Closing Session

Ottawa, Feb. 8.—The Canadian Forestry Association concluded their thirteenth annual convention in the railway commission rooms of the house of commons this afternoon. The principal resolution asked for from both federal and provincial governments an increased expenditure on forest management in this country, deprecating the fact that less than a cent an acre was now expended on forest lands.

The association urged on the federal and provincial governments the necessity for providing a system of appointments and the qualifications of appointees and of making appointments permanent during good behavior, and that federal government appointments for this purpose should be placed in the hands of the civil service commission.

It was resolved to impress upon the government the necessity of maintaining the connection with the forestry branch an experimental laboratory for testing and investigating the physical and mechanical properties of Canadian woods with a view to extending the possibilities of their use and for other purposes.

The association deprecated the practice of exporting in large quantities Christmas trees of spruce and balsam, and recommended legislation to prevent that practice.

An executive committee to meet every three months was appointed as follows: The president, the vice-president, Hon. Sydney Fisher; Hon. C. E. Edwards; Hon. H. Campbell, G. F. Chown and Dr. B. E. Fernow.

The association reaffirmed its attitude in favor of the inspection of the public domain and the inclusion in forest reserves lands unsuited for agriculture, or where the forests are required for the protection of watersheds, and urged on the federal and provincial governments the carrying out of such a policy at the earliest possible date.

The treasurer's report showed an expenditure during the year of over \$6,000, and a balance on hand of over \$1,500. The fees from members for the year amounted to over \$2,000.

### SAYS HOLIN TRIED TO SELL RAZOR TO VICTIM OF THEFT

#### John Daley and Other Barbers Give Evidence of Interest in Police Court Case

There was interest in the police court this morning in the case of William Holin, or Peterson, charged with breaking and entering the barber shop of John Daley at 45 Dorchester street, on the night of January 5, was taken up. The prisoner was arrested on Saturday last by Policemen O'Leary, on charge of being driven in Sydney, also was suspected of having stolen a turkey from a wagon in Market street. His arrest the police have been working on the Daley case and in consequence of evidence secured, the charge was made against him.

In court this morning he pleaded not guilty to the charge and the preliminary hearing was begun. He asked to have the case adjourned so that he could be represented by counsel, but he was told by the court that he had conducted his examination of witnesses the same as on previous occasions, that he could get along very nicely without a lawyer.

"You are a bright young fellow, and I feel sorry for you," said His Honor. The first witness called was John Daley, proprietor of the barber shop in Dock street. He said that on the morning of January 6 he went to his store and found that it had been broken into. A pane of plate glass had been broken out of a door in the rear and several drawers were scattered about the floor. The money still was in the drawer. Several towels were lying about with blood on them and there was blood on the handles of the drawers. Between thirty and forty-two razors and cases were missing. A dozen razors were produced in court, and out of them he positively identified three. The stolen goods were valued at about \$30.

Cross examined by the prisoner, the witness said that he had been talking with Detective Killen and that the latter said he suspected the prisoner then. That was on the Tuesday following the robbery. The prisoner had gone to his store on the Monday following the robbery and had tried to sell him a razor. He had not seen any cuts on the prisoner's hands at that time. He identified the razors by certain marks on them.

James Cunningham, a barber of 88 Wall street, told of a man calling at his store and selling him a razor for twenty-five cents. He could not positively identify the prisoner. The man in question told him his name was Holin and that he lived in Britain street. This occurred about two weeks ago.

Frank Bookan, who conducts a barber shop in Brussels street, said that the prisoner left a razor in his shop to be honed on January 29. He had honed Holin twenty-five cents at the time, but did not buy the razor from him. He identified a razor produced in court.

Harry Short, a barber at 77 Britain street, said that Holin had called at his store on January 8 and offered to sell him a razor for fifty cents. He did not buy the razor, but the prisoner left the razor at his store and borrowed five cents from him. He, the prisoner said, at the time that he was going over to Daley's store to sell the razor. The witness had heard of another man going around selling razors.

The prisoner was remanded to jail.
