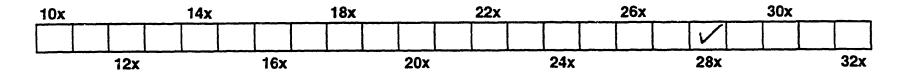

An Act to incorporate The Canada Military Asylum.

HEREAS Colonel Gordon Higgins, of the Royal Regiment Preamble. of Artillery, President of an Association commonly known as "The Canada Military Asylum" the Reverend George Mackie, D. D., the Reverend John Cook, D. D., the Reverend R. G. 5 Plees, the Reverend George Cowell, the Reverend Gilbert Percy. David Dumbreck, Esquire, Staff Surgeon, Heneage Grubbe, Lieutenant Colonel of Her Majesty's 66th Regiment of Foot, William Yorke Moore, Lieutenant Colonel of Her Majesty's 54th Regiment of Foot, John Ross Wheeler, Major of the same, Walter Simpson. 10 assistant Surgeon of Her Majesty's 66th Regiment of Foot, Alfred Knight, Captain unattached and Town Major of Quebec, Henry Cornwall, Barrack Master at Quebec, and Thomas Blatherwick, Esquire, Staff Assistant Surgeon, members of the Acting Committee of the said Association, have by their petition to the Legislature re-15 presented, that the said Association hath been established for many years, for the purpose of affording relief to the Widows and Orphans resident in Canada of Soldiers in Her Majesty's service, and of discharged Soldiers residing in Canada, who may need such relief, and

have in and by their said petition prayed that the said Association 20 be incorporated; and whereas in view of the philanthropic object and the great advantages to be derived from such an Institution it is expedient to grant their prayer ; Be it therefore enacted, &c.,

That the Rector of Quebec, the Commandant of Garrison of Certain Func-Quebec, the Minister of St. Andrew's Church, Quebec, the Principal tionaries and 25 Military Medical Officer at Quebec, the Chaplain to the Garrison porated, of Quebec, the Town Mayor of Quebec, Daniel Thorndike, Lt-Col, R. E., Henry Powell Wolff, Lt-Col, R. E., Henry Coope. Stace, Capt., R. A., Frederick Stanley Carpenter, Asst. Comis'y-Genl., Walter Simpson, Thomas Blatherwich, with all such persons 30 as now are or may hereafter become members of the Association aforesaid, under the By-laws thereof, shall be and they are hereby declared a body politic and corporate, under the name of the "Canada, Corporate "Military Asylum," and by that name shall have perpetual succes- names and powers. sion and a common seal, and shall have power from time to time to

35 alter, renew or change such common seal at their pleasure, and shall by the same name from time to time and at all times hereafter be able and capable to purchase, acquire, hold, possess and enjoy, and to have, take and receive to them and their successors, to and for

orestate, and any lands, tenements and hereditaments and real or immoveable property and estate, situate, lying and being within this Pro-Real property vince, not exceeding in yearly value the sum of one thousand pounds currency, and the same to sell, alienate and dispose of, and to purchase 5 others in their stead for the same purpose, and by the said name shall and may be able and capable in law to sue and be sued, implead and be impleaded, answer and be answered unto in all courts of law and places whatsoever, in as large, ample and beneficial a manner as any other body politic or corporate, or as any persons able or capable in law 10 may or can sue and be sued, implead or be impleaded, answer and be answered unto in any manner whatsoever; and any majority of the By-laws, &c. members of the Committee of Management or other body to whom the direction and management of the affairs of the Corporation shall be entrusted, shall have power and authority to make and establish 20 such By-laws, Rules, Orders and Regulations not being contrary to this Act or to the laws in force in this Province, as shall be deemed useful or necessary for the interests of the said Corporation and for the management thereof, and for the admission of members into the said Corporation, and from time to time to alter, repeal and change the 20 said By-laws, Rules, Orders and Regulations, or any of them, and those of the said Association in force at the time of the passing of this Act, and shall and may do, execute and perform all and singular other the matters and things relating to the said Corporation and the management thereof, or which shall or may appertain thereto; 25 subject nevertheless, to the rules, regulations, restrictions and provisions hereinafter prescribed and established.

Property of this Association.

II. And be it enacted, That all and every the estate and protion vested in perty, real and personal, belonging to the said Association, or held the Corpora by any person or party for the use or purposes thereof, and all 30 debts, claims and rights whatsoever due to the said Association, or to any person as representing or acting for the said Association, shall be and they are hereby vested in the Corporation hereby established, which shall be liable for all debts due by the said Association, or lawfully contracted by any person or party acting in its name or 35 on its behalf.

Present Bylaws con-tinued in force.

III. And be it enacted, That the present By-laws, Rules and Regulations of the said Association, shall be the By-laws, Rules and Regulations of the said Corporation until others be enacted and made in their stead; and the President and other members of the 40 Acting Committee of the said Association and all officers thereof. shall be and continue to be the President and members of the Acting Committee and officers of the said Corporation, until others in their stead shall be appointed or succeed them, according to the By-laws, Rules and Regulations made or to be made for the government of 45 the said Corporation.
