OF THE
Special Synod of the Diocese of Montreal.

ASSEMBLED TO ELECT A BISHOP AND METROPOLITAN.

FIRST DAY.

MONTREAL, May 11th, 1869.

The opening services were held this day in the Cathedral, and commenced at half past ten o'clock a.m.

Morning Prayer was said by the Rev. Canon Balch, and the Rev. Canon Loosemore.

The first Lesson was read by the Rev. Canon Bond, and the second by the Rev. Canon Bancroft.

The Ante-Communion service by the Bishops of Quebec and Toronto. The sermon was preached by the Ven. Archdeacon Leach.

The Holy Communion was administered by the Bishops of Huron, Quebec and Toronto, and the Dean of Montreal.

At 2 p. m. the Synod met for business in the Cathedral School Room, the Dean of Montreal presiding.

After Prayer the roll of the Clergy was called by the Clerical Secretary, and that of the Laity by the Lay Secretary.

A quorum of Delegates being present,

The Dean then delivered the following address :

REVEREND BRETHREN AND BRETHREN OF THE LAITY,—

It is not my province nor have I personally the inclination to inquire into or discuss the cause, much less to attempt to ascertain on whom lies the blame of the failure of this Synod to elect a Bishop and Metropolitan at the meeting convened for that purpose in the month of November last. Suffice it to say we did fail to carry out the object for which we then assembled—and we are now met again to endeavour, by the assistance of the Holy Spirit, to select a Brother fit to be an overseer in this portion of the Church of God, which we ought to remember was purchased by the precious blood of Jesus Christ.

Although I deem it to be both unbecoming and unnecessary for me even to allude to the cause which unhappily prevented us, in November last, from being of one mind on the subject which we met to decide, my age and position may nevertheless entitle me to venture to offer a few words of advice on this solemn and important occasion. In doing so, I would remind you, in the words of St. Paul, that a "Bishop must be blameless, the husband of one wife, vigilant, sober, of good behaviour, given to hospitality—apt to teach, not given to wine, no striker, not greedy of filthy lucre, but patient—not a brawler, not covetous—one that ruleth well his own household, not a novice—and having a good report of them that are without." These brethren, are the divine directions which the Holy Spirit, by St. Paul, gave to Timothy, concerning the qualifications of a Bishop, and have been truly said to describe all the virtues which they of that sacred order ought to be imbued with, as well as the vices from which they should be clear. Strive then to keep these directions in view, and to discard from your minds all party spirit and prejudices, to feel the deep responsibility imposed upon you—and determine not to separate, on the present occasion, without making choice of some one to preside over us as our Chief Pastor, and thus maintain amongst us the order and discipline of God's Holy Church, to the overthrow of Satan's power, and the final establishment of Christ's Heavenly Kingdom.

The Dean announced that a communication had been received from the General Convention of the Church in the United States relating to the late Metropolitan of the Dominion and requested the Secretary to read it. At the Dean's suggestion, the Synod stood whilst the following Minute was read :

HOUSE OF BISHOPS,

Nineteenth Day, Oct. 23th, 1868.

On Motion of the Bishop of Maryland the following Preamble and Minute, reported by the Bishop of Connecticut, as chairman of the committee appointed to recommend suitable action in relation to the death of the Bishop of Montreal, were adopted.

Whereas, This convention has received information of the lamented death of the Most Rev. Francis Fulford, D.D., Bishop of Montreal, and Metropolitan of Canada, it is ordered by this House, with the concurrence of the House of Clerical and Lay Deputies, that the following minutes be adopted and entered in the Journal.

The Bishops, Clergy and Laity of the Protestant Episcopal Church in the United States of America, in General Convention assembled, offer to their brethren, the Bishops, Clergy and Laity of the United Church of England and Ireland in the Dominion of Canada, the assurance of their sympathy and prayers under the afflictive bereavement which, in the loss of their Metropolitan, it has pleased God to send upon them.

Intimately connected with our own Episcopate, by having united in several Episcopal consecrations, well known and honored among us privately and in public as the preacher at our last General Convention, we cordially unite with his brethren, his clergy and his people in bearing our testimony to his zeal and devotion as a minister of God's word, and to the piety and godliness of his private life. May God give to the

Vote.

Diocese, and the Province a successor to the departed prelate who may worthily carry on the work which he has been called to lay down.

Which was adopted by 102 yeas, 69 nays.

(*) Mr. BAYDGES, in compliance with the request said : I am sure this House will not attribute to the Committee the introduction of this question. It was their opinion arising from their earnest desire that there should be the utmost possible peace and harmony in the meeting that it would be better not to make any statement of what transpired at their interview with the House of Bishops. But as the question which has been raised is undoubtedly one of very considerable importance, we feel it to be our duty now to state as briefly as possible what transpired.

The Committee, as I mentioned yesterday, was received by the House of Bishops with the utmost possible kindness and courtesy, and were permitted to have a very full and frank discussion with that House upon the subject before us. I may now state as to the result of that discussion that we ascertained emphatically from the House of Bishops that under no circumstances would they send down the names of any Presbyter of the Diocese of Montreal. About that there is not the smallest room for doubt.

Afterwards a suggestion was thrown out by their Lordships in the shape of a question to the Committee, as to how the nomination by the House of Bishops of Presbyters from other Dioceses in Canada would be received by this House. The opinion of the Committee was that if no Presbyters from the Diocese of Montreal were to be sent down, it would aggravate the difficulty if Presbyters from other Dioceses were sent down.

We then executed the duty which was entrusted to us by stating to the House of Bishops in the most courteous language we could use what had been said to myself and the other members of the Committee before we went up to their Lordships in regard to the manner in which the name of

The Bishop of Huron stated to us distinctly that he had all along proposed that the name of the Bishop of Rupert's Land should be sent down with the other bishops.

The Bishop of Huron told us further that he had all along protested against the name of the Bishop of Rupert's Land not being sent down, and that he had also protested against sending down the names of Presbyters from England about whom this House could have no possible knowledge. I think now, Mr. Dean, that I have stated in substance what passed in the House of Bishops.

If I have said anything incorrectly or have not given full enough explanations, the other members of the Committee can supplement what I have said. I should also add that when the House of Bishops told us distinctly that they would not send down the names of any Presbyters of the Diocese of Montreal, the Bishop of Quebec expressed some slight dissent from that opinion.

I stated very distinctly, I thought, that after the House of Bishops refused to send down the names of any Presbyter from the Diocese of Montreal, they threw out the suggestion in the shape of a question to us, as to how the name of a Presbyter from any other diocese in Canada would be received. They put it in the shape of a question to us, and our answer was that we thought any such step as that would rather complicate than tend to weaken the difficulty.

AFTERNOON SESSION.

Mr. BRYDGES said he had been requested by the Committee to report the result at which the Committee had arrived. He would not make any lengthened remarks, as it was the opinion of the Committee that they should not have a discussion on the result of the conference as discussion did not tend materially to remove differences. The Committee met in the kindest spirit, and there could not have been a more gentlemanly, forbearing and courteous spirit than that manifested by every member of the Committee. He regretted to say that the Committee could not come to any unanimous conclusion, and they were of opinion that it would be useless to present a report unless it had been unanimously adopted by the Committee. The Committee therefore adopted the following resolution:—

“ That this Committee being unable to make a unanimous report, recommend that the Synod proceed with the balloting, and that if after two or more ballots there is no election this Committee have an interview with the House of Bishops.” He added that the Committee feared that another ballot would not result in an election, and should that be the case, he thought that it was their duty to make a strong effort to point out to the House of Bishops the difficulty in which they were placed, and which could only be removed by their sending down names that would be likely to meet with the unanimous acceptance of the Synod.

Letter addressed to the Bishop elect, from the Senior Bishop of the House of Bishops, and the Chairman of the Diocesan Synod, the Very Revd. Dr. Bethune, Dean of Montreal:—

MONTREAL, May 14, 1869.

TO THE REV. CANON OXENDEN.

REV. SIR,

We have the honor to inform you, that at an adjourned meeting of "The Synod of the Diocese of Montreal," held this day, you were unanimously elected to be Bishop of Montreal and Metropolitan of Canada.

In making this announcement, we think it proper to mention, that in view of the conflicting interests of the Diocese of Montreal, individually, and of the House of Bishops and of the other Dioceses, collectively, very considerable difficulty has been naturally experienced in making choice of a fit and proper person to fill so distinguished a position in the Church. So great indeed has been the difficulty that the efforts attendant on the first meeting of the Synod, held in the month of November last proved entirely fruitless, and even at the adjourned meetings held during the present month, the prospects of an election seemed equally hopeless. At the very moment, however, when after repeated failures the members of Synod had almost despairingly concluded that an election, under the circumstances, was impossible, the accidental mention of your name at once dispelled all existing difficulties, and resulted, as has been already stated, in the unanimous election of yourself as Bishop and Metropolitan of Canada.

One cannot fail in all this to trace the finger of Divine Providence, and we sincerely trust that no obstacle may exist to prevent your acceptance of the high and holy office to which it hath thus pleased God to call you.

The Secretary of the Synod received letters from the Bishop Elect and Metropolitan, dated July 12th and 13th, saying that arrangements had been made by the Archbishop of Canterbury, with the consent of the Colonial Office, for his consecration in Westminster Abbey, Sunday, August the 8th, and that he has taken passage for Montreal in the Canadian Steamer, of August 19th.

The Very Reverend the Dean convened the Clergy in the city of Montreal, Saturday, July 24th, at twelve o'clock, in the Vestry Room of the Cathedral, to prepare a suitable address of welcome to the Lord Bishop on his arrival in this country.

The Rev. Canon Bond, in the absence of the Dean and Archdeacon, was called to the chair, and the Rev. Mr. Dumoulin appointed Secretary.

On motion, the meeting adjourned until Monday, the 26th.
