THE HOUSE OF LORDS AND THE IRISH CHURCH.

The Peers of England, that is the conservative Peers, have got a fright. The measured dignity of their stately legislative pace has been broken by the passage of the Irish Church Bill through the House of Commons, and they have actually confessed themselves flurried to the extent of holding a meeting to consider the most efficacious means for defeating the good intentions of the real representatives of the people. Patriotic men are they, and we may be prepared to hear considerable aristocratic twaddle about the infringement of the Royal prerogative, and the invasion of long established rights. If the English House of Lords means anything at present (for it has sadly degenerated) it means a body that has power, when it is seized by a fit of obstinacy, and sees that it is safe in the stand it takes, to combat for a while the popular will. There was very little fear of the triumph of the Bill in the Commons; the majority of the members elected to support it, and they have paid their vows to the people; but in the House of Lords its fate has excited most interested speculation in consequence of the uncertainty which it was certain would attend it. And so Lord Derby has forgotten his gout for the nonce and hobbled up to record his condemnation of the most laudable effort that has ever been made to do justice to all parties in Ireland. Lord Cairns is no less uncompromising, and a majority of eighty is confidently reckoned on to give the veto to the Bill on its second reading. Lords Salisbury and Carnarvon were more moderate and reasonable than the peers above mentioned, and probably having in view the dangers of rejecting in toto such a popular measure exerted their eloquence in favor of modification, and making the best terms they could with the Liberal party.

It is scarcely probable that the Lords will yield their position without at least making a show of fight to maintain it. They will come into direct collision with the people, who at the last election gave their opinion on the question in a manner that could not be mistaken, and then there may be seen such agitation and excitement as has not been witnessed since 1832. Eighty of a majority are formidable odds to contend with, and if they be contumacious we cannot see that there will be any but one result, namely, that the Bill must be dropped for the present. Of course if the Queen were inclined she could easily overcome the obstacle by the creation of a number of Peers sufficient to carry the measure, but then the number is so large and the precedent might afterwards prove so annoying that it is scarcely probable this will be done. All great reforms have encountered rough gales, and the Irish Church Bill cannot expect smooth sailing any more than the others. But it must eventually triumph, for it is evident that the time for it to do so has come, or at most, is not far distant. What are a few Peers, what a handful of rabid Tories in the north of Ireland to impede the progress of a movement supported by the great bulk of the nation, and sympathized with by the remainder of the christian world? The peers may, as they did in the case of the Reform Bill, demonstrate their power by throwing it out the first time it comes before them; but they will discover that they must also allow it to pass, as they did that measure, if not with their avowal, at least with their tacit consent.

THE WEALTH OF ENGLAND.—Though Mr. Disraeli may have over shot the mark when he described the national debt of England the other day as a "feabite" it does appear to be insignificant when compared with the commerce of the country. The amount passing through the Clearing House in 1868 reached the enormous sum of £3,534,039,000, or seven times as much as the national debt. This was an increase of £370,000,000 on the previous year, and it shows conclusively the commercial and monetary activity of the country, notwithstanding the financial crisis through which it has passed. On the 24th Stock Exchange settling days the total amount passing through the Clearing House was £550,622,000, or an increase of above a hundred millions on the preceding year. How is it, then, that with this enormous mass of wealth, pauperism and poverty should exist to such an alarming extent as to create grave apprehensions, if not absolute panic, in the public mind?

Quarter Sessions.

Mr. McCurry for appellant, the Chief Constable managed his own case. Verdict for respondent.


