RULES OF THE HALIFAX CLUB.

NAME.

I.—This Association shall be known as the HALIFAX CLUB.

NUMBER OF MEMBERS.

II.—The Halifax Club shall consist of not more than two hundred members, exclusive of honorary, supernumerary and privileged members.

POLITICS, RELIGION.

III.—Politics and religious questions of every description shall be excluded from the objects of the Club.

CANDIDATES.

IV.—Each Candidate for admission shall be proposed by one member and seconded by another. The Candidate's name and

usual place of residence, his rank, profession or other description, shall be inserted at the time of proposal in the book for Candidates, and signed by the proposer and seconder.

RULES OF BALLOT.

V. 1. The ballot for members shall take place on the first Wednesday in each month, to commence at One and to end at Four o'clock, P. M. A list, dated and signed by the Secretary, containing the name of each Candidate to be balloted for, with those of the proposer and seconder, shall be put up in a conspicuous place in the Reading Room at least seven days before the day of ballot. During the hours of ballot, a notice to the effect that the ballot is going on shall be affixed to the list, with a particular request that members will attend. The ballot boxes shall be examined and secured previous to use, by the Secretary and one member of the Committee; and after the ballot is over the

boxes shall not be removed until they have been opened and examined by the Secretary in the presence of at least two members of the Committee. The result of the ballot as regards each Candidate shall be immediately entered opposite their names respectively on the list, and signed by the Scrutineers. Each Candidate must have at least thirty votes to constitute his election, and one black ball in five shall exclude. In the event of any Candidate not having the required number of votes his name will be placed at the top of the list for next ballot. Any Candidate who shall have been twice black-balled, will not be eligible to be again proposed.

ELECTION BY COMMITTEE.

2. Whenever the Committee of management may consider it expedient, they shall have power to elect both full and privileged members, provided that such election shall be by ballot, at which at least ten members must vote; one in five to exclude.

A list containing the name of each candidate together with that of his proposer and seconder, shall be placed in the morning room for at least seven days before the election ; this list shall contain a notice that the ballot will be by the Committee.

Should the ballot result adversely to the candidate, the proposer and seconder shall have liberty to bring the name before the members of the Club for a new ballot.

Any candidate who shall have been twice black balled, will not be eligible to be again proposed until two years shall have elapsed from date of last ballot.

NEW MEMBERS.

VI.—On the admission of each new member the Secretary shall notify the same to him, and furnish him with a printed copy of the Rules. He shall also request him to remit the amount of his entrance fee and subscription to the Treasurer, or to the Secretary at the Club House.

RULE VII.

At a special meeting held on 11th July, 1901, the following resolutions affecting Rule VII were passed :

Resolved,—That the annual subscription payable by the members, be temporarily increased from and after the first day of January, 1902, by the sum of five dollars per year; the sum realized in each year from such increased subscription, together with any other sums available for the same purpose—to be applied to the redemption of certain bonds to be issued under a certain mortgage, as agreed upon at the special meeting held on the 6th inst.; and that such temporary increase of the annual subscription be continued until all bonds have been redeemed.

Further Resolved,—That the provisions of Rule VII, so far as they relate to the amount of the annual subscription, be and they are hereby temporarily suspended accordingly.

ENTRANCE AND SUBSCRIPTION.

VII.—The entrance money, payable on admission to the Club, shall be Eighty Dollars, and the annual subscription Thirty Dollars. But members elected after the month of January, in any year, are only required to pay pro rata for the remainder of the year in which they may be elected. All subscriptions shall be payable on the first day of January in each year; after which day no notice of withdrawal shall exempt the retiring member from the payment of the current year's subscription.

NEW MEMBERS TO PAY BEFORE VOTING.

VIII.—No new member shall be admitted to ballot for a Candidate or vote on any occasion whatever, or to enjoy any of the privileges of the Club, until he shall have paid his admission fee and subscription.

FAILURE TO PAY ON ENTRANCE.

IX.—Should a new member not pay his admission fee and first year's subscription

within three months from his admission into the Club, if in America, or within twelve months, if abroad, the Secretary shall report the circumstances to the Committee, who shall cause his name to be erased from the list of members, unless he can justify the delay to the satisfaction of the Committee.

WHEN MEMBERS NOT ALLOWED TO VOTE.

X.—From and after the first day of February in each year, no member of the Club shall be allowed to vote at a ballot, or to act as a member of the Committee, until he shall have paid his subscription for the current year.

FAILURE IN PAYMENT OF SUBSCRIPTION.

XI.—The name of every member who shall not have paid his subscription before 2nd February shall then be put up in the public room, notice of which shall be sent to him or his agent, by the Secretary, and if the subscription be not paid on or before

the last day of the third month, after the same fell due, the defaulter shall cease to be a member of the Club, and his name shall be erased from the books by the Committee ; but he may be re-admitted on assigning to the Committee reasons which they may deem satisfactory for his failure of payment.

SUPERNUMERARY MEMBERS.

XII.—Any member leaving the Province may, on written application to the Committee before 1st January, and on payment of an annual subscription of five dollars, but not otherwise, become a Supernumerary Member, and during his absence be exempt from the annual subscription. He shall be liable, however, to the payment of his annual subscription for the year in which he departs from the Province, and for that in which he returns to it less the five dollars so paid as above, provided he shall remain within the Province for more than one month from the date of his

return, and if he shall remain that space of time only, he shall be entitled to the privilege of the Club for that period. No member's name shall be retained or placed on the Supernumerary List until payment of the current year's subscription of five dollars, before 2nd February.

COMMITTEE OF MANAGEMENT.

XIII.—The general concerns of the Club shall be managed by a Committee of fifteen members. The Committee shall be elected by ballot, of whom one-third shall go out annually by rotation, the vacancies to be filled up at the General meeting; but the five retiring members may be re-elected, and the Committee may fill any vacancy that may occur in their body by resignation or otherwise during the year; such appointment to be in force until the next annual meeting. A Treasurer shall be elected at the Annual General Meeting, who shall be *ex officio* a member of the Committee. The Treasurer elect will be

required, before entering on the duties of his office, to provide security to the amount of Four Thousand Dollars.

MAY MAKE RULES, ETC.

XIV.—The Committee shall, at its first meeting after each annual election, or as soon thereafter as they may consider convenient, appoint from its own body as many Sub-Committees as may be required to superintend the several departments of the Club; and shall make from time to time such Regulations (consistent with these General Rules) as they shall think necessary for the well-being of the Club.

TO MEET WEEKLY.

XV.—The Committee (three of whom shall form a quorum) shall meet weekly, on a stated day, to transact current business, and to audit the accounts.

EXPULSION OF MEMBERS.

XVI.—Any infraction of the Rules and Regulations of the Club shall be taken

immediate cognizance of by the Committee ; and in case the conduct of any member shall, in the opinion of the Committee, or of any thirty members of the Club, who shall certify the same to them in writing, be injurious to the character and interests of the Club, the Committee shall be empowered to recommend such member to resign ; and if the member so recommended refuse to resign, then the Committee shall be authorized to suspend him from the privileges of the Club, until his conduct shall have been investigated and decided upon by a Special General Meeting to be convened for that purpose upon a requisition of thirty members, as provided by Rule XX ; and whenever any circumstance shall occur likely to endanger the welfare and good order of the Club, or whenever the Committee shall think it expedient to submit the conduct of any member to the judgment of a General Meeting, the Committee shall summon a Special General Meeting, giving fourteen days notice there-

of ; and in the event of it being voted at that meeting, consisting of at least fifty members, by two-thirds of the persons present—to be decided by ballot,—that the name of any member should be removed from the Club, then in that case the subscription of such member for the current year shall be returned, and he shall cease to belong to the Club. Such decision to be final.

RETIREMENT OF MEMBERS.

XVII.—Any member whose dues are all paid shall be at liberty to withdraw from the Club, on his written application to that effect, sent in to the Committee. The Committee are authorized in their discretion to re-admit to the Club on such pecuniary terms as they may consider right, such full members as may have resigned their membership from any cause and wish to rejoin the institution.

RETIRING TO FORFEIT ALL RIGHTS.

XVIII.—Any member who shall withdraw, resign, or be expelled, or shall cease

to be a member of the Club, shall forfeit *ipso facto*, all right or claim thereon, or in, or to its property or funds ; and any member who shall be expelled shall forever thereafter be ineligible to be re-admitted a member of the Club.

GENERAL MEETINGS.

XIX.—There shall be two General Meetings of the Club regularly every year, one on the second Thursday of February, for the purpose of electing the Committee for the succeeding year, and receiving from the Committee a report and abstract of the accounts and general concerns of the Club for the past year, together with an estimate of the receipts and disbursements of the current year ; which report and estimate shall be printed for the use of the members, and one copy put in each of the public rooms of the Club at least seven days before the first General Meeting. At this meeting members shall be at liberty to bring forward any subject having reference

to the management and concerns of the Club. The other regular General Meeting shall be held on the fourteenth day after the former, for the purpose of deciding on such propositions as may have been submitted at the first meeting. The chair shall be taken at all annual and special General Meetings at 5 o'clock P. M., precisely. The accounts of the Club shall be audited by an auditor not a member of the Committee.

EXTRAORDINARY MEETINGS.

XX.—The Committee shall have power at all times to convene an extraordinary meeting of the Club, on giving fourteen days notice, to be posted during that period in the public rooms of the Club, specifying the object of such meeting, in the form of resolution, to be signed by not less than six members of the Committee; and at such extraordinary meetings no subject shall be discussed beyond that specified in the notice. The Committee shall also call an extraordinary meeting at any time, on a

like notice, and under similar restrictions, on the written requisition of thirty members not being of the Committee, who must state distinctly their object.

NEW RULES, - HOW MADE, &c.

XXI.—If any new rule or alteration of an old one be duly proposed at the first regular Annual Meeting, and approved of and confirmed at the second regular Annual Meeting that day fortnight, by two-thirds of the members then present, whatever the numbers may be, the same shall be considered as adopted by the Club; but with this exception, no new Rule or alteration of an old Rule shall ever be made without the sanction of an absolute majority of two-thirds of the members present at a special General Meeting, and forty members at least voting on the occasion, and twenty-eight days notice being given; nor unless the proposed new rule or alteration of an old one has been posted up in the usual place in the public rooms twenty-eight days previous to the day of meeting.

HOUSE HOURS.

XXII.—The Club shall be open every day for the reception of members at seven o'clock in the forenoon in the summer, and at eight o'clock in the forenoon in the winter, and shall be closed and the lights extinguished at one o'clock, A. M., except on Saturdays, when the house shall be closed at half-past eleven o'clock, P. M., and on Sundays when it shall be closed at 11 o'clock, P. M. No member shall be admitted into the Club House, after these hours, under any pretence whatever, unless specially authorized by the Committee.

STRANGERS, THEIR ADMISSION, &c.

XXIII.—Each member shall be allowed to bring a stranger to dine with him, under such regulations as may be made by the Committee, the dinner to be charged at rates to be regulated by the Committee; it being expressly understood that the bill is to be discharged by the member. The Committee are also empowered to regulate

the admission of strangers in company with members, at other times, and they shall decide what rooms they are to be admitted to. The Committee have the power to suspend this rule during such periods as they may think necessary, for the convenience of the Club, notice of such suspension being posted up in the coffee-room at least one week previously. Persons residing within the limits of the County of Halifax shall be eligible to be introduced to dine as the guests of members under regulations to be made by the Committee, but the Committee shall be empowered, on special occasions, to admit to the Club residents of Halifax, whenever it may be considered expedient to do so.

PAYMENT OF CLUB BILLS.

XXIV.—All members are to pay their bills for every expense they incur in the Club before they leave the house, the servants having positive orders not to open accounts with any individual

NO GRATUITIES.

XXV.—No member shall give any money or gratuity to any of the servants of the establishment, or permit any stranger to do so.

NO PROVISIONS TO BE SENT OUT.

XXVI.—No provisions cooked in the Club House, or wines or other liquors, are to be sent out of the house, on any pretence whatever.

NOT TO TAKE AWAY PAPERS, &c.

XXVII.—No member shall take or permit to be taken from the Club, on any pretence whatever, or shall injure or destroy any newspaper, pamphlet, or other article, the property of the Club.

COMPLAINTS.

XXVIII.—All complaints respecting Breakfasts, Dinners, &c., stated on the back of the bill, and signed by the member so complaining, must be specially noticed

by the Committee at their next meeting; and all complaints respecting the servants or domestic arrangements of the Club must be stated by letter signed by the member complaining, which letter addressed to the Secretary must be laid by him before the Committee, at their next weekly meeting.

ADDRESS OF MEMBERS.

XXIX.—Each member of the Club shall give his address, or that of his banker or agent, from time to time, to the Secretary; and all notices being sent to such address shall be considered as duly delivered.

DOGS.

XXX.—No member is on any account to bring a dog into the Club House.

PRIVILEGED MEMBERS.

XXXI.—The following persons may be elected as Privileged Members, without payment of entrance fee, but subject to the subscriptions hereinafter specified :

1. Officers in Her Majesty's Army, and persons holding Civil and Military appointments under the Imperial Government, who may be stationed in Nova Scotia for an indefinite period. Subject to a yearly subscription of thirty dollars or half yearly subscription of fifteen dollars.

2. Persons residing outside the County of Halifax—when their permanent residence is within the Province—subscription as in Rule VII., otherwise as in section one.

3. Members of the Provincial Government, whose ordinary residence, otherwise than official, is outside the County of Halifax—subscription as in Rule VII.

4. Other eligible persons who shall satisfy the Committee that their residence in the County of Halifax is temporary or precarious or liable to be terminated by the occurrence of circumstances beyond their control—subject to annual or semi-annual subscription as in section one.

5. Strangers visiting Halifax who shall satisfy the Committee that their residence

there is not likely to exceed three months—on payment of a subscription of eight dollars for that period.

6. Officers in Her Majesty's Navy—for such periods and on such terms as the Committee in their discretion may decide, and after having been balloted for, may renew their subscriptions each successive season, while on the station, without further ballot.

Privileged Members, other than those referred to in sections five and six, who may be elected in the month of June or December, will be required to pay *pro rata* for the month in which they are elected, in addition to their regular annual, or semi-annual subscription.

All Privileged Members shall be subject to the Rules and Regulations of the Club generally, and after having paid their subscriptions, but in no case before, will be admitted to all the advantages of the Club, except that of being elected members of

the Committee, or voting in any way in the affairs of the Club.

Privileged Members desirous of retiring from the Club will be expected to give notice thereof in writing to the Secretary previous to the expiration of the period for which they have subscribed; any Privileged Member failing to do so, or who shall frequent the Club after that period, will be liable for the subscription for the ensuing period.

Privileged Members may become Full Members by being again balloted for and elected as such, and on payment of the entrance fee and subscription as provided by Rule VII.

Each Candidate as a Privileged Member must be so designated in the book and also on the list of Candidates for election posted in the public room, and no Candidate for Privileged Membership shall be placed on said list, unless his name shall have been submitted for the approval of

the Committee one week before the date of election.

All Candidates for Privileged Membership, referred to in sections one, five and six of this Rule, may be elected by the Committee, and after they have been proposed and seconded, may use the Club until their election. But any such Candidate, before taking advantage of this privilege, will be required to pay to the Secretary or Treasurer his subscription in advance, which, however, will be returned to him in the event of his not being elected a member of the Club.

HONORARY MEMBERS.

XXXII.—The Committee shall have the power to admit as "Honorary Members" the Governor-General of Canada, the Lieutenant-Governor of the Province, the General Commanding the Troops in this Garrison, and the Admiral commanding the Fleet on this Station, and the General commanding the Militia of Canada, such

Honorary Members to pay no entrance fee or subscription ; and they may also admit to the privileges of the Club, for such periods as they may from time to time think fit, any persons of distinguished rank and position visiting this city to whom it may seem proper to offer such a compliment, but the resolution to admit them must be agreed to by a majority of the Committee.

FOURTEEN DAYS PRIVILEGE.

XXXIII.—Any member wishing to introduce a friend temporarily visiting Halifax, and not residing in the Province, (the Island of Cape Breton excepted), as an Honorary Member of the Club, must send in a written application for permission to do so, stating the name and profession of such friend, to the Committee at their weekly meeting, for their sanction ; or he must obtain, by request, the signatures of two members of the Committee to his application as approving of it. The appli-

cation thus signed must then be handed to the Secretary, who will notify the person named therein that he has been admitted to the Club for fourteen days, and this privilege may be extended, with the consent of the Committee for the further period of one month on payment of five dollars, but it shall not be extended to more than one friend to each member at one time. Every member to whom this permission may be accorded, will be held responsible for the eligibility of his nominee, as well as for his observance of all the rules of the Club.

Commissioned Officers of H. M. Navy visiting this port, and Officers of the Army on joining the Staff or Regiments stationed in this garrison, or on returning from general leave of absence, may be admitted by the Committee under this rule, for fourteen days: or if they signify their wish to become privileged members and have been duly proposed and seconded, until they can be balloted for; but any

Officer, before taking advantage of this last proviso, will be required to pay to the Secretary or Treasurer his subscription in advance, which however, will be returned to him in the event of the ballot proving adverse. The name of every Honorary Member, with that of his proposer, will be entered in a book provided for that purpose on the day of his admission ; but the period for which the privileges of the Club may be granted him will be reckoned from his first entry to the Club House to partake of them. If, however, any Honorary Member shall fail to avail himself of the permission within the fourteen days, it will then be cancelled. No person shall be eligible to be proposed as an Honorary Member after having been in Halifax fourteen days, nor for more than twice in any one year.

All ordinary members of the St. James' Club and Mount Royal Club, Montreal ; Garrison Club, Quebec ; Toronto Club, Toronto ; Hamilton Club, Hamilton ; Rideau Club, Ottawa ; Union Club, St.

John ; Piccadilly Club, and Colonial Club, London, England, who shall be duly certified as such, and whose usual place of residence is without the Province of Nova Scotia, shall be entitled to the privileges of the Club for fourteen days.

RULES TO BE PRINTED, &c.

XXIV.—These rules and regulations shall be printed, and a copy of them together with a list of the Committee, shall be delivered to every member of the Club, or transmitted to his address, and thenceforth become binding upon every member of the Club ; but no member shall be absolved from the effect of these rules on any allegation of not having received them.

HOUSE REGULATIONS.



HOUSE REGULATIONS.

COFFEE ROOM.

Breakfasts may be served from eight until eleven o'clock, A. M.

Hot Lunches and Dinner from one to three, P. M., and from six to eight, P. M.

Hot Suppers up to ten o'clock, P. M., on giving notice before eight o'clock.

Cold Meats and Tea and Coffee and Toast, at any hour up to eleven o'clock, P. M.

No Wine or Liquor shall be served to any members in the Coffee Room, except with Breakfast, Lunch, Dinner or Supper.

Members will fill up their Dinner orders themselves, and must on no account employ the waiters to do so.

No hat, cap, stick or umbrella shall be taken into the Coffee Room or Morning Room.

Articles of glass, earthenware, etc., which may be broken by the members either in the Coffee Room or elsewhere in the House, will be paid for by them at prices to be fixed by the Committee.

VISITORS — DINING.

Residents within the limits of the County of Halifax may be admitted to dine as guests of members, and any such guest shall have the privilege of the Club House for that evening, or as long as his host remains. Provided always that the same person cannot be admitted to the Club House more than twice in any one year. Members must give notice to the Steward before two o'clock, p. m., of their intention of having guests to dinner on that day; and must enter their names at the same time in a book to be prepared for that purpose.

A member cannot be permitted to invite more than two such guests (residents) on any one occasion. In all cases members

will be held responsible for the conduct of their guests, and will be required to pay all bills. In no case can visitors make any gratuity to servants.

In order to avoid inconvenience in the coffee-room, members giving a dinner party of over six persons, at which there are visitors, may be required to occupy the private dining room. No person or persons who have ever been expelled, or rejected by the Club, can be admitted as guests.

Members cannot be permitted to invite visitors as guests to dinners given in the name of the Club, until the consent of the sub-committee in charge of the dinner has first been obtained. Visitors (residents) cannot be invited to Table d'Hote dinners.

Members are expected to ascertain if their proposed guests are eligible, under these regulations, to dine at the Club.

These privileges may be suspended by the Committee at any time it may be considered advisable to do so.

PRIVATE DINING ROOM.

The Private Dining-Room may be engaged by a party of not less than five, for their exclusive use during the evening, by giving notice to the Steward on the morning of the day on which they may wish to dine; and on such terms as the Committee may direct. And the Card-Room adjoining may also be secured, provided the party consist of not less than ten persons.

BILLIARD ROOM.

The following regulations will be in force in this Room :—

1st.—The Game of Pool shall have choice of tables, and take precedence over Billiards and Pyramids, and may be played in consecutive games.

2nd.—For Billiards the tables can only be engaged for one game of fifty or one hundred points. Precedence in playing and choice of tables given according to entry of names on the marker's slate.

Players of Billiards should intimate to the Marker whether they intend to play a game of 50 or 100 points.

The charges will be as follows :—

POOL—Five cents per ball—Stars to pay extra.

BLACK POOL—Fifty cents per hour for five players or less ; over that number ten cents per ball. For a second hour or part thereof, ten cents per ball.

BILLIARDS—Fifteen cents for a game of 50; twenty-five cents for a game of 100 points, or two consecutive games of 50.

PYRAMIDS—One cent per ball. Two consecutive games twenty-five cents.

CAROM GAMES—Fifteen cents for game of fifteen points.

Twenty-five cents for game of twenty-five points.

No Carom Game to exceed twenty-five points.

OTHER GAMES—By the hour, fifty cents.

No games shall be commenced after 11.45 P. M.

Players are particularly requested immediately after play to obtain their cheques and deposit them in the box.

The Marker is instructed on the conclusion of each game, to present to the loser a cheque for the amount of the game, together with the box in which the same is to be deposited.

CARDS.

No Cards shall be sold for use in the House, but each player shall pay fifteen cents per day, to be collected by the Hall Porter.

Second-hand Cards for use out of the House can be purchased from the Hall Porter for 15 cents per pack.

No rubber of whist shall be commenced after 12.45 o'clock, A. M.

SMOKING.

Smoking will be permitted in all the rooms except the Morning Room, Coffee Room and Private Dining Room, unless the last is engaged for dinner, in which case smoking is permitted at the option of the party occupying the room.

And as regards the Coffee-Room when there is a table de'hote dinner, or a dinner party consisting of not less than twenty persons, smoking to be restricted to cigars and cigarettes.

ENTRANCE HALL.

No stranger will be admitted to view the House, unless accompanied by a member, and then only between the hours of ten and twelve in the forenoon.

No large boxes or articles of baggage belonging to a member will be admitted into the hall, and bags or portmanteaus sent by members wishing to dress, will be conveyed to the Dressing-Room.

DRESSING ROOM.

Any portmanteau, bag or baggage of any kind must be taken away immediately after use, and not allowed to remain in the Club for future use. No servant of the Club will be employed by any member to clean clothes, boots or shoes, or to assist him in dressing.

No member, except on special duty, nor servant of a member, will be allowed to go down into the basement story of the House, apportioned for the use of the servants of the Club, nor will any such servant be allowed to go into any other room than the Dressing-Room, and then only to assist his master in dressing.

HALL PORTER.

He shall enter in his book once a day the name of every member coming into the House, and will see that members introducing strangers write their names and

address, with that of the introducer, in the book kept for that purpose.

Strangers calling to see members of the Club will be shewn by him into the Reception Hall or other room set apart by the Committee for that purpose, and intimation of their arrival immediately sent by him to the member inquired for, if in the House. If a letter for an absent member be called for by any other member who may wish to forward it, the latter will be required to pay the postage (if any), and to sign an acknowledgment in the Porter's book of his having received the letter, in case of future question.

He shall report to the Secretary all letters arriving at the Club addressed to strangers.

GENERAL SERVANTS REGULATIONS.

No officer or servant will receive, under penalty of dismissal, any present whatever from the members, guests or tradesmen of the Club, and any tradesman detected in

giving such, will be forthwith discontinued and never dealt with again.

Servants while on duty will not talk to each other, except on matters connected with their business; and no servant is permitted to address an individual member in the house on matters either personal or relative to the concerns of the Club, all communications of the latter kind to be made to the Secretary for the information of the Committee.

If any money or articles supposed to be the property of members, should be found by the servants in the Club House, they will be delivered to the House Steward.

No application for reinstatement of a servant, who may have been dismissed on the representation of a member, will be read or taken into consideration, unless it come through and be recommended by the member by whose representation he or she was dismissed.

Servants will be held responsible for breakage and loss of and damage to the property of the Club.

No servant of the Club shall be sent out of the House on any errand or pretence whatever, unless upon Club business by the Steward, Secretary, or member of Committee, or to post letters at stated periods, or to call a cab from the nearest stand.

MISCELLANEOUS.

No pamphlet, advertisement, or notice of any kind will be laid on the tables or put up in the Club by a member, without the consent of the Active Committee. Any pamphlet which it may be wished to make known to the Club, shall be sent to the Committee for approval.

The local daily papers are on no account to be taken out of the Morning Room during the day or evening of publication, nor any other papers for one day after they are laid on the table.

Sandwiches or biscuits may be served to members in the Billiard, Smoking and Card Rooms.

No refreshment of any kind will be served after twelve o'clock, P. M., unless specially authorized by the Active Committee for the month, on timely application in writing to them.

The foregoing Regulations may be altered by a majority of the General Committee at any meeting, notice of such alteration having been given at the previous meeting, and communicated to each member of the Committee, together with the date of the meeting for final disposal of the same.
