And I hereby call upon all Electors to examine the said lists, and if any omission or other errors be perceived therein, to take immediate proceedings to have the said errors corrected according to law.

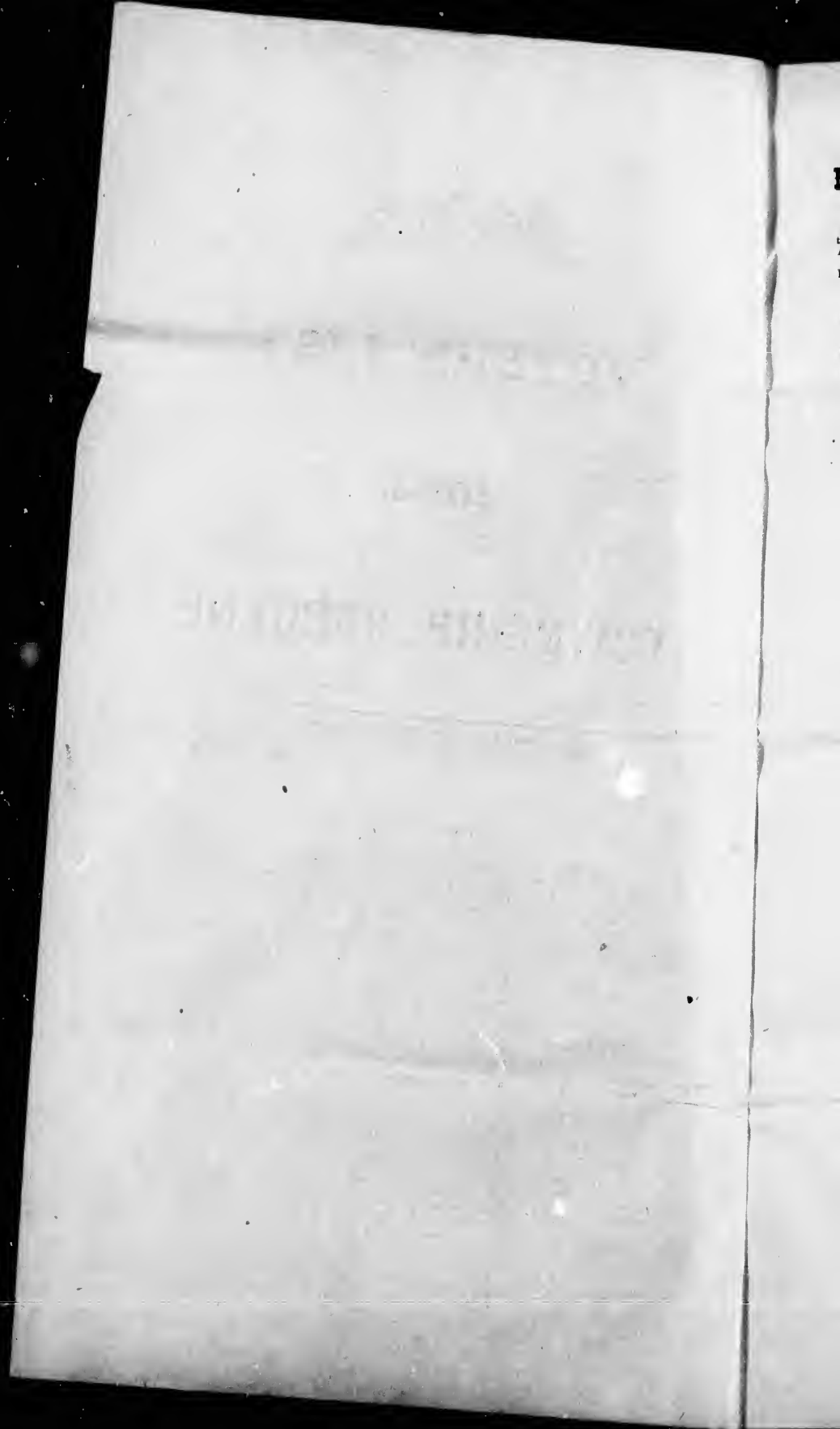
