Boy Scouts Increase in Canada.

The Maritime Headquarters of the Boy Scouts Association, at Truro, N. S., are in receipt of the Census Returns of the Boy Scouts Movement in Canada for the past year. A very healthy growth in troops, Officers and Scouts is shown notwithstanding the great drain upon all leaders of the Movement during the past four years.

Every encouraging sign is shown by the number of business men and heads of families with growing boys of their own who are acting as Scoutmasters, Instructors and Examiners. More and more are men of affairs realizing that the Boy Scout Movement has been discovered the most definite and practical program ever undertaken for the development of good citizenship and the formation of the character among boys.

The above statement of Scouts and Wolf Cubs show that during the past year over 19,000 Canadian Boys received Boy Scout Training as members of 767 Troops under the leadership of more than 1250 adult leaders.

The Chequer's Mistake.

The 'Moncton Transcript' has this to say regarding the Governor-General's attendance at St. Paul's Church: 'The Register is in error. The chequer down in Halifax only took the Duke of Devonshire by mistake to one Anglican Church instead of another. Goodness only knows what would have happened to this country had he been taken by mistake to a Presbyterian, a Baptist or a Methodist church. Is it not about time that those who prepare programmes for the Governor-General on his official visits over the country should recognize in practice the fact that in Canada there is no State Church, and that all churches stand on terms of equality?'

Short Course in Agriculture.

The College of Agriculture is putting on a Short Course this year as it has done each year, during the month of January, since 1915. Plans are practically complete for 1919. The Principal is still corresponding with the railway managements, hoping that with the conclusion of war conditions, more satisfactory railway rates may be obtained. A telegram received recently from the Eastern Passenger Association, at Montreal, states that his request will not be finally answered until Dec. 17th. Annual Public Exercises of Wolfville High School.

On Friday evening, Dec. 13th, Wolfville High school held its annual public meeting in the Opera House, for presentation of certificates and distribution of prizes.

The first feature of the evening was a short program of music of which the opening number was a patriotic solo, 'Union and Liberty.' Miss Wilson effectively rendered the solo and was supported by a chorus of High school students and a few other selected voices.

Miscellaneous DeWolfe was next heard in a violin solo which was rendered with Miss DeWolfe's usual charm and skill. Vocal solos next by Mr. Mason and Miss Wilson were much enjoyed by the audience.

The second part of the program began by the reading of an essay, 'The Lion of Lucerne,' written and read by Miss Margaret Ford of the graduating class.

Certificates were then presented to students of the three High school classes who succeeded last June in winning the Government certificates for which they wrote.

For the information of the public, it should be stated that the High school is composed of three classes of students known as Grades IX, X and XI. Grade XI is the third year of the course and constitutes the graduating class.

Every year, at the close of the school in June, students from these three classes write examinations, set by the Educational Authorities at Halifax. These examinations are conducted by the special officers appointed by the Superintendent of Education. Dr. Wieslock, of Acadia, is the officer for Wolfville station. The papers written at these examinations are read and marked by leading provincial educationalists, appointed by the Council of Public Instruction. The system is so devised that the High school teachers have nothing to do with the conduct of these examinations or the marking of papers written thereat; nor do those who examine and mark the papers have any means of knowing whose paper is being examined and marked. The system is free from favoritism and absolutely impartial.

The generosity of a number of our public-spirited citizens made it possible to distribute prizes to the value of fifty dollars. Those who contribute to this fund are: Mayor Haies, W. H. Chase, George Munro, Captain Beardsley, \$5.00 each; Dr. Thompson, A. M. Wheaton, \$1.00 each; and Acadia College a scholarship worth \$24.00. The basis of award of prizes was the standing made in the Government examinations.

The following prizes were distributed:

- GRADE XI. First—Acadia College Scholarship, value, \$24.00. Won by Miss Margaret Ford for highest standing, presented by Dr. Cullen. Second—Five dollars, won by Theodore Rand. GRADE X. First—Five dollars, won by Miss Mary Patrinquin; second—three dollars, won by Allan Parker. GRADE IX. First—Five dollars, won by Allen Smith; second two dollars, won by Gertude Rogers. SPECIAL PRIZES. Five dollars—For highest standing made by any pupil in the school, won by Miss Margaret Ford of Grade XI. This pupil also has the distinction of making the highest standing in Grade XI in King's county and second highest average in Nova Scotia. Three dollars—For highest standing made in Latin by any pupil in the school, won by Miss Hilda Johnson, standing 88. Donor of prize, Dr. Thompson, of Acadia College. Two dollars—For highest standing by a pupil of Grade VIII at the High school entrance examination, won by Grace Beardsley.

A year ago children in all grades joined contributions for purchase of fifty dollar Victory Bond. The bond, now worth fifty-two dollars and seventy-five cents, was presented to the Navy League of Canada through its representative here, the Rev. G. W. Miller, who suitably acknowledged the gift.

Can't Afford This.

According to figures submitted by Professor T. N. Carver (Economics) and Professor Walter B. Cannon (Physiology), of Harvard, the brewers in the United States used in 1916 enough foodstuffs to supply the energy requirement of 4,500,000 working men for a year. The report of the Internal Revenue Department shows that Boston brewers make 25 per cent of the beer made in the United States. In other words they used foodstuffs enough for about 112,000 workmen, or 186,000 children since the average child's ration is about three-fifths that of a working man. As the Administration has required the brewers to reduce by 25 per cent the amount of foodstuffs used in beer from now on, it is fair to estimate that the Boston brewers are using foodstuffs sufficient to supply the energy requirement of 1,500,000 children. There are now only 115,534 school children in all of Boston's public schools!

Children Cry FOR FLETCHER'S CASTORIA

Drastic Prohibition Measures.
The New Brunswick Temperance Alliance have passed a strong resolution in favor of steps being taken at Ottawa to see that the very necessary Dominion prohibition be enforced by direct prohibitory legislation at the next session of Parliament.
What is pronounced by officials of the Anti-Saloon League to be the most drastic prohibition law ever enacted in the United States will become operative in the State of Washington this month. Under its provisions any person with as much as half a pint of liquor in his possession may be arrested. Violators are subject to a fine of from \$50 to \$250, or to 90 days in jail or both. The law differentiates between possession for one's personal use and possession for sale. The person who is caught with liquor in his possession for the purpose of sale is a felon, subject to imprisonment in the State penitentiary for from one to five years.

Troop trains with returning soldiers are to be given preference over all other trains. This is the rule of the C. P. R. in so far as it is consistent with safety, according to a circular just issued by Vice-President A. D. MacTier. This was the rule of the C. P. R. when our soldiers were hurrying to the front, and it is to be the rule now that they are returning to their homes. "What is particularly desired," says the circular, "is that all officers and employees concerned shall, in so far as possible, place themselves in the position of a soldier's father, mother, wife, sister, or other relative of the returning soldier, and deal with them as they would wish to be dealt with under similar conditions."
"All this being accomplished, it will add substantially to the welcome the company desires to give to returning soldiers, as well as to the comfort and convenience of relatives and friends who desire to welcome them."
In order that relatives and friends desiring to meet troop trains should have information as to the hour of arrival of particular instructions regarding the location of the train, the circular is particularly explicit. It is to be the rule that all troop trains, with all particulars available as to the names of steamships from which the passengers come, and any other details of this information should be promptly and regularly posted on station bulletin boards, and corrected from time to time as may be necessary. Operators should keep in close touch with the movement of the trains, and the information posted may be up to the minute. Train agents should be at all times fully informed in connection with the trains and their movement and they, as well as other employees, should be kept posted to deal courteously and patiently with all enquiries, giving them correct and clearly the fullest information possible in response to their enquiries.
