

Held in the Hall of Fuller Lodge, No. 5, Albion Mines, on the 15th day of February, 1870.



Albion Mines, Nova Scotia, Tuesday, February 15th, 1870.

The Right Worthy Grand Lodge of the Lower Provinces met this day in semi-annual Session. Deputy Grand Master R. J. Griffith called the Lodge to order, and opened in due form. A letter was read from Grand Secretary Fraser, stating his inability to attend on account of illness. P. G. John Matheson of Fuller Lodge was appointed Secretary pro. tem.

Grand Representative R. Doull, having notified the Lodge that he could not be in attendance, his report was read by the Grand Secretary, p. t. and passed to Committee.

To the R. W. Grand Lodge of the Lower Provinces:

REPRESENTATIVES AND BROTHERS.—We are now assembled in Semi-annual Session in compliance with the Constitution and usages of the Order, and for the Pepresentatives of the various Lodges in this jurisdiction to convene. It affords me much pleasure to meet with you on this occasion, and submit to you a statement of my doings for the past six months.

I assure you that in laying before you this my first report, that I feel gratified in having to Inform you that our Order shows evident signs of advancement and increase in this jurisdiction, and that ere iong the principles of "Friendship, Love and Truth," will be found sown broad east not only where it is now but in every city and town in the Dominion.

In the first place I have issued dispensations to institute Lodges as follows: Pioneer Lodge, No. 9, St. John, N. B., on the petition of R. R. Barnes, A. Robertson, G. T. Knollin and others.

Also, St. Lawrence Lodge, No. 8, Charlottetown, P. E. I., on the petition of J. P. Irving, J. W. Falconer, W. H. Barnard, Andrew E. Patrick and W. B. Allen.

Also, Griffith Lodge, No. 7, Truro, N. S., on the petition of James E. Geldert, James Nelson, D. Nelson, P. J. Chisholm and John D. Fraser.

The officers of the above Lodges were all elected and installed into their office in due form,

At the beginning of the present term, I visited the different Lodges and installed the officers. The season not being very favorable and the distance so great, I forwarded a dispensation to Pioneer Lodge, No. 9, St. John, authorising P. G. Barnes to instal the officers in that Lodge.

St. Lawrence and Griffith Lodges being but recently instituted, I thought for the better working of the Lodges that the officers retain their offices until sometime in the Spring or Summer season, the members of the Grand Lodge would then have an opportunity of visiting and installing in ample form.

The absence of appeals, and the harmony existing in the different Lodges impress me with the hope that the quiet working of our Order, is gaining for it a character, and establishing such an institution in our land as is suitable to meet the social and intellectual wants of the community. The character and virtues of our Order will be closely scrutenized by the public, let our conduct be such as will commend our principles, and then we will expect a full realization of the bonds of Friendship, Love and Truth. Business will be brought up for your consideration, which I know will have your best attention.

In conclusion Brothers I thank you for your assistance and connsel, whenever called upon, and your attention to duties. I respectfully submit this report for your consideration.

To the R. W. Grand Lodge of the Lower Provinces B, N. A.

In compliance with the constitution of this R. W. Grand Lodge, the undersigned Grand Secretary respectfully presents the following report:—

Since we last met, two if not three new Lodges have been added to our number making six Subordinate Lodges in this jurisdiction. I

have received the Report of Pioneer Lodge No. 9. St. John N. B., showing a membership of 24 up to 31st Dec. 1869. They have paid up their dues in full to that time, but have refused to pay the per capita tax until they know something more about it. I explained the matter to them and told them I would not insist on its being paid until after the sitting of the Grand Lodge, when I would bring the matter before this body for their action.

St. Lawrence Lodge, instituted in October 1869, and being so late in the season, the term of their Offices was allowed to extend to the 30th June 1870, consequently from them I have received no report.

The Lodge In Truro I can say very little about having heard nothing about it since I delivered the Dispensation to D. G. M. Grifflth.

I have been in receipt of the following publications some of which I have subscribed for, others by favour of the publishers, "American Odd Fellow" "Odd Fellow "Odd Fellows Companion" and "Canadian Star."

Charters for the new subordimate Lodges will have to be granted at this meeting of the Grand Lodge, in view of this I have been in correspondence with the Grand Secretary J. B. King of the Grand Lodge of Ontario, in reference to procuring Charter Blanks, I have received samples from him, and he offers to have them printed to sult our jurisdiction, provided we order one hundred copies at \$150. But I thought they might be procured from some State Grand Lodge cheaper, and promised to bring the matter before you.

Provision will have to be made for the payment to Fuller Lodge No. 5, Albion Mines, of the \$100 borrowed money, which comes due on the 15th April next, also the interest or else an extension of the Note for one year longer.

There is also another debt of \$50, U. S. Currency, due the estate of the late Wm. Curtis, which I intended to have pald after the funds came in on the 31st December, but knowing that Fuller Lodge would want their money, I decided to wait till after the meeting.

According to orders given at last session I had 50 copies of the Proceedings printed, distributing them among the various Lodges in the jurisdiction and also to those in the United States who favored us with theirs,

I would recommend that the Constitution of the Grand Lodge be revised and printed, as I have had several applications for them from Subordinates; there is also wanted a supply of Working Books and Lodge Supplies.

The Constitution and By-Laws of Pioneer Lodge, No. 9, I have received, and presented them to this Grand Lodge for approval.

HALL IN SAN FRANCISCO, CAL., SEP. 1869.

To the Right Worthy Grand Lodge, I. O. of O. F., L. P. B. N. A.:

BROTHER REPRESENTATIVES AND BROTHER PAST GRANDS:—As your Representative, I attended the meeting of the Grand Lodge of the United States, held in the City of San Francisco, In September 1869.

Having travelled from the extreme Eastern Point of this Continent, on the Atlantic, to the extreme Western, on the Pacific, and the longest distance of any Representative who attended the meeting of the Grand Lodge. It was not without some personal sacrifice that I was able to represent you on this memorable occasion, but I can assure you that I was more than amply repaid, not merely by the opportunity thus afforded me of seeing much of the Continent that otherwise I might not have been privileged to see, but also by the hearty reception and kindly greetings that I received, along with the other Representatives, not only from our large hearted brethren of the Pacific Coast, but from all who had an opportunity of extending them to us along the road.

The meeting of the Grand Lodge at San Francisco was made by our Brethren of the Pacific Coast an occasion ever to be remembered, not only by those who constituted that body, but by all and every one who witnessed their Grand Reception and munificent Entertainment, in the "Golden City."

At Omaha the Brethren of that City gave us a right hearty welcome and a Grand Entertainment. At several places along the road the Brethren turned out in force to welcome and cheer us on our way.

At Winnamuce the Grand Lodge of Nevada extended to us the "Right Hand of Fellowship," and a cordial greeting there. Grand Master Hayden made an able and interesting speech, which was responded to in a suitable manner by our Grand Sire.

At Sacramento the Brethren received us in a handsome manner, provided for us during our stay in that City, and entertained us with a Public Dinner and Grand Ball. At this City the Grand Representatives participated in the imposing ceremonics of laying the Corner Stone of an Odd Fellows' Hall.

At Alameda Brother Parker entertained the Grand Representatives and all who accompanied them to a most Splendid Luncheon before they crossed the ferry to San Francisco, thus exhibiting the largeness of soul of some of our California Brethren.

From Alameda we crossed over to San Francisco, by steam ferry, to meet with such a reception, as was never extended to such a body of men on this Continent before. Antid the booming of eamon, the ringing of bells, and a grand display of bunting we landed in the City, and at the tail end of a procession of Odd Fellows, interspersed with many bands of music, the head of which we could not see, we murched through some of the principal Streets, which were lined by tens of thousands of the Citizens. The scene was altogether the grandest I ever beheld, and one never to be forgotten. It was not merely members of the Order, of the City, that gave us a right, but every Citizen. During our stay in San Francisco, we were the recipients of much kindness and hospitality from Citizens outside the Order as well as from those belonging to it.

Upon assembling at Pacific Hall, just before the opening of the Grand Lodge, the Grand Master of California addressed the Officers and Representatives of the G. L. U. S., in the following mode of cordial welcome:—

MOST WORTHY GRAND SIRE, OFFICERS AND REPRESENTATIVES:

At last the long looked for hour has come. The Grand Lodge of California stands face to face with the Grand Lodge of the United States, which ought to be in name, which it will be in fact—"The Supreme Grand Lodge of Odd Fellowship."

For a few days you have trod the soil of this Great State; you have gone with us as we promised on the night of your arrival, out through the "Golden Gate" into the Pacitic; you have there and then had your souls filled with thoughts too big for utterance.

I could see as I moved among you, that never before were you so inspired with the grand extent of the Continent, the grand feature of America and her institutions, the omniscience the omnipresence and the omnipotence of God. When you sailed by Yerba Buena, Alcatraz and Fort Point, out through the remarkable Channel leading from the Bay of San Francisco into the Ocean of Oceans, you seemed to feel that these mountains were there sundered by His Almighty hand, expressly to point out to the people who should inhabit this Continent, the gateway into which civilization should march, to the ends of the earth; and as the Steuner turned and headed for the Bay again, it was plain that you all felt that here was Empire. Brothers I am not mistaken, and with these high thoughts, and these throbbing hearts. I know that you have resolved so far as in you lies to make Odd Fellowship here and in all the civilized world a great humanizing moral power. I know that you have all within the last three days, stood in view of your selemn responsibilities, you have renewed your vows upon our altars. You have thanked God that He has brought you safely here, permitted you to take by the hand the Brotherhood on this coast, and to see these wonderful things.

Brotherhood! Nothing so deep down in the human heart; nothing so touching as the feeling of kindship, with the whole human race, the feeling that everywhere on the face of the earth, man would weep it he knew you were sad. Come then and accept these chairs, occupy the Itall, accept the hospitality of the City. Whatever the Grand Lodge of California can do to make you stay pleasant, will be done. From the graves of our fathers you come, from the dear spots where we

Ever green to the memory of these days. May our common Father give you that wisdom in council and that largeness of heart which shall exalt and perpetuate Odd Fellowship.

There were present at the meeting Representatives from every State in the Union except one, from Australia, Sandwich Islands, Ontario, and Lower Provinces. The Session throughout was characterized by harmony and good feeling, and much important business was transacted.

The motion for the restoration of the Aporn was laid over till next Session.

The Grand Sire, in his able and interesting report, shows that the Order, during the past year, has made great progress. I will only copy from that report the following decisions, which were confirmed by the Grand Lodge:—

1st. A Brother of the Searlet Degree in good standing, desiring a a Certificate of his grade, to enable him to join an Encampment, is entitled to receive the same, from the Secretary of the Lodge, in due form, upon application, and no vote of the Lodge is necessary for such Certificate.

2nd. The Grand Sire has no power to authorize Royal Purple Degree Members to wear aprons at the celebration of the 26th April, or on any other occasion.

3rd. The Grand Sire has no power to authorize Subordinates, under the jurisdiction of the State Grand Bodies, to apply to Sister Lodges outside the jurisdiction, for pecuniary sid for building Odd Fellow's Halls.

4th. The costumes were in the G. R. D. cannot be worn on public occasions.

5th. A Brother of the Patriarchal Degree is entitled to receive the Semi-annual Word.

6th. Voting in a Lodge is by the usual sign of an Odd Fellow. except on ballot for membership, and is proscribed by the work.

7th. A Patriarch under suspension in his Encampment, is not eligible to office in a Grand Encampment; and should such Patriarch be elected, it is not competent to instal him.

8th. It is unlawful for the Charge Books, or others containing or relating to the secret work of the Order, to be taken from the Lodge Room.

9th. The N. G. of a Lodge, being the proper custodian of such books, may entrust them to his subordinate Officers, for the purpose of qualification, while in the Lodge Room.

10th. The laws of the Order prohibit the writing of the Initiatory Charges, as well as all other parts of the secret work.

11th. The O. B. N. of N. G. (30 Charge Book) fully answers.

12th. A Lodge or Encampment has the right to visit other Lodges or Encampments, when accompanied by its Presiding Officers, outside its own jurisdiction, without Cards or a A. T. P. W.

13th. Not Confirmed.

14th. Grand Officers should address the Chairs as other members, Grand Honors should be given immediately after the recognition by the Officers of the Lodge.

15th. I do not understand that Gloves are dispensed with for members of the R. P. Degree.

16th. A Lodge is bound to recognize and give a member P. G. Regalia, who is admitted by Card certifying that he is a P. G., if he has not P. O. Degrees.

17th. Suspension for cause cannot be indefinite, nor for any unreasonable length of time.

18th. Not Confirmed.

19th. A member visiting a Subordinate Lodge shall be examined in the A. T. P. W. and also in the Degree in which the Lodge is open.

20th. An Encampment cannot expel from the Order—only from its own body; hence trials should if possible be had in Lodges as loss of membership in a Lodge severs connection with the Encampment.

21st. A Grand Lodge of a State may confer the power on a Grand Master, during the recess, to grant a petition, from a Subordinate Lodge to restore an expelled member to said Lodge.

22nd. A Grand Lodge of a State, pursuant to law, may authorize Public Installation by Subordinate Lodges. (Jour. 2971 & 2.)

The Grand C, and R. Secretary concluded his admirable report with the following satisfactory and encouraging remarks:—

The figures just given show that as an Order we have a net Capital, of invested Funds, of over Nine and a half Millions of Dollars, above the legitimate demands of our present need; the question arises, whether we measure up to our full ability as philanthropists and humanitarians. Do we occupy the field which lays open before us carnestly inviting laborers to its golden harvest, commensurately with our whole ability? We have done much within the last forty years, and the offering has gone up like the "alms and prayers" of the good old centurion, "for a memorial before God," but there is work yet to be done, and ever will be whilst the world and humanity survive. We began our career simply as assurers of each other against sickness and death; beyond ourselves our next aim was to care for those "in whom we live again," our second selves, our families; to material support to those we super-added in time, moral aid; the area of our ministrations has continued to amplify and enlarge, comprehending as it now does many collateral auxiliaries to the general object. In all these we these was enimently, and shall we resting upon this reward, be contented "with our laurels," or shall we go forward for further trimphs under the broad banner of Odd Fellowship? The world moves, and shall we in active sympathy with its fruitful genius onward "pitch our moving tent," or passively lag behind? That we have accomplished our original mission, and nobly, is very true; all our obligations have been met yet resources remain. Can we not avail of these and of the propititious fortune which smiles upon our labors to enlarge their value to our membership, to our widows, to our orphaned ones, to humanity at large? Let us diligently inquire into this subject. There is no organization of men in the world in which abounds greater elements of material power, and whose combined energy harmoniously directed is eapable of producing a larger influence for good within its

legitimate scope. Let us invoke His counsels and favor who has ever been our friend and support, let us learn our whole duty as men and brethren, and under His guidance enter with alaerity and wisdom upon its performance.

I will not extend this Report, by giving you details, of the doings of the Grand Lodge, which you will find in full in the published reports.

In accordance with the requirements of our Laws, I herewith submit to you the report of my official acts, with the various duties devolving upon me, during the term now expired, together with such suggestions, as in my opinion, call for your deliberation at the present Session.

Charters:—A Charter has been duly signed and delivered to Pioneer Lodge, No. 9, St. John, New Brunswick.

Dispensations:—Dispensation was granted to Brother P. G. Barnes to instal the officers of Pioneer Lodge; the most of the officers of that Lodge being absent when I was there in July.

Also, granted Dispensation to Pioneer Lodge, to instal and confer Degrees on members, at a distance, with a view to form a new Lodge in Frederickton, N. B.

Installations:—At the meeting appointed for installation, I visited Fuller Lodge, No. 5, officially, and on being admitted with the other Grand Officers proceeded to instal the officers for the present term, which being done in ample form I declared the officers installed. I also visited Norton Lodge, No. 6, officially, accompanied by the other Grand Officers, and thereupon the officers of that Lodge where installed in ample form. I also visited Eastern Star Lodge, No. 2, officially, and being admitted, accompanied by other Grand Officers, proceeded to install the officers, for the present term; on the Vice Grand being presented for installation, objections where made to the effect that not having a majority of votes cast, his election was illegal. On enquiring, I found this objection to be correct, whereupon I ordered a new nomination and election for members eligible to fill the office of V. G. Nominations having been made I ordered a ballot to be taken, the result of which was the election of V. G.; after which the installation was proceeded with, and the installation of officers declared in ample form.

I then proceeded to St. John, N. B., and visited Pioneer Lodge, No. 9, officially, and having all things in readiness, I installed the officers in ample form.

I also visited St. Lawrence Lodge, No. 8, Charlottetown, P. E. I., and installed the officers in ample form.

G., during the meetings of the Lodges, for reference to Law and usage, and thus much unnecessary delay is avoided, the time of the Lodge saved and a great deal of correspondence with the Grand Lodge saved.

In the Appeal of Bro. Yorston from decision of Eastern Star Lodge, your Committee could not agree with respect to the legality of the election of V. G. Bro. Campbell and Doull being of opinion that the election of any officer when a ballot is east by a member of another Lodge or by a member of the Grand Lodge while in his official capacity is illegal, and they are of the opinion that he cannot act in the double capacity at the same time. Bro. Mitchell is of a different

opinion, and thinks the election legal. Campbell and Doull are of the opinion that as the election was in their opinion illegal, the Lodge had a perfect right to declare it so, and the N. G. had a right to put the motion, Mitchell is of a different opinion. Your Committee however agree in recommending that as the point is one that has not to their knowledge been raised before in this Jurisdiction, it be referred to the Grand Sire for decision.




