4.—The Sheriff shall immediately upon receipt of his copies, cause one of them to be posted up in a conspicuous place in the Court House; the Clerk of the Peace, upon receipt of his copies, shall cause one of them to be posted up in a conspicuous place in his office; every Public or Separate Head Master or Mistress shall in like manner put up one on the door of the School House; and every Postmaster shall post up one of his copies in his Post Office.—39 V., C. 11, S. 4, S. S. 2.
