European Intelligence.

Government has advertised for tenders to convey mails by screw steamers between the Cape of Good Hope and Calcutta, via Mauritius and Ceylon.

Caird & Co. of Greenock are building a screw steamer of 700 tons burthen for the Nova-Scotia, Newfoundland, and Bermuda Royal Mail Packet Company.

The Limerick Chronicle states, that the screw steamship European, on the line between Limerick and London, will make a voyage from the Shannon to New-York in the spring.

FRANCE.—The following is the reply of Louis Napoleon on the presentation of the result of the votes:

France has comprehended that I departed from legality to return to the right. Upwards of seven million votes have absolved me.

My object was to save France and, perhaps, Europe, from fears of trouble and anarchy. I understood well all the grandeur of my mission. I do not deceive myself as to its difficulties, but with the counsel and support of all right-minded men, the devotedness of the army, and the protection which I shall receive, so far as I can, from Heaven to grant me,

I hope to secure the destinies of France by founding institutions responding to the democratic instincts of the nation, and the desire of a strong and respected government. To create a system which reconstitutes authority without wounding the feelings of equality, or closing any path of improvement, and to lay the foundation of an edifice capable of supporting a wise and benevolent liberty. (Cross of Vale Napoleon followed the speech.)

CRUEL MILITARY PUNISHMENT.

A pretty general opinion prevails in Canada and in the old country, that the British soldier is infinitely worse used and more severely punished than the United States' soldiers. The following, however, which we copy from the New-York "Herald" of the 26th ult., and which is by no means a solitary instance of such erroneous opinions:—"Yesterday morning one of the soldiers stationed on Governor's Island was tied for some hours with his back against a tree, and his hands fastened over his head, which was uncovered, amidst all the rain and the press storm. He was thus exposed to the gaze of the passengers in the ferry boats of Hanover avenue ferry, who expressed their indignation at such treatment of a human being. We know not what was the alleged misconduct of the soldier.—[Montreal Gazette.]

SINGULAR TRIAL.—Since the opening of the Circuit Court, the case of Baldwin vs. Dr. Waddell has engaged the attention of the Court. From the evidence adduced it appeared that the plaintiff severely flogged his hand last summer while working in the mills; that Dr. Waddell was called in, who dressed the wound, but that the patient lost his hand. It was attempted to prove that Dr. Waddell did not treat the wound properly, and the patient was induced to bring an action against the Doctor, fixing the damages at \$5000. The cause attracted a good deal of attention, as it was currently reported out of doors that it was the result of a conspiracy against Dr. W. The Judge charged the Jury last evening, and after an absence of about an hour, they returned with a verdict in favour of Dr. Waddell. The Hon. R. L. Hazen, and Wm. Jack, Esq., were the Counsel for the defendant; and Messrs. W. J. Ritchie, and A. R. Wetmore, for the plaintiff.—New Brunswick.

PROVINCIAL PARLIAMENT.

HOUSE OF ASSEMBLY.

Friday, Jan. 16.
Mr. Thomson presented a Petition from John Wallace Postmaster at Saint George, praying an increase of Salary, for the reasons therein stated;—referred to the Committee for taking into consideration claims from Couriers and Carriers of Rail.

Mr. Porter presented a Petition from Rev. M. A. Wallace, of the Parish of Saint Stephen, praying a return of Duty paid by him on an Organ imported for the use of the Roman Catholic Church at that place;—referred to the Committee for Trade.

Mr. Porter presented a Petition from Ebenezer Doubell of the Parish of Saint David, praying Legislative aid to enable him to rebuild a Grist Mill, Carding, and Twisting Machine, by reason of his establishment having been totally destroyed by Fire in the month of October last; received and referred to the Committee appointed to take into consideration the subject of the Agricultural Interests of the Province.

Mr. Thomson presented Petitions from Robert Watson, Esquire, Comptroller of the Customs and Deputy Treasurer at the Port of Saint Stephen, praying remuneration for his services as Comptroller at said Port.

Mr. Porter, by leave, presented a Petition from William Tread, Junior, and others, Trustees of the Saint Stephen Academy, in the Parish of Saint Stephen, praying Legislative aid to enable them to procure a Library &c. for the use of said Institution; referred to the Committee on School Petitions.

Mr. Robinson presented a Petition from Thomas Crossley, a licensed Teacher, praying to be remunerated for teaching a School in the city of Saint John;—received and referred to the Committee on School Petitions.

Captain Robinson presenting a Petition from the Trustees of the Saint Stephen's Academy, praying for pecuniary aid, said that this was not an ordinary School Petition; the inhabitants of Saint Stephen had sacrificed a large sum of money, and had built a School House, for the purpose of establishing an Academy of a very superior nature, in ordinary Schools; and they now asked for legislative aid, to enable them to complete the fitting up of their Institution with the necessary Library and apparatus.

The petition was received, and referred to the School Committee.

Tuesday, Jan. 20.

The House was occupied to day in receiving Petitions. Hon. Mr. Wilmett presented a petition from Cartier against the Bills sent from the Common Council relative to the City debt. A Bill for the erection of St. James' Parish in this City, was introduced and read the first time. A Particularized Bill was introduced by the Government. Dispatches were sent down in reference to the Revenue Bill, and the Colonial-Reciprocal Trade Act, both of which required amendment.

Wednesday, Jan. 21.

Messrs. Hincks, Young, and Tasche arrived at a late hour last night. Today they were introduced to His Excellency, and afterwards formally presented in both Houses of the Legislature. The day was principally spent in the reception of petitions, of which a great many went to St. John. The Bill to provide for building a Registry Office in St. John was committed and passed.

Progress was reported on the Bill relating to the Steamboat Landing. The House in Supply voted the usual grants to Lighthouses, School Teachers, &c.

The Canadian gentlemen will enter upon business with the Executive to-morrow.

After they have transacted the business relative to the Railways, they will visit St. John, intending to proceed to the United States by Calais and Boulogne, and return to Canada by way of Boston.

Thursday, Jan. 22.

The Canadian Delegates are said to have expressed themselves strongly in favour of the Railroad route by the Valley of the River St. John. The Government has prepared a project which will be submitted to the Delegates.

Bills to regulate the printing of the Acts of Assembly; to add the territory obtained by this Province by the settlement of the Canada-Boundary question, to the Counties of Victoria and Restigouche, and to Incorporate the St. Stephen's Boom Company, passed in Committee.

The Attorney General introduced a Bill to amend the Law for the collection and prosecution of the Revenue.

The Bill relating to Public Wharves in Portland passed.

The Auditor General's accounts were laid on the table.

In reply to the Address moved by Mr. Harding relative to the correspondence on the subject of the Judge's fees, the Governor promised to give the information required.

The time for receiving Petitions is extended to Tuesday next.

Friday, Jan. 23.

The House transacted much ordinary business to-day, and disposed of several local Bills. Progress was reported on the Bill for the erection of St. James' Parish, in Saint John. Mr. Needham objected to the wording of the Bill, which contained the clause, "as by law established," in relation to the Episcopal Church. The Bill relating to the erection of a Steamboat Landing in Saint John, has passed in committee.

The Executive-Council sat some time to-day, after which a conference took place with the Canadian Delegates. It is rumoured that a course of proceeding with respect to Railways had been agreed upon, as regards Canada and this Province, in which the concurrence of Nova-Scotia is necessary. The Canadian gentlemen with Mr. Chandler, leave

to-morrow morning, and will proceed with all despatch to Halifax. Any difficulty now existing will very likely be removed by this prompt and vigorous action, and by the joint proceeding of the three Colonies.

Saturday, 24th Jan.

Petitions continue to pour in. The Canadian Delegates accompanied by hon. Mr. Chandler left for Halifax this morning.

European Intelligence.

The American Mail Steamer *Arctic* arrived New York on the 20th, from Liverpool, with dates to the 7th inst.

Cotton, Flour and Wheat had advanced in value.

France was quiet. Coins hereafter to bear the likeness of Napoleon. The new Constitution was shortly to be published,—the first Article giving the title of Emperor to the President.

The prisoners of War will be released on condition of leaving France in one year.

As the President was passing out of Elysee he was shot by the Seny, who was immediately arrested and shot.

The Royal Mail Steamer *Azores*, from Southampton for the West Indies, took fire and was entirely consumed. There were 255 persons on board, of whom only 22 were saved.

LATER FROM CALIFORNIA.

Arrival of the El Dorado.

The steamer *El Dorado*, from Quebec, arrived at New York on Wednesday night, with the California and Sandwich Islands mails. Her report says her freights \$1,082.07, specie on freight, and \$200,000 in the hands of passengers.

The *Calaveras Chronicle* has the following return to the reported rich discoveries in the vicinity of Chilian Gorge. The new diggings are called "Sport Hill" from the fact that their extraordinary richness has tempted over nearly all the old sparseness of miners, who may now be daily seen yielding pick and spade as busily as the hardy miners. It would be useless to repeat the extravagant stories, none of which are controverted, that we heard of those extraordinary diggers, but we know by our own observation, that this is one of the richest places, in California.

The San Diego Herald gives an account of the execution of two men named Bill Marshall and Jim Yeridgo, tried and convicted by a military court martial, on a charge of having prevailed on the Indians to murder a mounted Stock, together with three others.

The expedition against the Indians appears to have been very successful. Their town of Agua Calientes had been burned. Nevertheless the Indians appeared to be still creating great havoc; only a few days previous to the above date, they had murdered sixteen who were crossing the country with droves of sheep.

Anouir, the chief Indian insurgent, was present at San Diego, and was, it was supposed, at San Francisco, long on the 16th instant.

SLANDER AGAINST KOSKUH.—The statement that Koskuk challenged Capo Long is utterly without foundation. Long and his first lieutenant, the Hungarian, so briefly that the other officers interferred almost in the face of their commander. But Koskuk would not, and did not, recognize the insults offered by any other way than by showing his wilfulness and determination to leave the ship. This is reliable.—(N. Y. Times.)
