The impression prevailed that the question of defence was entirely an Imperial matter, be-cause colonial dangers might result from Im-perial policy. The speaker admitted that ex-tension of the Empire might require that por-tions of it might incur danger. Encland's policy was, however, essentially a pache one, but danger of war aris-ing from a policy of some other country should induce colonists to make their defences efficient. Distant parts of the Empire were within the sphere of possible aggression. European nations were showing an increased

European nations were showing an incre desire for colonial and foreign possessi

desire for colonial and foreign possessions. The solerun and reasonable sense of interest and security which the colonies had in the shield which the Imperial Government threw over them should convince them that it was to their interest to contribute men and means to the mutual defence. In ad-dition to this, Lord Salisbury said he hoped that the connection between the colonies and England would become more real, and that the spectacle would be presented to the world of a vast Empire founded, not on force or 'subjection, but on sympathy and resolute co-operation.




