The duties collected at the Toronto Customs House during April amounted to \$225,375.72, against \$188,860.61 for the corresponding month last year.

LATELY ARRIVED English colonists have purchased 10,000 acres of land west of the Turtle Mountains, Manitoba, from the South Western hailway at four dollars per acre.

The Customs receipts at this port for April, ult., amounted to \$517,054; for April, 1880, \$328,113. The Inland Revenue receipts for the past month aggregate \$102,529, against \$90,-378 for April, 1880.

Massus, McKenzie, Powis & Go. of this city, ten merchants, have removed to the spacious premises, corner St. John and Hospital streets, formerly occupied by Buchanan, Leckie & Co.

The town of Lindsay, Ont., quite recently voted a bonus of \$20,000 towards establishing a cotton and woollen factory within its bounds; the town also gives a site free, and exempts the property from all taxation for ten years.

The Merchants and Ontario Banks have each declared a 3 per cent. dividend, and the Bank of Ottawa also declares a semi-annual dividend of 3 per cent. The Dominion Bank has declared 4 for the current half-year, and the Federal and Bank of Hamilton, each 3½ per cent.

A PHILADELPHIA press despatch announces that the leading coal companies have "resolved to make no change in the line, city, and harbor prices of coal for May." The combined Anthracite coal interests have agreed to suspend mining on three days of each week for the remainder of this month.

shortly in the eastern part of that city. A "white labor" boot and shoe factory commenced operations at Victoria, B.C., on Friday last.—On the same day, over 600 Chinese railway laborers are reported to have arrived at Victoria per steamships.

Seizures by the Customs authorities on both sides of the line for alleged attempts to defraud on the part of shippers and importers are becoming shockingly common. During the past week a carload of Canadian hay—which continues to meet with a large export demand from Americans—belonging to an extensive dealer at Stottsville, named Laberge, was seized at Rouse's Point, on the Canadian side. The car contained 13 tons and 59 lbs. of hay, which Laberge had entered at the Custom House as 10 tons. Laberge paid the difference and recovered the hay.

AT THE annual meeting of shareholders of the Bank of New Brunswick, held at St. John on Monday last, a statement was presented showing the liabilities, including rebate of \$50,000 and cash amounting to \$1,045,446.45, bearing interest, to be \$4,334,248.28; the resources of the Bank amount to the same sum, and included are \$555,072.55 due from other banks. The old directors were re-elected.

The Gailing Gold Mining Company, Belleville, will, it is stated, employ some 300 miners this summer.—The Pontiac County Council intend to send a deputation to the Quebec Government this month to urge the immediate commencement of the Pontiac extension of the Occidental Railway.—A large number of men are at work on the Eastern section, near Coteau Landing, of the Canada Atlantic Railway, and the contractor expects to have the road ready for cars to run as far as Alexandria in July

MESSRS. Forbes, Stevenson & Co., wholesale boot and shoe manufacturers, this city, have assigned in liquidation, with liabilities amounting to \$23,000, and assets \$30,000. Some three or four years ago Mr. Forbes compromised with his creditors at 50c in the dollar, showing then a surplus of about \$6,000; shortly afterwards Stevenson entered into partnership with Forbes, investing \$10,000 in the business. The firm were hard-working and fragal, but the senior partner lacked sufficient of the suaviter in modo, so important now-a-days to every man in business. Their capital also proved insufficient for them to withstand the sharp competition in the trade, which has rendered them unable to sell goods at a profit, and, getting steadily behind for two or three years past, finally called a meeting of their creditors, held on Monday last. The result was the assignment, and, although the condition of the firm shows that they have about sunk the amount of capital invested, they expect to be able to pay in full.

THE New York Court of Appeals has rendered a decision against the life insurance companies who contested the payment of their policies in the case of Walton Dwight of Binghamton. Col. Dwight obtained insurance to the amount of \$225,000 between Aug. 18 and Sept. 17, 1878, in various companies, including \$10,000 each in the Ætna of Hartford, Travelers' of Hartford, Union Mutual, Me., National of Montpelier, New England Mutual of Boston, State Mutual of Worcester, Mutual of Springfield and Berkshire of Pittsfield. On Oct. 15 Dwight was taken sick, and he died Nov. 15. A thorough autopsy was made of his body and an inquest held, but nounnatural cause of death could be discovered. The insurance companies, however, were suspicion, and all refused to pay their policies except two.

The amending Act of 1880 reads, "In the item concerning 'Oil-Cloth,' after the word 'printed,' insert the words, 'Table-covers similarly prepared, and oiled or painted window-blinds'." In the Tariff changes that went into operation on the 26th February, 1881, is the following amendment: "17. Strike out the items respecting 'Oil-Cloth for floors, &c.'.....and substitute the following in lieu thereof: 'Oil-Cloth for floors, tablecovers, window-blinds and scenery, in the ... piece, cut or shaped, oiled, enamelied, stamped, painted or printed, thirty per cent. ad valorem. See JOURNAL OF COMMERCE of March 4th.

FINANCE AND INSURANCE REVIEW.

MONTREAL, MAY 6, 1881.

THE QUEBEC LEGISLATURE.

The speech delivered by the Lieutenant Governor of Quebec at the opening of the Session on the 28th inst. does not lead us to anticipate either a protracted session, or one that will be productive of much public benefit. We are told that "few measures of a public nature will be sub mitted to you this session," an assurance which is rather calculated to afford relief. The measures indicated, with one exception, do not strike us as likely to provoke party controversy, although Mr. Joly's remarks justify us in assuming that there will be a vigorous warfare between the Government and the opposition. The

exceptional measure is one for amending the Constitutional Act by extending the duration of the Legislature of the Province. There has been no public discussion of this question, and it is quite probable that there is no serious intention of passing a bill during the present session, but that it is thought desirable to ventilate the subject. We presume that there is no intention of prolonging the term of the present House of Assembly.

The question of most interest for the Province just at present is the state of the finances and, in connection therewith, the future policy of the Government regarding railways. The mover of the address took occasion to advocate the claims of two railways to Provincial aid, and we have no doubt that additional ones will be preferred by members for counties on the south of the St. Lawrence. It may be hoped that we shall not have a renewal of the railway rings, and that the Government will be firm in its resistance to all propositions which may involve an increase to the public debt, which is already a source of great anxiety. An assurance is given that the statement of the railway receipts will be found very satisfactory, and that it "will enable you to appreciate the steps to be taken by my Government for the future working of this great enterprise." Whatever these steps may be, there will probably be a general concurrence of opinion as to the importance of severing all connection between the Government and the railway. The Ministers must have found out by this time that the control of public works, and the patronage incident thereto, are not productive of any advantage to a Government, but quite the contrary. We have not been inclined to join in the aspersions which have been thrown on the Premier in connection therewith, but we are thoroughly convinced that the subsisting arrangements are prejudicial to the influence of the Government.

We find no reference to the railway extension to Toronto, which is known to be promoted by gentlemen acting in behalf of the Government railways, and whose aid must take the form of money which must, it appears to us, be furnished by the Province of Quebec. If any new scheme of railway expenditure should be proposed, it may be feared that it will not only involve a large additional expenditure of an unproductive character, but that, in order to secure the votes necessary to pass it, other enterprises of a more exceptional character will have to be aided. The Minister who is specially responsible for guarding the public treasury is Mr. Robertson, and he enjoys the reputation

of being a man of prudence, and is well aware of the special difficulty that exists in the Province of Quebec in obtaining additional revenue. It is, perhaps, premature to discuss the railroad policy of the Government on such vague information as the public are yet in possession of, but the subject is one of such great importance, and the Quebec Legislature has been so reckless on former occasions that we cannot but feel very apprehensive as to the course that will be adopted during the present session.

THE BEET SUGAR INDUSTRY.

It is premature to exchange congratulations on the establishment of beet sugar manufactories in at least three counties in the Province. It is possible that with the enormous protection, which is only intended to be given temporarily, and with the aid of subsidies, the beet sugar industry may be established, but, while wishing the enterprise every success, we own that we have no confidence in temporary protective measures, and we think it an unwise act in the Government to hold out the inducement of temporary protection to encourage the investment of capital in buildings and plant, which may prove unremunerative when the products are subjected to revenue duties. The promoters of the manufacture of beet sugar, many of them practical and successful business men, have stipulated for exemption from excise duties for a term of years, but we venture to predict that, when that term has expired, there will be a demand for the continuance of the exemption, accompanied by a declaration that, unless it be granted, all those engaged in the manufacture will be utterly ruined. We are not aware of any instance of a person engaged in a protected industry being willing that such protection should be withdrawn, unless, perhaps, we except some of our prominent cotton manufacturers, who, we imagine, would prefer a little more foreign competition to that of a multitude of factories at home, - and we must not conceal from ourselves that a powerful party in Ontario and in the Maritime Provinces is pledged to a readjustment of the tariff, in case it should obtain power at the expiration of the present Parliament. The beet sugar industry is in an exceptional position. There is a general concurrence of opinion. that, for revenue purposes, it is absolutely necessary that sugar should be taxed, as it is in all countries, except England, where it is consumed. We doubt much whether any Minister would be bold enough to propose to Parliament to give a bonus in money to every manufacturer of beet sugar equivalent to the amount

which will be lost to the revenue by his products. The loss will be just as great if beet sugar is allowed to go into consumption temporarily, free of duty, and when the time comes for putting on an excise tax there can be no doubt whatever that there will be intense public discontent. The manufacturers will forthwith reduce the price of beets, which will create dissatisfaction among the producers, who will consider themselves illused, and all the parties interested will clamor for the continued exemption of beet sugar from any tax. Time will prove whether these views are correct.

CATTLE RAISING.

The partial failure of the hay crop in the United States last year, and the suddenness with which winter set in upon wild grass sections both in Canada and that country, created an unusual demand for feed and forage during the winter. Agents and speculators in hay, were to be found all over the country, and farmers in some sections sold their hay delivered in the market town, early in the winter as low as \$6 per ton. We sounded a note of warning on the subject last fall in referring to the short-sightedness of certain Bruce County (Ont.) farmers in selling their hay at such prices, and considerable money has been made in various sections of the country by those who took the hint and entered upon the purchase of Canadian hay for the American markets.

The growth of our cattle trade with Great Britain, promoted in some degree by the embargo upon American beeveswhich notwithstanding every endeavor, public and private, continue to be afflicted with the foot and mouth disease-renders it important that some means beyond distillery feeding be devised whereby a larger number can be fattened for spring ship. ments. The present condition of affairs cannot last; as soon as the European markets are open without reserve to the cattle trade of the United States, our people will find a difficulty in competing with "raisers" who can command open field pasturage all winter, as in Texas with its enormous area, or with those some degrees farther north, where only a few days in the winter are too severe for out. door feeding.

Some recent American experiments based upon an old idea derived from the French, to whom in this respect, as well as in the sugar beet industry, the world is mainly indebted, tend to show how cattle can be economically kept and fattened during our long Canadian winters. It is

not alone in cattle raising that the new departure commends itself; the products of the dairy can be very materially enlarged and extended, and with the low temperature, the quality of dairy and store-packed butters can be improved after the methods adopted in Denmark and other countries of Europe, formerly described in the columns of the Journal of Commerce.

The new system is called Ensilage. As applied to grass, Ensilage is much older than the experiments of M. Goffart, the Frenchman to whom the agricultural world is indebted for the development, if not the origin, of the ensilage of maize. The following is from a work published by Grieswald in 1842:

"A curious mode of preserving grass for forage, instead of making it into hay, has been tried in Germany, in East Prussia; and it is this: Pits are dug in the earth, ten feet or twelve feet square and as many deep. They are puddled with clay, and lined with wood or brick. Into these pits four or five hundred weight of grass, as it is cut, are put in, a layer at a time, sprin-kled with salt at the rate of one pound to one hundred weight, and if the grass is dry, that is hundred weight, and if the grass is ary, that is free of rain or dew, two or three quarts of water are sprinkled over the layer. Each layer is trodden down by five or six men, and rammed firm, especially round the edges, with wooden rammers, the object of which is the exclusion of air. A little straw is then scattered over the layer to mark its dimensions afterwards. Layer is placed above layer till the pit is filled to the top, when the topmost layer is well salted, and the pit covered with boards, or a well-fitted lid, upon which is put a covering of earth of one and a half feet in thickness. Such a pit will contain five layers of grass, and should be filled in two days. The grass soon ferments, and in about six days subsides to half its original bulk. The lid is examined every day, and every crack in the earth filled up to exclude the air, which, if allowed to enter, would promote the putrefactive fermentation in the grass. When the first fermentation has ceased, the lid is taken off, and fresh grass put in, trodden down, and salted as before. The pit will now contain about ten tons of grass, equal to two or three tons of hay. The pits should remain shut for is weeks before being used, and then are used in succession. The grass thus treated has the appearance of having been boiled, and its sharp acid taste is very agreeable to cattle; and twenty pounds a day with chopped straw will keep a cow in good condition all winter, and twenty-eight pounds will cause a cow to give a rich and well-tasted milk.

The system as at present in vogue in New Jersey is due to a New York grain merchant, and is the result of experiments with the view of improving the size and quality of the native corn by an admixture in alternate rows of a species of luxuriant Southern corn. This did not ripen in time, but was twice as tall as the local species. In order to preserve it for feed he tried the Ensilage system, with satisfactory results, which is simply by pressure and by exclusion of the air. The experiment referred to was on rather a large scale. It all seems simple enough when seen, but the simplest things are always those which one arrives at after matured thought. On entering the barn two deep pits are seen, sunk right into the floor of the barn. The exact dimensions are, for each, length, forty feet; width, thirteen feet; depth, twenty feet. These pits are lined with concrete made of rubble and Rosedale cement. They are solid and substantial. These are the silos, which hold the ensilage.

The corn is planted in May, and cut about the middle or end of September, when it is some eight to ten feet high. The product is about sixty tons per acre, of green stalks and leaves. In the case referred to thirteen acres were planted; and from the yield, 780 tons gross of green stuff cut, 120 cattle were fed. It is perhaps possible that a yield of 60 tons per acre can be had from the corn referred to, but we observe that 22 tons are given as the average crop of Corn Fodder at the Agricultural College Farm, near Guelph, where brain and muscle go hand in hand. The very small amount of land used for this purpose, as in the New Jersey experiment, seems wonderful. Just as soon as the corn is ready, which is distinguishable by the tasseling and the formation of a few nubbins, in go the men, who lay it low. It is at once carted to the barn where are the silos. The green stalks and leaves are submitted to the action of ordinary cutting-machines, the only precaution necessary being that the knives be kept as sharp as possible, so that the green stuff shall not be bruised, as by rough handling the juices are expelled, and to that extent air takes its place in the cells of the plant -a thing to be avoided as much as possible. Two cutting-machines are used. which make the fodder into lengths of one-half and one inch.

Now as to the method of filling the silos. The cutting-machines deliver the green stuff into the cement-lined pits, the capacity of each being 300 tons. As the material goes in it is not trodden on, but worked evenly into the silos by changing the direction of the delivery. When the pit is full, level with the floor, a wooden case is placed like a fence around the pit, which case is seventy-five per cent. in height of the depth of the pit, for the ensilage by compression sinks about this much. The pit being twenty feet deep, when it and the fifteen-foot case are full, then the whole mass of green material is covered over with stout wooden planks, made in sections. These sectional covers are among the most important adjuncts of the silos, and in their proper construction a great deal of the success of the operation depends. These covers are made of two-inch-thick spruce plank, tongued and grooved, and firmly battened together, four feet wide, and one inch less

in length than the width of the silo. As the silo is forty feet long, it will take ten of them to cover it. The object in making them only four feet wide will be apparent later. Now when the sile or pit is full of green stuff, even to the level of the fifteen feet additional, the sectional covers are put on the green stuff, and these are weighted evenly and carefully. With many who have basements under their barns, a silo, or pit, could be made outside, close to the basement wall, located in a place where it would be most convenient to use in the basement, or otherwise, by making a passageway to the pitor sile, through the foundation walls of the barn. Any form or construction of silos, or pits, which answers the location and condition may be used, such as pits or wells, open only at the top, the food being put in and taken out from the top only. Such silos, or pits, would have the advantage, that successive croppings might be put in the same pit, or silo, one above the other, each being sealed with a layer of earth when put in. The deeper the sile, or pit, the more they will contain in proportion to measurement, owing to the greater density of the contents from the weight of the mass above; and the greater the pressure the more thorough the exclusion of air, and, without any doubt, the better preservation of the ensilage.

There is no reference to the use of salt in the system as recently practised by a few persons in the New England States. The whole secret of ensilage depends upon a simple mechanical one, that of perfectly even continuous compression. The air must be excluded, and also the ambient moisture. One of them weights his covers by placing on top of each silo fifty tons of grain or ground feed in bags, which he afterwards uses to mix with his ensilage at time of feeding. He recommends, in case grain is not handy, that barrels be filled with gravel or sand, and used for the same purpose. As soon as the weighted covers are applied, the mass gradually sinks, until it reaches a level with the floor, and if the pit has been properly constructed, after the sinking down is concluded, the pits, or silos, are exactly filled. In about ten days the mass has come down to its bearings. In two weeks after it has been put down it is ready to use, and the operation is completed.

COAL PRODUCTION AND CONSUMPTION.

Coal, iron and textile fabrics being three of the principal commodities of the world's commerce, reliable statistics concerning

them offer a peculiar interest, inasmuch as they show the values required to satisfy the wants of all civilized nations. An Austrian professor has recently published a work which treats of the subject in an apparently satisfactory manner. rapid increase in the production and consumption in these commodities during the period from 1865 to 1873 proved that the economical condition of all countries was then at its best. The crisis of 1873, however, produced a reaction which spread over the whole globe, and it is only during and since the last months of 1879 that signs became apparent which pointed to a change for the better.

The production of coal has enormously increased within a comparatively brief period. Great Britain, which at the opening of the eighteenth century produced about $2\frac{1}{2}$ million tons, and in 1860 over $83\frac{1}{2}$ millions, had increased its coal production in 1878 to 137 millions. In 1787 France raised only 211,000 tons; in 1860 it produced eight millions, and in 1878 it produced 17 millions. The United States advanced from $1\frac{1}{3}$ million in 1830 to 3 millions in 1840, to over 15 millions in 1860, and to $54\frac{1}{3}$ millions in 1877.

The vast fields of lignite tertiary in the Saskatchewan and Souris regions, in the North West territory, which are of unknown extent, and not yet worked, are not, of course, included in the above estimate; vast fields of true bituminous coals are also reported still farther north, but we have as yet no authentic information as to their richness or extent.

In England about one-third was consumed by the manufacture of iron and steel, and more than one-fifth by the rest of the large industries, more than one-sixth for domestic purposes, and the remainder by gas-works, water-works, mines, railways and steamships. In France the metallurgical, industrial and gas works consume 72 per cent; the household 13 per cent., and the mines 4 per cent of the total amount. RELATIONS OF CANADA WITH FRANCE.

Senator Fabre has returned to Canada after a protracted absence in France, during which he has been carrying on what

seem to be very irregular negotiations with the French Government, regarding trade with the Dominion. We are now assured that the French Government will almost immediately issue a proclamation, "extending certain desired concessions. "now only granted to countries in special "treaty with France, which Canada is not." We infer that the "desired concessions" must be simply that France will put Canada on the footing of the most favored nations, as Canada has always placed France. We have heard a good deal of late from French Canadians of the importance of conciliating the Covernment of France by making concessions in the form of a reduction of duty on French imports, as an inducement to France to do justice to Canada, which she has never yet

Complaints have been made, without a shadow of foundation, against the Imperial Government for not protecting the interests of Canada when negotiating commercial treaties with France. It must be obvious, after a few moments' reflection, that we cannot enjoy our present privilege of regulating our own tariff, and at the same time expect the Imperial Government to pledge itself as to our commercial policy. We can understand and make every allowance for the strong feeling that has of late been manifested by the French Canadians in favor of increased intercourse with France. French capitalists have turned their attention to Canada as a field for the profitable investment of money, and have made a loan to the Quebec Covernment, and have established the Credit Foncier, and taken an interest in the Pacific Railway. With these operations the French Government has not been concerned, and up to this time that Government has acted towards Canada rather unfairly. We admit that our own Government has been much to blame for the treatment which it has received. It has pursued a policy of humble solicitation for justice, offering to make concessions of various kinds as an inducement to France to place Canada on the footing of other nations. We have been admitting French goods on precisely the same terms as those from Great Britain, while France has been imposing on Canadian imports duties considerably higher than from other countries, and for this most unfair policy blame has been attached by French Canadian writers to the British Government. Had the Government of Canada recommended Parliament to impose an extra duty of ten or twenty per cent. ad valorem on the imports of all countries which imposed discriminating duties on Canadian imports, the French Government would have long since changed its policy towards us.

The justice of such a course could not be impeached, and the citizens of France, who are interested in the export trade, small though it may be comparatively, would have brought a pressure to bear on their own Government, that would, in all probability, have secured the desired result. We have seen no indication up to this time, that the question at issue between France and Canada has been properly appreciated. Deputation after deputation has been sent to Paris to beg as a favor what ought long since to have been demanded as a right. Mr. Fabre's mission is said to have been successful, but we have no doubt that, if the statement should prove to be correct, the result has not been obtained without concessions on our part which should never have been exacted. We shall look with interest for further information as to what Mr. Fabre has actually accomplished during his protracted mission to Paris.

ENGLISH COTTON MANUFACTURE.

The American Consul at Manchester, England, has been gleaning some interesting statistics relative to the condition of manufacturers and business in his district. In 1879, out of 125 cotton spinning and manufacturing companies mentioned in the Oldham Chronicle, 104 paid no dividends, and in most cases made losses, more or less serious. In 1880 the number paying no dividends was reduced to fifty, and there were nineteen which paid dividends of ten per cent. and overthree of them paying twenty, and one twenty-two per cent. The following shows the average earnings per day in an East Lancashire Cotton Weaving Mill, the hours of labor being 56 per week:

ireman 64 to The employment represented by the lower rates of wages, say from 28 to 72 cents, are chiefly filled by women or girls and boys. In one of the largest mills of the district, out of 2500 operatives employed, 70 per cent. are women, and of these 40 per cent, are under twenty and 10 per cent. are under fifteen. These figures would hold approximately throughout the districts. Most of the married operatives live in cottages owned by the mills, the system of "boarding" being comparatively unknown. Unmarried operatives hire a room from some married operative, and furnish their own food. For 66 cents per week a small brick cottage containing a "living room" and two bed rooms can be had; for 81 cents. per week, one can be had which adds a kitchen and parlor to the rooms in the former tenement; and \$1.00 per week pays for a cottage with an extra bedroom. and \$1.25 to \$1.50 per week provides a cottage with four bedrooms, a parlor, kitchen and scullery. These cottages are built in blocks, are subject to careful inspection by a sanitary officer, and are usually kept clean and neat. It will be seen from the following table of the retail prices of provisions, that the operative on this side of the Atlantic has no occasion to envy his English competitor on that head:

BANKRUPTCY LEGISLATION.

A new Insolvent Act proposed in England has some interest for Canadians. Like ourselves, the people of Great Britain realize that all legislation on the subject has

hitherto been a disastrous failure. A benevolent law in its conception, and by no means foolishly constructed, the late Act deserves higher consideration than it has ever obtained. But, while theoretically excellent, it was practically mischievous. The evils were known only too well to the business community; they were evils that went on increasing from year to year until creditors almost ceased to look for any assets worth mentioning out of a bankrupt estate. Merchants got completely tired out, and, after the first momentary chagrin, usually made an effort to avoid any further reminder of the trouble, in most cases left the matter in the hands of the assignees, and did not attend meetings of creditors. They fancied it the better policy to look after those who remained staunch, and to avoid worrying themselves over "spilt milk." Every year it appeared that the assets grew less, until 30 cents began to be looked upon as a good offer. Compositions gradually became easy, and bankruptcy pure and simple more and more avoided.

In Canada, as in England, creditors seldom performed their part in the working of the Act. Neither they nor the inspectors sufficiently supervised the estates, contenting themselves with merely attending to their duties in a sort of routine fashion. To the supineness of creditors, or, rather, it may be said, to their lack of public spirit, is to be chiefly attributed the failure of the Act. Here and there where a creditor or inspector showed a zealous disposition herras accused of hardheartedness, was soon overpowered, and had to abandon his position. Once the creditors in this way deserted their duty. the law became simply an engine in the hands of unscrupulous lawyers and assignees. Too often was there felt to be collusion with the debtor; at all events they generally managed to get well paid for their work; a lower commercial morality became prevalent all round, for, where business becomes a kind of gambling, scruples disappear. Assignees, originally designed to be the protectors the creditors without being the enemies of the debtor, in too many instances became, along with the solicitors with whom they hunted in couples, mere plunderers. Merchants fell into the habit of treating an account owed by an insolvent as money lost; they signed off, wrote off the debt, and finished with it. Thus it arose that the assignee became, in a great measure, an irresponsible person, and he would not be human did he not often yield to the temptation thus put before him. It was also too frequently his interest to side with the

debtor rather than with the creditors; and so sure did merchants become that little or nothing was to be gained by throwing a debtor into bankruptcy, that they were usually ready to accept the smallest composition offered rather than take proper steps to protect themselves. Such, briefly, was the deplorable outcome of the law. The most cunningly devised rules for protecting the creditors and for facilitating the swift despatch of business were either ignored or adroitly turned into a means of robbery, fraud and conspiracy against the rights of creditors.

The new Act framed in England reverts to the principle of official control, and hopes by substituting the Board of Trade, as proposed in Montreal, the nominators of the assignees or trustees, to remedy the mischief which the Act, as now existing in that country, has caused. Under the new law, "liquidations by management" and compositions will disappear alike, and insolvent estates will be dealt with only in bankruptcy. The debtor is still allowed to present a petition, but the moment he has done so all control of his affairs passes to the Court. An official trustee takes charge of the estate till the creditors meet, which they must do within seven days; proxies are not abolished, but their abuse is checked; they can no longer be held by the debtor's solicitor, nor can they be used by any one to vote for his own appointment as a trustee. No compositions of less than five shillings in the pound is possible; it also provides for a percentage limitation of costs, both of the Court as well as the trustee. The creditor himself must make up a statement of his affairs within three days at his own cost.

Some of the new points introduced were features of the late Dominion Act. The main principles of the proposed Bill are good, but it may well be feared that the merchants and legislators of the Mother Country have not as yet had their fill of experience in the matter. They are more favored than we of Canada in having no "across the lines" as a dernier ressort for him who is closely pressed, or who thinks that fresh fields and pastures new are to be preferred to further efforts in the path of honesty.

A NEW TELEPHONE.

The remarkable discovery made by Graham Bell and Sumner Tainter that the rapid intermittent incidence of rays of light on discs of hard substances produces sonorous vibrations has attracted very much attention and has excited much physical work to solve an unexpected problem. The advocates of the emission theory of light have striven for 200 years to obtain such a proof of their theory and have

failed. Why have Bell and Tainter succeeded, or have they succeeded at all? May not their phenomena be due to some other cause than to the incidence of light? It was suspected by many that it was a heat effect, and not a light one at all. M. Mercadier, in Paris (Compter rendus, Dec. 6, 1880), and Professor Tyndall (Proc. R. S. Jan. 3, 1831), have placed this beyond the region of doubt, and now Mr. Preece, electrician to the London, Eng., Post Office, has completed the claim of evidence by a careful and elaborate inquiry into the cause of the phenomena. In the first part of his maper recently read before the Royal Society, he has shown that ebonic and india rubber, though opaque in the light rays, are remarkably diathermanous or transparent to the heat rays, and therefore that radiant heat can act through screens of those materials. Indeed, ebonite is shown to be almost perfectly transparent to radiant heat, while it is absolutely impervious to light. He next shows by experiments made on very delicate apparatus that no more vibrations than six per second can possibly be produced by the direct impact of heat waves causing expansion of the mass of the disc, and therefore that the Bell-Tainter effect is not due to the absorption of heat changing the volume of hard substance experimented upon. He next inquires whether the effect observed is due to a molecular pressure similar to that which produces the rotation of the radiometer, for this being a mere surface action, the element of time is eliminated. Many experiments are described which were made with discs of various kinds in different ways, but the results were so unsatisfactory and variable that the question was raised whether the discs vibrated at all. By the aid of microphones and specially-constructed . chambers, it is proved clearly that the undulations are those of the contained air, and not of the discs. In fact, the sounds were intensified by removing the discs. Moreover, the effects were materially assisted by coating the sides of the containing vessel with a substance highly absorbent of heat, such as the carbon deposited by burning camphor. It is next shown that the effects are dependent on the number of heat rays that pass through the discs, and not on those that are incident on them, and that the greater the absorbent character of the air or vapour contained in the case, the more intense the sounds emitted. All these results are repeated and shown with ordinary flasks lampblacked on their exterior and interior. Finally, it is shown that there is a time element introduced, and that the loudness of the note emitted depends not only on the rapidity with which the contained air absorbs the radiant energy, but also on the rapidity with which it gives up its heat to the sides of the case and the exits open to it. It varies also with the form of the enclosed space and with the character of the contained vapour, and with the diathermancy only of the discs. The effect being thus due to radiant heat. and its absorption by suitable surfaces, it was next shown that if a spiral of wire be completely enclosed in a lampblacked case sounds wereemitted when corrents of electricity wererapidly and intermittently transmitted through the wire, and, moreover, that when these currents were produced by a proper microphonetransmitter articulate speech was produced. Hence these phenomena are simply effects of radiant heat, and they are due to the changes or volume in absorbent guses and vapours produced by the absorption of thermometric heat in a confined space. All the varied and novel experiments which Mr. Graham Bell performed when he was recently in Europe with solids, liquids and gases, with tubes, flasks and discs, are thus brought within one simple explanation, and are due to a remarkable influence of degraded heat rays on absorbent vapours. The final result of this inquiry has been, not only to unravel an exceedingly interesting scientific problem, but to produce another form of telephone based on a new principle.

SHADE TREES ALONG THE HIGHWAYS .- The people of the New England States are at length thoroughly alive to the importance of planting trees along the roadside. In the towns and villages great progress has been made, as anybody visiting them may observe, and no one can for a moment question their usefulness. Many towns and villages and a very few farms in Ontario, can boast of elegant rows of maples, clms, &c. but their extension along the highways is still s arcely considered. In 1869 the State of Massachusetts passed an Act, which is still in force, under which any town may at a legal meeting grant a sum, not exceeding twenty-five cents for each of its ratable polls in the year next preceding that in which such appropriation is made, to be expended under the direction of the Selectmen in premiums, or in any other way deemed advisable, to encourage the planting of shade trees by the owners of real estate upon the adjoining public squares or highways. Connecticut has recently passed an Act which provides that any person planting or protecting forest trees one-quarter of a mile or more along any public highway, may receive for ten years an annual bounty of one dollar for each quarter of a mile so planted; the forest trees to include the elm, maple, tulip, ash, basswood, oak, black walnut and hickory; the elms to be not more than sixty feet apart, and the others not more than thirty feet apart. This offer has imparted quite a stimulus to tree planting, and private parties have supplemented this bounty by liberal encouragement. In some parts of Connecticut prizes of \$40, \$25, \$20 and \$15 are offered to the persons who may plant this spring the best and longest rows of trees along any public roads of that town, the awards to be made by three non-resident experts and announced at an Agricultural Fair next October. Every village and municipality should have its tree association.

F. Lemay, tailor, Lindsay, Ont., has compromised with his creditors at 45c, in three, six, nine and twelve months, secured. He was formerly in business at Peterboro' with one Cadotte, but the firm failed in 1878 and paid 35 per cent. of their liabilities. Lemay continued the business, and was chiefly supplied by a Montreal dry goods firm, but latterly, it is stated, has had too many depending upon him for support. Liabilities about \$5,000, and assets nominally the same. The business will be closed.

MR. NEIL, of Neil, Parish & Co., sash and door manufacturers, Toronto, has left that city

and is supposed to be in Detroit. The firm is in financial difficulties.

Potatoes.—Offerings on the Montreal retail markets are large, and owing to a "break" in the American markets, prices are easier; 65c is the highest figure obtainable for Early Rose or Chill. White potatoes can be bought at 55c per bag. The demand for export continues; over 90,000 bushels were shipped to the States last month.

Dawson Keen, retail hardware merchant, London, Ont., has placed his estate in the hands of trustees, selected from his creditors. The estate shows a surplus, and a meeting will be held on the 10th inst., to receive a report, Kerr has been considered weak for some time past.

THE WILLAND canal was opened throughout on Wednesday last; business at the opening of the season is reported betier than for many years.—Mr. William Wainwright, passenger agent of the Grand Trunk railway, has been promoted to the position of Assistant General Manager, in de vacant by the recent appointment of Mr. Drinkwater as Secretary of the Canadian Pacific Railway Syndicate. The appointment received by Mr. Wainwright, after many years of faithful, winning service, meets with general satisfaction.

W. H. Hill, of the firm of Hill Bros., general storekeepers, Seaforth, Ont., left for parts unknown on 26th April last. On the 30th April an assignment of his estate for the benefit of his creditors was executed to John Beattie. After W. H. Hill left it appeared that several notes which fell due the previous day, and had been protested, were pronounced by some of the parties to be forgeries, and this may account, probably, for his sudden flight. His liabilities are reported to be over \$30,000, of which fully one-half are due to a leading Toronto dry goods firm; assets, about \$15,000. The principal creditors are in Toronto. The business was formerly conducted by the Hill Bros.' father, Wm. Hill, who sold out to his sons about two years ago and started a cheese factory; he is still liable as endorser for about half of the firm's indebtedness. All his property, however, is said to be held in his wife's name. One of the sons visited this city a few weeks ago, and renewed accounts with a couple of our leading wholesale houses.

A LEIPSIC journal gives a method for hardening glass lamp chimneys so that they will not crack. The chimneys are placed in a pot of cold water, to which salt has been added, the water boiled over a fire, and then allowed to cool slowly. The glass will afterward resist any sudden changes of temperature. The same process will make all crockery, stoneware, porcelain, etc., more durable.

J. A. Welsh, a Hamilton grocer, has assigned —Isaac Sillick, another grocer at Teeswater, Ont., has assigned in trust. John McNaughton, grocer, Chatham, Ont., assigned, and a receiver appointed.—A. McIlbraith, a Listowel founder, has been asked by creditors to assign.—Wm. Adamson, an old Yonge street grocer, Toronto, has suspended, with liabilities of \$20,000 and assets, \$15,000.

The greatest accumulation of gold known to modern times, if not in all history, is now in the vaults of the Treasury Department at Washingon. The vaults contain \$173,000,000 in gold, besides \$55,000,000 in silver. The Bank of England has only \$75,000,000 in gold.

MERCANTILE SUCCESS.

There is no royal road to learning, nor is there an easy and flowery path to success in merchandising. It seems to be the belief of many people who are ignorant of such matters that the profits of merchandising are enormous, and that everything necessary to the establishment of a flourishing and profitable business is a little capital or credit, a store, and an announcement of those facts. Merchandising is a profession, requiring more time in apprenticeship than most of the mechanical trades, and is more difficult to learn than many of them. It is no easier to become a good merchant than it is to become a good lawyer or physician, and good merchants are just as rare as good lawyers and doctors.

A country merchant who has been selling goods in Missouri for forty-six years on being written to in regard to the standing of a new firm, replied to the wholesale dealer who made the inquiry as follows: "They are clever men, raised on their father's farm. He died and left them some real and personal property. They have little education, no business experience and little business capacity. As farmers I would credit them; as merchants I would not. If you are even with them stay so; if you are not, get your money as soon as possible, for you know, as I do, that not more than one farmer boy in a thou sand succeeds as a merchant in either country or town. In saying this I feel that I am doing them a kindness and perhaps saving you a few dollars. I have been merchandising for fortysix years, and yet it keeps me busy to pay my bills promptly. How will it be then with those who have little capital and no business experience?"

We do not wish to discourage young men from embarking in business on their own account. On the contrary we believe that it should be the object and the object of the object of any other inexperienced person to invest a little capital in business with the hope to succeed. Success is not only uncertain under the circumstances but almost impossible.

Profits, from the effect of close competition, are now very small; stocks have to be carefully selected and closely bought, and then judiciously taken care of, and the Grocer does not wish to encourage a clerk to endeavor to organize a usiness of his own until after he has served an apprenticeship with some good merchant, and qualified himself to conduct a business. We would therefore advise all young men who desire to enter commercial life to begin in the old-fashioned and only reliable way—at the bottom of the ladder as a clerk, until qualified. If they have the requisite capital, without experience, it is far better to invest the money in a safe way, where it will bear interest, until the necessary training and business education is completed—St. Louis Grocer.

MONTREAL WHOLESALE MARKETS.
THURSDAY, 5th May, 1881.

There has been no material increase in trade manifested since our last reference. A steady consumptive demand for all leading staples is reported, and, with the exception of sugars, which have been remarkably strong and advancing this week, values rule generally steady, at about former figures. New butter is slightly about former figures. New butter is slightly lower, and hides have advanced about ic per lb. within the week; hardware continues brisk to the extent of the country demand, and pig iron continues weak and unsettled. In breadstuffs little has been done on export account; shippers are deterred from operating by the high freights asked at this port, vessel owners wanting 1s. 6d. more than the ruling rates at New York. Otherwise, the shipping season has been fairly inaugurated; regular line steamships have arrived in port from Liverpool, and at least two have sailed again for that port, with cargoes, chiefly cattle. The Richelieu line of cargoes, chiefly cattle. The Richelieu line of boats have commenced running between Hamilton and Montreal, and several freight vessels are in the canal. The rates of discount, and of interest on loans are unchanged. Sterling Exchange rules firm at 9½ to 9½ prem, for round amounts, and 9½ prem cash over the counter. Drafts on New York drawn at ½ to ½ prem. On the Stock Exchange business has been increasingly active, with a strong advancing market, Montreal Bankleading in the upward movement, having advanced for the week about 11 per cent. The nadding in the upward movement, having advanced for the week about 11 per cent. The market closes strong, with an advance to-day of 3½ per cent. for Montreal and Merchants, buyers closing at 207½, and holders at 207½ for the former, and at 127 and 127½ respectively for the latter. Montreal Telegraph fell 2½ per cent., closing at 123 bid. Richelieu, also, declined 1 per cent.; it is stated on good authority that arrangements are all but complete for the that arrangements are all but complete for the running of an opposition Steamboat line this summer, the promoters being American capitalists. BOOTS AND SHOES.—There is little change to report. Our manufacturers are kept fairly busy executing the last of the early spring orders and attending to sorting-up orders per mail A few travellers have gone out during the week, and they report stocks in the country not much reduced. The spring movement in this, as in other branches, has been retarded by the unfavorable weather. The requirements of fall stock are commencing to attract more attention, but there will be little done in this direction for some weeks. Remittances continue good; few renewals were asked on the 4th inst.

Coal.—The opening of navigation, and arrival of Anthracite coal by water, has had the effect of reducing prices materially in this market; some leading dealers are now selling stove coal at \$6.50, and egg and chestnut at \$6.25. The demand is reported fair for the season. The first cargo of Scotch steam coal from Leith has arrived at Quebec, and been sold at \$5 per chaldron.

CATTLE, ETC.—The supply at the market on Monday last was not large, but good prices were obtained for butchers' cattle throughout. The demand for shipment was light, owing partially to the rumors afloat of the appearance of foot and mouth disease among the cattle in England. Prices paid for choice stock ranged from 5c to 5½c, and for poor to medium, 4½c to 4½c per lb. Sheep sold at 6 and 6½c per lb., some for shipment. Live hogs sold at 7½c per lb. in small lots.

DRY Goods.—Trade generally is quiet; one or two leading houses have experienced a rather or two leading nouses have experienced a tailer dull week, while others, more especially those favored with the visits of Lower St. Lawrence merchants, coming in by boat, have done a tolerably good business for the time of year. Purchases at this stage of the season are naturally and business for the season are naturally and the season are naturally a rally small, and business for the next few weeks is expected to be of a light sorting-up character. The weather, up to date, has been quite unfavorable to this trade; complaints against the weather are heard from all parts of the country. Travellers have been leaving almost every day during the week, and scarcely sufficient time has elapsed for them to give an account of them-selves. Stocks in the warehouses here, though well assorted still, are pretty well reduced. England prices rule low and in buyers' favor for nearly all kinds of cotton and woollen goods. Payments have exhibited an improvement; a large amount of money on paper became due yesterday, 4th inst., and was generally promptly paid. Only a few short-time renewals were asked for. A leading firm here, on making up the returns for April, were pleased to discover that remittances had been much better than for the corresponding month for several years, and showed about 30 per cent, increase on those for the like period last year.

DAIRY PRODUCE.—In the local Butter market business has been confined to supplying the local trade with new make, the supply of which has been steadily increasing. Prices have continued to rule in buyers' favor, and, as predicted in our last report, have further declined; 18c is about the highest figure that will be paid to-day for fine new Townships or Morrisburgs. Inferior grades are obtainable at 15c to 16c. Receipts are liberal, and, with stocks accumulating, dealers willingly part with their fine goods at 18c. In old butter there is little or no interest manifested; stocks are about exhausted, and our "prices current" on another page are entirely for the new make. A new feature is the demand in Liverpool for the Newfoundland market; during the past few days some 1,500 pkgs. butter have been bought in Liverpool for Newfoundland, at from 40s to 60s. In New York business is rather slow; the even disposition of buyers is to move with caution, but, on the whole, the market shows signs of steadiness, though there is no evidence of positive reaction. But few sales have been made to exporters. Greameries quoted at 22c to 23c, stale butter at 20c to 21c, and Western rarely brings over 17c. The local Cheese market; buyers in

the country are paying 11½c to 12½c for factories, and here fine old factory is quoted at 13½c to 14c, and new offerings at 12c to 13c. Liverpool market remains steady at 70s., and New York market is reported slow and gradually weakening; shippers are making determined efforts to secure a concession. Strictly choice white cheese is scarce, and has sold there at 13c, but for colored stock, no matter how fine, 12¾c is about the highest bid, with buyers not at all anxious. Old cheese is scarce, and held at full former figures, with holders not anxious to operate.

FLOUR AND GRAIN .- The English Breadstuffs market has developed a decidedly easier tendency within the week, and to-day the easier feeling seems to have reached a climax in Liverpool, lower prices all round for wheat hirerpool, lower prices all round for wheat being cabled. The imports in the United King-dom for the week show a decrease of 75,000 qrs wheat, an increase of 40,000 qrs. corn, and 15,000 brls. flour. The Western grain markets are reported firm to-day, with an upward tendency, but the local grain market rules decidedly inactive. The volume of business done here in grain for the week is small; there have been no sales of Canadian wheat for export, shippers complain that prices are too high, with present freights, to enable them to compete with the American exporters. In do compete with the American exporters. In American wheats either there is very little doing yet for export, as prices here, compared with New York, including freight and insurance, are much too high, especially in view of ance, are much too nigh, especially in view of the persistency with which freights are upheld; en grain 3s 3d to 3s 6d is asked to Liverpool, against 1s 8d to 2s from New York. Consequently shippers are unable to operate. Some charters have been taken for grain to Liverpool this week at 3s 3d. A large quantity of Canadian peus, bought early in the Spring, is being chiraced now but at present prices. is being shipped now, but at present prices shippers are holding off, and there must be a yielding in some direction soon if business is to be done. Holders are asking 89c; no buyers at over 871c. Oats are worth 371c to 38c; there over \$14.c. Oats are worth \$14.c to 550; there have been cargo lots sold at these prices, but 374c is about the highest bid to-day. Rye is quiet and easy at \$1.03 to \$1.07, and corn is quoted at 55c to 554c in bond. The local Flour market has been more active since the opening of navigation. In sympathy with the recent tone of the English markets, the demand has increased at firmer prices, especially for Superiors and Spring Extras. The supply of these grades is scarcely adequate to the demand. Superiors have changed hands in round lots at \$5.37½ to \$5.40 for shipment to the Maritime Provinces and points East of this city. No transactions on export account re-ported. Several cars of Spring Extra sold to-day at \$5.20 to \$5.25, an advance of about 5c. on last week's prices, and several carloads of strong Bakers' at \$5.50 to \$6.15. Bag flour is also in better request, and several thousand of Ontario bags have changed hands, at \$2.60 per cental. American flour is being imported largely for bakers' use, to supply the deficiency in Canada Spring wheat flour.

FRUITS.—The market is stagnant for nearly all kind. Apples continue dull of sale, at \$2.50 to \$3 for choice, and \$1.50 to \$2 for inferior to second-class stock. Oranges extremely scarce, and sell in small lots at \$4.50 to \$5 per box, or \$8 per case. Lemons in light demand; queied at \$3.50 to \$4 in boxes, and \$5 to \$5.50 in cases. Pine apples worth \$3 per dozen, Bananas \$3 per bunch, and Cocanuls reported in good request at \$5 per hundred. The New York Times says the fruit growers of Delaware have given up all hope of any profit from peaches in that State this season. "Not in 25 years has there been a worse showing: the belief is general among the growers that a great majority of the peach trees have been so injured as to make them useless. Many enterprising growers are already making arrangements for planting new orchards to take the place of trees dead or dying. Should the fear of growers prove correct that the peach orchards of the State have been practically destroyed, it will

result in serious loss, as not less than \$5,000,000 are invested in peach cultivation on the peninsula, more than half of which is invested in Delaware."

FURS .- The offerings of furs in this market are confined chiefly to Spring Muskrats, which command 18c for pruned trapped skins; shot skins are selling at about 12½c. But very few Mink Skins are offered, and bring from 50c to 75c for late catch. Beaver in good demand at \$3 per lb. Other kinds of furs might be quoted ps per 10. Other kinds of turs might be quoted for general information, but the offerings are very trifling. The stock of *Deer* and *Elk* skins has been sold out completely, and manufacturers of moccasins are anxiously awaiting the new collection, not obtainable before July, as they are bare of stock, and dependent alto-gether on what can be obtained this season for future production. The scarcity and demand will no doubt enhance the value of these goods beyond the figures ruling in previous years. Holders here of European furs are actively pushing their sale, and Seals can be purchased in small lots at figures bordering closely on London prices. Persian Lambskins are scarce, and will no doubt command high prices later in the season, as the article is said to be entirely sold out in Russia and other European markets. Dark Otters have been bought in Europe for this market at prices higher than ever before; it is a question, however, as to whether they will be wanted at the prices current by manufacturers. Astrakans are in increased demand for this market, as well as for South-Eastern Europe, and have advanced in value 10 to 15 per cent. Squirrels average fully last year's prices, and continue quite popular for ladies' wear, for linings, etc.

GROCERIES .- Sugars .- There has been quite a movement in Sugars during the week, with advance established for all kinds. Granulated is held by refiners at 9gc, and the lowest Yellow is about 74c, an advance of about 7 from lowest point. Sales and re-sales of Refinet Sugars include probably 3,000 bbls for the week. Some low British Refined were placed at about '7c to '7c for quantity, bags and casks. In Raw Sugars holders are firm. Teas, -Cable advices from Yokohama report that the market opened not quite so late as expected. The opening prices for choicest on 23rd April were \$50 to \$55 the picul; declined to about \$43 to \$45 within the last two days. Fine Teas with us retain their value, but trade is not active beyond ordinary wants. In Young Hysons, Gunpowders, imperials and Black Teas there is steadiness. *Molasses*.—Nominally firm for Barbadoes, but business is light. Syrups steady. Rice dull, at \$3.70 to \$4.20. Coffees - With the exception still of scarcity and high figures for Mocha, there is little of moment to notice in this article. Spices .- Pepper retains the high figures current for some time; other spices quiet. Fruits.—Some Valentias are going to London from New York. No change in Raisins generally. Currents firm.

HARDWARE AND IRON.—There is little or no change to note in the character of business, or tone of the market. Our leading hardware houses are extremely busy filling orders to supply the legitimate country demand, but there is no speculative spirit manifest and no heavy transactions reported, while prices rule steady and unchanged, throughout the list. The travellers are returning home, heavy having had a highly successful trip. Payments reported "very good, indeed." Bar Iron continues to move out in good-sized lots for consumption, at quotations; about 200 tons of Siemens bars have sold in lots during the week at \$2 to \$2.25. There is the usual consumptive demand also for *Tin Plates*, which have been selling freely all week in small lots at our quotations, which are said to be lower than the present cost of importation. Canada Plates have sold in round lots to arrive, at \$3.15 ex ship; quoted in the warehouses here at \$3.25. Orders for Nails are fairly numerous, and the manufacturers resolved at their meeting last Monday to continue selling at old prices for the time being. Pig Iron.—The market remains

unsettled; enquiries from western consumers are becoming more numerous, and a few round lots of Summerlee have been sold within the week at \$19, duty paid; some purchases of Summerlee and Coltness for June and July shipment have also been made on the basis of our quotations. There are, undoubtedly, some enger sellers here, who are selling, it is said, at prices fully \$1 per ton below the present cost of importation, and this has a weakening effect, so much so that cable enquiries as to the advisability of shipments have to be answered in the negative. Iron is very low in Glasgow, warrants being quoted at about 48s.; and freights are also low, latest quotation given being 5s. from Glasgow to Montreal. There is a steady consumptive demand, and small lots of from ten to twenty tons each continue to be sold here at \$18 to \$18.50 for Eglinton, and \$19 to \$19.50 for Gartsherrie and Summerlee.

HIDES AND SKINS.—Owing to the strong competition in the demand, referred to last week, together with the rather light offerings, prices for native hides are higher, 9½c to 10c being paid to butchers, and 10½c charged by dealers for No. 1. Other grades are quoted in proportion, ½c higher than last week. Western hides still quoted at 10½c to 10½c, with no sales to report. Culfskins readily command 11c per 1b, and Lambskins worth 20c to 30c each, as to size and quality.

Wines and Liquors.—Business generally remains inactive, at unchanged prices, but there has been tather more doing the past week in a jobbing way. Sales are chiefly to supply the retail consumptive demand. The advance for Champagnes, referred to last week, does not appear to have been general. A leading importer states that he is selling to arrive at the same prices as for stock held here, which have been quoted all along, while another quotes "Bollinger," which will cost 5s. more than last year, to import, 50c to 75c higher, and reports Tarragona ports and pure Spanish Sherries scarce, with an advance of £3 to £5 per pipe of 115, Imperial gal.

LUMBER.—Trade active, and prices firm. Owing to the difficulty in getting logs to the mills this dry season, probably one-third of the logs will remain in the small streams, which will advance prices according to the diminished supply. Stocks in the States are low, and a brisk demand is looked for from that quarter.

SEEDS.—The demand for Clover in small quantities is still active. Stocks are light and prices firm, at \$4.50 to \$4.80 per bushel. Timothy is without change, the market being well supplied. Last week's quotations of \$2.50 to \$2.65 per bushel still rule.

LEATHER. - Market continues quiet; it is now between seasons with manufacturers, whose wants are light, and they are generally disposed to wait until the time of actual need before making extensive purchases. The demand for Spanish and Slaughter Sole, however, has improved, and sales have been made at full prices; some holders of Slaughter are asking an advance of 1c on previous prices, as the prospective supply has been decreased somewhat by the destruction by fire last week of a large tannery at Portsmouth, Ont. No sales, however, are reported, at advanced figures. Spanish Sole is firmer, in consequence of a further advance within the week of he for dry hides in New York, and advance for Sole leather ere long. Some dealers appear to be under the impression that there will shortly be an advance for Bluck leathers also, but, while prices have most probably touched bottom the heavy stocks held here would seem to be an argument against an early advance. In Splitts, Opper, Buf and Pebble, there is little doing, the demand being quite moderate. No important transactions within the week, and no actual changes in values.

MILLINERY.—The season has opened fairly well, and promises a satisfactory trade. The leading houses here report a much larger busi-

ness done last mouth than during April last year; some importers state that the trade this spring reminds them of their experience five or six years ago, prior to the general trade depression. Travellers are said to be doing well in the country districts, notwithstanding the backward, chilly weather, and remittances were never known to be better, scarcely any renew-als being asked. As is usual at the opening of navigation, country buyers are commencing to visit the market, which, with two additional houses opening, will doubtless be increasingly attractive, and a busy time is expected next week. All classes of bugle goods are in active demand, these being fashionable for this season. Silk goods, also Satin de Lyons for dolmans and jackets, and black Spanish laces, which are rather scarce, will be largely worn. In hats, the Porcupine are all the rage in both England and America. There are many novelties shown in regular straw goods; fancy Italian plaits are perhaps the most note-

Ous .- A fair jobbing trade has been done in oils, especially Cod, of which several jobbing lots have changed hands within the week at 58c to 59c lmp, gal. Straits oil is reported in moderate request, at quotations favoring buyers; range prices, from 55c to 57c as to size of lot. In Lins ed there is little or nothing doing; stocks scarce and in few hands, and the English market being quoted slightly higher this market rules firm at last week's prices. Turpentine exceedingly scarce, and commands outside figures on the spot, but is quoted lower for lots to arrive by canal. No, quotable transactions re-ported; prices quoted at 70c to 72c, as to quan-tity.

Provisions. - The Western provision markets were somewhat depressed vesterday, and prices necordingly lower. Pork in Chicago having declined 124c to 174c per brl. on the previous day's quotations. Lard also declined 10c to 15c per 100 lbs., closing at \$11.25 June, \$11.30 July. It is expected that four additional packing houses will open in Chicago in a few days, and thus increase the supply of hog products. The local provision market has remained quiet The local provision market has remained quiet and steady all week, dealers being kept tolerably busy supplying the country demand, at last week's prices. Mess Pork still selling in small lots at \$20.50 to \$21 for Western; a few small lots of Canada are held at \$21.50. Land in fairly good request, but supply rather light at the moment; plenty to arrive, however. Fairbanks' selling in pails at 15c to 154c, the latter being an extreme outside figure: tierces latter being an extreme outside ligure; tierees worth 144c. Hims in light demand, in-adequate to the supply; plain sugar-cared selling at 13c to 134c, as to lot, and Davis' canvass. ed worth 14c to 14c. Green bacon quoted at 94c to 94c and cured do, at 11c to 12c. The egg market has continued quiet and easy at 14c to 142c, with supply fully equal to the demand.

Wood -The market rules firm but quiet, for foreign wools. The leading Canadian mills are reported to be well supplied, and no important move is therefore expected before midsummer. Prices are considerably lower than usual at this time of year, and any marked stir in manufac-tured goods would almost certainly be followed by an advance in values for the raw material. Sales for the week include a few round lots of Sates for the week include a few round lots of Greasy Cape at 18c to 19c, and Australian at 22 to 28c, as to quality. The leading American markets are reported dull, but a marked change is recloug, thought inevitable, as stocks in the hands of manufacturers are quite small. An authentic Boston report for the week ending 30th April says: "the sales show some falling off but on the whole of his agreement increase." off, but, on the whole, a fair average business has been done. Manufacturers still purchase can-tionsly, only for immediate wants, and there is no indication of any improvement. There has been scarcely a week for a year when manufacturers have purchased with any confidence, and it is evident that there is an abundant supply in the country. It is doubtful if they will buy freely until the prices for the new clip have been fixed. About 1,000,000 lbs. Australian have just been received from Melbourne, a large portion of which goes to manufacturers; this wool costs 40e to 45e to import, and, if placed upon the market now, would not bring over 35c to 40c. The London sales commence on the 10th May, and although the prices are uncertain our market will have to remain at a point sufficiently low to discourage any further importations, as there is enough wool in the country, if we except carpet descriptions, to supply all our wants."

Sterling exchange has been active at an advance; 60day bills are now quoted at 109} to 109} between banks and 1093 over the counter, and demand bills at 110 to 1101. Gold drafts on New York at § premium. There has been an active stock market this week, and prices of banks have appreciated in sympathy with Bank of Montreal. 






Fig. 5-No. 1 or Reverse Jaw.
