



RE-ORGANIZATION

OF THE

BAPTIST CONVENTION

OF OREGON AND WASHINGTON.

AND OF THE

OREGON BAPTIST STATE S. S. CONVENTION.

The above named Conventions held their arnual meetings in conjunction with the Baptist Church of Albany, Oregon, beginning June 25, 1877.

Their annual meeting had not been sustained, and their work had fallen into neglect, to some extent, if not entire-At this meeting, the question of perpetuating the Convention and sustaining its work, was warmly discussed. It was determined to re-organize the two Conventions, forming them into one new Society; and a committee was appointed to draft a Constitution. The committee consisted of Rev. J. C. Baker, Chairman: A. W. Kinney, W. C. Johnson, B. F. Dorris, Revs. R. Thompson, Rev. J. T. Huff, Rev. C. W. Rice, Rev. R. C. Hill, Rev. G. J. Burchett. This committee reported a Constitution, which, after some amendments, was adopted, and is published with these Minutes. The name of the new organization, as provided in the Constitution, was The Baptist Missionary and Educational Society of Oregon, Washington, Idaho and B. C.

Organization under this Constitution was effected by

electing Rev. C. W. Rees, Pres.; Hon. Henry Warren, Vice Pres.; Hon. W. C. Johnson, Sec.; Hon. B. F. Dorris, Treas.

The following Boards were elected:

Board of Mission.—A. W. Kinney, Henry Warren, W. C. Johnson, R. Thompson, B. F. Dorris, David Hurst, G. J. Barbour.

S. S. Board.—C. W. Rees, A. J. Hunsaker, W. H. Latourette.

Educational Board.—G. J. Burchett, John Connor, R. C. Hill, A. W. Kinney, W. C. Johnson.

The next meeting was appointed to be held at McMinnville, the last Thursday of Oct. of the present year, according to the Constitution. Rev. G. J. Burchett was appointed to preach the annual sermon, with Rev. C. W. Rees as alternate. Afterwards the Society was adjourned.

Note.—This statement was prepared and entered upon the records of the Society, by its order, at the first annual meeting at McMinnville, Oct. 25, 1877. It is published with these *Minutes* as per similar order at the second annual meeting at Oregon City, Oct. 31, 1878.

SYNOPSIS OF MINUTES

First Annual Meeting.

Pursuant to adjournment, the Baptist Missionary and Educational Society for Oregon, Washington, Idaho and British Columbia, met in annual session with the Baptist Church at McMinnville, Oregon, 25th of Oct., 1877, at 10 o'clock, A. M., and was called to order by Hon. Henry Warren, Vice President. After singing and prayer, S. C. Price was chosen Secretary, pro tem.; after which, the Society proceeded to enrollment. After enrollment, officers were elected as follows:

Pres., Rev. J. C. Baker, of Salem; Vice Pres., Rev. A. S. Coats, of Portland; Sec., Rev. S. C. Price, of The Dalles; Treas., David Hurst, of McMinuville.

The preacher of the annual sermon and alternate, both being absent, the preaching of the annual sermon was adjourned. Committee on Order of Exercises was appointed. Society adjourned to 2 o'clock, P. M.

2 o'clock, P. M.

The Society was called to order by the President. After devotional exercises, the report of the Committee on Order of Exercises was submitted and adopted.

Vice President in the chair. Bro. Baker, for the chairman of the Board of Mission, present the report of the Board. Following this report, the election of the Boards of the Society, was in order. Revs. A. J. Hunsaker, J. T. Hunff, E. Russ, were appointed a committee to nominate

said Boards. The committee retired, and the Society engaged in a season of prayer for the guidance of the Holy Spirit. The committee then reported, which, after amendment, was adopted as follows.

S. S. Board.—Rev. E. Russ, Mrs. Henry Warren, Mrs. M. A. Hurst.

A. J. Hunsaker, E. Russ and S. Hill, were appointed a Committee on Printing Minutes. Adjourned to 7 o'clock, r. M.

7 o'clock, P. M.

The Society was called to order by the President. After devotional exercises, Rev. A. S. Coats, of Portland, preached the Missionary sermon. Text, Isaiah 40, 3. Following the sermon, was a discussion of the report of the Board of Missions, after which, pledges for the Missionary work were taken, amounting to \$312. Adjourned to 9 o'clock, to-morrow.

OCTOBER, 26th, 9 o'clock, A. M.

Society met and was called to order by the President, after a season of devotional evercises.

The Minutes of yesterday's proceedings were read and corrected. The President announced the following Committee on next Anniversary: J. Beezley, D. Hurst and T. W. Boardman.

1st. The publication of a Missionary sheet, to be called the BAPTIST BEACON.

2d. That it be published by the Mission Board of this Society.

3d. That its design shall be to dissiminate missionary intelligence and foster the missionary and educational spirit among our churches.

4th. That it be published monthly.

5th. That the Mission Board appoint one of their members to supervise its publication.

G. J. BURCHETT, Chairman.

Adjourned.

7 o'clock, P. M.

The Society was called to order by the President. The Committee on Order of Exercises made supplemental report. Rev. S. C. Price, of The Dalles, then preached the Educational Sermon. Text, Mark 4, 28, last clause. Following was a discussion of our educational work.

The Committee on next Anniversary, reported as folows: Place of meeting, Oregon City; preacher of annual sermon, S. C. Price; alternate, J. C. Baker; report adopted. Adjourned.

OCTOBER 27, 9 o'clock, A. M.

The Society met, and in the absence of President and Vice President, was called to order by the Secretary. A. J. Hunsaker was chosen President, pro tem. Brother David Hurst offered the following resolution, which was adopted.

Resolved, That all moneys belonging to this Society, accruing from whater source, after defraying necessary expenses, shall belong to the fund of the Missionary Board of this Society.

The Society engaged in a discussion of our missionary work until the hour for preaching arrived; when Rev. J. W. Osborn preached from 1 Cor., 12:21.

Pursuant to adjournment, the Baptist Missionary and Educational Society of Oregon, Washington, Idaho and British Columbia, convened for its second annual meeting with the Baptist Church at Oregon City, Oregon, Oct. 31, 1878, and was called to order by the President, Rev. James offered some excellent remarks on the next topic, "How to Organize and Sustain Sunday Schools in Destitute Places." This topic was further discussed by Revs. J. C. Baker, C. H. Mattoon, J. B. Jones, J. Wichser.

On motion of Rev. J. C. Baker, a Committee of Three was appointed to consider and report on Sunday School contributions to aid in the support of our Colporteur Missionary. Brother Baker, Mrs. Nellie Warren and Miss L. A. Mitchell, were appointed such committee.

Adjourned to 1 P. M., after prayer and benediction by Rev. W. E. N. James.

7 o'clock, P. M.

The Society was called to order by the President. Rev. J. I. Tailor, of Corvallis, led in prayer. The congregation sang, "Stand up, stand up for Jesus."

The Committee on Devotional Exercises, reported as follows, which report was adopted: Devotional exercises to-morrow from 9:30 to 10, led by Rev. C. Sperry; 10 to 12, business as per order of exercises; 12 to 2, recess; 2 to 4, business as per order of exercises.

The S. S. sermon being the order of exercises, Rev. G. J. Burchett read Deut. 6th chap., 1st to 16th verse, and led in prayer. The congregation sang, "I love to tell the story." After the song, Rev. James Wells, of Gervais, preached the S. S. sermon. Text, Deut. 6, 6-7. After the

sermon, the congregation sang, "See, as a gentle shepherd stand." Following the sermon, was a general discussion of the S. S. work, opened by Hon. F. O. McCown, of Oregon City, and continued by Brethren J. C. Baker, C. H. Mattoon, C. W. Rees, W. E. N. James, J. B. Jones, F. O. McCown.

Rev. A. S. Coats, Secretary of the Board of Missions, presented the annual report of the Board. (See the report.) A motion for its adoption was offered by Rev. Jas. Wells, and seconded. While the motion was pending, addresses were made by the Missionaries of the Board, relative to their work on the field.

Rev. J. C. Richardson, senior missionary, was introduced by the President, and gave a very interesting account of his work, speaking of the destitution of the field, the willingness of the people to receive the word of life, and the universal kindness with which he had been received wherever he had gone in the work of the Society.

Before the next missionary was called on, the President

introduced Rev. H. W. Brown, the Evangelist, who, in response, spoke briefly of the necessity of mission work on this field.

Rev. W. E. N. James, Colporteur Missionary in W. T., wat next introduced, who gave a very encouraging account of his work, in visiting places of greatest destitution, carrying the word of life where it had been comparatively unknown, and organizing Sunday Schools where nothing was doing in the direction of teaching the Word of God.

The congregation stood and sang, "O happy day that fixed my choice."

Rev. J. T. Huff, the last appointed Missionary of the Board, was now introduced, and likewise gave a very encouraging account of his work. He had been but a few months in the field, and had been most of this time in B. C., where a new church at New Westminister had been organized under most encouraging circumstances. He also gave a touching account of the hungering for the word of life among some of the Indians in B. C., and earnestly appealed to the Society to take measure as soon as possible to send a missionary among them.

Report of the Board of Missions.

The second annual report of the Mission Board of the Baptist Missionary and Educational Society of Oregon. Washington, Idaho and British Columbia:

DEAR BRETHREN OF THE SOCIETY: You Mission Board beg leave to submit the following account of their transactions, together with a brief synopsis of the work performed by our Missionaries, as their report for

synopsis of the work performed by our distination, as their report to the year for which they were elected to this service:

Immediately on our election, we met in the Chapel of McMinaville College, Oct. 25, 1877.

After prayer by Brother David Hurst, our organization as a Board was effected in the choice of Rev. J. C. Baker, of Salem, as President, Rev. A. S. Coats, of Portland, as Secretary, and Brother A. W. Kinney. Salem, as Treasurer. After a careful canvass for a Missionary to send into the ripening harvest, the choice fell upon Rev. J. C. Richardson, of Eugene City. His salary was fixed at eight hundred dollars per year, payable quarterly—his necessary traveling expenses met from the funds of the Board. It was resolved to contract no debts, and to stop the work on one month's notice should not the necessary funds be forthcoming. Brother Baker was requested to take charge of the publication of the BEACON, and also to inform Brother Richardson of his election as our general Missionary. It was decided to hold public meetings in connection with our Board meetings, and thus to interest our people as far as possible in the great work of home evangelization.

The Board adjourned to meet in Portland, Nov. 15, 1877. At this meeting, held in the pastor's study of the First Baptist Church. Brother Baker announced that Brother Richardson had decided to enter upon the missionary work; and copies of their correspondence was ordered on file. Prolonged discussion was held us to what the General Missionary policy of the Board should be, and it was universally conclusions. ded that the crying needs of the entirely destitute portions of our destitute field, should first be answered, as far as possible, by our missionaries—that they should seek to lay foundations for churches where none exist. rather than act as evangelists in helping pastor's of churches already established. Brother N. W. Garretson was requested to draw up a statement setting forth this policy, for publication in the BEACON. As our Missionary setting forth this policy, for publication in the BEACON. As our Missionary has to draw his salary quarterly, it was resolved to urge our churches to contribute quarterly to his support, and one appointed in each Association to bring the matter before the churches. Brother Richardson was present at this meeting and did good service in the public meeting held at the same time—speaking at length upon the topic: "My Views of the Work." He went directly from the meeting to Lane county, where he began his missionary labors proper. It was voted that the missionary year should begin Nov. 15th, and that the Board should hold its meetings quarterly. terly.

The Board adjourned to meet with the Baptist Church in Turner, Feb. 12, 1878,

At the meeting of the Board, Brother Richardson was also present, and presented his first quarterly report, which showed that God had been with him in his labors, and was smiling upon the work undertaken. The Secretary was instructed to embody an abstract of this report in his report of the meeting, to the Beacon. It was decided that juctice to all concerned. required our missionaries to distribute their labors over the entire field, as far as this could be done consistent with an economy of time and expense. The public meetings held in connection with the meeting of the Board of an interesting character, and it is believed were productive of

The Board, after transacting its usual routine business, adjourned to meet

in Salem the second Tuesday in May.

For the greater convenience of its members however, the fourth meeting of the Board was held in Portland on May 20th. At this meeting the second quarterly report of Bro. Richardson was read, showing a vast amount of work performed with encouraging success. An abstract of this report also appeared in the Beacon. It was resolved to present our missionary work at each of the coming Associational meetings, and persons chosen to do the same. The president was instructed to prepare blank pledges to be used through the Associations for securing money for the missionary work. Rev. W. E. N. James was appointed colporteur missionary to labor in the South-western parts of Washington Territory, at a remmeration of twenty-five dollars per month, and instructed to secure the entire amount, if possible, on the field of labor. It was voted to recommend the officers of this society to secure the incorporation of the same as

soon as possible.

The Board adjourned to meet during the session of the Willamette

Association at Salem.

Pursant to adjournment this Board met at Salem June 22d. meeting, so encouraging were the reports from the Associations of the deep interest on the part of all our churches in our mi sionary work, and so liberal their pledges, that your Board felt justified in electing Rev. J. T. Huff as our second general missionary, at a salary of eight hundred dollars pc. year and traveling expenses. Bro. Huff entered upon the work on the ninth day of July, and has spent most of his time ever since then in Washington Territory and British Columbia with manifest to ens of the Divine approval. Brothers Baker and Coats were instructed to prepare blank reports for the use of our missionaries, and their reports were called for on the 1st of January, April, July and October of each year. Realizing the necessity of developing as far as possible the grace of giving among our people; and also the necessity of having as large a proportion of our funds as possible from the places where our missionaries labor, they were instructed to take collections for the work wherever they held meetings. This instruction, as has also been all the instructions of your Board to our missionaries, is to be interpreted as advisory rather than imperative—the missionaries themselves being in all cases, the final judges as to when and how they can best serve the Master. The Board adjourned to meet at the call of the chair.

The final meeting of the Board was held yesterday, October 31st, in the basement of this church. The treasurer's report was presented and Rev. G. J. Burchett and Bro. F. O. McCown requested to audit the same. We refer this Society to that report for information in regard to our

thancial status.

The report of Bro. Baker as Editor of the "Beacon" was also presented. and this Society will doubtless wish to listen to the same.

Report of the Editor of the Baptist Beacon.

To the Missionary Board of the Baptist Missionary and Educational Society:

DEAR BRETHREN: I take pleasure in submitting for your consideration, the following report concerning the publication of the BAPTIST BEACON: When the first copy was issued, September, 1877, it was for the purpose of awakening our people to the importance of attending the annual neeting of the Society to be held at McMmnville in October following. Its success in this particular, coupled with the evident necessity for some medium of communication between our people on this large and important field, induced the Society at its last annual meeting, to order its issue by the Board for the entire year, and your choice of myself to edit and manage its publication followed.

Under your direction, I have issued and cirulated monthly, 1000 copies. They have been mailed each month to every church and minister on our field whose address I could obtain. To the present date, there have been issued and distributed, in round numbers, 13,000 copies. Most of the churches have responded with clubs, and many with individual subscriptions, which, with some few donations, have paid for the entire issue and left at date of eport, 70 cents in favor of the paper.

In the editorial and business annuagement of the paper, I have done the best I could under the circumstances, and the draft upon my time and trength, has been of no insignificant character. My eidest daughter has rendered very material aid in mailing nearly the entire issue, and also in writing for the paper.

To the best of my ability and judgement, though with many defects, which I feel sure the Board will, in kindness, overlook, I have tried to keep in view the entire work of the Society, Missionary, Educational and Sunday School.

From all parts of the field, we have received unexpected encouragement, both personally and by letter, of deep and growing interest in the paper and our work, and I am persuaded that among the agencies used during the year for promoting the interests of the Society, and uniting our people in the one great work, the BAPTIST BEACON has borne a very conspicuous part and problems has been an indigrousible agency.

in the one great work, the Baptist Beacon has borne a very conspicuous part, and perhaps has been an indispensible agency.

From many of the brethren, and from all parts of the field there seems to be a demand for the enlargement and more frequent publication of the Beacon. I call your attention to this demand, and suggest that its consideration be in open session, and that great caution be exercised upon this point. I think it a necessity to our work that its publication be continued, and incline to the opinion that to double its size and still publish it

monthly, would probably be best, fixing its price at 75 cents in clubs of five, and \$1.00 to single subscribers.

Thanking the Board, and all the brothren and churches, for their hearty co-operation and kindly consideration, I most respectfully submit this my report. J. C. BAKER.

Elder James Magers was born in West Verginia, June 1, 1824. Moved with his father to Ohio, in 1839; and in the year 1842, made a profession of religion, and joined the Baptist church, in which he sustained his membership until his death. About the year 1861 or 1862, he was ordained a minister of the Gospel, by a council convened with the first French Prairie church, and discharged pastoral duties for said church at sundry times, and occasionally preached for other churches till his Master called him home to rest from his labors. He departed this life Feb. 3d. 1878.

Elder Reuben Dickens was born in Montgomery county, Va., Jan. 31, 1799. Removed to Tenn. in 1831, and from thence to Mo. in 1828. He came to Oregon in 1848. He became a member of the Baptist church in 1845, and was ordained to the ministry in 1850. He was an active laborer in the Baptist cause during our early history in Oregon; but his feeble health rendered him comparatively inactive during the last year of his life. He died Sept. 3d, 1878, in the hope of a blessed immortality.

Elder Richard Miller died at his son's residence near Turner, Marion county, Oregon, Sept. 8, 1878, aged 80 years, 5 months and 6 days.

Mr. Miller crossed the plains in 1848, and settled in Yamhill county a few miles from McMinnville. He went to Cal. in 1849, for the benefit of his wife's health; returned to his home in 1851, and continued to reside there until his wife's death in 1863. Since then he has lived among his children. Father Miller, as he was familiarly called, had been a member of the Baptist church for 50 years, and an ordained minister for 48 years of that time. Few men of his opportunities was better able to defend the faith than he. He new what it was to suffer affliction. For the past 35 years, he was never entirely free from pain. Four sons and two daughters mourn his loss, and two children have "gone before." Peace to the ashes of Father Miller, and all honor to the memory of the pioneer at rest.

Rev. H. G. Davenport died at his home in Eugene City, of paralysis of the blood after an illness of 41 hours, Sept. 8th, 1878. Deceased was a native of Ohio. He moved to Iowa, where he lived and labored in the ministry for a number of years. He went to California in 1865, and continued his residence there until his removal to Oregon in 1875. During his residence in Oregon his home was in Eugene, where he labored for a time as pastoral supply. As a christian and as a minister he was full of zeal for the Master, and anxious for the salvation of souls. He was stricken down when away from home, and was utterly helpless and unnconscious to the last. He had been in excellent health just before his illness, and was prosecuting his usual business with accustomed vigor when stricken down. Truly the ways of God are inscrutable.

PROCEEDINGS

OF TRE

State Society for Women's Work in Missions.

Saturday, 10 o'clock, a. m., November 2d, 1878.

In connection with the Baptist Missionary and Educational Society, a Woman's Missionary meeting was held being the first session of the State Society for Woman's Work in Missions. In the absence of the President, Mrs. L. L. Bailey, the meeting was called to order by the Sectary. Mrs. J. C. Baker led in prayer, after which, the sisters sang, "Come, Holy Spirit, Heavenly Dove."

A motion was made, and unanimously carried, that Mrs. Baker preside as President of the meeting.

Mrs. Baker having recently visited San Francisco and communicated personally with the officers of the Pacific Coast Society, felt prepared to represent their desires, saying the General Society will endorse all our work, as an independent State organization, if we would send our money through this General Society.

A very interesting communication from Mrs. Conro in behalf of the Pacific Coast Society, was read by the Secretary, urgently appealing the sisters of Oregon to remain auxiliary to that Society, feeling a separation would greatly retard the progression of the cause of missions on the entire coast; and as they have labored prayerfully, doing all they could to create new interests and advance the work, a motion was made by Mrs. J. T. Huff, "That the Woman's Baptist Missionary Society of Oregon, remain

auxiliary to the Woman's Society of the Pacific Coast." Seconded by Mrs. Laughary.

This being an unexpected subject, but few of the sisters felt prepared to take part in the discussion. There was some opposition. An amendment to the resolution was offered by the Secretary, "That we would co-operate with that Society the coming year, upon the condition that they publish the Treasurer's report of moneys received and forwarded from the North Pacific Coast, in the "Helping Hand." The amendment was adopted.

The Secretary was instructed to correspond with the Executive Board of the Pacific Coast Society, and report the decisions of the sisters of Oregon.

The meeting then adjourned till 2 o'clock, p. m. At 2 o'clock, the Society was called to order by Mrs. J. C. Baker. About fifty members were present.

The meeting was opened by singing, "All Hail the Power of Jesus' Name," followed by reading from the Scriptures by Mrs. Baker, and prayer by Mrs. Amelia Fisher of Albany.

Mrs. McCown, of Oregon City, welcomed the sisters in behalf of the church circle by reading a very interesting letter from that anxiliary.

Mrs. Warren read letters from various circles and mission bands, which were full of interest and encouragement, expressing earnest desires to share in the work of christian elevation for heathen women. Three mission bands and five circles were reported.

A very instructive and eloquent essay upon the Necessity of Woman's Work in Missions, was read by Mrs. F. O. McCown.

An essay from Miss L. A. Mitchell, upon the Influence of Mission Work upon Christians, was listened to with much interest.

Mrs. Warren addressed the women upon the Importance of Sustaining a State Society, and gave brief extracts of the work of Rev. Mr. Clough in Tilugee.

Mrs. Laughary followed with a brief recital of Reminiscences of personal acquaintance with Mr. and Mrs. Clough,

which was listened to with great interest.

A report was made by Mrs. A. S. Coats, State Treasurer, from circles and thank offering fund for Mrs. Clough, showing an aggregate of about \$160 on hand, to be forwarded immediately to the General Society.

Mrs. Baker addressed the meeting with words of encouragement; also relating a few of the early trials and struggles of the Ongole Missionaries, previous to Mr.

Clough entering that field.

A collection was taken up towards defraying expenses of minutes.

After singing "The Morning Light is Breaking," and benediction by Rev. A. S. Coats, the meeting was dismissed. The sisters dispersed, some with newly awakened impulses, and many with renewed zeal, believing that God would honor our efforts with his blessing, and the work of our Divine Master will grow, and the multitudes of perishing pagan women will be uplifted to the rank of christianity.

To the Baptists of Oregon, W. T., B. C., and Idaho.

At the annual meeting of the "Baptist State Convention for Oregon and Washington Territory," held with the First Baptist Church of Albany, June 26, 1877, the Constitution of the Convention was revised, and the name of the Society was changed to read as follows:

ARTICLE I.

This organization shall be called the Baptist Missionary and Educational Society of Oregon, Washington, Idaho and British Columbia.

ARTICLE II.

The object of this Society shall be to promote, foster, and sustain the Missionary and Educational work of Baptists on this field. It shall seek to unite our entire denomination in sustaining missionaries, aiding feeble churches, promoting Sunday School work, and building up the cause of christian education.

ARTICLE III.

This Society shall be composed as follows:

1. Annual members, who shall become such by contributing one dollar annually, to its funds.

2. Life members, who shall become such by the payment of twenty dol-

lars, at one time, or by four consecutive annual payments of five dollars each. 3. Each church of our denomination, contributing annually, to the funds of this Society, shall be entitled to representation in its annual membership by three delegates.

Each Baptist Association co-operating in the work of this Society,

shall be entitled to three annual members.

ARTICLE IV.

The officers of this Society, shall be a President, Vice President, Secretary and Treasurer. They shall be elected at each annual meeting of the Society, by ballot by a majority vote, and shall discharge the duties incumbent upon such officers.

ARTICLE V.

This Society shall hold its annual meeting beginning on the last Thursday of October, at such place as may be determined by the Society from year to vear.

ARTICLE VI.

At each annual meeting of this Society, a Board of Missions shall be appointed, consisting of seven members, who shall have charge of the general missionary work of the Society, including the raising and disbursement of funds. Four members of this Board shall constitute a quorum for the transaction of business.

ARTICLE VII.

All missionaries under appointment of this Society, shall be members in good standing of Baptist churches. They shall be required to teach and develop, on their respective fields, the missionary spirit, the support of the ministry, and the importance and value of systematic benevolence, and make quarterly reports of their work to the Board of Missions.

ARTICLE VIII.

At each annual meeting of the Society, there shall be appointed a Sunday School Board, consisting of three members, who shall have charge of the Sunday School work of the Society. They shall arrange to hold Conventions and Institutes, as the Society may direct, and shall provide a programme to occupy two sessions of the annual meeting of the Society.

ARTICLE IX.

At each annual meeting of this Society there shall be appointed an Educational Board, of five members, who shall have charge of the educational work of this Society, in co-operation with the Board of McMinnville College. This Board shall arrange to occupy one session of the annual meeting of the Society in the interest of christian education.

ARTICLE X.

Each of these several Boards shall be permitted to adopt such measures as may be necessary to seem the co-operation of other Societies in carrying forward our work. Provided that such measures shall not, in any wise, abridge the independence of this Society.

ARTICLE XI.

Each of the foregoing Boards shall make a full report of its work to the Society at its annual meeting.

ARTICLE XII.

The officers of this Society, together with the members of the several Boards, shall hold their offices until their sucsessors are appointed by the Society.

ARTICLE XIII,

This Constitution may be amended at any annual meeting, by a twothirds vote, provided notice of said amendment shall have been given at the annual meeting next preceding.
