Telegrams from Massowah state that quiet prevails at Kassala and its vicinity. These advices also state that Pas Mangascia, has taken refuge in Temben and that his forces have been dispersed.

TOO TIRED TO WORK.

LONDON, Jan. 22.-At the Thames police court a fat pauper, who has given the authorities at Popular workhouse no end of trouble, was charged with re-fusing to work. The fellow, who is only 28 years old and five feet four inches in height, weighed nearly 300 He was required to get up at 6:30 o'clock in the morning, but was generally two hours late, and he dodged all his tasks, claiming that he was too tired to work. Often he would be found asleep during the daytime, and when spoken to by the master simply said he was tak-ing a rest. The man, who puffed and blowed as he waddled into the dock, said he had no desire to work; he only wanted to be let alone, and he wouldn't bother nobody. The magistrate gave him a brief lecture on the duties of life in a workhouse, and saying a change would do him good sent him to prison for one month with hard labor.

A similar case was heard at Lambeth, with the exception that the defendant was lazy without being fat. He refused to do his allotted task, and complained that all he got to eat was a bit of bread, which was not enough to work on. The ward superintendent took direct issue with the defendant on this point, and declared that if he had performed his task he would have received five meals, consisting of bread and gruel. Telling him he could not expect rump steak for breakfast in a workhouse, the magistrate sent this pauper to jail for five

Wilfrid Laurier, eader of the party; Sir Oliver Mowat Premier of Ontario, and Mr. Patterson M.P., of Brant. All the Liberal lieutenants of any prominence were pres-

AN IMMENSE AUDIENCE. The Windsor Hall was packed to overflowing, and long before 8 o'clock the doors had to be closed, and many people were unable to gain admittance. G. W. Stephens, president of the Liberal Club, presided, and introduced the speakers. When Mr. Laurier, Sir Oliver Mowat and Mr. Patterson appeared on the platform they were greeted with tumultuous applause. Among the other prominent Liberals present were James Sutherland, M.P., J. D. Edgar, M.P., J. J. McLaren, Q.C., Julius Scriver, M.P., Hon. F. G. Marchand, leader of the Quebec Liberals.

OVATION TO MR. LAURIER. Hon. Wilfrid Laurier, who was the first speaker, was greeted with great applause. Mr. Laurier asked, "Is this Montreal, the great Conservative city of Canada?" Well might he doubt this and think he was in Liberal Scotland. But this was Montreal, and he did not forget it. Neither did he forget the fact that for the last sixteen years the people of the commercial metropolis had cast their votes for the Conservative policy. 

FARMERS IN FORCE

Gather at the Institute Meeting in Ilderton,

Regardless of Rough Weather - Good Practical Suggestions Propounded and Valuable Information Imparted.

(Special Correspondence of the ADVERTISER.) ILDERTON, Jan. 22.-Although yesterday opened very unfavorably, a large number of the most intelligent and progressive farmers in the neighborhood were present. Mr. T. Baty occupied the chair, and in his opening address complimented East Middlesex on having secured practical men as speakers, but advised the hearers to practice such information only that

they could approve of.

GOOD ROADS. Mr. J. G. Munro next spoke on "Good Roads." He considered it a live question. He was not going to give any particular method of making roads, but wished to state some facts that might lead out their thought on the matter. He advised the necessity of a uniform method of construction, and thought the constructing and maintaining of roads ought to be given to an independent man, who had no interest in the votes of the municipality. He considered underdraining the first step in making a good roadbed for he is confident four a good roadbed, for he is confident four inches of gravel on a dry roadbed of more benefit than two feet of gravel on a wet one, and considered two drains—one on each side of the road, within a few feet of the road ditches-the most convenient method to make the high-way dry. He strongly advised that the council engage men by the year to keep the roads in proper repair. He also advised the screening of gravel or the pur-

chase of a stone crusher. Question-What will it cost to crush stone? Answer—\$1 per cord. ENSILAGE.

Charles Simmons, of Ivan, spoke for a few minutes on ensilage, testifying that after an experience of four years he was thoroughly satisfied with his silo. He considered corn was the most profitable crop for the Ontario farmer to grow. He plants his corn with the drill in rows 30 inches apart, but considers that growing in hills will give very nearly as heavy a crop, and will give a better chance to keep the ground clean. He grows about 5,000 bushels of roots each year. The speaker considered it best to feed to each animal no more than about 20 pounds each of roots and ensilage, with other coarse

foods THE VALUE OF CLOVER. Mr. Rennie gave some important information on "The bearing that clover seed occupies to agriculture." He considered clover the keystone to successful agriculture. It is a nitrogenous plant, and has in it the proper ratio, namely, 1 to 5. He advised farmers to feed it more instead of grain, as it is less liable to heat the blood, is a flesh and strength producer, and is used most largely in feeding the best stock of the old land. This last year, by feeding less grain and more clover at the Guelph farm, he reduced the feed bill \$2,000. Such a change is coming over Europe that instead of shipping commerciai ma clover seed. The seed houses of Toronto alone last year shipped 60,000 pounds of clover seed to Europe. On his farm of hard clay, the speaker had never lost a catch of clover in fifteen years, which he attributed to sowing the seed ahead of the tubes of the drills, thus keeping the seed from falling in the grain drill and being choked out. JUDGE ELLIOTT'S CONFESSION.

At the Dominion court of revision for this city yesterday Judge Edward Elliote made the statement that he candidly bemade the statement that he candidly believed over a dozen parties had sworn to downright untruths during the day. This is a startling declaration to come from an experienced jurist. It once again illustrates the objectionable character of th

Dominion Franchise Act. The inquisitorial measure is a direct incentive to perjury, and at the earliest moment ought to be replaced by a system of simple registration,

such as we have for Provincial elections. When a law promotes crime, and it is at the same time costly, vexatious and unsatisfactory to both political parties, it should not have a single defender in any community. But so strongly do the men in power at Ottawa believe in the possibility of using it to help to maintain themselves in office, in constituencies where their agents are not so closely watched as they are in this city that they positively refuse to repeal it. This is another measure that will not burden the statute book after the new Government, soon to be formed at Ottawa,

WORK AND WAGES. The high tax newspapers ridicule the idea that anyone is out of work in Montreal, Ottawa, Toronto or any other place in the Dominion, and assert that if a man is not employed he is lazy or incompetent.

This is adding insult to injury. First the high tax leaders obtained the votes of many workers on the distinct promise that they would provide plenty of work at good wages for everyone, Now when they are asked to implement their promise, when they have taken city workers till they have little surplus cash, and curtail their purchases, these men turn to the unemployed, and say, "You are not honest; you would have work if you were not lasy or incompetent."

Is it not a fact that in this city and in every other center of population there are today many workers who are neither lazy nor incompetent without employment? It is not the province of a government to find work for men, but it is surely the grossest of deceit for political leaders to obtain the support of workers on the promise that they would supply them with work at good wages, and then, when exposed, to turn round and insult the men whom they duped.

The best way to improve conditions in this country is for the Government at Ottawa to keep its hands off industry. BEGINNING TO TALK SENSE. Nor is he any better off if public be extravagantly or unwisely The overcrowding of a branch of the civil service means that more money than is necessary is spent to provide the country with a certain amount of completed work. Who pays this extra money? The taxpayer, of course; and he not only pays the money so wasted, but he also pays the cost of collecting this unneeded money for himself. The same thing occurs when a party Ministry appoints three moderately incompetent men to do work that, by careful selection, it could find two men capable of doing. The three men are chosen for party reasons, while, of course, the two men must be selected rigidly, because of merit; and it might happen that neither of them had ever served the party an hour. A sinecure imposes additional taxes upon the people in the same pleasant manner; and a public work they could worry along without is doubly paid for out of the same purse .- Montreal Star.

THE BRITISH WAY. We are willing to go for precedents to the old land, which has passed through that ordeal before us. In 1846 Sir Robert Peel carried England over from protection to free trade, and he did it by a gradual process which avoided all disturbance of values, and which avoided all financial crises. That is a precedent which, good for England, is good for Canada, and which ought to be still more sensible for Canada to adopt than it was for England, because the interests involved are not so great in Canada to-day as they were England then-(cheers)-and the step was a much longer one than the step would be here. The step in England was all the way from protection to free trade, whereas we propose in Canada to go from protection to a revenue tariff. Under such circum-stances the duty is plain for the Liberal (Cheers.) I have expressed here exactly what we want. Upon the question of principle there can be no compromise. We stand here against compromise. We stand here against protection and in favor of a customs tariff based upon the principles of revenue and nothing else. (Cheers.) The balance of the \$4,000 was paid to the executors of the estate, and a quit claim was asked. The executors contend that the \$1,500 should have been paid to them, and Justice Meredith decided in their favor. McCrimmon will have to recover the \$1,500 which he paid to the two legatees. UNDER SIXTY FEET OF SNOW The Central Pacific Railway Buried Disastrous Floods in Lower

California. SAN FRANCISCO, Cal., Jan. 22.-A severe snow storm has been raging on the line of the Central Pacific Railroad for the last 24 hours, the snow being 22 feet deep on the level at the summit. On the Shasta route a formidable fall of snow has occurred at Upper Soda Springs, near Dunsmore, burying the track 60 feet deep under snow, bushes and rocks. Hundreds of men are now clearing the track, but it is not expect-

ed to be clear for two days. The river at Napa City has overflowed its banks, and the best portion of the city is inundated. At Sonora several bridges have been swept away, and the roads are impassable. At Escenda, in Lower California, many buildings have been swept away by the rise of the river and several lives lost.

Forty-Fourth Annual Meeting of the Congregation.

A Liberal Grant Made to Mr. Murray's Widow.

Interesting Debate on the Yearly Report-Will the Scotch Cemetery Be Closed?

For the four and fortieth time the annual meeting of St. Andrew's Church was held last night. The night was bitter cold, and a stormy nor'wester deducted somewhat from the usual large attendance. The chair was occupied by Mr. R.A. Little, chairman of the board of managers, and after an opening hymn a very feeling prayer was offered by Mr. Alex. Fraser. After referring to the prosperity attending the church during the year, Mr. Fraser said: "Still our joy is mingled with sadness, as we come here and present ourselves at this annual meeting without our pastor."

Mr. Little then presented the annual report. It read as follows: "The board of managers, in submitting their forty-fourth annual report, deplore the loss which the congregation and city sustained by the death of their late pastor, the Rev. J. Allister Murray, whose minis try in St. Andrew's Church was productive of much good, and whose life and character were an example to all. His elequence in the pulpit and his untiring exertions in attending to all the work of the congregation endeared him to everyone. His death occurred on the 21st day of October.

"To Mrs. Murray the managers extend their strongest sympathy, and submit that in view of the long and earnest services of Mr. Murray, and in keeping with his generous disposition, it is the duty of the congregation to do whatever they deem reasonable for Mrs. Murray, and thereby lessen

the effect of her great loss. "The congregation have shown their unity and loyalty to St. Andrew's during the year by maintaining their regular attendance and increasing their subscriptions, the total sum collected for all purposes being \$9,422 89. This is the more praiseworthy when we consider the unusual depression everywhere prevailing, and that the pulpit has been for the most part filled by strangers.

FINANCE. "The total receipts for the year ending 31st December-including weekly contributions, \$5,341 20; collections, \$467 75; sundries, \$32 34—have been \$5,841 29, and the expenditure has been \$5,960 66, leaving a deficit of \$119 37. This deficit has been covered by a loan of \$125, leaving a balance on hand of \$5 63.

"In comparing the revenue from weekly contributions and collections with that of the previous year from the same sources, it shows an increase of \$252 42 in the envelopes and a decrease of \$88 30 in the open collections. The revenue for the year

amounts to \$6 77 per sitting. "The canvass of the congregation undertaken by the managers in the early part of the year with the object of increasing the venue, though not wholly meeting our anticipations, still had an undoubted beneficial effect.

PEWS AND MUSIC. "Throughout the year there has been great demand for pews downstairs, and consequently there are few sittings un occupied in the body of the church, though there are still some good pews vacant in

the gallery. "Attention is also called to the necessity of immediate notice being given whenever any person has occasion to vacate sittings. It is not unusual that the only intimation of the removal of such parties is through the secretary reporting that no envelope contributions are being received. It would be of great advantage to the congregation if a definite, limited time of not ess than three months were fixed, at the end of which sittings that have not been occupied, and whose holders have ceased to contribute, should be at the disposal of the pew committee.

IMPROVEMENT AND CEMETERY. "The improvement and cemetery com-

mittee has kept your property in the best possible state of repair with the strictest regard to economy. Your committee would recommend that, while the board exercises a general supervision over the cemetery, in future owners attend to the repair of monuments and proper care of plots.

"Under the head of improvement and debt fund, your committee has completed the changes commenced during the year 1893, and have refitted the Sabbath school class rooms at a cost of \$1,055 45. The amount contributed to this fund up to the present time is \$2,007 03. The amount on hand to the credit of the fund is \$856 54.

"The board respectfully recommends that the expenditure in connection with our central Sabbath school be sent in monthly to the managers, and that all expenditures be agreed to previously by the chairman of a Sabbath school committee, to be appointed by the board. You will be called upon to elect six managers in the place of G. A. Somerville, M. H. Rowland, R. A. Gray, J. B. Laidlaw, Jas. Houston and R. A. Little, whose term of office has just expired, but all of whom are eligible

for re-election. "The best thanks of the congregation for their efficient services are due and are hereby tendered to the ladies of the congregation, the choir, the ushers, the Christian Endeavor Society and the auditors for their valuable services during

the year. "Out of a total number of fourteen meetings the number attended by each member he board was as follows: R. A. Little Dr. Gardiner 11, Alex. Gillean 11, R.

Gray 12, Jas. Houston 9, J. B. Laidlaw Dr. Macarthur 10, James McSween 10, James Mills 13, T. H. Purdom 7, M. H. Rowland 12, G. A. Somerville 5." FINANCES DISCUSSED.

BULLETS FOR STRIKERS.

The Situation in Brooklyn Grows

BROOKLYN, Jan. 22.-The mayor has issued a proclamation as follows: "Law and order must prevail first in this community, must be respected by all and must be enforced on all, even if it takes the entire force of the State.'

The situation has grown more serious during the day. Tonight the outlook is most grave. The breach between the striking employes of the trolley lines and the companies has been widened by today's doings. Master Workman J. Connolly declares that the troops of the Seventh Regiment raided a peacable assem blage of workingmen, seized their papers and records and ran things with a high hand. The militia admit throwing out a cordon of soldiers for two blocks, from the Ridgwood depot, and incidentally penning 200 strikers in the Odd-fellows' Hall for two hours while the cars were operated on Gates avenue line. They deny seizing books and papers.

Fifteen linemen went on strike of their own accord early in the day, and were ordered back to work by Connolly, but when he heard of the affair at the Oddfellows' Hall he ordered all the linemen to quit work tomorrow morning. If the men bey there will be few cars operated until their places are filled, if they can be filled. There was trouble all day on the Gates

avenue line. One shot was fired by a Seventh Regiment man before it was over. A charge was made by the military at Croadway and Halsey street at 11 o'clock tonight. Some small boys had been jeering the soldiersi but there were few men about.

A drunken man started from Conway's saloon to cross Halsey street. He was fired upon and hit in the face, sustaining a compound fracture of the jaw, His name is Thomas Ahens. He will die. Dr. Mitchell, of the Brockly City Railroad, was shot in the arm. Two of the bullets from the guns of the militia went through the large plate glass window of the store of John Eckhoff, narrowly missing the clerks behind the counters.

At 11:40 the neighborhood was almost deserted. There were less than twenty men present when the shooting occurred, and there is said to have been no excuse

The car companies made some progress towards resuming traffic. More cars have been run on the lines which have been open for three or four days, and new lines were opened. In one case police and troops lined the route for blocks and shot at people in windows who threw missiles and in the other cavalry charged with drawn sabres to rescue a car in the hands of the mob. Booth these affairs in which troops figured, took place in broad daylight. More disturbances were reported from various parts of the city. There were only a dozen arrests in connection with the disturbances. Strikers captured men hired by the companies to fill their places. In some cases they used moral suasion, and in others, it is said, they used force to kidnap the non union men.

Uniondale, a small farming suburb of Hempstead, was the scene of a lively and somewhat dramatic occurrence on Friday afternoon. Mrs. Margaret Walters, who is the head of a family consisting of herself and Mr. Walters, set the whole section in a flutter by horsewhipping her husband and engaging in a rough-and-tumble battle with the proprietor of the only saloon in the place. Mrs. Walters is a plump, round little woman of culture and refinement. She is a professional nurse, and enjoys the respect and esteem of all Uniondale and the more pretentious village of Hempstead. To the Belmonts, Morgans, Walcotts, Danas and other swell families about Hempstead and Meadowbrook there is no one who can fill the place of Mrs. Walters, and much of her time is spent in a professional way at those places. Twenty-one years ago Mrs. Walters left Brooklyn, went to Union-dale and was married to Albert Walters. Though he has had steady employment for the past fifteen years the pretty little cottage in which the couple live was built with the earnings of his wife. The neighbors say she is able to

take care of it.
Up to two years ago Uniondale was a temperance village, there never having been a saloon within its quiet precincts. Then Deacon Duryea's son Garry opened a saloon in direct opposition to the wishes of his father, who is a strict prohibitionist. The indignation of the old residents knew no bounds. There the outcome of the venture. Walters became a frequenter of the place to such an extent that his wife was compelled to forbid Duryea to sell him liquor. Duryea had received an appointment as special deputy sheriff under Sheriff Doht, and on Friday received through the mail a pretty silver badge to lend emphasis to his authority. The badge was a beauty, and Duryea began celebrating its receipt by calling in his patrons and setting up a free keg of beer. During the day Duryea met Mrs. Walters in Hempstead, and told her that her husband was drinking at his place. The woman hastened home, and taking a long horsewhip started for the saloon. As she passed the barroom window she saw her husband in the place. She went around to the side door, where her knock

brought Mrs. Duryea.
"Is my husband here?" she asked. "No," replied the saloon-keeper's wife, looking inquiringly at the long whip.

'Nor he ain't been here, neither. "He is here and you know it," retorted the visitor. Mrs. Duryea, who had a bar of soap in her hand, made an advance toward Mrs. Walters, who then dodged through the door into the barroom. In the meantime Walters had climbed out of a window and ran across the lots to his home. Mrs. Walters expressed her mind freely to the saloon-keeper's wife. The crowd in the bar-room stood aghast while the wordy warfare progressed. Then the plucky little woman started out in search of her recreant husband. Mrs. Walters was followed by a jeering crowd. She found her husband hanging over the front fence, and, without a word, began plying the horsewhip After receiving three sharp cuts Walters retreated to the house. Later in the afternoon Mrs. Walters met Duryea near his saloon. The man advanced toward her, and shaking his fist in her face demanded to know why she had insulted his wife. Duryea took her by the shoulders, Mrs. Walters says, and shook her before the bystanders could interfere. Mrs. Walters displayed the black and blue marks of his fingers on her arms today. Duryea demanded the payment of \$10, which he had loaned to Walters, and Mrs. Walters went into Grocer

Smith's store and borrowed the amount. Returning to the saloon, she laid the money on the bar and asked for a receipt. The sight of the woman threw Duryea into a fury again. He sprang upon the bar and threw three beer glasses and a club at her, she declares. She dodged the glasses, but was hit by the club. The saloon-keep-er then seized the woman and flung her roughly about the room. The woman finally escaped, more dead than alive. Mrs. Walters told the story to an Eagle reporter today. Mrs. Shaw, who is sister of Duryea and the wife of the village blacksmith, was at the home of Mrs. Walters. She said that her brother's saloon had been the means of breaking up her home and ruining her husband. The couple now live apart.
Mrs. Walters' friends are urging her to prosecute the hotel man.

SULLIVAN'S NEW OPERA

TUNEFUL MUSIC AND FUN FOUND IN "THE CHIEFTAIN."

An Amusing Piece Concocted Upon the Adventures of an English Tourist Who Is Captured by Some Spanish Brigand and Becomes Their Leader.

Brightness, lightness, tunefulness, and local color may be taken as the leading characteristics of the new comic opera at the Savoy theatre, London, by F. C. Burnand and Sir Arthur Sullivan, recently.

The plot may be thus briefly summar ized: Peter Grigg goes for a photographic excursion in the Spanish mountains, where he is captured by a band of brigands whose chieftain has disappeared. The law of these gentry is that if the chieftain does not return within a certain time, any stranger arriving in their midston a given day is elected ipso facto chieftain, and becomes the affianced husband of the chief tainess. Under pressure of pointed guns, pistols and daggers, Mr. Grigg accepts the inevitable. He is at once established as



the affianced husband of Inez de Roxas, the chieftain's deserted wife. The gang has captured, and holds prisoner pending ransom, Rita, a young English lady, to whom Count Vasquez is engaged, and for whose rescue he ventures disguised into the robbers' den. Having sent the ransom, he and Rita are released, leaving poor Grigg with the ladrones. The count then sending money for Grigg's ransom, the poor man is released on parole. Inez and the leading ladrones go disguised in search of their missing chieftain, Ferdinand, who is trying to quit Spain. To avoid recognition, Ferdinand assumes the disguise of a courier, in which capacity he falls in with and conducts Mrs. Grigg, who has come to search for her missing husband. The parties meet at Compostella, where Count Vasquez and Rita, his newly married wife, are also staying, on their honeymoon. The unhappy Grigg, unable to explain to his real spouse the reason of his absence, as that would necessitate his telling her of his affianced Spanish bride, gets his friends to help him get out of the difficulty. This they do by concocting a cock-and-bull story in which Grigg poses as a hero, and his wife is thereby satisfied. Unfortunately, was a great deal of speculation as to Inez and the ladrones recognize their temporary chief, whom they blackmail under threat of exposure to his lawful spouse. The real chieftain is, of course, recognized. claimed by his wife, and welcomed by his lieutenants, who wish to share in the embezzled funds and new plunder. Mr. and Mrs. Grigg return to their suburban home

and all ends merrily. The play opens with a pretty set showing the brigands' rendezvous. Here enter the two lieutenants, Sancho and Jose. They begin quarreling and are stopped by the chieftainess, who suddenly appears and sings a charming song—"Let others seek the peaceful plain"—with very pretty chorus of "Vive la Reina." To make sure of the "ladrones' law" the gang consult Pedro Gomez, the lawyer and astrologer of the ladrones, who "expounds the law on the usual conditions" and explains how, why, and when the first stranger who comes into their midst is to be elected chieftain. After a pretty trio the bandits clear off and Rita comes on and sings a delightful song about "tinkling sheep bells," the while the Angelus is heard in tuneful tintinnabulation. Presently enters Count Vasquez in the guise of a shepherd. After singing in a quintet with the bandits Count Vasquez and Rita join in a fine duet, during which Vasquez doffs his disguise and appears in the uniform of a Spanish officer. Having gone off into captivity the tourist Grigg appears on snap shots bent. He explains his objects in an extremely funny song, "From Rock to Rock," and as he is taking a photograph is himself taken prisoner. This scene ends with a very comic trio and a Bolero dance.

The second act opens on a very pretty typical Spanish scene, representing the exterior of a posada, or inn, in a picturesque

village on a winding stream, with rustle bridge in the rear, and charming landscape as a background. The Count enters and opens with a tuneful tenor song in mock sentimental style, with refrain of "Up in the Early Morning." After a pleasant chorus of gold washers, Maraquita sings a pretty number, "Gold from a Cave." This is followed by a charming song, "Two Happy Gods," with most effective harp accompaniment. The count and Rita then recall their first happy meeting at the Convent des Oiseaux, in Paris, where he, being Spanish and she English, they conversed in French, "so that none of the Parisian visitors could understand" them. Upon this they break out into what was undoubtedly the hit of the evening. This was a duet, "Ah, oui, j'etais une pensionnaire," sung in school-girl French, and in burlesque of grand opera. As a whole, the opera is bright, tuneful, and gay. In the matter of dialogue and lyrics Mr. Burnand comes well out of the inevitable comparison with precious Gilbertian operas. As regards the music, though perhaps somewhat disappointing in the first act, in the second it is generally very good, and quite equal to Sir Arthur Sullivan at his best.



B. B. ALLEN'S DEATH.

A Report that the London Detective Was Not Murdered.

The Government Investigated It-Purely an Accident, It Is Said.

(Toronto World, Jan. 23.) On Oct. 27, 1893, B. B. Allen, of London, Ont., a county constable of Middlesex, was found lying dead in the woods at Long Point beside a dead deer. He had been engaged by the lessee of the Long Point reserve to remain there during the hunting season on the watch for poachers. A rumor became bruited about that he had been murdered by some poachers whom he had detected in the act of shooting game. An inquest was held and an open verdict returned to the effect that Allen died from the effects of a gunshot wound, but how or by whose hand

THE HONEY MEN.

Annual Meeting of the Ontario Bee-Keepers' Association.

The President's Address-Not an Encouraging Year-Interesting Papers by Experts-Ontario Government Commended.

STRATFORD, Ont., Jan. 23.-The annual convention of the Ontario Beekeepers' Association opened here in the City Hall yesterday afternoon, President A. Pickett, of Nassagaweya, in the chair. There was a large attendance of honey raisers from all parts of the

Province. The president, in a short address, reviewed the work of the past year from the beekeepers' standpoint, which, upon the whole, has been rather discouraging. The bees wintered well and came out in spring with few losses, but the cold and wet weather following drove them back to their hives and compelled them to live on their winter stores, with the result that they were exhausted before the weather became favorable for the gathering of a fresh supply. In consequence many died of starvation. The survivors gathered but little clover honey, and other blooms being cut short by the drought, the result was little more than half a crop. He made feeling reference to the death of the late secretary, Mr. Corneil, and recommended a resolution of sympathy with the bereaved family. He was pleased to notice that their annual meetings were increasing in attendance, and also that the Provincial Government had taken an active interest in promoting the honey making industry by appointing a foul-brood inspector, and in other ways. He hoped that in the near future assistance financially for the association would be forthcoming from the same quarters. He commended the work of Foul-Brood Inspector McEvoy and expressed hope that ere long the disease would be a thing of the past in the Pro-

A. E. Sherrington, of Walkerville, contributed a paper on "Conventions, and How to Make Them Successful." He advocated that papers presented should deal with practical live questions such as would interest every bee man and provoke a general exchange of opinions. Prof. Fletcher, of Ottawa, addressed the convention on the subject of spraying fruit trees in bloom, and its bearing on bee culture. He also read a paper dealing with the same question by Prof. Webster, of Wooster, Ohio, whom he described as one of the most eminent entomologists on the continent. The reader agreed with Prof. Webster that bees are in danger of being poisoned by spraying the bloom of fruit trees, and that the danger remains until the bloom has fallen. It was hoped that legislation would be provided to

obviate this danger.
At the evening session Wm. McEvoy, foul-brood inspector, presented his annual report, showing that that disease was on the decrease and was now to be found more in the newer settled parts of the Province than in the older localities. He had destroyed fifteen hives of diseased bees since last meeting. Then followed a paper on the sub-

lect, "Will the Bee-keping of the Future Differ From That of the Past?" by W. Z. Hutchison, of Flint, Mich. He described the bee-keeping of the past, with its homely appliances. Now there are specialists who are gradually bringing the industry under a more per fect system, and the indications are that with improved appliances and methods a more profitable and satismethods a more prontable and satisfactory avocation will be the result.

R. H. Smith, St. Thomas, took for his subject, "How Are the Bees Wintering?" Proper preparation was necessary to successful wintering. He recommended clams packed in chaff, but favored cellar wintering in extreme climates. With proper attention


