An Act to define the Boundary Line between the fourth and fifth Concessions of the Township of Cornwall.

WHEREAS certain persons, proprietors of land in the Fourth Con-
cession from the Indian reservation, to the east of Lot No. 7, in
the Township of Cornwall, have set forth by their Petition to the Legis-
lature, that their side lines were run in 1817 to the line forming the rear
5 of the said Concession according to the Patents granting them their
Lots, and prayed that the said rear line which was run in the said year
by Duncan McDonald, (Greenfield,) Deputy Provincial Surveyor, be
confirmed and declared to be the correct rear line of the said Concession ;
and whereas the said line is the correct and true rear line of the said
10 Concession, according to the said Patents, and it is expedient to grant
the prayer of the said Petition, Be it therefore declared and enacted, &c.,
that—

Preamble.

The line run by the said Duncan McDonald in the said year 1817, from
the western extremity of Lot No. 7 of the said Concession No. 4, to the
15 Indian reservation or eastern extremity of the said Concession, dividing
the said Concession from the Fifth Concession of the said Township of
Cornwall, is and shall be deemed to be and to have been the rear line of
the said Fourth Concession.
