At The Federal Capital

Monday, April 19th, was the last private members' day in the House of Commons, and the greater part of the time was occupied in the discussion of a resolution introduced by Dr. Edwards, member for Frontenac, Ontario, expressing the idea that the Federal Government should establish a bureau of education. The question was discussed at considerable length by members on both sides of the House. The opposition to the principle involved in the resolution was based on the discussions of the British North American Act, which specifically assigned matters educational to the provinces. The Right Hon. Sir George Foster, Acting Leader, delivered a very excellent address on the question under review, and with-out expressing any very strong views he suggested to the mover of the resolution that, now having it fully discussed, it would perhaps be advisable for him to withdraw it. Dr. Edwards then closed the debate in an address of considerable force, and ended by withdrawing the resolution. Apart from some matters of routine this constituted the work of the first day of the week ending April 24th.

On Tuesday, the 29th, Mr. McKenzie King, leader of the opposition, availed himself of the opportunity afforded by the leader of the Government in moving the House into committee of supply, to place on record his explanation of his conduct during the war. The explanation was long and embraced much correspondence, which was placed on Hansard, and a great many allusions to the part he had taken negotiating regarding matters of labor and technical operations in different institutions and manufacturing in the United States, and the pronoun "I" was very frequently interjected into the narrative, which the hon. gentleman was pleased to dictate to the public in the columns of the Hansard. But when all was said that the hon. gentleman could possibly think of in connection with his movements and his conduct and his domestic affairs, during the years of the war, there was nothing that could be construed into anything like a tenable excuse for his failure to offer himself for enlistment in the Canadian Expeditionary Force. The hon. gentleman had long held up to the assembled members of Parliament that he was very desirous of making a personal explanation and of combating and refuting statements that had appeared in the newspapers regarding his failure to take an active part in the fighting forces, when the safety of the country and the perpetuation of our institutions were at stake. He had his opportunity, he has made his declaration and the general opinion is that he has not only not improved his position, but that his last state is worse than the first.

The debate on the Grand Trunk acquisition bill was continued from time to time during the week, the members of the opposition placing all manner of untenable objections in the way of the passage of the bill. It meant simply, as far as anyone

in the hope of making some little political capital in the country. However, after they had exhausted themselves the bill duly passed from the committee stage and was read a third time. A very pathetic incident occurred in the Commons Chamber on Thursday the 22nd. A few days previously, Sir George Foster, Acting Prime Minister, intimated that on Thursday the 22nd, which was the anniversary of the battle of St. Julien in which the Canadian soldiers had rendered such extraordinary service to the country, and in which they had suffered severely, members would remain for a few moments in silent prayer immediately after the Speaker had read the prayers for the day. Accordingly, when the moment arrived all stood with bowed heads for several moments, a complete hush fell over the chamber, no sound was heard, and doubtless all present were in deep and prayerful thought regarding their friends and all the brave sons of Canada who had fallen in their country's cause at the battle of St. Julien.

A very important government measure which held the attention of the House during the week was the Electoral Franchise Act. The bill was considered in committee from day to day, and much progress had been made, but a holdup was effected on the clause relating to the appointment of returning officers. The bill set forth in the clause in question that returning officers for the Federal Elections shall be appointed by the Governor General in Council. Now, it is proper to state that this is the manner in which returning officers for Federal Elections have been appointed ever since Confederation. Under the Conservative and Liberal Governments no objection, as far as recorded, has been taken to this procedure. Moreover, when the Liberals were in power from 1897 to 1911 at least two different Franchise Acts were passed, one in 1898 and another in 1908. In each of these as well as in all such laws that prevailed previously to this, the appointment of presiding officers was by the Governor General in Council provided for, and there is not any record of any objection having been taken to this principle by members of the Liberal party. More than this, it has not been discovered during all the years of Canadian Confederation that more than one returning officer had improperly conducted his business in this respect, or had misused or abused his powers under the Act. One only was reported as having gone wrong, and he was prosecuted and punished for his crime. It does not require very much consideration to manifest the fact that, for instance, postmasters and collectors of customs without going any further, would be the least possible suitable persons to appoint as returning officers for many reasons. In the first place, in many ridings and counties throughout Canada there is in many a town and village a post office where there is more than one official carrying on the work. Now if one of such postmasters for instance, should be appointed a returning officer, it would mean that his work as postmaster would have to be neglected. He would have to carry on as postmaster or as returning officer, and in either case someone else would have to be appointed. Without going further, this will convey the idea of the ridiculousness of the position taken. The same would apply to collector of customs in many places. The conduct of the opposition in this particular plainly indicates how extremely anxious they are to grasp at any straw that would afford them an opportunity of using the Franchise law and the election machinery for their own partisan political purposes.

Local and Other Items

A very sad accident occurred Friday at Covehead Road, about two miles from York Station. Mr. and Mrs. Fred McDonald had been in town in the afternoon and while they were away from home their youngest child, a little girl of two years of age, wandered away from the other children who were all playing together. She had been missed for ten minutes or so and when Mr. and Mrs. McDonald got home they started a search for her. They soon discovered that the child had got into the well house and had fallen into the well. Neighbors were summoned and the child's body was recovered.

Dr. McDonald was notified of the accident and considered that an inquest was unnecessary as there was no one present at the time of the accident but the other children of the family.

The child had no difficulty in getting into the well house as the staple was out of the door.

The affair is exceedingly sad; the deep sympathy of the community goes out to the heart-broken parents.

Murder of Two Americans

Washington, May 3.—The murder of two more Americans in Mexico, reported today to the state department, accentuated the concern with which officials here are watching developments beyond the border.

Requests for additional warship protection at points on the east coast of Mexico already had been forwarded to the navy by the state department.

On the border, the reported closure of the port of Juarez was interpreted as indicating defection of the federal garrison under General Escobar to the rebel cause. Less of this entry port officials said, would be a serious blow to the federals because of its revenue producing capacity. They believe complete rebel control of the state of Chihuahua would be the logical result.

The murder of Eben Francis Greenlaw and his young son, by Mexicans near Eloro, only 125 miles from Mexico City brought from the American embassy in Mexico City a prompt and emphatic demand that the Mexican government arrest and punish the murderers.

The American government contends that the Carranza authorities were responsible for the protection of the Greenlaws because of the presence of Mexican troops in the immediate vicinity.

Destroyers will be stationed at Tampico, Tuxpan, Vera Cruz and Fronteras, ready to take off any Americans who may be in danger either from the Mexican federal authorities or the rebels. General Oregon has pledged himself to protect foreign lives, and interests, if elected to the presidency, a consular report to the state department said. Oregon also included in his platform a declaration in favor of renewal of foreign investments in Mexico. He accused President Carranza of violating the constitution in assuming dictatorial powers and of having injured Mexico through adoption of a policy calculated to drive out foreign capital.

Irish Verdict Against Sergeant

Dundalk, Ireland April 30.—The coroner's jury conducting an inquest into the death of Thomas Mulholland, who was shot in a street here on April 16 and died an hour after the shooting, returned a verdict yesterday that "death was due to a bullet fired without justification and with intent to kill, by Sergt. Bustard." The verdict was widely cheered by the Sinn Feiners present. A police witness testified that while a patrol was passing along the street, its members were attacked by a body of men three times their number. Sergt. Bustard admitted that he had fired to hit.

The independent state of Iceland has applied for membership in the League of Nations. Other applications to be heard at the Rome meeting of the council of the league are from the republics of Georgia, San Marino and Luxemburg.

Colin Rankin, 94 years of age, an ex-Hudson Bay factor, dined with his wife at the celebration held in Montreal on Wednesday night in honor of the three hundredth anniversary of the granting of the Charter of the Hudson's Bay Company.

A very large audience greatly enjoyed the delightful singing of Mr. Paul Dufault, the noted French Canadian tenor, at the Prince Edward Theatre Monday evening, as well as the playing of his assistants, Mr. Alfred Carrier, pianist, and Mr. Jules Dubois, cellist.

Three hundred pounds of mail were burned up late on April 27th when a postal plane on its way from Washington to Newark, N. J., became lost in a fog over the Orange Mountains, grazed some trees on the hillside, crashed to the ground, and burst into flames. Wesley L. Smith, pilot, was only bruised.

Sir Robert Borden will probably arrive in Ottawa about the middle of May, according to a recent statement from an authoritative source. He is in Asheville, North Carolina, at the present time, and messages to friends in Ottawa state that his health has improved wonderfully since he began his tour of the United States.

Three men were killed and six slightly injured when a snow slide on April 29 dashed into a working party on the Government railway at Mile 75, between Anchorage and Seward, Alaska, sweeping scores of men into the ice filled waters of Turnagain Arm. Prompt work with ropes and improvised rafts effected the rescue of all but three.

There was a large attendance at the Charlottetown market yesterday, and a good deal of produce is moving. Prices continue to increase. For potatoes, dealers were paying from \$3.10 to \$3.25 bushel, oats about \$1.25 a bushel, young pigs \$7.00 to \$10.00 each, pork 23 cents and a quarter, or half cent better in some cases. Eggs were 48 cents and butter 68 cents. Hides are down to 15 and 18 cents, and calf skins about 40 cents.

The Chamber of Deputies in Paris on April 29 passed a bill prohibiting the export of works of art which the state considers form a part of the nation's artistic patrimony. An export duty was placed on other ancient objects of art of 30 per cent ad valorem, plus 50 centimes per thousand francs for objects valued up to 100,000 francs, and of 100 centimes for those valued over 100,000 francs.

That he was in sympathy with persons desiring to establish themselves in tents and shacks during the summer months' to get away from high rents and housing difficulties, was the statement of Mayor Gray of Winnipeg on April 29th. "The city," he said, "should be very lenient with regard to the placing of tents and shacks, particularly on and along the river bank. Citizens should not be forced to comply with all the regulations at such a time as this, when it is impossible to secure sufficient accommodations." The Mayor also stated that people were clamoring to be allowed to erect tents.
