MY LORD,

Government House, Montreal,  
15th January 1839.

WITH reference to your Despatch of the 14th December, No. 17, I have the Honour to transmit to you a List of the Members of the Special Council nominated by me on my assuming the Administration of the Government after the Departure of Lord Durham.

I considered it of Importance, under the Circumstances in which the Province was placed, to re-appoint all the Members who were in the Council last Year under my Administration of the Government, and to add to it Mr. Moffatt and Mr. Mondelet.

Mr. James Stuart, having been appointed Chief Justice of the Province, declined accepting a Seat in the Council, unless Her Majesty's Ministers might think it desirable that he should be appointed Chairman to the Council in the Absence of the Governor.
