TOPICS OF THE DAY.

The estimates of expenditure of the Provincial Government for the current year were tabled by Premier Peters on Monday last. They amount to \$283,945.

On Tuesday evening of last week a largely attended political meeting was held at Fort-Augustin. Speeches were delivered by D. Ferguson, Esq., and several others, and at the close a resolution of want of confidence in the Government was put to the meeting and carried unanimously.

The final supplementary estimates were submitted to the Dominion Parliament on Monday last by Hon. Mr. Foster. Private Edward Island's share amounts to upwards of \$32,000 and includes \$20,000 for reconstruction of Souris breakwater; \$1,000 for Sturgeon wharf; \$4,000 for dredging at Cape Breton; \$6,000 for repairs to breakwater at Wood Islands; and \$1,000 for the breakwater at North Rustico.

Once again we call the attention of our readers to the question of Overseers' certificates. The overseers for the ensuing year will be appointed in April, and any one who has performed his statute labor or paid his commutation money for the present year should see to it that he has his certificate before the old overseers go out of office. No one knows how soon they may be required, and the new Overseers will not have power to grant such. We trust this warning will be sufficient for our friends.

Seeing that their celebrated amalgamation-gerrymander—disfranchising bill of last session was not allowed to become law, the Government, this year, embodied these questions in three separate bills. Regarding the first of these, the amalgamation bill, we had something to say last week; the second refers to the gerrymander of King's County and is coming under consideration in the House. The outlines of the new Government district are to be the same as contained in the bill of last year. The ostensible reason of the Government for introducing the bill is the equalization of the voters in the districts affected; but the real motive of the change is the hope of crippling the second, third and fourth districts that they may return supporters of the Government. Of this bill we will have more to say later on.

The third and most iniquitous of the three bills in question is that which disfranchises the Dominion officials. The Liberals of former days, Coles and Whelan, and their co-workers devoted their talents, their energies and their very lives to the task of obtaining for the people of this Province the privileges of freemen and the right of manhood suffrage. But here is a Government that prostitutes the name "Liberal" by introducing the most illiberal measure ever submitted to the legislature of a civilized country, a bill to deprive a large number of our citizens of rights which every free man holds, or should hold almost as dear as his very life. Taxation without representation caused a mighty revolution on the North American continent a little over a century ago, and here, in this Province, on the outward rim of the nineteenth century, a Government arrogating to itself the title of "Liberal" dares to trample on the people's most sacred and most cherished rights and to revert to the despotism of more than a hundred years ago. All these Dominion officials are liable to be taxed for whatever purposes the Government may see fit; but henceforth they are to have no voice in deciding how these taxes are to be expended. No, no, their voice must no longer be heard in determining how their taxes shall be spent; for the "Liberal" Government of Prince Edward Island has decided they shall from this time forward be as dumb dogs, who dare not open their mouths. By slightly changing the words of a celebrated writer, regarding the French Revolution, we are not approximately exclaim, "O liberalism, how much political iniquity is perpetrated in thy name!"

But what justification do the Leader of the Government and his colleagues advance for this high handed piece of political iniquity? None whatever. Were the Dominion Government Grit instead of Conservative, we would not hear of any such question as disfranchising the officials. Naturally enough, in view of the fact that the Conservatives have been so long in power at Ottawa, most of the officials in the Railway, Post Office, Customs and other departments of the Dominion Government Services here are Conservatives, and at an election for the Local Legislature would be likely to vote against the Grit candidate. In this they would only be exercising their privileges as free British subjects; but, in the hope of gaining a party advantage, Premier Peters has made up his mind they shall be deprived of the inalienable right of every British subject, and he has endeavored to himself to vote against the Grit candidate. SESSIONAL NOTES.

Having any occasion to transact official business with them was liable to be insulted. These men, not only voted against the Government from which they drew their support, but freely spoke against it, and otherwise showed their antagonism to it. Yet these men have not been interfered with by the Dominion Government. The Premier made a very long and labored speech in introducing this measure. He was evidently seeking to cover up his tracks in some way, but it was a vain endeavor, everyone listening to him could perceive the injustice of the measure. He pointed out that the Dominion officials were disfranchised in Ontario and Nova Scotia. Very true, and in both these Provinces they have been disfranchised by Grit Governments. He held up Premier Fielding, of Nova Scotia as a paragon of political sagacity. Well, Mr. Fielding has been in power in Nova Scotia for nine years and has succeeded in running the Province upwards of three million dollars in debt. In the last four years he increased the debt to the extent of \$1,793,609, and his deficit for last year was \$122,486.40. By disfranchising the Dominion officials, and running the Province irrevocably in debt for money with which to bribe the electors, he manages to keep in power. No wonder our Premier regards him as a model statesman, for he himself is rapidly following in his footsteps by saddling a permanent debt on the Province, gerrymandering the districts and disfranchising the Dominion officials.

Judging by the enthusiasm with which some members of the Government and some of their followers supported the bill for prohibiting the importation and sale of intoxicating liquors, they have strong convictions on the putting down of liquor.

"Miserable poltroon," "coward," etc., were some of the epithets hurled across the floor of the House by some members of the opposition parties, during a heated debate on Wednesday afternoon last. This indicates a high degree of excitement on the part of the debaters; but does not, by any means, add to the dignity of the proceedings, and when coming from Ministers of the Crown is particularly disgusting.

Mr. Bentley has been chosen by the members of the Opposition as their Leader in the House. The choice is a good one. He has been a long time in the Legislature, was for several years a Minister of the Crown, and is consequently familiar with parliamentary procedure. Mr. Bell, doubtless, laid the cut out of the bag, and exposed the true inwardness of the Government's position when he pointed out that the two-third clause could not be legally binding and that a Legislature could tie the hands of future Legislatures. He quoted from the acts of union between England and Ireland, and England and Scotland, certain provisions which were to be observed for all time; but which future parliaments unhesitatingly repealed when they thought proper to do so. Friday, however, Mr. Bell went back on his professions of the previous day, and placed himself on record as a faithful follower of the Leader of the Government. He got what he wanted, the order book contained a notice that the Premier intended to introduce a resolution, on which to found a bill for the establishment of a registry office in Prince County. This had the effect of strengthening Mr. Bell's wavering political faith and since then he has been a Grit through and through.
