PREFATORY NOTE.

•••

The object of this Statutory Record is to supply what has for a long time appeared to me to be a very real want in a small way, namely, a ready guide to those who have occasion to refer to the Revised Statutes of Canada or Ontario, which shall shew them at a glance whether any particular Act or section of an Act, to which they may have occasion to refer, has been amended, repealed, or supplemented by subsequent legislation. Alterations of the Statute law are so incessant that, without some such guide, there must often be a feeling of uncertainty whether any particular enactment in the Revised Statutes is, at any given time, still in force and intact. It is my purpose, if this number of the Record is favourably received, to endeavour to remove this uncertainty in the future, by publishing either a supplementary number or a re-consolidation of this Record every year.

The only difficulty has been to combine completeness with such conciseness as to admit of publication at a low price. After trying various methods of arrangement, the one here adopted has seemed to me to be, upon the whole, the best.

It has been necessary, however, in order to secure conciseness, to refer in most instances simply to the Statutes in which repeals or amendments of particular sections are to be found, and not to the particular sections in those Statutes;

but, inasmuch as the amending or repealing Statutes generally deal with the sections affected in their consecutive numerical order, there is very little difficulty in rapidly turning to the particular section of the amending or repealing Act which affects in each case the section in question in the Revised Statutes.

It may be added that, with the same view to conciseness, where the sections in the Revised Statutes are stated in subsequent Acts to be "repealed and new sections substituted," these are classified in the Record as amendments simply.

I cannot hope, in dealing with the Legislation even of two Sessions, to have altogether escaped omissions and inaccuracies; but I shall be extremely grateful to have my attention called to any that may be detected, so as to secure their correction in future numbers of the Record.
