Every Public or Seperate School Head-Master or Mistress, shall, in like manner, post up one of his or her copies on the door of the School house, and every Post-Master shall post up one of his copies in his post office,

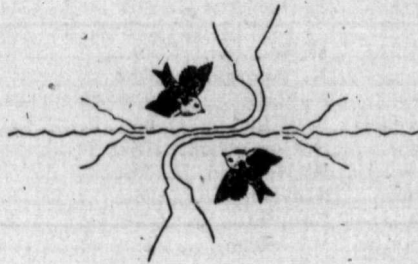
