## P R E F A C E.

---

As the time of Advocates, especially of those in large practice, and of the Officers of the Courts, is valuable, and as there occur not unfrequently occasions when they have not a moment to spare, the undersigned has compiled the following Tables, in order to obviate delay in the choice and application of Law Stamps, under 27-28th Vic., ch. 5, which is to come into force on the 1st proximo.

Amongst other particulars conducive to that object, he has found it necessary to include in those Tables an indication of the smallest number of stamps with which each particular fee and tax may be paid; otherwise, such a number of the smallest denomination of stamps might be used as to interfere inconveniently with the writing endorsed on some Law-Proceedings, besides materially increasing the duty of those officers, both in the examination and the defacement required by law of such stamps.




