

CONSTITUTION AND RULES

of

The Ladies' North-West Conservative League

NAME, OBJECTS, ETC.

- 1. 'This League shall be called the North-West Ladies' Conservative League.
- 2. That of Regina shall be the central or parent society.
 - 3. The objects of the League shall be:
- (a) To secure thorough and uniform organization.
- (b) To assist in the arrangements for organizers, dissemination of literature, canvassing, etc., during a campaign.

MEMBERSHIP.

4. The League shall consist of members of all duly organized societies and the council of the

League of Representatives selected by each affiliated local Conservative League, or the president thereof, in case no selection shall have been made to attend the annual meeting.

OFFICERS AND DUTIES.

- 5. The officers of this League shall consist of a president, two or more vice-presidents, a secretary and a treasurer.
- 6. The president shall preside over all meetings of the League and Executive Committee, enforce the due observance of the constitution, and decide all questions of order. In the absence of the president the first vice-president, and in her absence the second vice-president, shall preside. If all are absent, a chairman shall be selected from among the members present.
- 7. The secretary shall keep full and correct minutes of all meetings of the League, and shall send out notices of all meetings.
- 8. The treasurer shall receive and account for all moneys belonging to the League, and on the certificate of the president, pay all debts incurred by the League.

EXECUTIVE COMMITTEE.

9. The Executive Committee, in the intervals between the meetings, shall have an oversight of the affairs of the League, and swell the membership roll.

TIME AND PLACE OF MEETING.

- 10. The first annual meeting of this League shall be at Regina, on January 17th, 1901. An executive meeting shall be held at least quarterly.
 - 11. The meeting shall be called to order at the hour of three o'clock in the afternoon, or at such other hour as the president may determine, due notice being given to each local League.
 - 12. Special meetings of the League may be called by the president, or shall be called by the secretary on the written request of five members. Three members shall form a quorum.
 - 13. There shall be an annual fee of one dollar, payable by each local League on joining the central League. The membership fee shall be twenty-five cents.

ALTERÁTION OF THESE RULES.

14. Alteration of these rules shall be made at the annual meeting, or at a special meeting called for that purpose.

ORDER OF BUSINESS.

- 15. The order of business at all meetings shall be as follows:
- (a) Receiving the fees and credentials of the delegates.
- (b) Reading the minutes of previous and special meetings.
- (c) Reading reports of secretary, treasurer and auditor, and also finances.
- (d) Reading communications.
- (e) Election of officers.
- (f) General business.
- (g) Selection of next place of meeting.
- (h) Speeches. God save the Queen.
- 16. This constitution, modified by place and circumstances shall be the model for the constitution of each local North-West Conservative League.
