DIOCESE OF MONTREAL.

ANNUAL MEETING OF THE CHURCH SOCIETY.

This meeting took place on Tuesday, 18th January, at the National School House. At noon the members of the Society met to transact preliminary business, and at 7 o'clock in the evening, the public meeting took place. The Hall of the School House was crowded by the assembly.

Upon taking the Chair, the Lord Bishop remarked, that it was fitting in opening this meeting, when the Society had re-assembled after a year's interval, to enquire what had been done during that time. Happily he could reply-much. The Society's Act of Incorporation had received the Royal assent, and they now stood there upon a stable and satisfactory basis. Those who had charge of the interests of the Society had since then endeavoured to reduce its elements into order, and to provide machinery with which to carry on its future operations. By-laws and Rules had been framed and a plan matured for insuring the lives of the Clergy,-a thing which had been much needed for a long time. tions to the Widows' and Orphans' Fund, that its judicious application for their future benefit had been secured. The Act providing for the temporalities of the Church had also received the Royal assent. All these things formed, however, but the shell or skeleton, without life or vigor, unless the Spirit of God breathed upon what would otherwise be but dry bones, in answer to their earnest prayers. He hoped that in the year to come, with God's blessing, the work they had in hand, the diffusion of the means of grace and the salvation of souls, would be much further advanced; that the members of the Society would be more earnestly devoted to these good works. They were not met there for the pleasure of the passing hour, to listen to a report, to speeches and resolutions, but by communion with each other to inspire in the hearts of all the members of the Church assembled, a zeal in its service. He would not go into the details of the operations of the Society; that task had been entrusted to other hands, but he hoped that the effect of the proceedings that night would be, that those present would go forth determined to do all in their power during the coming year to aid and advance the objects of the Society, and that, as a result of their endeavors and the prayers offered up in that behalf, they might look for a more abundant measure of success for the time to come, to the glory of God, and the advancement of His kingdom upon earth.

The Secretary of the Society (the Rev. Mr. Rogers) then read the Report of the Central Board for the past year.

Dr. Holmes rose to propose, as the first resolution, the adoption of the Report.

The Rev. A. DIGBY CAMPBELL seconded the resolution.

The motion having then been put from the chair, was unanimously agreed to.

Mr. D. S. RAMSAY moved the second Resolution, which was as follows:--

Resolved,-That the Society, grateful for the amount of support received during the past year, would impress on all the members of the Church of this Diocese, the necessity for increased contributions to the funds of the Society, to enable it to carry on the several works in which it is engaged, and specially to extend its missionary labors.

The Rev. Mr. Bond seconded the resolution.

The Resolution was then put, and carried unanimously,

The Rev. Dr. LEACH moved the third Resolution, which was as follows:-

Resolved,—That this meeting desires to record the satisfaction

with which the members of the Church in this Diocese have observed the kindly interchange of Christian sympathy and fellowship between the Church of England and our brethren in the United States during the past year.

The Rev. Mr. BANCROFT seconded this Resolution.

Major Campbell moved the fourth Resolution, which was as follows :-

Resolved,—That the thanks of the meeting be tendered to the officers of the Society for their services during the past year.

The Rev. Mr. Inwin seconded the resolution, which was then

put from the chair, and unanimously carried.

His Honor Mr. Justice McConp then moved that the Lord Bishop should leave the chair, and the Rev. Mr. Townsend should take it, and the Rev. Gentleman having taken the chair accordingly, His Honor proceeded to move the following resolution:

Resolved,-That the thanks of the meeting be offered to the Bishop for the deep interest he has manifested in the affairs of the Society, and for ins able conduct in the chair.

The Lord Bishop said, that it was never very pleasant to sit by

and listen to such converse about one's self, as had just taken place, but he was nevertheless deeply grateful for the kind feeling towards him, manifested by the speakers and the meeting. desired to refer to one or two topics which had been the subject of comment during the evening's proceedings. With reference to the restrictions placed upon the reception of Clergymen ordained in the United States into the Cure of souls in this Province, that was one of the remains of old legislation which ought now to be abolished, and he hoped that it shortly would be. Dr. Holmes had expressed great unwillingness that we should have anything to do with legislation: the only object of seeking legislation, was in order to set us free from old trainmels, and enable us to varry on our own affairs. He (Dr. II.) had also desired it to be understood that the Clergy did not constitute the Church. He believed he spoke the opinion of all the Clergy around him when he stated that they heartily concurred, as he did himself, in that desire. (Applause from the Clergy.) He had sought to impress it on the Laity upon all occasions when an opportunity had been afforded him. It had tended, he believed, to produce no little apathy among the Laity, that they did not remember that all persons baptized into the Church were members of it, and formed part of it, as well as its Bishops or Clergy, and no persons would more heartily rejoice to see the feeling diffused abroad that they were all one body, than the Clergy themselves. (Applause.) He could not help reverting to the Position of the Church in the United States, because, situated as we are here, while we receive our doctrine from, and owe allegiance to the Church in England, of which we form part, yet in matters of discipline and temporalities, we must follow their example. It was indeed a refutation of the common accusation against the Church at home, that it flourished only because it was a State Church, and supported by State aid, that the same Church was flourishing so vigorously in a country where no government aid was extended to it. He was rejoiced in the depth of his heart to see the fellowship of the different branches of the Church recognized by the world. What reproaches had been offered to Churchmen that she was not Catholic, but was shut up within the four seas of Britain. Now she girdled the world with her Churches, and her Prelates and Clergy flock together to solemn festivals from every quarter of the globe. Regarding the English Church as the great bulwark against Romanism, he did consider the great manifestation witnessed by Mr. Bancroft, as matter of heartfelt congratulation. It afforded to the world a great and convincing proof that the reformed faith of the English Church is a Catholic faith. When he witnessed the flourishing condition of the Church at New York, he experienced feelings of deep thankfulness for this proof of her Catholicity. He was told when he saw the 200 Glergymen present at Dr. Wainwright's consecration, march into Church, that at the time of his ordination to the Ministry, that was about the total number of the Episcopalian Clergy in the United States. So wonderful an

increase had been made during the period of one mar's ministry. He only feared for the Church in Canada, that its members would be discouraged at the difficulties of starting. They did not see the results flowing from the small sums raised. As had been happily remarked, the acorn had just been planted here, and it will take years to bring the tree to maturity, but we could see that seed had been planted with life in it, and it was germinating; we must foster and advance its growth. In conclusion, he begged to thank them for the manner in which they had received his name. If they, the laity, would but afford the Clergy their hearty support and cooperation, then they would be able to go on and increase an hundred fold. He trusted that that great meeting was an index of increasing zeal to be displayed in the service of the Church and the Society for the coming year.

A collection having been taken up, His Lordship closed the

In the Buckingham case, the estimated cost of the Church was £310, towards which the Incumbent, his personal friends, and the inhabitants, raised by their exertions a sum of £229.

The Society for Promoting Christian Knowledge, and this Church Society have added £50, leaving a balance required

to complete the Church of £31.

In the Gore application, out of a sum of £9%, the estimated cost of a Parsonage house, the inhabitants have raise £66 and built a substantial dwelling; and the Rev. Incumbent says that the balance, or £30, will leave the Glebe and Parsonage house (worth £2.70) "free of debt."

In the Hemmingford case, the inhabitants have raised £125, to pay their half of the new purchased Glebe, an exertion which proves them zealous in the good cause, and they now say, through their elergyman, that if this Society will grant them £25 or more, they will put up a Parsonage house before next

winter.

The Lay Committee feel the urgent necessity there exists for complying, to the extent of their abilities with applications of the nature of the above; when the members of the Church do show their zeal by a fair taxation of themselves, this Society is bound to aid them, and means must be found to do so. In order to effect this, and not anticipate the income of the next year, your Committee respectfully suggest the propriety of selling the Bank Stock belonging to the Society, and the appropriation of its proceeds exclusively towards the objects of Church Endowments, and Church, and Parsonage house building.

This sum, with due care and economy, keeping always in view the comparative means and contributions of those seeking aid, will give encouragement to all, and secure the immediate completion of several unfinished churches, and add to the comfort

and respectability of the missionaries.

BY-LAW.

To make provision for the due administering and improving the Widows' and Orphans' Fund, of the Church Society of the Diocese of Hontreal.

I,

That all rents, issues or profits of lands or tenements, held by the Society for the relief of the Widows and Orphans of Clergymen, and all meneys given or granted for the same purpose, unless special provision be made by the grantor or donor of the same for the distribution thereof otherwise, shall be put to the credit of a fund to be called the Widows' and Orphans' Fund.

And that the Society shall, and will, put to the credit of the Widows' and Orphans' Fund yearly, and every year, a sum of money equal to One Pound Five Shillings for each duly recognized Clergyman in the Diocese, from the Fund for General Purposes, providing that Fund will be as such a charge upon it; and that after the current and customary expenses of the Society are paid, the charges for the Widows' and Orphans' Fund shall be the first paid from the General Purpose Funds, and that such sum shall be put to the credit of the Widows' and Orphans' Fund on the day of

year, on the Lord Bishop of the Diocese forwarding to the Treasurer a list of the Clergy duly recognized, signed with his hand.

That each Gergyman, either Incumbent or Travelling Missionary, having Cure of Souls in this Diocese, in order to entitle his Widow and Children to claim the annuity hereafter provided; from the passing of this By-Law, or claim the annuity hereafter provided; from the passing of this By-Law, or from the time of his appointment in the Diocese, shall remit to the General Fund of the Society, the sum of £1 17s. 6d., per annum; shall observe the directions, from time to time given by the Lord Bishop of the Diocese, in respect to the Collections to be made on behalf of the Widows' and Orphans' Fund, unless such Clergynau shall have been excused by the Lord Bishop of the Diocese in writing under his hand, from making such Collection or Collections in any Charch, Chapel or Station, served by him; and such excuse or dispensation, when given, shall have been forwarded to the Secretary of the Church Society of the Diocese of Montreal, whose duty it shall be to make a regular entry of such exemption, which shall be considered, so far as any claim upon such Fund is concerned, as though such Collection or make a regular entry of such exemption, which shall be considered, so has any claim upon such Fund is concerned, as though such Collection or Collections had been made, by the Clergyman so exempted. Provided that nothing herein contained shall be construed to prevent a Clergyman duly licensed, or recognized by the Lord Bishop as a Curate, or Assistant Minister, from participating in the benefits of the Widows' and Orphans' Fund, although no Annual Collection may be made by laim.

That a Managing Committee be annually chosen (at the Annual Meeting) to control the affairs of the Widows' and Orphans' Fund, consisting of five, two of which shall go out annually, but eligible to re-election, and it shall be the duty of such Committee to prepare, for the consideration of the Society at its Monthly Meetings, all business relative to the management, investment and improvement of the Widows' and Crephans' Fund, and no matter expected with the appropriate transfer and the shall had been matter connected with the management or investment of the said I and shall be decided upon until it has first been submitted to such Committee, for them to report thereupon to the Central Board.

The Trensurer shall lay before the Central Board, at its Meeting, in December in each year, a statement of all Moneys invested, or in his hands, belonging to the Widows' and Orphans' Fund; and of all Moneys received and paid on account of the said Fund since the last annual statement. And the Secretary of the Lay Committee shall, at the same time, lay before the Society, a statement of all Lands held by the Society by grant or otherwise, on behalf of the said Fund.

That from and after the passing of this By law, the Society shall pay an annuity to the Widow of every Clergyman who, at the time of his decease, shall have been duly licensed to the Cure of Souls in this Diocese, and recognized by the Bishop, or have been placed on any Retired List with the consent of his Lordship, and, from the passing of this By-law, or from the time of his nppointment in the Diocese, shall have been a subscriber as set forth in Rule III, per annum; and who shall have complied with the requirements of this By-law, such annuity to be of Forty Pounds currency, payable in two equal half-yearly payments, on the first day of January and July in each year: the first of such half-yearly payments, or such portion thereof as may have accrued from the day of the death of her husband, to be made on the day above rentioned next following the death of her husband, so long as she shall remain a Widow. In the event of marrying again, the question of continuation of annuity to be re-considered by the Managing Committee. And in case such Widow shall, at her death or marriage, have four or more Children by her late husband, under the age of eighteen years, such annuity shall be paid to the Guardians of such Children; and should there be less than four Children, then such a sum not exceeding Ten Pounds, shall be paid as aforesaid for each, and, that all annuities paid for Children shall cease on the day at which they attain the age of eighteen years. And in case of a Clergyman deceased, leaving no Widow but leaving Children, then such Children to enjoy the annuity as above provided: Provided always, that the Widow and Children of a Clergyman shall not be in the receipt of an income from other sources exceeding £150 per annum; or in case of Children, that the Guardians of such Children shall not be in the and the Guardians of such Unidren shall not be in the receipt of an income from other sources exceeding £150 per annum for their benefit.

COLECTATION OF FROSTE VILLAGE CHURCH.

The Lord Bishop of Montreal arrived at Froste Village from Lennoxville, on Monday, 16th January, accompanied by the Revds. Principal Nicolls and J. Scott, and on the following day conscerated the new Church which has been lately erected Much credit is due to the clergyman and members of the Church in this little place. for the zeal and liberality they have shewn in connection with this work. The edifice, if not perfectly correct in all its details-as a specimen of the early English style of architecture, certainly exhibits far better taste and a greater approximation to ecclesiastical propriety, than is to be seen anywhere in this part of the country; and is, we hope, to be considered an advance towards a better order of things. It is a substantial stone structure, fifty-six feet in length (including the chancel,) with a high pitched open roof. It is fitted up with open seats and lecterns made of butternut,

and very neatly finished. The furniture of the interior, which I the earliest instance of a consecration on record in the Old Teswas exceedingly admired by every one, was provided by the industry of the Froste Village Ladies' Sewing Society. The petition was read by the Innumbent, the Rev. D. Lindsay, and the ceremony of Consecration having been proceeded within the usual manner, the Deed of Consecration was read by the Rev. Joseph Scott, who attended the Bishop as Chaplain. The prayers were read by the Rev. A. T. Whitten; and the Lessons and Epistle and Gospel by the Rev. Messrs. Balfour and Whitwell, all of whom had previously held a charge in the District. The Choir was a very effective one, assisted by some members of the Choir from Waterloo. An able and appropriate Sermon was preached by the Rev. Principal Nicolls, in the course of which the respective duties of both pastors and people were forcibly detailed; and a collection was taken up, amounting to £10 10s. The Church was filled by a crowded congregation, a large number of whom will, we trust, continue to be constant attendants in this material "House of Prayer," towards the erection of which they have so liberally contributed; partaking in the pure services of our Reformed Church, hearing the true Gospel preached by their faithful pastor, and being built up themselves as living stones of a Spiritual Temple. The following clergymen were also present :- the Rev. Messrs. James Jones, Wm. Jones, Slack, Robinson, Constantine, R. Lindsay, Machin, and Allen; who were all most kindly entertained at the houses of different

DIOCESE OF VICTORIA.

(From Overland China Mail of 20th Sept.)

Consecration of the Cathedral On Sunday morning, (September 19,) St. John's Cathedral was consccrated by the Bishop of Victoria; the building having been opened for Divine Service above three years ago by licence from the Bishop of London, but, through delays of a technical nature, never before having been formally consecrated.

On this occasion the garrison were present, in addition to the

ordinary morning congregation.

According to the usual form, the Bishop was met at the west door by the trustees of the Church, and by them conducted to the vestry. On his Lordship's appearing at the communiontable, the deed of petition for consecration was presented to him by the Honorable W. T. Mercer, Major Hope Graham, R. D. Cay, Esq., C. St. G. Cleverly, Esq., Trustees in behalf of the Government; the Honourable J. F. Edger, and T. C. Leslie, Esq., Trustees elected by the pew-renters. Immediately after this, the Bishop and Clergy present proceeded down the middle ! aisle of the Church to the western door; at the same time reciting the 24th Psalm in alternate verses. When the Bishop, with the Chaplains, had returned to the space within the communion-rails, the Ordinances of the local legislature, authorizing the erection of the Church, and giving to the trustees the power of liquidating all sums due on the building, were presented on the part of His Excellency the Governor by R. D. Cay, Esq. The usual form of Consecration Service was then read by the Bishop; at the conclusion of which, the formal Sentence of Consecration was read by the Rev. S. W. Steedman, Colonial

Morning prayer was then said, being varied by lessons from the Old and New Testament, and a collect, epistle and gospel,

suited to the occasion.

Morning prayer being ended, a sermon was preached by the Bishop, from 2 Chronicles vii. 12, in which, after referring to

tament, and drawing a contrast between the material splendour of Solomon's temple and the higher spiritual glories of a Christian temple, he alluded to the very peculiar circumstances under which St. John's Cathedral had been dedicated to Almighty God, standing on the borders of the vast empire of China, and on the farthest outpost of Christendom. Attention was also drawn to the many providential events which stamped a peculiarity on the present period in the history of mankind; and to the vast responsibilities which rested upon the European community in China in connection with the extension of Christianity and civilization through the world. His Lordship concluded by pressing upon the congregation the duty of clergy and laity uniting their efforts in promoting these important objects.

The whole service was marked with great attention on the part of the assembled congregation; and at the close a collection was made at the doors, amounting to between 300 and 400

dollars, in aid of the current expenses of the Church.

SOCIETY FOR PROMOTING CHRISTIAN KNOWLEDGE.

The Ven. Archdeacon Robinson in the Chair.

After the reading of several communications from the Bishops of Calcutta, Colombo, Montreal, Melbourne, &c., and the voting of several grants in aid of objects specified and recommended by their Lordships, the Standing Committee called the attention of the Board to the case of Pitcairn's Island and its inhabitants. Reference was made to a letter which had been received from Rear-Admiral Moresby on this subject, in connection with the Society's former services in their behalf, and which had been laid before the Meeting in November. The following particulars, in the form of an Address from the Committee of the Pitcairn's Island Fund, were brought under the notice of the Board :-

"The eventful history of the 'Bounty,' which led to the occupation of Pitcairn's Island by part of the mutineers, with some men and women of Tahiti, in 1789, is well known. After a few years spent in violence and unbridled licence, the Tahitian men, and seven of the nine mutineers, including Fletcher Christian, the leader of the mutiny, came to an untimely end; one of the remaining two died of consumption; and, within ten years of their landing, John Adams remained the single survivor of the men who had taken possession of the island. This remarkable man became impressed with the solemn responsibility of his position, when he found himself surrounded with a number of young persons, all children of the mutineers, between the ages of five and fifteen, ignorant of God, and likely, under the influence of their Tahitian mothers, to become idolaters. About the same time he bethought him of the Bible, which had been much used by Christian, and also by Young in his last illness. On finding this, as well as a Prayer Book, which had also been saved from the the 'Bounty,' he set himself to read their contents, which at first he was scarcely able to do from his imperfect scholarship. Still he persevered, so that he was shortly able to instruct the young people to read; and he became so impressed and imbued with the Gospel lessons of salvation, that he undertook the regular religious instruction of the inhabitants. From this time peace and contentment pervaded this small Christian community. Larly in 1829 John Adams died, at the age of sixty-five years.

"Five months before his death, a young man, moved with a desire of assisting him in his work, arrived in the island, and being kindly received by the inhabitants, was, immediately on the death of Adams, appointed to the office of schoolmaster and pastor. In these capacities, as well as that of their medical adviser. Mr. Nobbs has almost unintermittedly continued ever since among them. During that period, now between 24 and 25 years, several ships have visited the island; and the accounts brought back by the visitors of the singular innocence and simplicity of manners that prevail among the inhabitants, have from time to time excited great interest in the public mind.

" In the month of August last, Admiral Moresby Commander in Unief in the Pacific, visted Pitcairn, and he has strongly confirmed, in his despatches, all the favourable accounts previously received of its inhabitants. In compliance with their wishes, he received Mr. Nobbs on board the 'Portland,' and provided him with an immediate passage to England, with the view to the fulintment of their long-cherished desire of having a regularlyordained pastor in the island.

"Under the authority of the Bishop of London, Mr. Nobbs was admitted to Deacons' Orders by the Bishop of Sierra Leone, on the 24th of October, 1852. He received Priests' Orders at the hands of the Lord Bishop of London on the 30th of November, and hopes to leave England for Valparaiso, on his way to Pitcairn's Island, about the middle of December.

"The Society for the Propagation of the Gospel has placed Mr. Nobbs on its list of missionaries, with a salary of £50 per annum.

"The very scanty resources of Pitcairn's Island, containing a population of one hundred and seventy persons, within a circuit of four miles and a half, with limited extent and imperfect means of cultivation, and the great need that exists of many articles of daily use, which they cannot at present obtain, induce some friends of Mr. Nobbs, and of this interesting community, on the recommendation of Admiral Moresby, to raise a fund of moderate amount for the passage and outfit of Mr. Nobbs, and for the supply of such things as are most pressingly required by the inhabitants. Labourers' and carpenters' tools, a proper bell for the small wooden church, communion plate, medicines, two or three clocks, besides clothing of various sorts; some simple articles of household furniture, and cooking utensils, together with stores of provisions, are immediately needed; and further supplies of these are likely to be required for some years to come.

"It may be right to add, that the Admiral has most liberally followed up his recommendation by offering 100l to the fund that may be raised for the above purposes."

It was ageed that £100, be granted towards the Pitcairn's Island Fund.

In communicating to Mr. Nobbs this unanimous vote of the Board, the Chairman expresed to him the warm interest felt by the Society, and by members of the Church generally, in the spiritual welfare of the inhabitants of Pitcairn. He had noticed with much satisfaction the friendly reception given to their pastor in this country; and now that he was about to revisit them as a clergyman, in Priests' Orders, he wished him a safe and happy return.

Sir Thos. D. Acland, Bart., M. P., after expressing his entire concurrence in the part taken by Admiral Moresby, as detailed in the statement laid before the Board, observed that it was important to have the testimony of the Rev. W. Holman, who has been left at Pitcairn during the temporary absence of Mr. Nobbs. The following extract from a letter addressed by Mr. Holman to his father, Captain Holman, in Devonshire, was read to the meeting :-

"The accounts of the virtue and piety of these people are by no means exaggerated. I have no doubt they are the most religious and virtuous community in the world; and during the month I have been here, I have seen nothing approaching a quarrel, but perfect peace and good will amongst all.

The Rev. G. H. Nobbs acknowledged the Society's grant which had just been voted, as well as grants of Bibles, Prayer Books. and Books and Tracts sent out on former occasions for the benefit of his fellow-islanders. These had proved most useful and acceptable. He had been more than once round the world; and in various places, at Valparaiso, Panama, the West Indies, and other parts, he had met with books bearing the Society's stamp, and found them much esteemed.
