The Grand Master submitted the following Report:-

Thank God, another year has passed without any serious disaster to ourselves, or the Order under whose Banner we hail.

Here your Grand Master would request you to unite together in peace and good-will to all mankind, and especially our great Brotherhood, and to war only against vice, in all its forms; to obey the mandates of our Order; to succor our distressed brethren; to watch over and protect their orphans, and to wipe away the tear from that once happy wife, but now disconsolate widow.

It gives me great pleasure to meet so many familiar faces, who have stood firm through the trials of adversity, and stand as pillars in our great moral association. And likewise some new faces, who look as if the Jewels of our Order would not tarnish in their hands.

Much praise is due our Worthy Grand Secretary for the whole souled interest he has manifested, in advancing the cause of our Order among us.

I would commend to your notice the Reports of D. D. G. Masters Woodyatt and McLean, who have been up and doing in the good work, and by whose exertions, two bright links have been added to the chain of Odd-Fellowship in our jurisdiction.

I regret exceedingly the disturbed and warlike spirit that now prevails to such an alarming extent between the Northern and Southern sections of our neighboring Republic. God grant that the spirit of peace and good-will may ever prevail in Canada, our beloved country. May we live up to and cherish the principles of our Order, and retire at a good old age to where no bloody battles will be fought, or malice arrows hurled, but purple waves of living thought, surge through the angel world, and the widow's wail, the orphan's cry are changed to songs of praise.

During the recess, Dispensations have been issued for three Subordinate Lodges, viz: first Simcoe, second Thames Lodge, and the third for Hamilton, which last has not been organized as yet. The two first are

respectfully submitted for your approval and confirmation.

From my correspondence with the Grand Secretary I learn that in the Village of Ayr, active preparations are being made for the organization of a Lodge of our Order, with a fair prospect for the future.

Brothers, we should all unite in giving encouragement to the daughters of Rebecca, for women in past ages, have almost invariably laid the foundation for great enterprise and great reforms. Then let us multiply her social advantages, enhance her dignity, minister to her intelligence, and by manly gentleness be the champion of her genius, the friends of her fortunes, and the equal, if you can, of her heart.

An application was made to me by the N. G. of Olive Branch Lodge of Detroit, Mich., to allow a certain party residing in the Village of Windsor, C. W., desirous of joining the Order, to connect himself with Olive Branch Lodge, inasmuch as our nearest Lodge was situated some fifty miles distant. I felt much pleasure in granting the necessary permission, and hope in time to receive an application for a Charter from that source.

Application was made to me for my decision, as to the legality of expulsion of members, for the non-payment of dues. The decision that I gave was, that it is a custom at variance with the principles and spirit of Odd-Fellowship, and of course I must pronounce it illegal. The digest, our highest authority, declares the practice impolitic and unjust, to visit misfortune with the extreme penalty of the Law, designed for criminal offences. Brethren, I cannot sanction a wrong in my jurisdiction, and hope the Representatives present will respect my motives if they condemn

Elgin Lodge, No. 32, has surrendered her Charter and working Books, a report of which will be laid before you during the present session. The following will show that the cause of Odd-Fellowship has not

been slumbering within the past year:

There have been ninety-two initiations, twenty-seven withdrawals, fifty-six suspensions, thirty-five expulsions, four deaths, three re-instatements, seven admissions by card, and an average of contributing members as shown by Reports for Dec. and June of 500.

There have been 230 degrees conferred, \$507.50 paid widows and orphans, \$90 paid for burying the dead, \$207 paid for relief of brethren. The W. & O. Fund amounts to \$7350.09.

Brethren, I will not detain you longer from the work of the Session, I shall gladly convey to you all the information in my power, so far as connected with the order. Regretting my inability to do justice to the office I have held among you, I submit the foregoing with my best wishes for my successor in office, and the prosperity of our Order.

On motion of Rep. Tait, the G. M. report was referred to the following Special Committee for distribution of subjects to appropriate committees, Wm. H. Read, Henry Sewell, and Jas. Woodyatt.

The Grand Secretary made the following Report:-

To the R. W. G. L. of Canada West, P.O. O. F.

OFFICERS AND REPRESENTATIVES,—At the close of the last, session of this Grand Lodge, in pursuance of the practice of my predecessors, I attended to the publication and distribution of the proceedings of that Session.

The distribution extended to those Grand Lodges in the United States, accessible by regular mail, and I have to acknowledge the receipt in return, of Reports from nearly all of those Grand Lodges, from the perusal of which, very much is to be learned, of interest to this Grand Lodge and to the order generally.

In commemoration of the life services and death of the late Past Grand Sire, Thomas Wildey, subjects calculated to enlist the mingled admiration and tenderest sympathies of every good Odd-Fellow, they have all adopted appropriate resolutions.

He died at the City of Baltimore, October 19th, 1861, in the 78th year of his age, venerated and beloved by Odd-Fellows and good men

everywhere.

In order to provide for the deficiency required for the lithographing of our new Charters, the Secretary was authorized at the last Session, to apportion the whole cost of Charter among the Lodges according to their representation, and call upon them for any deficiency remaining due by them.

Notwithstanding the adoption of this resolution, there seemed to be a very general desire to raise the amount required, by voluntary contributions from the Lodges, and several Reps having guaranteed from their respective Lodges, sums, in the aggregate nearly covering the deficiency, I deemed it advisable to make the appeal and await their voluntary action.

The amounts thus received are in addition to what these Lodges had before paid to the same object, and will be given in my statement of Receipts.

Having acted on this measure (not without advice) but without authority, I shall most cheerfully contribute the present deficiency, if the Grand Lodge Fund is to suffer on account of my action in the matter.

It will be seen by reference to the correspondence with this office, that an opportunity has quite recently offered for the disposal of a quantity of lithographed Charters, and from what I can learn of the wants of other Grand Lodges, I am satisfied, that the Charter has only to be seen to be appreciated and sought for.

The design is a most beautiful and comprehensive one, doing credit both to the head and heart of the donor, Bro. John R. Peel, our present Deputy Grand Master, and with an alteration of two or three words in the printed portion, could be adopted by any other Grand Lodge.

I believe a very creditable revenue may be derived from the sale of Blank Charters, and with a view to the purchase of the stones upon which our present Charters were struck off, I submit such estimates for the stones and the cost of printing or lithographing, as I have been able to obtain.

In response to the resolution on page 27 of last journal, ordering the return of the original Dispensations of Lodges, on the receipt of the new Charters, I have received the Dispensations of Union, Erie, Gore, Samaritan, Imperial, Forest City, Avon, and St. Marys Lodges.

Of the existing Lodges that have not complied with the resolution referred to, I believe three of them hold Dispensations from the Grand Lodge of the United States, issued before the organization of this Grand Lodge, and seem to be of the opinion that this Lodge cannot recall their Dispensations.

This opinion is, I think, erroneous, since full authority and control of all Subordinate Lodges in this Jurisdiction was transferred by the Grand Lodge of the United States, to this Grand Lodge, immediately upon its organization.

This much is certain, no Lodge can reasonably claim two Dispensations or Charters—one or the other should be returned.

Of those Lodges that did not receive the new Charter, Rose, Morpeth, Industry and Ontario Lodges, (some of them long since extinct,) have made no return of either their Dispensations, Books or other effects.

From Ontario Lodge no report has been received since Jan. 1861, and I have been unable to obtain even a reply to my letters of inquiry, addressed to their last Rep., and D. D. G. M. for that District.

Industry Lodge was also under his charge, and his long silence is

wholly unaccountable, and apparently discreditable to him and the Officers of those Lodges.

I deem it a duty which this Grand Lodge ewes to itself and to the Order, that such conduct should not go unnoticed; the guilty parties should be found out, and unless restitution and amendment is made promptly, let them "atone to the offended law," by having their conduct held up to scorn, and their names published to the Order and the world as men "void of the principles of honor."

The new By-laws of Long Point Lodge, as also several amendments to the By-laws of other Lodges, which amendments have received the sanction of the R₁/W. Grand Master, are on file for confirmation by this Grand

The Dispensation for Excelsior Lodge in Hamilton, which was issued in March last, is still in my hands, and I would recommend that a Charter be granted instead.

I herewith submit correspondence with this office, which should receive the attention of this Lodge.

The returns from the Subordinate Lodges, have in most cases been promptly made, and I submit the following abstract:

From a comparison of our Revenue, and Disbursements, you will see the necessity of reducing our expenses if possible, and of adopting some new source of income. The adoption of the Proxy Representation will accomplish the one object, and the sale of Blank Charters will effect the second. Both of these subjects, it is desirable, should receive the consideration of the Finance Committee, and be reported to you in some tangible form for adoption.

In reference to the compilation of the Grand Lodge proceedings, and in order to facilitate the labors of my successor, and also to ensure accuracy and order in the journal, I would recommend that all motions and reports should be in writing, and on uniform sized slips of foolscap, as it is impossible with our present practice, for the Secretary to take down correctly all the motions made verbally, or to file properly reports and motions written on all sorts and sizes of paper, varying from gilt-edged to scraps of wrapping paper and envelopes.

I would also respectfully recommend that in future the Grand Secretary be instructed to have our Journals printed the size of the Constitution volumes, and paged from the commencement of our Grand Lodge proceedings, with a view to binding, and an index as practiced by other Grand Lodges.

In conclusion, I return you my cordial thanks for the confidence you reposed in me, and the honor you conferred upon me at your last Session, and for the uniform courtesy I have received from the Fraternity in the discharge of my duties.

While surrendering my position to a worthy successor, I can only say, that if I have so far succeeded in advancing the work we all have at heart, as to merit the approbation of the Brotherhood I have endeavored to serve, my highest ambition will have been attained.

SIR AND BROTHERS,—The duty that devolves upon me at this time of submitting to you a report of the proceedings of the Most Worthy Grand Lodge of the United States, is one which affords me much pleasure in rendering a cheerful obedience.

I assure you that it was with a mixture of strange feelings, that I for the first time entered the City of Baltimore, as your Representative. Owing to the high state of excitement the country was then in, travelling over miles of railroad protected by armed soldiers, was something new and novel, and entering a city which had but recently been disturbed by an excited and infuriated mob, was calculated to lead a reflecting mind to think and ponder, and more than all this, going almost in sight of two of the largest contending armies that probably ever met, (and certainly that ever done so little,) hourly expecting to engage in battle; I say, strange were the thoughts and feelings that were constantly revolving in my mind. I thought how many good and true Odd-Fellows there were arrayed face to face in both those armies, and I inwardly hoped that the institution of Odd-Fellowship would indirectly exert an influence in stilling those elements of discord, soothing the spirits of passion, and direct in harmony a united effort to restore peace and prosperity to that great country.

Upon arriving in the City of Baltimore, I found everything as quiet as if nothing had happened; law and order reigning triumphant, but under the authority of a Provost Marshal and his guards, which were kept walking the streets constantly day and night. And on Monday morning, the 16th day of September, 1861, a quoram of Representatives assembled in the Odd-Fellows' Hall, in the City of Baltimore, and the United States national ensign floating over that beautiful building, dedicated to the principles of friendship, love, and truth.

The Most Worthy Grand Sire, R. B. Boylston, of South Carolina, was not present to preside over the deliberations of Grand Lodge, but in his absence the chair was ably and satisfactorily filled by the Right Worthy Deputy Grand Sire, Milton Herndon, of Indiana, also that able and efficient officer Jas. L. Ridgely. Grand Cor. and Recording Secretary was not able to be with us but a few hours, in consequence of a severe attack of summer complaint, rendering him very weak, and unable to attend to any business at all, which was a source of deep regret to the Representatives assembled, his chair however, was ably filled pro. tem. by Representative Thomas, of Connecticut.

of the work and condition of the whole order, but it is too lengthy to embody in this report, and I would recommend it to the careful perusal of every member who feels interested in Odd-Fellowship, he thus speaks of Canada West.

The annual report shows a gratifying condition of the order. During the year an application was received for a Subordinate Encampment, to be located at St. Catherines, which being conformable to law, was granted by the M. W. Grand Sire, and the warrant issued on the 20th March, 1861, with a special deputation to Patriarch J. B. Hunter, of the Jurisdiction of Northern New York, to institute the same. The Encampment by the name of Union No. 1, was instituted accordingly by Brother Hunter, in July last, whose report showing that the Patriarchal Order was introduced into Canada West, with a good prospect of success, is herewith submitted.

The Financial Statement as given in the report of Grand Secretary, is as follows:

The Revenue of the year up to the 6th Sept. 1861, amounts to \$8,131 91 Falling due on that and payable during the session............ 5,368 39

Leaving available......\$11,200 30

This balance is chargeable with special appropriations of last session of \$5,650, and the mileage and per diem of this session of \$12,000, amounting to \$17,650 00

But by reason of the absence of at least one third of the Jurisdictions, the mileage and per diem will be reduced about \$4,000.....\$4,000 00

\$2,449 70

To this amount must be added the expense incurred during recess, for printing, a new edition of the Journal, new steel plate card engravings, and portrait engravings for new Journal, \$1,280 12.....\$1,280 12....

Estimated real deficiency......\$3,729 82

This statement presents an approximate view of the financial condition of the Grand Lodge, which will be somewhat varied, though not materially, by further receipts into the Treasury. In view of the general prostration

of all the monetary and business interest of the country, it is a much more gratifying condition of finance than could reasonably have been expected. I see no way in which this deficiency can be overcome, except by a liberal and magmanimous act of personal sacrifice on the part of the representatives themselves, which doubtless will, under the circumstances in which the Grand Lodge is placed, be promptly made. A reduction in the rate of mileage from five to three cents per mile, will provide for the entire deficiency, and it is believed will not oppress a single individual, however distant his home from the place of meeting.

Your Representative would here mention that the suggestions of the Grand Secretary, which I have just embodied in this report, were acted upon by Grand Lodge. And the mileage and per diem, instead of being \$8,000 as estimated by Grand Secretary, was reduced to \$4,760, thereby leaving the financial affairs in a better condition than they have been for

The number of members returned in good standing up to Sept. 1861, is 149,239. The annual receipts from Lodges show a sum of \$900,981. The amount paid during the past year for the relief of Brothers, was \$257,902. The amount paid for the relief of widowed families was \$60,815. The amount paid for educating orphans was \$94,707; and for burying the dead \$56,660.

The report of the R. W. Grand Corresponding and Recording Secretary, is finished in the following language, which I perceive is not published in the revised journal of the proceedings, and why it was left out I cannot conceive, for there is nothing in it that could hurt the feelings of any Brother, but on the contrary, the language is beautiful and appropriate.

"Upon a review of the condition of the order presented by the reports from the various Jurisdictions, the heart is gladdened that amid the terrible scenes which now pervade the land, its glorious mission of mercy blessed and prospered of God, has been unchecked, and its great office of benefaction to man, continues to be exerted with a single eye to its high calling; yet in the midst of our gratulation, and thanksgiving to a beneficent Providence, for the especial favor vouchsafed to our order, we have not escaped the withering influences inseparable in the nature of things, from so all permeating a calamity as that which now afflicts our country."

The Most Worthy Grand Sire of the order, R. B. Boylston, of South Carolina, whom it was your pleasure by your suffrage, at the last session, to honor for his long, valuable, and eminent services, not less than for his distinguished ability and private virtues, is not here to grace his high chair of office, that seat honored by long list of his predecessors, whose administration has consecrated their names and memory to our best affections, has been occupied by few equal to him, and by none superior in ability, it is

to-day under the constitution, by reason of his absence, held by the Worthy Deputy Grand Sire.

The R. W. Grand Marshal, Bro. E. D. Farnsworth, of Tennessee, is not found in his place, and the voice of Virginia, South Carolina, North Carolina, Georgia, Alabama, Mississippi, Louisiana, Texas, Florida, Arkansas and Tennessee, which we have been for so many years accustomed to hear within these walls, participating in our councils, enlightening, instructing, and animating us by their experience, is not now heard, and will

not be heard during our deliberations.

The seats which the Representatives of these Jurisdictions in our Brotherhood were wont to occupy, are not now occupied, and when the Recording Secretary shall call the roll from time to time, his familiar voice will not be heard by our brethren from the South, nor will there come up any response from their vacant places. We shall not grasp their hands in friendship, nor read their inward joy, as it sparkles from the eye when friends and brothers meet. We shall not meet with them in committee labor, nor measure lances with them in the arena of debate as heretofore. Why this spectacle? I dare not trust myself to answer, however choice and prudent may be the language employed, or however pure the motive, lest the answer should offend that consecrated law of our ritual, which ignoring with vestal honor, the divisions and classifications of human society, studiously avoids all affinity, with systems of faith or sect whether religious or political. The answer leaps nevertheless spontaneously from our saddened hearts, and invokes us to measure up in this crisis, to the full standard of Odd-Fellowship.

You, Representatives, are the great heart of that order, from you her lifeblood passes into all her veins. In the language of one of our distinguished and ever-beloved Patriarchs: "You are the watchmen on her towers, the rulers in her palaces. Her destiny is with you. Her fortunes are in your hands. God grant that her unity, her prosperity, and her perpetuity, may come forth from your councils; strengthened and assured by the light of wisdom, attempered and chastened by the broad spirit of brotherly love."

The several amendments to the constitution which were in order, were laid over in consequence of there being so few Representatives present, until the next meeting of Grand Lodge, all present feeling a disposition to do as little business as was possible. There were some decisions made by Grand Lodge, which may be of sufficient importance to include in this report. A brother suspended for non-payment of dues, and the Lodge afterwards surrenders its Charter, may be admitted to membership upon such terms, as the State Grand Lodge may by law prescribe. The Grand Lodge of the United States having no law applicable to the case. (Journal 3,350.)

The Grand Lodge Degree being by the laws of the Order a reward for official services, and not to be conferred for any other consideration than the regular performance of the duties of the Noble Grand's chair, brothers are

A brother reporting himself out of care thereby abandons any further claims of benefits for that sickness. (Journal 3,360.) When by the laws of the Local Jurisdiction, appeals are required to be made within a limited time, and that time is suffered to pass by without the appeal having been made, the right of appeal is gone. (Journal 3,366.)

The committee on the revision of the secret work of the order, reported in secret session. That they had divided their labors as follows: to Representative Stuart was assigned the encampment work, to Representative Dwinelle the degrees, and to Representative Nicholson, the initiatory work. Each member of the committee gave a short statement of their views on the work, and agreed to be fully prepared to report at the next session.

There were several efforts made to hold the next session of Grand Lodge in some other place, and five or six different places were proposed, and as quickly voted down, but the following Resolution being proposed by Rep. Nicholson, and adopted, had the effect to satisfy all present.

Resolved,—That should circumstances justify the Grand Secretary, and if in his opinion, the safety and security of the archives and books of the Grand Lodge may require it, he be authorized to remove the same to Philadelphia or New York.

Resolved,—That in the event of a probable interruption of the meeting of this body in Baltimore, in 1862, the R. W. Deputy be authorized to convene the Grand Lodge at some central and convenient place, sufficient notice to be given to the different Jurisdictions.

The following Resolutions were also proposed by Representative Escavaille, of Maryland, and unanimously adopted:

Resolved,—That the members of this Grand Lodge will employ every means, and will endeavor to impress upon the minds of their constituents, the necessity of cultivating and practising those principles and sentiments which will be best calculated to preserve our beloved order intact, wherever its benign influence has spread, wherever the banner of Odd-Fellowship has been unfurled.

Resolved,—That it is the duty of every good Odd-Fellow at all times, so to act and so to speak, that their words and their deeds may give no just cause of offence to those whose circumstances have for the time being, been cut off from friendly and social intercourse with us.

Resolved,—That this Grand Lodge hopes and will continue to hope that the trying difficulties now existing, and which have shaken our common country to its very foundation, causing distrust and estrangement between brothers and friends, may be speedily and amicably settled, and that the storm which is now raging in the hearts of the people of this once peaceful and happy land, may be assuaged, and the clouds which have darkened the

hopes and blighted the prospects of a whole nation, may be swept away, giving place to a cloudless sky, a bright-and gracious sunshine, shedding peace, harmony, and joy over and throughout this wide spread land.

The Grand Lodge met pursuant to adjournment.

Rep. Sewell, from Committee on Returns submitted the following Report, which was adopted.

CHATHAM, C. W., August 6th, 1862.

To the R. W. G. L. of Canada West .:

We, your Committee on Returns, having examined the various Lodge returns, beg leave to report as follows:

The returns of Thames, Elgin, Gore, Eureka, Forest City, Union, Imperial, Chatham, Samaritan, Long Point, and Rond Eau, are correct.

Brock Lodge is deficient in per centage seventy-nine cents. In half yearly report ending June 30th, 1862, from St. Marys Lodge we find that fourteen brothers are reported as suspended for con-payment of dues, the names of which are not inserted.

We find that Erie Lodge are not acting in compliance with the Constitution of Subordinate Lodges, as they are only charging four dollars per annum for dues.

In regard to Avon Lodge, return of June 30th, we find that they have received initiation fees for five brothers, for which this Lodge has received no per centage, upon enquiry we find that said initiation fees have been returned to the brothers, for the purpose of enabling them to become charter members of Thames Lodge, your committee therefore enquire if it is right the Grand Lodge should be at a loss of such per centage.

Your Committee would strongly recommend that all Lodges be instructed to make returns only of brothers that are actually good on the books at the

time of making out returns, and that the Secretary be instructed to notify all Lodges to such effect.

We would further recommend, in consequence of Lodges charging various sums for dues and degrees, that all Lodges be requested to insert in each return, the amount charged by them in such cases, as such proceeding will much facilitate the labors of future committees.

In conclusion, we would most respectfully suggest that Erie Lodge be requested to make up the deficiency of between \$4 and \$6, as received by them for dues, and to remit the same to the Secretary.

All which is most respectfully submitted.

We recommend that the amendment to Article 5th, Sec. 1st, of the By-laws of Union Lodge, No. 16, altering the scale of Initiation Fees, and that the amendment to By-laws passed by above Lodge, on the 19th day of August, 1861, striking off all widows who have received benefits over five. years, and all others who are or may hereafter be in receipt of benefits, shall be governed by the same. And also, that the amendment to the amendment to Article 6th, Section 4th, Clause 1st, adopted November 14th, 1859, providing for a continuation of widow's benefits, if found necessary by a two-third vote of the brethren present. Also, the amendment of Article 5th, Section 7th, Clause 1st, of the By-laws of some Lodges, making provisions for investing their funds in land and buildings; above having been approved by the advising Board, be sanctioned by this Grand Lodge

We also recommend the adoption of Clause 22, in the Worthy Grand Secretary's Report, and Clause 8, in the Worthy Grand Master's Address, and that the Charters be filled and forwarded to Long Point and Thames

Lodges, and to Excelsior as soon as organized.

The opinion of your committee coincides with that of the R. W. Grand Secretary, with reference to Clauses 13, 14, 15, 16 and 17, but any Lodge wishing to retain their original Dispensation may do so by returning it to the R. W. Grand Secretary, in order that it may be cancelled and returned.

With reference to the decision of the R. W. Grand Master, in Clause 12, in his address, on expulsion for non-payment of dues, your committee admit that it is a custom at variance with principles and spirit of our Order, yet we hold that it is not illegal to expel a member for non-payment of dues, but your committee would recommend that the term ceased to be a member, be used, instead of expelled for non-payment of dues.

We have examined the By-laws of Long Point Lodge, No. 42. and find

them correct.

In reporting upon the notice of amendment to Constitution of G. L., given at the last session of the Grand Lodge, with reference to the proportion to be appropriated for Widows and Orphans Fund, your committee recommend that Subordinate Lodges be allowed the privilege of fixing their own rate, but in no case shall it be less than one-fifth.

Your committee would also recommend the adoption of amendment to Constitution of the Grand Lodge, so as to combine the offices of Grand

Treasurer and Grand Secretary.

In accordance with the foregoing we respectfully submit the following: 1st.—Resolved, That amendments 1, 2 and 3, to By-laws of Union Lodge, No. 16, be adopted.

2nd .- Resolved, That Clause 22, in the R. W. Grand Secretary's Report

be adopted.
