An Act to enable the Town Council of the Town of St. Catharines to sell and convey certain Land purchased by the said Council for the purpose of a Public Cemetery.

WHEREAS the Town Council of the Town of St. Catharines, in the year 1854, purchased a part of Lot number seven in the seventh concession of the Township of Grantham for the purpose of a Public Cemetery; And whereas the said Council subsequently acquired another tract of land more advantageously situate for the purpose of a Public Cemetery and have expended a large sum of money in preparing the said last mentioned tract of land for Cemetery purposes; And whereas the said Council no longer requires the said land so purchased as aforesaid and desires to be authorized to dispose thereof: Therefore Her Majesty, &c., enacts as follows: Preamble.

10 I. The said Town Council of the Town of St. Catharines shall have full power and authority, to sell and dispose of that part of Lot number seven in the seventh concession of the Township of Grantham in the County of Lincoln, heretofore purchased by the said Council for the purpose of a Public Cemetery and to convey the same in fee simple to such person or persons as may be desirous of purchasing the same. Town Council may sell the said lot.

II. This Act shall be a public Act and the Interpretation Act shall apply to it. Public Act.
