An Act to constitute a second Registration Division in the County of Lotbinière.

WHEREAS, it is extremely inconvenient and onerous for the inhabitants of the Parishes of St. Sylvester, in the County of Megantic, and St. Giles and St. Agatha, in the County of Lotbinière, to have access to the Registry Offices of the Registration Divisions to which they now severally belong, that is to say, to the Registry Office of the County of Megantic for the Parish of St. Sylvester, and to the Registry Office of the County of Lotbinière for the Parishes of St. Giles and St. Agatha, and it is expedient to remedy such inconvenience; Therefore, Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:—

1. From and after the passing of this Act, the said Parishes of St. Sylvester, St. Giles and St. Agatha shall be united for the purposes of registration only, and shall constitute a separate Registration Division for the County of Lotbinière.
- 15 2. The Governor shall establish a Registry Office in and for the said Parishes at the most convenient place within the Division hereby constituted, and shall appoint a fit and proper person to be Registrar of and for the said Division.
- 20 3. The Registry Office now established in the County of Lotbinière shall be called the “Registry Office of and for the County of Lotbinière, Division No. 1,” and the Registry Office established by this Act shall be called the “Registry Office of and for the County of Lotbinière, Division No. 2.”
4. This Act shall be deemed a public Act.
