

MUNICIPAL OWNERSHIP

Reply to the "Special Commissioner" of the Ottawa Free Press and His Comments.

Some time ago The Ottawa Free Press sent a special commissioner to Port Arthur and Fort William to report on the condition of the municipal enterprises operated in these towns.

The report gave a very gloomy picture of municipal ownership as applied to Port Arthur and Fort William. These two towns own and operate their electric light, waterworks, telephone and street railway system. It appears that they strongly resent the article published in The Ottawa Free Press and they have issued in the form of a booklet a reply signed by Mayor Jackson and Town Clerk McNaughton of Fort William. Others who assisted in the preparation of the reply were Councilors E. S. Rutledge and Wm. Newcombe, J. J. Wells, Water and Light Commissioner, and F. E. Troutman, editor of The Times-Journal.

These gentlemen were appointed by the Town Council of Fort William as a special committee to reply to the article in The Ottawa Free Press. Here is the reply in part:

It is no secret that the Bell Telephone Co. in common with all other monopolies that have money invested in street railways, electric light and waterworks systems, are clamoring against the growing inclination on the part of people to own and operate these franchises, and are leaving no stone unturned to discredit such growth, and Port William, being a pioneer in the enterprise, is a particular object of attack. It is to the interest of monopolies to make it appear that these franchises are operated at a loss. We endeavor in this article to make it plain that the special commissioner did not tell the truth. The facts and figures submitted are all taken from the books of the town, and the same facts and figures are open to any person who desires to verify them. The report was submitted to the Town Council, and by it at a regular council meeting, and goes out as an official document of that body.

They have over and above this about 37 paid subscribers. We have sworn evidence of their own officials that they have entered into contracts in this town to supply, and have supplied, and are now supplying, free telephones. Our citizens remained loyal and as soon as the new plant was installed, the demand became so great for town telephones that we have not yet been able to install all that are on order.

In the evidence in the case of W. P. Stanser v. A. J. Woodhead, in the District Court of the provincial judge, the evidence of the Bell Telephone Co. was as follows: Question: You are the special agent of the Bell Telephone Co. Answer: Yes. The special commissioner says: But I was not able to obtain from the officials a definite statement of expenditure on the plant since the original contract was completed, or could I get any definite information as to the receipts or the cost of the maintenance of the telephone system.

Commissioner John J. Wells took the special commissioner to the town office, asked for and obtained the telephone register, and showed him receipts to over \$1,000, told him that the accounts rendered ending December 31, 1902, were not yet due, and that the amounts expended on capital account could not be ascertained at this time, but that the special commissioner of the Ottawa Free Press dare not deny this.

Fort William's Finance. The special commissioner says: There has been no audit of the town accounts for 1901, and no financial statement has been published or is available from any source which I could see.

There is probably no town in the province whose accounts are better kept than the town of Fort William. The annual statements of the town, as published since 1894, bear evidence of this, and many provincial accountants and treasurers of the larger municipalities have expressed themselves to the effect that Fort William's statements are one of the clearest and most comprehensive presented by any town in the province. The provincial auditor, J. W. Lang, says in his report for the year 1902: "The treasurer of Fort William is an efficient officer, I found his business correct, and his accounts kept. The financial statement for the year was an elaborate production."

The town accounts have been audited every year since incorporation and a financial statement published. The statement of the year 1902 was delayed on account of the fire in March, 1903.

The clerk of the town gives the debt and indebtedness as \$457,223. This statement is a half-truth, deliberately designed to convey a false impression. The debt and indebtedness (\$457,223.18) is the gross debt and indebtedness, and has been made up of sinking fund debt, and other debt, and is not the net debt, which is \$1,012,641, which makes the net debt about \$555,418.00.
